Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the financial statements of Austin Retina Associates 401(k) Profit Sharing Plan (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets in liquidation as of July 31, 2023 and December 31, 2022, and the related statement of changes in net assets in liquidation for the year ended July 31, 2023, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Basis for Opinion

We are required to be independent of the Plan and to meet our other ethical responsibilities, in accordance with the relevant ethical requirements relating to our audits. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our ERISA Section 103(a)(3)(C) audit opinion.

Emphasis of Matter – Plan Termination and Liquidation Basis of Accounting

As further discussed in Note 1 to the financial statements, the Administrative Committee of the Plan approved a plan of liquidation on August 14, 2022, and management determined liquidation is imminent. As a result, the Plan changed its basis of accounting from the going-concern basis of accounting used in presenting the 2021 financial statements to the liquidation basis of accounting used in presenting the 2022 and 2023 financial statements. Our opinion is not modified with respect to this matter.

Responsibilities of Management for the Financial Statements

Management is responsible for the preparation and fair presentation of the financial statements in accordance with accounting principles generally accepted in the United States of America, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

Management is also responsible for maintaining a current plan instrument, including all plan amendments, administering the plan, and determining that the plan's transactions that are presented and disclosed in the financial statements are in conformity with the plan's provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.

Auditor's Responsibilities for the Audit of the Financial Statements



NOTE 1 – DESCRIPTION OF PLAN

Austin Retina Associates 401(k) Profit Sharing Plan (the Plan) is a qualified retirement plan adopted by Austin Retina Associates (the Company). The Plan was originally effective May 1, 1979, and was amended and restated effective January 1, 2022. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA). The following description of the Plan provides only general information. Participants should refer to the plan document for a more complete description of the Plan's provisions.

Plan Termination: Effective August 14, 2022 (Termination Date), the Company made the decision to terminate the Plan. Upon Termination Date, all active participants became 100% vested. The Company will direct distributions to participants and beneficiaries within a reasonable period of time after the Termination Date. All plan assets were liquidated from the Plan by July 31, 2023.

Eligibility: Prior to the Termination Date, eligible employees could enter the Plan the first day of the quarter subsequent to completion of three months of employment and attainment of age 21. Eligible employees that had completed one year of service and attained age 21 were eligible for profit sharing contributions.

Contributions: Prior to the Termination Date, contributions were subject to certain limitations. Participants could elect to contribute up to 90% of eligible compensation. Participants who had attained age 50 before the end of the Plan year were eligible to make catch-up contributions. Employees would be automatically enrolled into the Plan with a 3% deferral following the date eligibility was met, unless elected otherwise.

The Company contributed 100% of the first 3% of compensation as a safe harbor nonelective contribution, as defined in the Plan. Additional employer profit sharing contributions and employer matching contributions could be made at the discretion of the Company.

Participants were permitted to deposit into the Plan distributions they had received from other retirement plan and certain IRAs, called a rollover contribution.

Participant Accounts: Each participant's account was credited with the participant's contributions and an allocation of (a) the Company's contributions, (b) Plan earnings and losses, and (c) forfeitures of employer profit sharing and matching contributions and was charged with his or her withdrawals and an allocation of administrative expenses. Allocations were based on participant contributions, eligible compensation, participant account balances, or specific participant transactions, as defined. The benefit to which a participant was entitled was the benefit that could be provided from the participant's vested account. Each participant directed the investment of his or her account to any of the investment options available under the Plan.

Retirement, Death and Disability: A participant was entitled to 100% of his or her account balance upon retirement, death or disability.

Vesting: Participants were vested immediately in their contributions, employer safe harbor nonelective contributions, and actual earnings thereon. Vesting in the Company's discretionary employer profit sharing and discretionary employer matching contribution portion of their accounts was based on years of continuous service. Participants became fully vested after six years of service.

Payment of Benefits: On termination of service, a participant could elect to receive a lump-sum distribution equal to the value of the participant's vested interest in his or her account. Any balance over \$5,000 required participant consent before distributions could be made. Any balance under \$5,000 and over \$60 was automatically rolled into an individual retirement account. Hardship withdrawals were also available subject to certain limitations.

Notes Receivable from Participants: Participants could borrow from their fund accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balance. Notes receivable were required to be repaid within five years unless for the purchase of a primary residence, in which case notes receivable were required to be repaid within 20 years. The notes were secured by the balance in the participant's account and bear interest, as determined by the Plan Administrator. Principal and interest were paid through payroll deductions.

Forfeitures: Participant forfeitures of nonvested balances would be used to reduce future employer contributions and pay the expenses of the Plan. At July 31, 2023 and December 31, 2022, unallocated forfeitures totaled \$0 and \$103,827, respectively.

Administrative Expenses: Certain expenses of maintaining the Plan were paid by the Plan Sponsor and are excluded from these financial statements. Administrative expenses include fees related to the administration of notes receivable that were charged directly to the participant's account and certain recordkeeping fees paid by the Plan. Investment-related expenses are included in net appreciation in fair value of investments.

Subsequent Events: Plan management has evaluated subsequent events for recognition and disclosure through April 8, 2024, which is the date the financial statements were available to be issued.

NOTE 2 – SUMMARY OF ACCOUNTING POLICIES

Basis of Accounting: Due to the Company terminating the Plan effective August 14, 2022; it was determined by Plan management that termination was imminent and therefore, the financial statements were prepared on the liquidation basis of accounting in accordance with accounting principles generally accepted in the United States of America (GAAP) for the year ended July 31, 2023 and December 31, 2022. The adoption of liquidation basis of accounting did not have a material effect of the financial statements.

Estimates: The preparation of financial statements in accordance with GAAP requires management to make estimates and assumptions that affect certain reported amounts of assets, liabilities and changes therein. Actual results may differ from these estimates.

Investment Valuation and Income Recognition: The Plan's investments are reported at fair value as further described in Note 4. Fair value is the price that would be received by the Plan for an asset or paid by the Plan to transfer a liability (an exit price) in an orderly transaction between market participants on the measurement date in the Plan's principal or most advantageous market for the asset or liability.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the plan's gains and losses on investments bought and sold as well as held during the year.

Notes Receivable from Participants: Notes receivable from participants are reported at their unpaid principal balance plus any accrued but unpaid interest, with no allowance for credit losses, as repayments of principal and interest are received through payroll deductions and the notes are collateralized by the participants' account balances. Related fees are recorded as administrative expenses and are expensed when they are incurred.

Benefits Paid to Participants: Benefits are recorded when paid.

Risks and Uncertainties: The Plan holds various investments. Investments are exposed to various risks such as interest rate, market, liquidity, credit and risks related to global events. Due to the level of risk associated with certain investments, it is least reasonably possible that changes in the fair values of investments will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits in liquidation.

NOTE 3 – CERTIFIED INFORMATION

Certain information related to investments and notes receivable from participants disclosed in the accompanying financial statements, including investments and notes receivable from participants held at July 31, 2023 and December 31, 2022, net appreciation in fair value of investments, dividends, and interest income on notes receivable from participants for the year ended July 31, 2023, was obtained by management and agreed to or derived from information certified as complete and accurate by Reliance Trust Company.

NOTE 4 – FAIR VALUE MEASUREMENTS

Fair value measurements are determined by maximizing the use of observable inputs and minimizing the use of unobservable inputs. The hierarchy places the highest priority on unadjusted quoted market prices in active markets for identical assets or liabilities (Level 1 measurements) and gives the lowest priority to unobservable inputs (Level 3 measurements). The three levels of inputs within the fair value hierarchy are defined as follows:

Level 1: Quoted prices (unadjusted) for identical assets or liabilities in active markets that the Plan has the ability to access as of the measurement date.

Level 2: Significant other observable inputs other than Level 1 prices such as quoted prices for similar assets or liabilities; quoted prices in markets that are not active; or other inputs that are observable or can be corroborated by observable market data.

Level 3: Significant unobservable inputs that reflect the Plan's own assumptions about the assumptions that market participants would use in pricing an asset or liability.

In some cases, a valuation technique used to measure fair value may include inputs from multiple levels of the fair value hierarchy. The lowest level of significant input determines the placement of the entire fair value measurement in the hierarchy.

The following presents the valuation methods and assumptions used by the Plan to estimate the fair values of investments.

Mutual Funds: The fair values of mutual fund investments are determined by obtaining quoted prices on nationally recognized securities exchanges (Level 1 inputs).

Stable Value Fund: The stable value fund is valued at the net asset value (NAV), as reported by the investment manager at year-end. The fund's underlying assets consist of investment contracts and security-backed contracts. The NAV is used as a practical expedient to estimate fair value.

NOTE 5 – PARTY-IN-INTEREST TRANSACTIONS

Parties-in-interest are defined under DOL regulations as any fiduciary of the Plan, any party rendering service to the Plan, the employer, and certain others. Certain administrative functions are performed by officers or employees of the Company. No such officer or employee receives compensation from the Plan. Some administrative expenses of the Plan are paid directly by the Company. Transamerica Retirement Solutions, LLC is a service provider to the Plan and, therefore, these transactions and the Plan's payment of fees to the service provider qualify as party-in-interest transactions. Notes receivable from participants also reflect party-in-interest transactions.

NOTE 6 – TAX STATUS

The Internal Revenue Service issued an opinion letter dated June 30, 2020 indicating that the pre-approved non-standardized profit-sharing plan adopted by the Plan, as then designed, was in compliance with applicable requirements of the Internal Revenue Code. Although the Plan has been amended from the original pre-approved non-standardized plan document, Plan management believes that the Plan is currently being operated in accordance with the Internal Revenue Code.

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the Plan. The plan administrator has analyzed the tax positions taken by the Plan, and has concluded that as of July 31, 2023 and December 31, 2022, there are no uncertain positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress. The plan administrator believes it is no longer subject to income tax examinations for years prior to 2020.
