Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the financial statements of Revolution Foods 401(k) Plan (the "Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of July 26, 2023 and December 31, 2022, the related statement of changes in net assets available for benefits for the period from January 1, 2023 through July 26, 2023 and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's (DOL) Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the Plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the DOL's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from a qualified institution as of July 26, 2023 and December 31, 2022, and for the period from January 1, 2023 through July 26, 2023, stating that the certified investment information, as described in Note 3 to the financial statements, is complete and accurate.

Opinion

In our opinion, based on our audits and on the procedures performed as described in the Auditor's Responsibilities for the Audit of the Financial Statements section:

- The amounts and disclosures in the accompanying financial statements, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America (U.S. GAAP).
- The information in the accompanying financial statements related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

Basis for Opinion

We conducted our audits in accordance with auditing standards generally accepted in the United States of America (GAAS). Our responsibilities under those standards are further described in the Auditor's Responsibilities for the Audit of the Financial Statements section of our report. We are required to be independent of the Plan and to meet our other ethical responsibilities, in accordance with the relevant ethical requirements relating to our audits. Emphasis of Matter-Plan Merger

As discussed in Note 1 to the financial statements, the Company's management made the decision to merge the Plan into the SuccessWise Pooled Employer Plan, effective July 1, 2023. All Plan assets were transferred to the SuccessWise Pooled Employer Plan as of July 26, 2023. Our opinion has not been modified with respect to this matter.

Responsibilities of Management for the Financial Statements

Management is responsible for the preparation and fair presentation of the financial statements in accordance with U.S. GAAP, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

The following description of the Revolution Foods 401(k) Plan (the “Plan”) provides only general information. Participants should refer to the Plan document for a more complete description of the Plan’s provisions.

General

The Plan is a defined contribution plan that was established in 2009 by Revolution Foods, Inc. (the “Company” or “Employer”) to provide benefits to eligible employees, as defined in the Plan document. The Plan is currently designed to be qualified under the applicable requirements of the Internal Revenue Code (“IRC”) and the provisions of the Employee Retirement Income Security Act of 1974 (“ERISA”), as amended.

The Company’s management made the decision to merge the Plan into the SuccessWise Pooled Employer Plan, effective July 1, 2023. All Plan assets were transferred to SuccessWise Pooled Employer Plan as of July 26, 2023.

Administration

The Company has appointed a 401(k) Plan Committee to manage the operation and administration of the Plan. The Company has appointed two officers to act as the trustees and contracted with Ascensus Trust Company (“Ascensus”) to act as the trustee and custodian of the Plan.

Eligibility

An employee is eligible on the first day of the month after completing 30 days of employment and must be at least 18 years old.

Participant Contributions

Participants may elect to have the Company contribute their eligible pre-tax or Roth after-tax compensation to the Plan up to the amount allowable under the Plan document and current income tax regulations. Participants who have the Company contribute a portion of their compensation to the Plan agree to accept an equivalent reduction in taxable compensation. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. Contributions withheld are invested in accordance with the participants’ direction.

Participants are also allowed to make rollover contributions of amounts received from other tax-qualified employer-sponsored retirement plans. Such contributions are deposited in the appropriate investment funds in accordance with the participants’ direction and the Plan’s provisions.

Employer Contributions

The Company may make discretionary Employer matching and profit-sharing contributions to eligible employees. The Company did not make any discretionary Employer contributions during 2023.

NOTE 1 – DESCRIPTION OF THE PLAN (Continued)

Vesting

Participants are immediately vested in their contributions, plus actual earnings thereon. Vesting in the employer’s contribution portion of their account plus actual earnings thereon is based on years of continuous service as follows:

<u>Completed Years of Service</u>	<u>Vested Percentage</u>
Less than 1 year	0%
1 but less than 2 years	0%
2 but less than 3 years	20%
3 but less than 4 years	40%
4 but less than 5 years	60%
5 but less than 6 years	80%
6 or more years	100%

Investment Options

Participants must direct their salary deferral contributions to selected investments as made available and determined by the Plan Administrator. Participants may change their investment options any time throughout the year through the Plan Sponsor.

Participant Accounts

Individual accounts are maintained for each of the Plan’s participants to reflect the participant’s contributions, rollovers from qualified plans of the participant’s previous employers, and allocations of the Plan’s earnings and administrative expenses. Each participant’s account is credited with the participant’s contributions, Plan earnings or losses and an allocation of the Company’s contribution, if any. The benefit to which a participant is entitled is the benefit that can be provided from the participant’s vested account.

Payment of Benefits

Upon termination of service due to termination, death, disability or retirement, the participants or beneficiaries may elect to leave their account balance in the Plan, or receive their total benefits in a lump sum amount equal to the value of the participant’s interest in their account or in the form of an annuity. The Plan allows for the automatic distribution of participant account balances that do not exceed \$5,000.

Financial Hardship Distributions

The Plan allows hardship withdrawals in accordance with Internal Revenue Service (“IRS”) regulations. Among other things, the withdrawal must be necessary in light of immediate and heavy financial needs of the participant and is limited to certain purposes.

NOTE 1 – DESCRIPTION OF THE PLAN (Continued)

Notes Receivable from Participants

The Plan allows participants to borrow up to the lesser of \$50,000 or 50% of their account balance. The note must be a minimum of \$1,000. The notes are secured by the participant's balance. Such notes bear interest at available market financing rates and must be repaid to the Plan within a five-year period, unless the note is used for the purchase of a principal residence in which case the maximum repayment period may be longer. The specific terms and conditions of such notes are established by the Plan. Outstanding notes receivable at December 31, 2022, carried interest rates ranging from 4.25% to 7.5% and mature through 2025.

NOTE 2 – SIGNIFICANT ACCOUNTING POLICIES

Basis of Accounting

The financial statements of the Plan are prepared in accordance with accounting principles generally accepted in the United States of America ("U.S. GAAP").

Administrative Expenses

Certain administrative expenses are paid directly by the Company. Expenses paid by the Company are excluded from these financial statements.

Use of Estimates

The preparation of financial statements in conformity with U.S. GAAP requires management to make estimates and assumptions that affect the reported amounts of net assets available for benefits and changes therein. Actual results could differ from those estimates.

Investment Valuation and Income Recognition

The Plan's investments are stated at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 4 for a discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation or depreciation includes the Plan's gains and losses on investments bought or sold as well as held during the year.

Management fees charged to the Plan for investments are based on assets invested and are deducted on a daily basis. Management fees are reflected as a reduction of investment return for such investments.

NOTE 2 – SIGNIFICANT ACCOUNTING POLICIES (Continued)

Notes Receivable from Participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Delinquent notes are reclassified as distributions based upon the terms of the Plan document. There were no deemed distributions for the period from January 1, 2023 to July 26, 2023. No allowance for credit losses had been recorded as of July 26, 2023 and December 31, 2022.

Payment of Benefits

Benefits payments to participants or beneficiaries are recorded when paid. Corrective distributions payable generally represent the distribution of certain assets to employees in order for the Plan to comply with ERISA nondiscrimination rules.

Risks and Uncertainties

The Plan provides for various investment options in any combination of investment securities offered by the Plan. Investment securities are exposed to various risks, such as interest rate, market fluctuations and credit risks. Due to the risk associated with certain investment securities, it is at least reasonably possible that changes in market values, interest rates or other factors in the near term would materially affect participants' account balances and the amounts reported in the statements of net assets available for plan benefits and the statement of changes in net assets available for plan benefits.

NOTE 3 – CERTIFIED INFORMATION

The Plan Administrator has elected the method of compliance permitted by 29 CFR 2520.103-8 of the United States Department of Labor's ("DOL") Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, Ascensus, the custodian of the Plan, has certified the completeness and accuracy of:

- Investments and notes receivable from participants reflected in the accompanying statements of net assets available for plan benefits as of December 31, 2022.
- Net appreciation in fair value of investments, interest and dividend income, interest income on notes receivable from participants and the transfer of assets out the Plan reflected in the accompanying statement of changes in net assets available for plan benefits for the period from January 1, 2023 through July 26, 2023.

NOTE 4 – FAIR VALUE MEASUREMENT

The fair value measurements standard establishes a framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements). The three levels of the fair value hierarchy under the standard are described below:

Level 1 – Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 – Inputs to the valuation methodology include:

- Quoted market prices for similar assets or liabilities in active markets;
- Quoted prices for identical or similar assets or liabilities in inactive markets;
- Inputs other than quoted prices that are observable for the asset or liability;
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 – Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following are descriptions of the valuation methodology used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2022.

Interest-bearing cash

Valued at the carrying value, which approximates fair value due to the short-term nature of such investments.

Registered investment companies (mutual funds)

Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-ended mutual funds that are registered with the U.S. Securities and Exchange Commission. These funds are required to publish their daily net asset value ("NAV") and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

The methods described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation method is appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

NOTE 5 – RELATED PARTY AND PARTY-IN-INTEREST TRANSACTIONS

Certain Plan investments and notes receivable from participants and the related interest income are managed and held by Ascensus, the custodian of the Plan. Such transactions, while considered party-in-interest transactions under ERISA regulations, are permitted under the provisions of the Plan and are specifically exempt from the prohibition of party-in-interest transactions under ERISA.

NOTE 6 – TAX STATUS AND UNCERTAINTY IN INCOME TAXES

The Company adopted a non-standardized form of a pre-approved plan agreement with a cash or deferral arrangement which received a favorable opinion letter from the IRS, which stated that the Plan and related trust are designed in accordance with the applicable sections of the Internal Revenue Code. The Plan Administrator and the Plan's tax counsel believe that the Plan is currently designed and is being operated in compliance with the applicable requirements of the Internal Revenue Code. Therefore, no provision for income taxes has been included in the Plan's financial statements.

U.S. GAAP requires the Plan Administrator to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not, would not be sustained upon examination by the IRS or the DOL. The Plan Administrator has analyzed the tax positions taken by the Plan, and has concluded that for the period from January 1, 2023 through July 26, 2023 and as of December 31, 2022, there are no uncertain tax positions taken or expected to be taken that would require recognition of a liability or asset or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

NOTE 7 – NON EXEMPT TRANSACTIONS

During the Plan year ended June 30, 2020, the Plan sponsor failed to deposit \$11,142 of participants' contributions and notes receivable repayments within the required timeframe as stated by DOL's regulations. The delay in remitting the contributions to the custodian was caused by administrative errors. The Company will deposit the lost earnings into the affected participant's account in 2024 to correct the error outside of the Voluntary Fiduciary Correction Program ("VFCP") in 2024.

During the Plan period ended December 31, 2020, the Plan sponsor failed to deposit \$100 of notes receivable repayments within the required timeframe as stated by DOL's regulations. The delay in remitting the repayments to the custodian was caused by administrative errors. The Company will deposit the lost earnings into the affected participant's account in 2024 to correct the error outside of the VFCP in 2024.

NOTE 7 – NON EXEMPT TRANSACTIONS (Continued)

During the Plan year ended December 31, 2021, the Plan sponsor failed to deposit \$142,424 of participants' contributions and notes receivable repayments within the required timeframe as stated by DOL's regulations. The delay in remitting the contributions to the custodian was caused by administrative errors. The Company deposited the late contributions and notes receivables, of which the Company calculated and deposited the lost earnings related to \$85,561 into the affected participant's account outside the VFCP in 2023. The Company will calculate and deposit the lost earnings on the remaining balance in 2024.

During the plan year ended December 31, 2022, the Plan sponsor failed to deposit \$481 of participants' contributions and notes receivable repayments within the required timeframe as stated by DOL's regulations. The delay in remitting the contributions to the custodian was caused by administrative errors. The Company deposited the lost earnings into the affected participant's accounts to correct the error outside of the VFCP in 2023.

During the plan year ended July 26, 2023, the Plan sponsor failed to deposit \$33,824 of participants' contributions and notes receivable repayments within the required timeframe as stated by the DOL's regulations. The delay in remitting the contributions to the custodian was caused by administrative errors. The Company will deposit the lost earnings into the affected participant's account in 2024 to correct the error outside of the VFCP in 2024.

NOTE 8 – EXCESS CONTRIBUTIONS REFUNDABLE

At December 31, 2022, the liability of \$61,193, represents the distribution of Plan assets to employees in order for the Plan to comply with ERISA nondiscrimination rules.

NOTE 9 – SUBSEQUENT EVENTS

The Plan has evaluated subsequent events through March 21, 2024, which is the date the financial statements were available to be issued and has determined that there are no subsequent events that require disclosure.
