### **Hypothetical Account**

A theoretical account that is maintained for each participant. Each account is credited annually with interest at 5%, and an allocation following the terms of the Plan Document.

### **Vesting**

100% vested upon participation in the plan.

### **Death**

100% of the Participant's Hypothetical Account.

### **Disability**

100% of the Participant's Hypothetical Account.

### **Plan Amendments**

Amended to terminate the plan effective March 3, 2023. The Plan sponsor deemed the adoption of this amendment to occur on the first day of the 2023 Plan year according to Section 412(d)(2).
