## **Independent Auditors' Report**

Plan Administrator, Plan Investment Committee, and Participants of the  
Network for Good Profit Sharing Plan

### ***Scope and Nature of the ERISA Section 103(a)(3)(C) Audit***

We have performed an audit of the financial statements of Network for Good Profit Sharing Plan (the "Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 ("ERISA"), as permitted by ERISA Section 103(a)(3)(C) ("ERISA Section 103(a)(3)(C) audit"). The financial statements comprise the statements of net assets available for benefits as of August 1, 2022 and December 31, 2021, and the related statement of changes in net assets available for benefits for the period January 1, 2022 through August 1, 2022, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audit of the financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the plan ("investment information") by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA ("qualified institution").

Management has obtained certifications from qualified institution as of August 1, 2022 and December 31, 2021 and for the period January 1, 2022 through August 1, 2022, stating that the certified investment information, as described in Note 3 to the financial statements, is complete and accurate.

### ***Opinion***

In our opinion, based on our audits and on the procedures performed as described in the Auditor's Responsibilities for the Audit of the Financial Statements section:

- the amounts and disclosures in the accompanying financial statements, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.
- the information in the accompanying financial statements related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

### ***Basis for Opinion***

We conducted our audits in accordance with auditing standards generally accepted in the United States of America ("GAAS"). Our responsibilities under those standards are further described in the Auditor's Responsibilities for the Audit of the Financial Statements section of our report. We are required to be independent of the Plan and to meet our other ethical responsibilities, in accordance with the relevant ethical requirements relating to our audits. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our ERISA Section 103(a)(3)(C) audit opinion.

### ***Emphasis of Matter – Plan Merger***

As discussed in Note 1 to the financial statements, the Plan was merged into the Bonterra 401(k) Plan effective August 1, 2022. Our opinion is not modified with respect to this matter.

### ***Responsibilities of Management for the Financial Statements***

Management is responsible for the preparation and fair presentation of the financial statements in accordance with accounting principles generally accepted in the United States of America, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

In preparing the financial statements, management is required to evaluate whether there are conditions or events, considered in the aggregate, that raise substantial doubt about the Plan's ability to continue as a going concern for a period of one year subsequent to the audit report date.

Management is also responsible for maintaining a current plan instrument, including all Plan amendments, administering the Plan, and determining that the Plan's transactions that are presented and disclosed in the financial statements are in conformity with the Plan's provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.

### ***Auditor's Responsibilities for the Audit of the Financial Statements***

Except as described in the Scope and Nature of the ERISA Section 103(a)(3)(C) Audit of the Financial Statements section of our report, our objectives are to obtain reasonable assurance about whether the financial statements as a whole are free from material misstatement, whether due to fraud or error, and to issue an auditor's report that includes our opinion. **Notes to Financial Statements**  
**August 1, 2022 and December 31, 2021**

**NOTE 1 – DESCRIPTION OF PLAN**

The following description of the Network for Good Profit Sharing Plan (“Plan”) provides only general information. Participants should refer to the Plan document for a more complete description of the Plan's provisions.

General

The Plan is a defined contribution plan covering substantially all employees of Network for Good, Inc. (the “Plan Sponsor” or “Company”). Network for Good, a tax-exempt organization and related party to the Company, is a participating employer. The plan was established January 1, 2003, and is subject to the provisions of the Employee Retirement Income Security Act of 1974 (“ERISA”), as amended.

Effective August 1, 2022, the Plan merged into the Bonterra 401(k) Plan. On August 1, 2022, assets amounting to \$8,225,007 were transferred from John Hancock Life Insurance Company to Fidelity Management Trust Company, the new trustee.

Eligibility

Employees who were aged 21 were eligible to actively participate in the Plan on the first of the month following their date of employment.

Contributions

Each year participants were able to contribute a percentage of annual compensation, as defined by the Plan, as pre-tax deferrals. The plan did not allow for after-tax (Roth) deferrals. Participants who had attained age 50 before the end of the Plan year were eligible to make catch-up contributions. Participants could also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans (rollovers).

The Company was permitted to make discretionary matching contributions and safe harbor employer contributions. The Company did not make a safe harbor contribution during the period ended August 1, 2022.

Participant Accounts

Each participant's account was credited with the participant's contribution and the Plan Sponsor's contributions, if any, and allocations of Plan earnings (losses), and was charged with an allocation of any administrative expenses paid by the Plan. Allocations were based on participant earnings, account balances, or specific transactions, as defined. The benefit to which a participant was entitled was the benefit that could be provided from the participant's vested account balance.

Vesting

Participants were immediately vested in both their elective contributions and contributions made by the Company, plus actual earnings thereon.

**NOTE 1 – DESCRIPTION OF PLAN (continued)**

Forfeited Accounts

At August 1, 2022 and December 31, 2021 there was no balance in the forfeited non-vested matching contribution account. Forfeitures of matching contributions could be used to offset employer matching contributions or to pay administrative expenses. As employees were immediately vested in contributions made by the Company, there were no forfeitures to report for the period January 1, 2022 through August 1, 2022.

Notes Receivable from Participants

Participants were permitted to borrow from their vested accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000, or 50% of their vested account balance. The term of the loan could not exceed five years, unless the proceeds were used to buy a primary residence. Participants could not have more than 2 loans outstanding at a time. The notes were secured by the balance in the participant's account and bore interest at a reasonable rate as determined by the Plan administrator, which was determined to be prime plus 1%. Interest rates were 4.25% on outstanding loans during the period January 1, 2022 through August 1, 2022. Principal and interest payments were paid through deductions to the participant's paycheck.

Payment of Benefits

Distributions from the Plan were permitted upon termination of employment, retirement, disability, or death. Participants could elect a lump-sum distribution. For accounts \$1,000 or less, the vested account balance could be automatically paid out to the participant as a single sum, unless the participant elects otherwise. For accounts with balances between \$1,000 and \$5,000 where the participant was no longer an employee of the Plan Sponsor and did not elect to receive a distribution, the participant's vested balance could be rolled over into an IRA by the Plan Administrator. The Plan permits in-service distributions for participants who were age 59 ½ or older as well as in the case of certain financial hardship situations, subject to the provisions of the Plan document. Minimum required distributions for participants who had reached age 72 also apply per Internal Revenue Service ("IRS") regulations.

Administrative Expenses

The Plan's administrative expenses could be paid by the Plan, the Plan Sponsor, or with forfeitures, as provided in the Plan document. Transaction expenses, such as investment expenses, loan, and distribution administrative expenses were charged directly to the participant's account and were included in administrative expenses.

**NOTE 2 – SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES**

Basis of Accounting

The financial statements of the Plan are prepared using the accrual basis of accounting, in accordance with generally accepted accounting principles in the United States of America ("GAAP").

Use of Estimates

The preparation of financial statements in accordance with GAAP requires the Plan administrator to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosures of contingent assets and liabilities. Accordingly, actual results may differ from those estimates.

Investment Valuation and Income Recognition

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. Plan management determines the Plan's valuation policies utilizing information provided by the custodian. See Note 4 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net depreciation includes the plan's gains and losses on investments bought and sold, as well as held, during the year.

Contributions

Employee deferrals, employer matching contributions, if any, and safe harbor employer contributions are recognized on the pay date to which they relate.

Notes Receivable from Participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. If a participant does not make loan repayments and the plan administrator considers the participant loan to be in default, the loan balance is reduced, and the delinquent participant note receivable is recorded as a benefit payment based on the terms of the Plan document.

Payment of Benefits

Benefits are recorded when paid.

**NOTE 3 – INFORMATION CERTIFIED BY THE PLAN CUSTODIAN**

As noted in the independent auditors' report, the Plan administrator has elected the method of annual reporting compliance as permitted by CFR 2520.103-8 of the DOL's Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, certain information disclosed in the accompanying financial statements and supplemental schedule, was obtained or derived from information supplied to the Plan administrator and certified as complete and accurate by John Hancock Life Insurance Company ("John Hancock"), the custodian of the Plan. This information includes:

- Investment values as of August 1, 2022 and December 31, 2021, as shown in the statements of net assets available for benefits and the fair value disclosures in Note 4.
- Notes receivable from participants, as shown in the statements of net assets available for benefits as of August 1, 2022 and December 31, 2021.
- Net investment income and interest income on notes receivable from participants, as shown in the statement of changes in net assets available for benefits for the period ended August 1, 2022.

The Plan's independent auditors did not perform auditing procedures with respect to information certified by the custodian.

**NOTE 4 – FAIR VALUE MEASUREMENTS**

GAAP establishes a framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements). The three levels of the fair value hierarchy are described as follows:

- Level 1 inputs consist of unadjusted quoted prices in active markets for identical assets and have the highest priority;
- Level 2 inputs consist of observable inputs other than quoted prices for identical assets; and
- Level 3 inputs are unobservable and have the lowest priority.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at August 1, 2022 and December 31, 2021.

*Pooled Separate Accounts:* Valued at net asset value (NAV) per unit based on quoted market prices of the underlying investments. The pooled separate accounts have daily redemptions and one day trading terms. There are no unfunded commitments at August 1, 2022. The funds are direct filing entities and as such, investment strategy disclosures are not required.

In accordance with ASC 820-10, certain investments that are measured at fair value using the NAV per share (or its equivalent) practical expedient are not classified in the fair value hierarchy. Because all the Plan's investments are pooled separate accounts, the fair value hierarchy table has not been presented.

The methods described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

**NOTE 5 – RELATED PARTY AND PARTY-IN-INTEREST TRANSACTIONS**

Plan investments are units of pooled separate accounts managed by the custodian of the Plan. Investment expenses and administrative expenses paid to the custodian qualify as party-in-interest transactions. The Plan also allows notes receivable from participants. These transactions qualify as party-in-interest transactions which are exempt from the prohibited transaction rules.

**NOTE 6 – PLAN TERMINATION**

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA.

See Note 1 for discussion of the merger of the Plan into the Bonterra 401(k) Plan.

**NOTE 7 – TAX STATUS**

The Plan adopted a defined contribution volume submitter plan sponsored by United Retirement Plan Consultants. The prototype plan has received an opinion letter from the Internal Revenue Service dated March 31, 2014, as to the volume submitter plan's qualified status. The opinion letter has been relied upon by this Plan. The Plan has been amended since the date of the opinion letter; however, the Plan Administrator believes the Plan is designed and is being operated in compliance with the applicable provisions of the Internal Revenue Code.

**NOTE 7 – TAX STATUS (continued)**

U.S. GAAP requires Plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination. Management evaluated the Plan's tax positions and concluded that the Plan has maintained its tax-exempt status and has taken no uncertain tax positions that require recognition or disclosure in the financial statements. Therefore, no provision or liability for income taxes has been included in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax period in progress.

**NOTE 8 – RISKS AND UNCERTAINTIES**

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the accompanying statements of net assets available for benefits.

**NOTE 9 – SUBSEQUENT EVENTS**

The Plan has evaluated subsequent events through April 10, 2024, the date the financial statements were available to be issued and is not aware of any additional significant subsequent events which would require recognition or disclosure in the financial statements.
