Independent Auditors' Report

Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed an audit of the financial statements of EveryAction, Inc. 401(k) Plan (the "Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 ("ERISA"), as permitted by ERISA Section 103(a)(3)(C) ("ERISA Section 103(a)(3)(C) audit"). The financial statements comprise the statements of net assets available for benefits as of August 1, 2022 and December 31, 2021, and the related statement of changes in net assets available for benefits for the period January 1, 2022 through August 1, 2022, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the plan ("investment information") by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA ("qualified institution").

Management has obtained certifications from a qualified institution as of August 1, 2022 and December 31, 2021 and for the period January 1, 2022 through August 1, 2022, stating that the certified investment information, as described in Note 3 to the financial statements, is complete and accurate.

Opinion

In our opinion, based on our audits and on the procedures performed as described in the Auditor's Responsibilities for the Audit of the Financial Statements section:

- the amounts and disclosures in the accompanying financial statements, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.
- the information in the accompanying financial statements related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

Basis for Opinion

We conducted our audits in accordance with auditing standards generally accepted in the United States of America ("GAAS"). Our responsibilities under those standards are further described in the Auditor's Responsibilities for the Audit of the Financial Statements section of our report. We are required to be independent of the Plan and to meet our other ethical responsibilities, in accordance with the relevant ethical requirements relating to our audits. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our ERISA Section 103(a)(3)(C) audit opinion.

Emphasis of Matter – Plan Merger

As discussed in Note 1 to the financial statements, the Plan was merged into the Bonterra 401(k) Plan effective August 1, 2022. Our opinion is not modified with respect to this matter.

Responsibilities of Management for the Financial Statements

Management is responsible for the preparation and fair presentation of the financial statements in accordance with accounting principles generally accepted in the United States of America, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

In preparing the financial statements, management is required to evaluate whether there are conditions or events, considered in the aggregate, that raise substantial doubt about the Plan's ability to continue as a going concern for a period of one year subsequent to the audit report date.

Management is also responsible for maintaining a current plan instrument, including all Plan amendments, administering the Plan, and determining that the Plan's transactions that are presented and disclosed in the financial statements are in conformity with the Plan's provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.

Auditor's Responsibilities for the Audit of the Financial Statements

Except as described in the Scope and Nature of the ERISA Section 103(a)(3)(C) Audit of the Financial Statements section of our report, our objectives are to obtain reasonable assurance about whether the financial statements as a whole are free from material misstatement, whether due to fraud or error, and to issue an auditor's report that includes our opinion. NOTE 1 – DESCRIPTION OF PLAN

The following description of the EveryAction, Inc. (“Company”) 401(k) Plan (“Plan”) provides only general information. Participants should refer to the Plan document for a more complete description of the Plan’s provisions.

General

The Plan is a defined contribution plan covering substantially all employees of the Company who attained age 18 and completed 6 consecutive months of service, during which the employee completed at least 130 hours of services per month. The plan was established January 1, 2004 and is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA), as amended. The Board of Trustees is responsible for the oversight of the Plan. The Plan’s assets were held by Ascensus Trust Company, the Plan trustee. The Company also retained Newport Group, LLC as the third-party administrator, which provides administrative, compliance and recordkeeping services.

Effective June 1, 2021, Salsa Labs, Inc. was admitted as a participating employer in the Plan.

Effective December 20, 2021, the Plan was amended to incorporate The Bipartisan Budget Act of 2018, and Code Sections 401(k) and 401(m) Final Hardship Regulations. Under these Regulations, the following changes, which were effective December 31, 2018, were made to the hardship provisions: 1) participants are not required to take a loan prior to requesting a hardship withdrawal, 2) earnings will no longer be excluded from amounts available for hardship, and 3) plan sponsors are no longer required to suspend the contributions of participants who receive a hardship.

Effective August 1, 2022, the Plan merged into the Bonterra 401(k) Plan. On August 1, 2022, assets amounting to \$28,542,554 were transferred from Ascensus Trust Company to Fidelity Management Trust Company, the new trustee.

Contributions

Each year participants were able to contribute a percentage of annual compensation, as defined by the Plan, as pre-tax deferrals. Participants who had attained age 50 before the end of the Plan year were eligible to make catch-up contributions. Participants could also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans (rollovers).

The Company was permitted to make discretionary employer matching contributions as well as a fixed employer nonelective contribution. The Company did not make either a fixed employer nonelective contribution nor a discretionary employer matching contribution for the period January 1, 2022 through August 1, 2022. Contributions are subject to certain limitations.

Participants were permitted to direct the investment of elective deferrals and Company contributions, if any, into any of the funds offered by the Plan as investment options. Participants were permitted to change their investment elections daily.

Participant Accounts

Each participant's account was credited with the participant's contribution and discretionary employer matching contributions, if any, and allocations of (a) the fixed employer nonelective contribution and, (b) Plan earnings (losses), and was charged with an allocation of any administrative expenses paid by the Plan. Allocations were based on participant earnings, account balances, or specific transactions, as defined. The benefit to which a participant was entitled was the benefit that could be provided from the participant's vested account balance.

Notes Receivable from Participants

Participants were permitted to borrow from their accounts a minimum of \$1,000 up to a maximum of \$50,000 or 50% of their vested account balance, whichever was less. The term of the loan could not exceed five years, unless the proceeds were used to purchase a primary residence. Participants were only permitted to have one loan outstanding at a time. The notes were secured by the vested balance in the participant's account and bore interest at a rate of prime plus 1%. Interest rates were 4.25% to 5.75% on outstanding loans as of August 1, 2022. Principal and interest were paid ratably through payroll deductions.

Vesting

Participants were immediately vested in their elective contributions plus actual earnings thereon. Vesting in the Company's discretionary employer matching and fixed employer nonelective contributions plus earnings thereon was based on years of continuous service. A participant vested 20% after the first year of service; 40% after the second year; 60% after the third year; 80% after the fourth year; and 100% after five years. However, if an active participant died or became disabled prior to completing five years of service or attaining the normal retirement age, the participant became 100% vested.

Forfeited Accounts

Nonvested amounts were forfeited upon termination and could be used to reduce discretionary employer matching contributions, reduce fixed employer nonelective contributions or pay administrative expenses of the Plan. As of August 1, 2022 and December 31, 2021, forfeited nonvested accounts totaled \$0 and \$33,901, respectively. For the period of January 1, 2022 through August 31, 2022, \$25,339 of forfeitures were used to pay administrative expenses. There were no forfeitures used to reduce employer contributions.

Payment of Benefits

Distributions from the Plan were permitted upon termination of employment, retirement, disability, or death. Participants could elect a lump-sum distribution. For accounts \$1,000 or less, the vested account balance could be automatically paid out to the participant as a single sum, unless the participant elected otherwise. The Plan permitted in-service distributions for participants who were age 59 ½ or older as well as in the case of certain financial hardship situations, subject to the provisions of the Plan document. Minimum required distributions for participants who reached age 72 also applied per Internal Revenue Service ("IRS") regulations.

Administrative Expenses

The Plan's administrative expenses could be paid by the Plan, the Company, or with forfeitures, as provided in the Plan document. Transaction expenses, such as investment expenses, loan, and distribution administrative expenses were charged directly to the participant's account and are included in administrative expenses.

NOTE 2 – SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Basis of Accounting

The financial statements of the Plan are prepared using the accrual basis of accounting, in accordance with generally accepted accounting principles in the United States of America ("GAAP").

Use of Estimates

The preparation of financial statements in accordance with GAAP requires the plan administrator to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosures of contingent assets and liabilities. Accordingly, actual results may differ from those estimates.

Investment Valuation and Income Recognition

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. Plan Management determines the Plan's valuation policies utilizing information provided by the trustee. See Note 4 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net depreciation includes the plan's gains and losses on investments bought and sold, as well as held, during the year.

Contributions

Employee deferrals and discretionary employer matching contributions, if any, are recognized on the pay date to which they relate. Fixed employer nonelective contributions, if any, are recognized in the year designated by the Company.

Payment of Benefits

Benefits are recorded when paid.

NOTE 3 – INFORMATION CERTIFIED BY THE PLAN TRUSTEE

As noted in the independent auditors' report, the Plan administrator has elected the method of annual reporting compliance as permitted by 29 CFR 2520.103-8 of the DOL's Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, certain information disclosed in the accompanying financial statements and supplemental schedule, was obtained or derived from information supplied to the Plan administrator and certified as complete and accurate by Ascensus Trust Company, the trustee of the Plan. This information includes:

- Investment values as of August 1, 2022 and December 31, 2021, as shown in the statements of net assets available for benefits and the fair value disclosures in Note 4.
- Notes receivable from participants, as shown in the statements of net assets available for benefits as of August 1, 2022 and December 31, 2021.
- Net investment income and interest income on notes receivable from participants, as shown in the statement of changes in net assets available for benefits for the period of January 1, 2022 through August 1, 2022.

The Plan's independent auditors did not perform auditing procedures with respect to information certified by the trustee.

NOTE 4 – FAIR VALUE MEASUREMENTS

GAAP establishes a framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements). The three levels of the fair value hierarchy are described as follows:

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

The following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at August 1, 2022 and December 31, 2021.

The methods described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

NOTE 5 – RELATED PARTY AND PARTY-IN-INTEREST TRANSACTIONS

Certain Plan investments are managed by the Trustee. Fees related to these investments are paid on a point basis and deducted from the returns on the investments. Investment expenses and administrative expenses paid to the Trustee qualify as party-in-interest transactions. These transactions qualify as party-in-interest transactions which are exempt from the prohibited transaction rules.

NOTE 6 – PLAN TERMINATION

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants would become 100% vested in their employer contributions.

NOTE 7 – TAX STATUS

The Plan has adopted Newport Group, Inc.’s Non-Standardized Defined Contribution Pre-Approved Plan. On March 31, 2014, the IRS stated in an opinion letter that the prototype plan adopted by the Plan, as then designed, was in compliance with applicable requirements of the Internal Revenue Code (“IRC”). Although the Plan has been amended since receiving the opinion letter, the Plan administrator and the Plan’s tax counsel believe that the Plan is designed and is currently being operated in compliance with the applicable requirements of the IRC and therefore believe that the Plan is qualified and the related trust is tax-exempt.

NOTE 7 – TAX STATUS (continued)

U.S. GAAP requires Plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination. Management evaluated the Plan's tax positions and concluded that the Plan has maintained its tax-exempt status and has taken no uncertain tax positions that require recognition or disclosure in the financial statements. Therefore, no provision or liability for income taxes has been included in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax period in progress.

NOTE 8 – RISKS AND UNCERTAINTIES

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the accompanying statements of net assets available for benefits.

NOTE 9 – SUBSEQUENT EVENTS

The Plan has evaluated subsequent events through April 10, 2024, the date the financial statements were available to be issued and is not aware of any additional significant subsequent events which would require recognition or disclosure in the financial statements.
