### 1. Description of the Plan

The Gramercy Health Group 401(k) Plan was established on June 1, 2003. Effective April 1, 2011, the name of the Plan changed to Health Care Navigator 401(k) Plan (the "Plan"). Effective March 15, 2016, Health Care Navigator, LLC assumed sponsorship of the Plan during 2015. The following is a brief description of the Plan and is provided for general information purposes only. Participants should refer to the Plan document for more complete information. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 ("ERISA").

The Plan was a defined contribution plan covering all eligible employees of the following related companies (collectively the "Company" or "Employer"):

SA-PT Operator Holdings, LLC and Subsidiaries  
SA-Encore Operator Holdings, LLC and Subsidiaries  
Hygeia Medical Equipment, LLC  
Halcyon Rehabilitation, LLC  
Apricity Resources, LLC  
Palladium Hospice and Palliative Care  
Percipience Health Management

During 2014, the following companies were closed or sold and are no longer part of the Plan: SA-PG Operator Holdings, LLC and Subsidiaries, SA-GA Operator Holdings, LLC and Subsidiaries, New Louisiana Operator Holdings, LLC and Affiliates, New Rochelle Administrators, LLC, New Surfside Administrators, LLC, Tamarac Administrative Services, Elite Rehabilitation AB Owner, LLC d.b.a. Elite Rehabilitation, Elite Rehabilitation of the Midwest, LLC, Elite Rehabilitation, LLC d.b.a. Elite Rehab Louisiana, Elite Rehabilitation Florida, LLC d.b.a. Elite Rehab Florida and Elite Rehabilitation Georgia, LLC d.b.a. Elite Rehab Georgia.

Health Care Navigator LLC terminated the Plan effective November 2, 2022, and management determined liquidation is imminent. As a result, the Plan has changed its basis of accounting from the ongoing basis to the liquidation basis used in presenting 2021 financial statements. All assets of the Plan were distributed as of December 16, 2022 and, therefore, the Plan ceased to exist as of that date.

#### ***Plan Administration***

Fidelity Management Trust Company was the trustee of the Plan and Fidelity Workplace Services LLC was the record-keeper of the Plan.

#### ***Eligibility and Enrollment***

Employees who worked 3 months or more in the Plan year and who were age 18 or older could enroll in the Plan. Employees were eligible to receive any Employer discretionary matching contributions immediately upon enrollment in the Plan.

### 1. Description of the Plan *(continued)*

#### ***Contributions***

Each year, participants could contribute up to 100% of their annual compensation on a pre-tax or Roth basis, as defined in the Plan. Participants who attained age 50 before the end of the Plan year were eligible to make catch-up contributions up to the statutorily permitted amount. Participants could also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans. Participants directed the investment of their contributions into various investment options offered by the Plan.

In accordance with the Plan document, the Company could make additional discretionary matching contributions, in a manner that is determined annually. During 2022, no discretionary contributions were made to the Plan.

#### ***Participant Accounts***

Each participant's account was credited with the participant's contribution and allocations of (a) the Employer's contribution and (b) Plan earnings (losses) thereon. Allocations were based on participant earnings, account balances, or specific participant transactions, as defined. The benefit to which a participant was entitled was the benefit that could be provided from the participant's vested account.

#### ***Vesting***

Participants in the Plan were fully vested at all times in their contributions plus unrealized earnings thereon. Employer discretionary contributions vested over a six-year period with 20% vesting after two years and an additional 20% vesting at the end of each year thereafter. As of November 2, 2022, all participants became 100% vested in their accounts.

#### ***Forfeitures***

Forfeitures of terminated non-vested accounts were first used to reduce administrative expenses of the Plan. Any remaining amounts could be used to reduce future Employer contributions. At December 16, 2022 and December 31, 2021, forfeited account balances held in non-participant directed accounts were \$0 and \$0. During 2022, \$2,940 of forfeitures was used to reduce administrative expenses or no forfeitures were used to reduce Employer contributions.

#### ***Payment of Benefits***

Benefits were paid upon retirement (age 65), death, disability, in-service (age 59 ½), hardship or termination of employment. Upon termination of service, a participant could elect to receive a lump-sum amount equal to the vested value of the participant's account, an annuity contract to be distributed under an option of the participant's choice, or a combination of both.

### 1. Description of the Plan (*continued*)

#### ***Expenses***

Certain expenses of maintaining the Plan were paid by the Company and were excluded from these financial statements. Administrative fees incurred in connection with participant activity charges were borne by the individual and deducted from their respective Plan assets. Investment related expenses were included in the net asset value (“NAV”) of the respective funds and, consequently, those expenses were not separately reflected but were a component of net depreciation in fair value of investments.

#### ***Notes Receivable from Participants***

The Plan offered a loan feature whereby a participant (borrower) enrolled in the Plan could borrow a minimum amount of \$1,000 up to a maximum of 50% of his or her vested account balance or \$50,000 (whichever is less). Loan transactions were treated as a transfer to (from) the investment fund or from (to) the loan fund. Loans were collateralized by the balance in the participant’s account and bear interest as determined at the time of loan origination. Principal and interest were paid ratably through payroll deductions. The borrower also paid a loan origination and record-keeping fee. The loan had to be repaid within a five-year period, unless the loan was used to acquire the principal residence of the borrower.

### 2. Summary of Significant Accounting Policies

#### ***Basis of Accounting and Use of Estimates***

The accompanying financial statements have been prepared in accordance with accounting principles generally accepted in the United States of America (“U.S. GAAP”), which requires management to make estimates and assumptions that affect certain reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

#### ***Investment Valuation and Income Recognition***

The Plan’s investments were stated at fair value. The mutual funds and money market fund were valued at the daily closing price as reported by the fund. The funds held by the Plan were open-end funds that were registered with the Securities and Exchange Commission and were deemed to be actively traded. These funds were required to publish their daily NAV and to transact at that price.

Purchases and sales of investments were recorded on a trade-date basis. Interest income was recorded on the accrual basis. Dividends were recorded on the ex-dividend date. Net depreciation in fair value of investments included the Plan’s gains and losses on investments bought and sold during the year.

#### ***Fair Value Measurements***

The Plan follows U.S. GAAP guidance on Fair Value Measurements which defines fair value and establishes a fair value hierarchy organized into three levels based upon the input assumptions used in pricing assets. Level 1 inputs have the highest reliability and are related to assets with unadjusted quoted prices in active markets. Level 2 inputs relate to assets with other than quoted prices in active markets which may include quoted prices for similar assets or liabilities or other inputs which can be corroborated by observable market data. Level 3 inputs are unobservable and are used to the extent that observable inputs do not exist. At December 31, 2021, all of the Plan's investments were valued using level 1 inputs.

#### ***Notes Receivable from Participants***

Notes receivable from participants were measured at their unpaid principal balance plus any accrued but unpaid interest. If a participant ceased to make loan repayments and the plan administrator deemed the participant loan to be in default, the participant loan balance was reduced and a benefit payment was recorded.

#### ***Payment of Benefits***

Benefit payments were recorded when paid.

#### ***Subsequent Events Evaluation by Management***

Management has evaluated subsequent events for disclosure and/or recognition in the financial statements through the date that the financial statements were available to be issued, which date is April 24, 2024.

### 3. Information Certified (Unaudited)

Certain information related to investments and notes receivable from participants held at December 31, 2021 (ongoing basis), and interest and dividends, net depreciation in fair value of investments, and interest on notes receivable from participants for the period from January 1, 2022 to December 16, 2022 (liquidation basis), was obtained by management and agreed to or derived from information certified as complete and accurate by Fidelity Management Trust Company, a qualified institution.

### 4. Tax Status

The Company has adopted the Fidelity prototype plan, which received an Internal Revenue Service ("IRS") opinion letter dated June 30, 2020 which stated that the prototype plan is designed in accordance with applicable qualification section of the Internal Revenue Code ("IRC"). The plan administrator believes that the Plan was designed and operated in accordance with the applicable requirements of the IRC. Therefore, no provision for income taxes has been included in the Plan's financial statements.

### 4. Tax Status (*continued*)

U.S. GAAP requires plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine examinations by taxing jurisdictions; however, there are currently no examinations for any tax periods in progress.

### 5. Party-in-Interest Transactions

Certain Plan investments were managed by Fidelity Management Trust Company. Fidelity Management Trust Company was the trustee of the Plan and, therefore, these transactions qualified as exempt party-in-interest transactions under ERISA.

Participants who were active employees could borrow from their accounts and such loans qualified as exempt party-in-interest transactions under ERISA. These loans were recorded as notes receivable from participants on the statements of net assets available for benefits.

Certain administrative functions are performed by officers or employees of the Company. No such officer or employee received compensation from the Plan.
