We are required to be independent of the Plan and to meet our other ethical responsibilities, in accordance with the relevant ethical requirements relating to our audit. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our audit opinion.

### **Emphasis of Matter - Plan Merger**

As discussed in Note 2 to the financial statements, the governing body of the Plan approved a merger of the Plan effective as of March 31, 2022 (Merger Date). Our opinion is not modified with respect to that matter.

## **Responsibilities of Management for the 2022 Financial Statements**

Management is responsible for the preparation and fair presentation of the financial statements in accordance with accounting principles generally accepted in the United States of America, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error.

In preparing the financial statements, management is required to evaluate whether there are conditions or events, considered in the aggregate, that raise substantial doubt about the Plan's ability to continue as a going concern for one year after the date that the financial statements are available to be issued.

Management is also responsible for maintaining a current plan instrument, including all plan amendments, administering the Plan, and determining that the Plan's transactions that are presented and disclosed in the financial statements are in conformity with the Plan's provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.

## **Auditors' Responsibilities for the Audit of the 2022 Financial Statements**

Our objectives are to obtain reasonable assurance about whether the financial statements as a whole are free from material misstatement, whether due to fraud or error, and to issue an auditors' report that includes our opinion. Reasonable assurance is a high level of assurance but is not absolute assurance and therefore is not a guarantee that an audit conducted in accordance with GAAS will always detect a material misstatement when it exists. The risk of not detecting a material misstatement resulting from fraud is higher than for one resulting from error, as fraud may involve collusion, forgery, intentional omissions, misrepresentations, or the override of internal control. Misstatements are considered material if, there is a substantial likelihood that, individually or in the aggregate, they would influence the judgment made by a reasonable user based on the financial statements.

In performing an audit in accordance with generally accepted auditing standards, we:

- Exercise professional judgment and maintain professional skepticism throughout the audit.
- Identify and assess the risks of material misstatement of the financial statements, whether due to fraud or error, and design and perform audit procedures responsive to those risks. Such procedures include examining, on a test basis, evidence regarding the amounts and disclosures in the financial statements.

- Obtain an understanding of internal control relevant to the audit in order to design audit procedures that are appropriate in the circumstances, but not for the purpose of expressing an opinion on the effectiveness of the Plan's internal control. Accordingly, no such opinion is expressed.
- Evaluate the appropriateness of accounting policies used and the reasonableness of significant accounting estimates made by management, as well as evaluate the overall presentation of the financial statements.
- Conclude whether, in our judgment, there are conditions or events, considered in the aggregate, that raise substantial doubt about the Plan's ability to continue as a going concern for a reasonable period of time.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audit.

### **2022 Supplemental Schedules Required by ERISA**

Our audit was conducted for the purpose of forming an opinion on the financial statements as a whole. The supplemental schedules of Schedule H, Line 4a - Schedule of Delinquent Participant Contributions and Schedule H, line 4i - Schedule of Assets (Held at End of Year) as of March 31, 2022 (Merger Date), are presented for the purpose of additional analysis and are not a required part of the financial statements but are supplementary information required by the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Such information is the responsibility of management and was derived from and relates directly to the underlying accounting and other records used to prepare the financial statements. The information included in the supplemental schedules has been subjected to auditing procedures applied in the audit of the financial statements and certain additional procedures, including comparing and reconciling such information directly to the underlying accounting and other records used to prepare the financial statements or to the financial statements themselves, and other additional procedures in accordance with GAAS.

In forming our opinion on the supplemental schedules, we evaluated whether the supplemental schedules, other than the information agreed to or derived from the certified investment information, including its form and content, are presented in conformity with the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA.

In our opinion, the information in the accompanying schedules is fairly stated, in all material respects, in relation to the financial statements as a whole, and the form and content are presented in conformity with the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA.

### **Other Matter - Auditors' Report on the 2021 Financial Statements**

We have performed an audit of the 2021 financial statements of the Plan. In accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA, our audit did not extend to any statements of information related to assets held for investment of the Plan that were certified by a qualified institution. In our report dated October 10, 2022, we indicated that in our opinion (a) the amounts and disclosures in the 2021 financial statements, other than those agreed to or derived from the certified investment information, were presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America, and (b) the information in the 2021 financial statements related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

NOTE 1 - DESCRIPTION OF PLAN

The following brief description of the Health Quality Management Group 401(k) Retirement Plan (the "Plan") is provided for general information purposes only. Participants should refer to the Plan agreement for more complete information of the Plan's provisions. The Plan is a defined contribution plan and was adopted on January 1, 2001.

Eligibility

The Plan covers substantially all employees of Quality Health Services Corporation and its affiliates (the "Company"). It is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA), as amended. The employee must have completed three months of service and be at least 18 years of age to be eligible to participate in the Plan and receive employer discretionary contributions.

Contributions

Each participant may contribute up to 100% of eligible compensation deferred and designated as an employee savings contribution, subject to Internal Revenue Service ("IRS") regulation limitations.

Pursuant to the Plan's provisions, and based on the results of the Plan's compliance testing, the Plan's sponsor may be required to make qualified non-elective contributions. For the period ended March 31, 2022, the Company did not make such contributions.

Participant Accounts

Separate accounts are maintained for each participant which are adjusted for employee deferrals, rollover contributions, employer discretionary matching contributions and allocations of forfeitures, administrative expenses and investment earnings. Allocations are based on participant earnings or account balances, as defined. Plan earnings are allocated based on the participant's share of net earnings or losses of their respective elected investment options. The benefit to which a participant is entitled is the benefit that can be provided from a participant's vested account. Participants direct all investment transactions within their accounts.

Vesting

Participants are 100% vested in their voluntary contributions, discretionary matching contributions plus actual earnings thereon.

NOTE 1 - DESCRIPTION OF PLAN – CONTINUED

Forfeitures

Forfeitures can be used to reduce the Company's contributions to the Plan. During the period ended March 31, 2022, there were no forfeitures.

Funding Policy

The Company is required to make all employee savings and employer discretionary matching contributions under the Plan for each taxable year. In no event shall the amount contributed by the Company in any year exceed the maximum deductible by the Company under Section 404(a)(3) of the Internal Revenue Code ("IRC").

Payment of Benefits

On termination of service due to death, disability, retirement or any other reason, the participant may elect to receive either a lump-sum distribution or installment payments over a period not exceeding life expectancy of the participant. The amount of distribution is equal to the value of the participant's vested interest in his or her account.

Notes Receivable from Participants

Participants may borrow from their fund accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000, or 50% of their vested account balance. The loans are secured by the balance in the participant's account, accrue interest at a rate determined by the Company's management that is based on rates currently being used by financial institutions lending money under similar circumstances (which ranged from 5.25% to 7.50% in the period ended March 31, 2022). Principal and interest are paid ratably through monthly payroll deductions over a term not to exceed five years. See Note 11 for temporary changes to the loan terms.

Plan Termination

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants will become 100% vested in their accounts.

Administrative Expenses

The Company pays most of the Plan's general and administrative costs.

NOTE 2 - PLAN MERGER

Effective April 1, 2022, the Company adopted the Oasis Retirement Savings Plan and its related trust ("Oasis Plan"). As of the date of this adoption, all Plan assets and participant accounts have been transferred to the Oasis Plan.

NOTE 3 - SUMMARY OF ACCOUNTING POLICIES

Plan's Fiscal Year

The Plan's fiscal year is from January 1 to December 31. In 2022, due to the Plan's merger, the fiscal year ended on March 31, 2022.

Basis of Accounting

The accompanying financial statements of the Plan have been prepared on the accrual basis of accounting in conformity with accounting principles generally accepted in the United States of America. Income is recognized when earned and expenses are recognized when incurred. Benefit payments are recorded when distributed by the Plan.

Investment Valuation and Income Recognition

Investments are stated at fair value, except for the fully benefit-responsive investment contracts, which are reported at contract value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Investment Committee determines the Plan's valuation policies. See Note 5 for discussion of fair value measurements. Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation (depreciation) includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Notes Receivable from Participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Related fees are charged directly to the borrowing participant's account and are included in administrative expenses when incurred. As of March 31, 2022 and December 31, 2021, no allowance for credit losses have been recorded. If a participant does not make loan repayments and the Plan administrator considers the participant loan to be in default, the loan balance is reduced, and the delinquent participant note receivable is recorded as a benefit payment based on the terms of the Plan document.

Benefits

Benefit payments to participants are recorded when paid.

Management Estimates

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and disclosure of contingent assets and liabilities at the date of the financial statements and the reported amounts of revenues and expenses during the reporting period. Actual results could differ from those estimates.

Concentration of Credit Risk

Financial instruments which potentially subject the Plan to concentration of credit risk consist of investments, which are placed with high credit quality financial institutions.

Subsequent Events

The Company has evaluated subsequent events through the date of the independent auditors' report, which is the date the accompanying financial statements were available to be issued.

For the year ended December 31, 2021, the Plan administrator has elected to have the audit of the Plan performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, Principal Life Insurance Company and Principal Trust Company, the Plan's trustees, have certified that the following investment information is complete and accurate:

- \* Fair value of investments and the carrying amount of notes receivable from participants as reflected in the Statements of Net Assets Available for Benefits as of December 31, 2021.

As permitted by ERISA Section 103(a)(3)(C), the audit did not extend to any statements or information related to the certified financial information.

**NOTE 5 - FAIR VALUE MEASUREMENTS**

FASB Accounting Standards Codification ("ASC") Topic 820, *Fair Value Measurements and Disclosures* ("ASC 820"), establishes a framework for measuring fair value. The framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. This hierarchy consists of three broad levels: Level 1 inputs consist of unadjusted quoted prices in active markets for identical assets and have the highest priority. Level 2 inputs consist of observable inputs other than quoted prices for identical assets (Level 1). Level 3 inputs are unobservable and have the lowest priority. The Plan uses appropriate valuation techniques based on the available inputs to measure the fair value of its investments. When available, the Plan measures fair value using Level 1 inputs because they generally provide the most reliable evidence of fair value. Level 2 inputs are used for investments for which Level 1 inputs were not available. Level 3 inputs would only be used if Level 1 or Level 2 inputs were not available. There are no plan assets requiring the use of Level 2 or 3 inputs for the periods presented.

**NOTE 5 - FAIR VALUE MEASUREMENTS - CONTINUED**

Following is a description of the valuation methodologies used for assets measured at fair value at March 31, 2022 and December 31, 2021:

*Mutual Funds:* Valued based on the daily closing price of the shares as reported by the fund. The mutual funds held by the Plan are open-end mutual funds registered with the U.S. Securities and Exchange Commission. These funds are required to publish their daily net asset value ("NAV") and to transact at that price. The mutual funds held by the Plan are considered to be actively traded and are classified as Level 1.

*Common / Collective Trusts ("CCT"):* These funds invest in collective trust funds as well as a variety of separate accounts and mutual funds. The fair value of the collective investment trusts and the separate accounts are not publicly quoted pricing inputs. The fair value of mutual funds are publicly quoted pricing inputs (Level 1). The fair value of all these investments are used in determining the NAV of the CCT, which is not publicly quoted but is available to current investors when they access their account values. The NAV is the basis for current transactions and the CCTs can be redeemed at their NAV as of the measurement date, with redemptions typically allowed on a daily basis. The Plan believes these investments have a "readily determinable fair value", are valued similarly to mutual funds and should be classified as Level 1 investments.

*Pooled Separate Accounts:* These accounts invest in either publicly traded domestic or international stocks, or in mutual funds, whose fair values are based on observable Level 1 publicly quoted pricing inputs. The NAV of the pooled separate accounts is determined using the fair value of the underlying securities. The NAV is the basis for current transactions and the pooled separate accounts can be redeemed at NAV as of the measurement date, with redemptions typically allowed on a daily basis. The Plan believes these investments have a "readily determinable fair value", are valued similarly to mutual funds and should be classified as Level 1 investments.

The methods described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

**NOTE 6 - GUARANTEED INVESTMENT CONTRACT WITH INSURANCE COMPANY**

The Plan holds a fully benefit-responsive guaranteed investment contract with Principal Life Insurance Company (Principal). Principal maintains the contributions in a general account. The account is credited with earnings on the underlying investments and charged for participant withdrawals and administrative expenses. The guaranteed investment contract issuer is contractually obligated to repay the principal and a specified interest rate that is guaranteed to the Plan.

**NOTE 6 - GUARANTEED INVESTMENT CONTRACT WITH INSURANCE COMPANY -  
CONTINUED**

Because the guaranteed investment contract is fully benefit-responsive, contract value is the relevant measurement attribute for that portion of the net assets available for benefits attributable to the guaranteed investment contract. The guaranteed investment contract is presented on the face of the Statements of Net Assets Available for Benefits at contract value. Contract value, as reported to the Plan by Principal, represents contributions made under the contract, plus earnings, less participant withdrawals and administrative expenses. Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investment at contract value.

There are no reserves against contract value for credit risk of the contract issuer or otherwise. The contract value of the investment contract at March 31, 2022 and December 31, 2021, was \$0 and \$47,761, respectively. The crediting interest rate is based on a formula agreed upon with the issuer, is reset on a semiannual basis and was 0.90% per annum during the period from January 1, 2022 through March 31, 2022.

Certain events limit the Plan's ability to transact at contract value. The contract has a potential surrender charge of 5% that may be charged based on cumulative transfer percentages and advance notice of intent to terminate if the Plan terminates its interest in the contract. The Plan administrator does not believe that any events that would limit the Plan's ability to transact at contract value with Plan participants or the issuer are probable of occurring.

**NOTE 7 - PARTY-IN-INTEREST**

Certain Plan investments are units of common/collective trusts and pooled separate accounts managed by companies affiliated with Principal Trust Company. Therefore, these transactions qualify as party-in-interest, as defined by the applicable ERISA rules and regulations. For the period ended March 31, 2022, direct fees paid by the Plan to Principal Trust Company for administrative services totaled \$2,030. These transactions are exempt from the prohibited transaction rules of ERISA.

**NOTE 8 - RISKS AND UNCERTAINTIES**

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the Statements of Net Assets Available for Benefits.

**NOTE 9 - TAX STATUS**

The Plan was adopted as a version of a prototype plan. In its opinion letter dated March 31, 2014, the IRS has stated that the prototype plan is designed in accordance with applicable sections of the IRC. Although the Plan has been amended since receiving the opinion letter for the prototype plan, the Plan administrator and the Plan's trustee believe that the Plan is designed and is currently being operated in compliance with the applicable requirements of the IRC, and, therefore, believe that the Plan is qualified, and the related trust is tax-exempt.

Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination. The Plan administrator has analyzed the tax positions taken by the Plan, and has concluded that there are no uncertain positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

**NOTE 10 - OPERATIONAL ERRORS AND CORRECTIONS**

During 2021, in several instances, the Company was late in remitting employee contributions and loan repayments to the trust, and also failed to process employee contributions in accordance with the participants' deferral elections. These occurrences constitute "non-exempt transactions" in accordance with applicable IRS and Department of Labor (DOL) regulations. In 2022, upon discovery, the Company corrected these errors and funded a qualified non-elective contribution and lost investment earnings for the periods of delinquency.

**NOTE 11 - CORONAVIRUS AID, RELIEF, AND ECONOMIC SECURITY ACT**

The novel coronavirus (or "COVID-19") has adversely affected, and may continue to adversely affect economic activity globally, nationally, and locally. These economic and market conditions and other effects of the COVID-19 pandemic may adversely affect the volatility of Plan assets. The extent of any adverse impact of the COVID-19 pandemic on the Plan participants' account balances and the amounts reported in the Statements of Net Assets Available for Benefits are unknown at this time. Operations of the Plan have not been adversely impacted.

On March 27, 2020, the Coronavirus Aid, Relief, and Economic Security Acts ("CARES Act") was passed into law, which was aimed at providing financial relief to small businesses and their employees amid the COVID-19 pandemic. The CARES Act contains various provisions impacting qualified retirement plans and their participants. These provisions may be adopted by plans immediately while implementing amendments at a later date. These provisions include relief from the 10 percent withdrawal penalty for participants under the age of 59.5 years for coronavirus-related distributions, as defined in the law, up to \$100,000 per participant; higher limits on the amount of new loans participants may request and temporary relief from loan repayments on existing loans; and relief from required minimum distributions for retirement age participants. Some of these provisions have been adopted by the Plan. Where amendments to the Plan would be required, the CARES Act permits employers to formalize the amendments as late as the end of the first plan year beginning on or after January 1, 2025. All such amendments would be retroactively effective to March 27, 2020, or a later stated effective date. As of March 31, 2022, the Plan document has not been amended to include the above provisions.
