We have performed audits of the accompanying financial statements of Full Spectrum Group, LLC 401(k) Plan (the "Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C). The financial statements comprise the statements of net assets in liquidation available for benefits as of May 22, 2023 and December 31, 2022, and the related statement of changes in net assets in liquidation available for benefits for the period January 1, 2023 through May 22, 2023, and the related notes to the financial statements (the "financial statements").

Management, having determined it is permissible in the circumstances, has elected to have the audits of the financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Management has obtained certifications from a qualified institution as of May 22, 2023 and December 31, 2022, and for the period January 1, 2023 through May 22, 2023, stating that the certified investment information, as described in Note 3 to the financial statements, is complete and accurate.

Effective November 8, 2022, the Plan was amended to freeze and terminate. All Plan assets were distributed as of May 22, 2023, at which time the Plan was discontinued. See Note 1 and 6 for further information regarding the Plan termination. In accordance with accounting principles generally accepted in the United States of America, the Plan has changed its basis of accounting to the liquidation basis used in presenting the May 22, 2023 and December 31, 2022 financial statements. Our audit opinion has not been modified with respect to this matter.

Responsibilities of Management for the Financial Statements

Management is responsible for the preparation and fair presentation of these financial statements in accordance with accounting principles generally accepted in the United States of America, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

In preparing the financial statements, management is required to evaluate whether there are conditions or events, considered in the aggregate, that raise substantial doubt about the Plan's ability to continue as a going concern for one year after the date that the financial statements are available to be issued.

Management is also responsible for maintaining a current Plan instrument, including all Plan amendments; administering the Plan; and determining that the Plan's transactions that are presented and disclosed in the financial statements are in conformity with the Plan's provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.

Auditors' Responsibilities for Audit of the Financial Statements

Notes to Financial Statements May 22, 2023 and December 31, 2022

1. Description of Plan

The following description of Full Spectrum Group, LLC 401(k) Plan (the “Plan”) provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan’s provisions.

General

The Plan was established on January 1, 2003 as a defined contribution plan available to all eligible employees of Full Spectrum Group, LLC (the “Company”). John Hancock Life Insurance Company (“John Hancock”) is the asset custodian of the Plan’s investment assets. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (“ERISA”). The Company is the Plan’s sponsor and serves as the Plan administrator.

Effective November 8, 2022, the Company decided to freeze and terminate the Plan coinciding with the sale of the Company to Coldwell Banker Richard Ellis. Thus, no further contributions were permitted or made under the Plan with respect to Plan compensation earned on or after the effective date. All Plan assets were distributed as of May 22, 2023, at which time the Plan was discontinued. See Note 6 for further information regarding the Plan termination.

Eligibility

The Plan covers eligible employees of the Company who have attained age 21. There is no minimum service requirement under the Plan for eligible employees.

Participant Contributions and Employer Contributions

Effective November 8, 2022, the Plan was amended to freeze and terminate and no further contributions to the Plan were permitted.

Participant Accounts

Individual accounts are maintained for each of the Plan’s participants to reflect the participant’s contributions, qualified rollovers, the Company’s discretionary matching or employer contributions, if any, allocations of the participant’s investment earnings or losses, and an allocation of certain transaction fees. The benefit to which a participant is entitled is the benefit that can be provided from the participant’s vested account.

1. Description of Plan (continued)

Investment Options

Participants must direct their salary deferral contributions to selected investments as made available and determined by the Plan administrator. Participants may change their investment options any time throughout the year.

Vesting

Participants are immediately vested in their salary deferral contributions plus actual earnings thereon.

The portion of the participant's account attributable to the Company's discretionary matching or employer contribution plus actual earnings became 100% vested upon termination of the Plan.

Notes Receivable from Participants

Notes receivable from participants are stated at their unpaid principal balance plus accrued but unpaid interest. Interest income is recorded on the accrual basis. Delinquent participant loans are reclassified as deemed distributions. Participants may borrow up to the lesser of \$50,000 or 50% of their vested account balance. Per the Plan document, participants are limited to a maximum of one loan outstanding at any time, with a minimum loan amount of \$1,000. Notes receivable from participants bear a reasonable rate of interest based on prime rate plus 1%, which is fixed for the duration of the loan. The loans are secured by the participant's vested account balance. The loan must be repaid within five years, unless the loan is used to purchase principal residence then payback period may exceed five years.

Payment of Benefits

Upon termination of employment due to death, disability, retirement, or other reasons, a participant may elect to receive a lump-sum amount equal to the value of the participant's vested interest in his or her account. The Plan allows for in-service withdrawals due to attaining the age of 59 ½.

1. Description of Plan (continued)

Forfeitures

Forfeitures are the portion of the employer's contributions that are lost by a participant who terminates employment prior to becoming fully vested under the Plan's vesting schedule. Forfeited amounts are held by the Plan and may be used to pay Plan expenses, allocated as additional employer contributions or used to reduce other employer contributions under the Plan. Cumulative forfeitures were \$0 and \$6,567 as of May 22, 2023 and December 31, 2022, respectively. Forfeitures were used to pay Plan expenses during the period ended May 22, 2023.

Risks and Uncertainties

The Plan provides for various investment options in any combination of fixed income securities, mutual funds and other investment securities. These investment securities are exposed to various risks, such as interest rate, market and credit. Due to the level of risk associated with investment securities, it is at least reasonably possible that changes in risks in the near term could materially affect participants' account balances and the amounts reported in the statements of net assets in liquidation available for benefits and the statement of changes in net assets in liquidation available for benefits.

2. Summary of Significant Accounting Policies

Income Tax Status

The Plan adopted the Prototype Non-standardized Profit Sharing Plan. The prototype plan obtained its latest opinion letter dated June 30, 2020, in which the IRS stated that the prototype plan, as then designed, was in compliance with the applicable requirements of the Internal Revenue Code ("IRC"). The Plan has not received a determination letter specific to the Plan; however, the Plan administrator believes that the Plan is currently designed and is being operated in compliance with the applicable provisions of the IRC and is therefore exempt from income taxes.

Basis of Accounting

The accompanying financial statements of the Plan are prepared on the liquidation basis of accounting in accordance with accounting principles generally accepted in the United States of America ("GAAP"). The Plan changed its basis of accounting to a liquidation basis as a result of the Company's decision to terminate the Plan. Since the assets of the Plan are required to be reported at fair value on the going concern basis of accounting, management believes there are no material differences between the going concern basis and the liquidation basis of accounting.

Use of Estimates

The preparation of financial statements in conformity with GAAP requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and disclosure of contingent assets and liabilities at the date of the financial statements, the reported amounts of additions and deductions from net assets during the reporting period. Actual results could differ from those estimates.

Investment Valuation and Income Recognition

The Plan's investments are stated at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan administrator determines the Plan's valuation policies utilizing information provided by the asset custodian. See Note 4 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade date basis. Dividends are recorded on the ex-dividend date. Interest income is recorded on the accrual basis. Investment income (loss) consists of realized and unrealized gains or losses in the fair value of investments, less investment expenses. Purchases and sales of securities are reflected on the settlement date.

Management fees and operating expenses charged to the Plan for its investments are deducted from income earned daily and are not separately reflected. Consequently, management fees and operating expenses are reflected as a reduction of investment return for applicable investments.

Cash and Cash Equivalents

The Plan considers demand deposits in banks or with the asset custodian as cash, and all highly liquid investments with a maturity of three months or less to be cash equivalents.

Notes Receivable from Participants

Notes receivable from participants are measured at amortized cost, which represents the unpaid principal balance plus the accrued but unpaid interest. Delinquent notes receivable from participants are recorded as deemed distributions based on the terms of the Plan.

2. Summary of Significant Accounting Policies (continued)

Administrative Expenses

Certain administrative expenses associated with the Plan are deducted from the Plan's assets, as the Company does not pay these expenses. These expenses are allocated proportionately based on the value of the participants' account balances. The Company pays for expenses such as other administration costs and periodic financial reporting.

Income Taxes

GAAP requires Plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan administrator has analyzed the tax positions taken by the Plan and has concluded that, as of May 22, 2023 and December 31, 2022, there are no uncertain positions taken or expected to be taken that would require recognition of a liability or disclosure in the financial statements.

3. Summary of Investment Data Certified by the Plan Asset Custodian

The Plan's investments were held by John Hancock at May 22, 2023 and December 31, 2022 and the following investment information was certified to be complete and accurate within the meaning of 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA:

- The total value of investments reflected on the accompanying statements of net assets in liquidation available for benefits as of May 22, 2023 and December 31, 2022.
- All investment information reflected on the accompanying statement of changes in net assets in liquidation available for benefits for the period January 1, 2023 through May 22, 2023.

4. Fair Value Measurements

Financial Accounting Standards Board ("FASB") Accounting Standards Codification ("ASC") 820, Fair Value Measurement, establishes a framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1) and the lowest priority to unobservable inputs (level 3).

The three levels of the fair value hierarchy under FASB ASC 820 are described as follows:

- Level 1: Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.
- Level 2: Inputs to the valuation methodology include a) quoted prices for similar assets or liabilities in active markets; b) quoted prices for identical or similar assets or liabilities in inactive markets; c) inputs other than quoted prices that are observable for the asset or liability; and d) inputs that are derived principally from or corroborated by, observable market data by correlation or other means. If the asset or liability has a specified (contractual) term, the level 2 input must be observable for substantially the full term of the asset or liability.
- Level 3: Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

The following is a description of the valuation methodologies used for the Plan's assets measured at fair value:

Registered Investment Companies: Registered investment companies are valued at quoted market prices that represent the net asset value of shares on a market exchange at the end of the trading day. Mutual funds held by the Plan are open-end mutual funds that are registered with the Securities and Exchange Commission. The registered investment companies are classified in Level 1 in the fair value hierarchy.

Pooled Separate Account: Included in pooled separate account, is a stable value fund which represents participation units of a collective investment trust for which the net asset value is based on the market value of the underlying investments. The stable value fund is composed primarily of fully benefit-responsive investment contracts that are valued at the net asset value of units of the bank collective trust. The Plan has concluded that the net asset value as adjusted and reported by the insurance company denotes readily determinable fair value. The stable value fund is classified in Level 1 in the fair value hierarchy.

The methods described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date. There have been no changes in the valuation methodologies used during the period January 1, 2023 through May 22, 2023.

The balance in registered investment companies as of May 22, 2023 and December 31, 2022 of \$0 and \$5,525,194, respectively, was measured using Level 1 inputs. The balance in pooled separate account of May 22, 2023 and December 31, 2022 of \$0 and \$50,743, respectively, was measured using Level 1 inputs.

5. Party-in-Interest Transactions

The following transactions qualify as exempt party-in-interest transactions. The Plan has investments in participation units held through sub-accounts of John Hancock, the asset custodian. Therefore, these investments and transactions qualify as party-in-interest transactions. The Plan also has a noninterest-bearing cash account with John Hancock. Certain expenses of the Plan are paid for by the Company. The Company is the sponsor of the Plan. The most significant of these costs paid by the Company are the salaries for the employees responsible for Plan administration and fees paid to a third party administrator. The Plan issues notes receivables to participants, which are secured by the balances in the participants' accounts.

6. Plan Termination

During 2022, the Plan administrator decided to freeze and terminate the Plan. The Plan was amended on November 8, 2022 to formally terminate the Plan. No further contributions were permitted or made under the Plan with respect to Plan compensation earned on or after the effective date. Participants became 100 percent vested in their employer contribution accounts.

The Plan was discontinued on May 22, 2023. All Plan assets were distributed per the participants' payout election in accordance with ERISA. Account balances of participants who did not make a payout election by the discontinuance date were disbursed to the qualified financial institution designated by the trustee.

7. Operational Error

Plan management identified the following operational error as of December 31, 2022:

- Failure to withhold contributions for certain participants from certain eligible wages, as defined in the Plan agreement, and failure to provide Company matching contributions to those participants.

The Plan administrator, in collaboration with outside benefits counsel, has determined the error to be insignificant and eligible for self-correction under EPCRS and the SECURE 2.0 Act. The Plan administrator has taken appropriate corrective actions to remedy these errors, and remit to the Plan and participants any lost earnings (if applicable). The accompanying financial statements do not include any accruals or provisions related to this error.

8. Subsequent Events

In preparing these financial statements, management has evaluated events and transactions for potential recognition or disclosure through February 8, 2024, the date at which the financial statements were available to be issued.

We have audited the financial statements of ***Full Spectrum Group, LLC 401(k) Plan*** (the “Plan”), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (an “ERISA Section 103(a)(3)(C) audit”) as of and for the year ended December 31, 2022, and as of May 22, 2023 and for the period January 1, 2023 through May 22, 2023, and we issued our reports thereon dated October 12, 2023 and February 8, 2024, respectively.

As permitted by ERISA Section 103(a)(3)(C), our audits did not extend to any statements or information related to assets held for investment of the Plan (“investment information”) by John Hancock Insurance Company (“John Hancock”), the asset custodian, which is an institution that is regulated, supervised, and subject to periodic examination by a state or federal agency, that prepared and certified the statements or information regarding assets so held in accordance with 29 CFR 2520.103-5. Our audits did not extend to the certified investment information, except for obtaining and reading the certification, comparing the certified investment information with the related information presented and disclosed in the financial statements and ERISA-required supplemental schedules, and reading the disclosures relating to the certified investment information to assess whether they are in accordance with the presentation and disclosure requirements of United States generally accepted accounting principles (GAAP). Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with GAAP.

Professional standards require that we provide you with information about our responsibilities under United States generally accepted auditing standards (GAAS), as well as certain information related to the planned scope and timing of our audits. We have communicated such information in our engagement letters dated May 11, 2023. Professional standards also require that we communicate to you the following information related to our audits.

Significant Audit Matters

Qualitative Aspects of Accounting Practices

Management is responsible for the selection and use of appropriate accounting policies. The significant accounting policies used by the Plan are described in Note 2 to the financial statements. No new accounting policies were adopted, except for adopting the liquidation basis of accounting due to the termination of the Plan, and the application of existing policies was not changed

significantly during 2022 and during the period January 1, 2023 through May 22, 2023. We noted no transactions entered into by the Plan during the year for which there is a lack of authoritative guidance or consensus. All significant transactions have been recognized in the financial statements in the proper period.

Accounting estimates are an integral part of the financial statements prepared by management and are based on management's knowledge and experience about past and current events and assumptions about future events. Certain accounting estimates are particularly sensitive because of their significance to the financial statements and because of the possibility that future events affecting them may differ significantly from those expected. The most sensitive estimates affecting the financial statements are (i) the fair value of the Plan's investments because of their significance to the financial statements, and (ii) the Plan will not incur amounts to remedy the operational error of failing to withhold contributions for certain participants from certain eligible wages, as that has been determined to be a liability of the Plan sponsor. We evaluated the key factors and assumptions used to develop such estimates in determining that it is reasonable in relation to the financial statements taken as a whole.

Certain financial statement disclosures are particularly sensitive because of their significance to financial statement users. The most sensitive disclosures affecting the financial statements are related to the Plan's investments in Note 3 and 4, Plan termination in Note 6, and the failure to withhold contributions for certain participants from certain eligible wages in Note 7. We believe the financial statement disclosures are neutral, consistent and clear.

Form 5500 Procedures

We are required to obtain and read a substantially complete draft of Form 5500 prior to dating our auditors' report. The purpose of this procedure is to identify any material inconsistencies between the draft Form 5500 and the Plan's financial statements. We identified no material inconsistencies in performing and completing our audits.

Difficulties Encountered in Performing the Audits

We encountered no significant difficulties in dealing with management in performing and completing our audits.

Corrected and Uncorrected Misstatements

Professional standards require us to accumulate all misstatements identified during the audits, other than those that are clearly trivial, and communicate them to the appropriate level of management. There were no uncorrected or corrected misstatements as a result of our audit procedures.

Reportable Findings

For purposes of this letter, a reportable finding is a matter that includes one or more of the following: (1) noncompliance or suspected noncompliance with laws and regulations, (2) a finding that in our professional judgment is significant and relevant to you regarding your responsibility to oversee the financial reporting process, and (3) an indication of internal control deficiencies identified during the audits that have not been previously communicated to management by other parties and that we determined are sufficiently important to merit management's attention.

We identified the following reportable finding in connection with our audits:

- 1) We determined there was a failure to withhold contributions for certain participants from certain eligible wages, as defined in the Plan agreement, and failure to provide Company matching contributions to those participants. The Plan administrator has taken appropriate corrective actions to remedy these errors, and remit to the affected participants any lost earnings (if applicable).

Disagreements with Management

For purposes of this letter, a disagreement with management is a financial accounting, reporting, or auditing matter, whether or not resolved to our satisfaction, that could be significant to the financial statements or the auditors' report. We are pleased to report that no such disagreements arose during the course of our audits.

Management Representations

We have requested certain representations from management that are included in the management representation letter dated October 12, 2023 and February 8, 2024. We would be happy to provide you with a copy of this letter upon your request.

Management Consultations with Other Independent Accountants

In some cases, management may decide to consult with other accountants about auditing and accounting matters, similar to obtaining a "second opinion" on certain situations. If a consultation involves application of an accounting principle to the Plan's financial statements or a determination of the type of auditors' opinion that may be expressed on those statements, our professional standards require the consulting accountant to check with us to determine that the consultant has all the relevant facts. To our knowledge, there were no such consultations with other accountants.

Other Audit Findings or Issues

We generally discuss a variety of matters, including the application of accounting principles and auditing standards, with management each year prior to retention as the Plan's auditors. However,

these discussions occurred in the normal course of our professional relationship and our responses were not a condition to our retention.

Other Matters

Our responsibility for the ERISA-required supplemental schedules accompanying the financial statements is to perform adequate procedures to evaluate whether the form and content of the ERISA-required supplemental schedules, other than that agreed to or derived from the certified investment information, is presented in compliance with the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA, and whether the information in the supplemental schedules related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

Internal Control Communications

Except as discussed in the following paragraph, in planning and performing our audits of the financial statements of the Plan, as of and for the year ended December 31, 2022 and as of May 22, 2023 and for the period January 1, 2023 through May 22, 2023, in accordance with GAAS, we considered the Plan's system of internal control over financial reporting (internal control) as a basis for designing audit procedures that are appropriate in the circumstances for the purpose of issuing our report on the financial statements, but not for the purpose of expressing an opinion on the effectiveness of the Plan's internal control. Accordingly, we do not express an opinion on the effectiveness of the Plan's internal control.

We were engaged to perform a ERISA Section 103(a)(3)(C) audits of those financial statements as permitted by 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under the Employee Retirement Income Security Act of 1974. As permitted by ERISA Section 103(a)(3)(C), our audits did not extend to any statements or information related to assets held for investment of the Plan by John Hancock that prepared and certified the statements or information regarding assets so held in accordance with 29 CFR 2520.103-5. Our audits also did not include a consideration of internal control relating to the investment information.

Our consideration of internal control was for the limited purpose described in the preceding paragraphs and was not designed to identify all deficiencies in internal control that might be material weaknesses or significant deficiencies and, therefore, material weaknesses or significant deficiencies may exist that were not identified. As discussed above under the caption *Reportable Findings*, we identified certain deficiencies in internal control that we consider to be significant deficiencies.

A deficiency in internal control exists when the design or operation of a control does not allow management or employees, in the normal course of performing their assigned functions, to prevent, or detect and correct, misstatements on a timely basis. A "significant deficiency" is a deficiency,

or a combination of deficiencies, in internal control that is less severe than a material weakness, yet important enough to merit attention by those charged with governance. We did not identify any deficiencies in internal control that we consider to be material weaknesses.
