Subject: Request for Penalty Relief for Late Filing of Form 5500-SF

Dear Sir/Madam,

I am writing to respectfully request relief from penalties imposed due to the late filing of Form 5500-SF for our 401(k) pension plan, sponsored by Smart Thinking LLC, for the plan year ending 2022.

As a small business, we strive to maintain compliance with all applicable laws and regulations. Unfortunately, we recently discovered an oversight in the filing of Form 5500-SF. This oversight occurred due to a misunderstanding with our payroll service provider, whom we believed was responsible for the filing of this form. It has come to our attention that the form was not filed because our 401(k) plan did not have any participants during the reporting period.

Upon discovering this issue, we have taken immediate corrective action by filing the 5500-SF as a final return to ensure compliance with the Employee Retirement Income Security Act (ERISA) requirements. We acted promptly upon learning of the filing requirement and have put measures in place to prevent such oversights in the future.

Given these circumstances, and considering that the plan had no participants and therefore no individual's retirement assets were at risk, we kindly request the IRS to consider abating the penalties associated with this late filing. We acknowledge the importance of timely compliance and deeply regret this inadvertent delay.

We are committed to upholding the highest standards of compliance moving forward and appreciate your consideration of our request for penalty relief under the IRS's First Time Abate policy or any other applicable relief provisions.
