Independent Auditors' Report

To the Participants and Plan Administrator of

Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the financial statements of The NewRez Family of Companies 401(k) Plan (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of January 6, 2023 and December 31, 2022, and the related statements of changes in net assets available for benefits for January 1, 2023 to January 6, 2023, and for the year ended December 31, 2022, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's (DOL) Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the Plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the DOL's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from a qualified institution as of January 6, 2023 and December 31, 2022, and January 1, 2023 to January 6, 2023, and for the year ended December 31, 2022, stating that the certified investment information, as described in Note 4 to the financial statements, is complete and accurate.

Opinion

In our opinion, based on our audits and on the procedures performed as described in the Auditors' Responsibilities for the Audit of the Financial Statements section:

- The amounts and disclosures in the financial statements, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.
- The information in the financial statements related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

Basis for Opinion

We conducted our audits in accordance with auditing standards generally accepted in the United States of America (GAAS). Our responsibilities under those standards are further described in the Auditors' Responsibilities for the Audit of the Financial Statements section of our report. We are required to be independent of the Plan and to meet our other ethical responsibilities, in accordance with the relevant ethical requirements relating to our audits. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our ERISA Section 103(a)(3)(C) audit opinion.

Emphasis of Matter

As discussed in Note 1 to the financial statements, the Plan merged into the Caliber Newrez Family of Companies 401(k) Plan, effective January 1, 2022, and all assets were fully transferred by January 6, 2023. Our opinion is not modified with respect to this matter.

Responsibilities of Management for the Financial Statements

Management is responsible for the preparation and fair presentation of the financial statements in accordance with accounting principles generally accepted in the United States of America, and for the design, implementation and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

In preparing the financial statements, management is required to evaluate whether there are conditions or events, considered in the aggregate, that raise substantial doubt about the Plan's ability to continue as a going concern for one year after the date the financial statements are available to be issued.

Management is also responsible for maintaining a current plan instrument, including all plan amendments, administering the Plan, and determining that the Plan's transactions that are presented and disclosed in the financial statements are in conformity with the Plan's provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.

Auditors' Responsibilities for the Audit of the Financial Statements

Except as described in the Scope and Nature of the ERISA Section 103(a)(3)(C) Audit section of our report, our objectives are to obtain reasonable assurance about whether the financial statements as a whole are free from material misstatement, whether due to fraud or error, and to issue an auditors' report that includes our opinion. Reasonable assurance is a high level of assurance but is not absolute assurance and therefore is not a guarantee that an audit conducted in accordance with GAAS will always detect a material misstatement when it exists. Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings and certain internal control-related matters that we identified during the audit.

1. Description of the Plan

General

The NewRez Family of Companies 401(k) Plan (the Plan) is a multiple-employer defined contribution plan and is subject to the provisions of the Employee Retirement Income Security Act of 1974, as amended (ERISA). The Plan was established on February 1, 2009, and was amended and restated as of June 3, 2021. The Plan covers substantially all related employees of NewRez, LLC (collectively, the Company or Plan Administrator). Empower Retirement Services serves as the record-keeper of the plan. Empower Annuity Insurance Company of America and Empower Trust Company, LLC serves as the Custodians (collectively the Custodians) as of January 6, 2023 and December 31, 2022 and January 1, 2023 to January 6, 2023 and the year ended December 31, 2022. Great-West Life & Annuity Insurance Company and Great-West Trust Company, LLC, an affiliate of Empower Retirement, served as the Custodian and record-keeper as of December 31, 2021. One officer of the Company serves as trustee (the Trustee) of the Plan.

Effective January 1, 2022, the Plan merged into the Caliber Newrez Family of Companies 401(k) Plan (the Affiliated Plan). This has been recorded as a Transfer Out to Affiliated Plan of \$5,116,342 and \$164,360,175 in the statements of changes in net assets for January 1, 2023 to January 6, 2023 and the year ended December 31, 2022, respectively.

The following description provides only general information. Participants should refer to the plan document for a more complete description of the Plan's provisions.

Eligibility and Participant Accounts

The Plan covers all employees of the Company who are not covered by a collective bargaining agreement or nonresident alien., as defined by the plan document. Employees become eligible for participation after the age 21 and upon completion of one month of service. Participants may enter the Plan on the first day of the month following the date on which eligibility requirements are satisfied.

Subject to certain limitations on annual additions, each participant's account is credited with participant's contributions, Company contributions and an allocation of plan earnings or losses, and charged with certain administrative expenses. The allocations are based on participant earnings, transactions, or account balances, as defined. Participants may modify investment elections, transfer existing account balances and obtain information regarding the investments on a daily basis.

Contributions

The Plan is funded through participant pre-tax and after-tax (Roth) elective deferrals, rollover contributions and Company matching and profit-sharing contributions. A participant may elect to contribute up to 100% of annual compensation, subject to certain maximum limitations imposed by the Internal Revenue Code (IRC) (\$20,500 for 2022 and \$22,500 for 2023). Employees who are eligible to make elective deferrals under the Plan and who have attained the age 50 before the close of the plan year are eligible to make catch-up contributions subject to the maximum limitation imposed by the IRC (\$6,500 for 2022 and \$7,500 for 2023). Rollover contributions representing distributions from other qualified defined benefit or defined contribution plans are permitted and may be made prior to meeting the eligibility requirements for participation in the Plan.

The Plan has an automatic enrollment deferral feature for new and existing participants set at 4% unless opted-out by the participants.

The Plan allows for Company discretionary matching contributions in amounts to be determined by the Company. From January 1, 2023 to January 6, 2023 and the year ended December 31, 2022, the Company made no discretionary matching contributions.

Benefits Paid to Participants

Upon normal retirement age, death, disability or termination, a participant's benefits may be payable in either installments for accounts with balances greater than \$5,000 or a lump-sum amount equal to 100% of the participant's vested account balance. Participants with vested account balances greater than \$5,000 may defer their distributions to a later date. In addition, the Plan allows for hardship distributions if certain criteria are met. Terminated participant balances less than \$5,000 will be "cashed out" as an involuntary lump sum payment.

Investment Options

The Plan provides for participants to direct both participant contributions and Company contributions into a variety of mutual funds of registered investment companies, common collective trusts, and a group annuity contract in accordance with participant investment elections and the provisions of the trust agreement. Participants should refer to the plan website for additional fund information.

Vesting

Participants are immediately vested in elective deferrals and rollover contributions, plus actual earnings received thereon. Vesting of Company discretionary matching and Company discretionary profit sharing contributions and earnings thereon is based on years of continuous service. Participants vest 25% the first year of service and an additional 25% each year thereafter. Participants are 100% vested after four years of service or upon occurrence of the participant's retirement, death or disability, as defined by the plan document.

Forfeitures

Forfeitures are available to reduce Company contributions or pay administrative expenses. These amounts are reported as a component of net assets available for benefits. At January 6, 2023 and December 31, 2022 and 2021, forfeited nonvested accounts available for future use totaled \$0, \$12,275 and \$3,939 respectively. During 2022, no forfeitures were used to reduce Company contributions or to pay administrative expenses. Effective January 6, 2023 and December 31, 2022, forfeited nonvested accounts of \$12,294 and \$9,307, respectively, were included in the transferred assets disclosed in Note 1.

Revenue Sharing

The Plan has a revenue sharing account, which is funded by the Trustee. Revenue sharing accounts are used to pay administrative expense or are reallocated to participant accounts. For the year ended December 31, 2022, there were revenue sharing contributions to the Plan of \$25,000, which is recorded as other income on the Statements of Changes in Net Assets Available for Benefits. During 2022, revenue sharing of \$25,000 was used to pay administrative fees. No revenue sharing was allocated to participants.

Notes Receivable From Participants

Participants may borrow from their fund accounts a minimum of \$1,000 up to a maximum of the lesser of \$50,000 or 50% of their vested account balance, whichever is less, subject to certain restrictions as defined by the Internal Revenue Service (IRS). The borrowings are secured by the balance in the participant's account and bear interest at a rate of prime rate, as posted by the Wall Street Journal, plus 1%. Any note must be repaid within five years unless for the purchase of a primary residence, in which case the repayment period is within 10 years. Notes receivable from participants are stated at original note amounts less principal repayments received to date. Repayments are made through payroll deductions and are reinvested in the participant accounts according to individual investment elections. As of January 6, 2023, there were no notes receivable to participants. Notes receivable from participants as of December 31, 2022, bear interest at rates of 7.25% with maturity date of October 2027. Notes receivable from participants as of December 31, 2021, bear interest at rates of 4.25% to 6.50% with maturities from January 2022 to December 2031.

Administrative Expenses

Certain expenses of maintaining the Plan are paid by the Plan, unless otherwise paid by the Company. Expenses that are paid by the Company are excluded from these financial statements. Fees related to the administration of notes receivable from participants and fees paid related to benefits paid are charged directly to the participant's account and are included in administrative expenses. Investment related expenses are included in net appreciation (depreciation) of fair value of investments.

2. Summary of Significant Accounting Policies

Basis of Accounting

The financial statements of the Plan are prepared on the accrual basis of accounting.

Estimates and Assumptions

The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America requires the Plan's management to make estimates and assumptions that affect certain reported amounts of assets and liabilities, changes therein, and associated disclosures. Accordingly, actual results may vary from the estimates used in preparing the accompanying financial statements.

Investment Valuation and Income Recognition

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date (See Note 3 - Fair Value Measurements). Contract value is the relevant measure attributable to fully benefit-responsive investment contracts because contract value is the amount participants would receive if they were to initiate permitted transactions under the provision of the Plan (See Note 5 – Group Annuity Contract). Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. The income or loss earned on participant accounts is allocated on a daily basis using the previous day's ending account balance. Net appreciation (depreciation) of fair value of investments includes the gains and losses on the investments bought and sold, as well as held during the year.

Payment of Benefits

Benefits are recorded when paid.

Notes Receivable From Participants

Notes receivable from participants are measured at their unpaid principal balances plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Delinquent notes receivable from participants are reclassified as distributions based upon terms of the plan document or note policy of the Plan. Notes receivables are valued at amortized cost, which approximates fair value. No allowance for credit losses has been recorded as of January 6, 2023, December 31, 2022, and 2021.

3. Fair Value Measurements

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). The three levels of the fair value hierarchy under the Financial Accounting Standards Board (FASB) Accounting Standards Codification (ASC) 820 are described as follows:

Level 1 - Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets.

Level 2 - Significant observable inputs other than quoted prices in active markets for which inputs to the valuation methodology include:

- quoted prices for similar assets or liabilities in active markets;
- quoted prices for identical or similar assets or liabilities in inactive markets;
- inputs other than quoted prices that are observable for the asset or liability;
- inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 - Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observables and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2022 and 2021.

Mutual funds of registered investment companies are valued at the net asset value (NAV) or quoted market prices of shares held by the Plan at year-end.

Common collective trusts are valued at the NAV of units of a bank collective trust, as provided by the Custodian. The NAV is based on the fair value of the underlying investments held by the fund less its liabilities. The NAV is not used when it is determined to be probable that the fund will sell the investment for an amount different than the reported NAV. Participant transactions (purchases and sales) may occur daily. Were the Plan to initiate a full redemption of the common collective trust, the Custodian reserves the right to temporarily deny withdrawal from the trust to ensure that securities liquidations will be carried out in an orderly business manner.

The methods described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. The Plan believes its valuation methods are appropriate and consistent with other market participants; even so, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

4. Information Certified by Custodians

The Plan Administrator has elected the method of compliance permitted by 29 CFR 2520.103-8 of the Department of Labor's (DOL) Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, the Custodians have certified to the completeness and accuracy of all investments reported in the accompanying Statements of Net Assets Available for Benefits as of January 6, 2023 and December 31, 2022 and 2021, and the supplemental Schedule H, Line 4(i) - Schedule of Assets (Held at End of Year) as of December 31, 2022, and the related investment activity reported in the Statements of Changes in Net Assets Available for Benefits for January 1, 2023 to January 6, 2023 and the year ended December 31, 2022.

5. Group Annuity Contract

The Empower Investments Fixed Account - Series Class VI is a fully benefit-responsive group annuity contract issued by Empower Annuity Insurance Company of America (formerly Key Guaranteed Portfolio Fund issued by Great West Life & Annuity Insurance Company). There are no reserves against contract value for credit risk of the contract issuer or otherwise. The crediting interest rate is based on a formula agreed upon with the issuer but may not be less than zero. Such interest rates are continuously reviewed and reset as needed on a quarterly basis. There is a surrender charge that may be charged based on cumulative transfer percentages and advance notice of intent to terminate if a plan terminates its interest in the contract unless a 12-month irrevocable advance notice is given. Certain unobservable inputs are assessed through review of contract terms (ex: duration or payout date) while others are substantiated utilizing available market data (ex: swap curve rate).

Certain events might limit the ability of the Plan to transact at contract value with the contract issuer. Such events include (1) amendments to the plan documents (including complete or partial plan termination or merger with another plan), (2) changes to the Plan's prohibition on competing investment options or deletion of equity wash provisions, (3) bankruptcy of the plan sponsor or other plan sponsor events (for example, divestitures or spinoffs of a subsidiary) that cause a significant withdrawal from the Plan, or (4) the failure of the trust to qualify for exemption from federal income taxes or any required prohibited transaction exemption under ERISA (5) premature termination of the contract.

No events are probable of occurring that might limit the ability of the Plan to transact at contract value with the contract issuer and that also would limit the ability of the Plan to transact at contract value with the participants.

In addition, certain events allow the issuer to terminate the contract with the Plan and settle at an amount different from contract value. Such events include (1) an uncured violation of the Plan's investment guidelines, (2) a breach of material obligation under the contract, (3) a material misrepresentation, (4) a material amendment to the agreement without the consent of the issuer.

6. Related-Party and Party in Interest Transactions

Certain of the Plan's investments are managed by the Custodians or an affiliate of the Custodians; therefore, these transactions qualify as party in interest transactions. The Plan issues notes receivable to participants, which are secured by the participant's account balances. These transactions also qualify as party in interest transactions.

Certain administrative functions are performed by officers or employees of the Company. No such officer or employee received compensation from the Plan.

7. Risks and Uncertainties

Investment securities are exposed to various risks, such as interest rate, market, concentration, and credit risk. Market risks include global events, such as a pandemic or international conflict, which could impact the value of investment securities. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the value of the investments will occur in the near term and that such changes could materially affect participant's account balances and the amounts reported in the Statements of Net Assets Available for Benefits.

8. Tax Status

The Plan is based on a nonstandardized pre-approved profit sharing/money purchase/CODA plan developed by Empower Retirement LLC, which received a favorable opinion letter dated November 14, 2022, from the IRS stating that the pre-approved plan constitutes a qualified plan under Section 401 of the IRC. The Plan Administrator believes the Plan, as adopted and amended, is operating within the guidelines of the IRC and continues to be tax exempt. Accordingly, no provision for federal income taxes has been provided in the accompanying financial statements.

Accounting principles generally accepted in the United States of America requires plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the organization has taken an uncertain position that more likely than not would not be sustained upon examination by the DOL or IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

9. Excess Contributions Payable

The Plan failed the discrimination test for the year ended December 31, 2021. As a result, excess contributions payable amounting to \$102,099 was recorded as a liability in the accompanying Statements of Net Assets Available for Benefits.
