### **Scope and Nature of the ERISA Section 103(a)(3)(C) Audit**

We have performed audits of the financial statements of the Jackson Orlando Associates 401(k) Plan (the "Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits--modified cash basis as of January 1, 2023 and December 31, 2022, and the related statement of changes in net assets available for benefits--modified cash basis for the period ended January 1, 2023, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's (DOL) Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the DOL's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from a qualified institutions as of January 1, 2023 and December 31, 2022 and for the period ended January 1, 2023, stating that the certified investment information, as described in Note H to the financial statements, is complete and accurate.

### **Opinion**

In our opinion, based on our audits and on the procedures performed as described in the Auditor's Responsibilities for the Audit of the Financial Statements section:

- The amounts and disclosures in the accompanying financial statements, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with the modified cash basis of accounting described in Note B.

- The information in the accompanying financial statements related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

### ***Basis for Opinion***

We conducted our audits in accordance with auditing standards generally accepted in the United States of America (GAAS). Our responsibilities under those standards are further described in the Auditor's Responsibilities for the Audit of the Financial Statements section of our report. We are required to be independent of the Plan and to meet our other ethical responsibilities, in accordance with the relevant ethical requirements relating to our audits. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our ERISA Section 103(a)(3)(C) audit opinion.

### ***Emphasis of Matter***

As discussed in Note A to the financial statements, the Plan merged with the Jackson Healthcare 401(k) Savings Plan (the "JH Plan") effective January 1, 2023. The Plan transferred control of its net assets to the JH Plan and ceased operations on the effective date. Our opinion is not modified with respect to this matter.

### ***Responsibilities of Management for the Financial Statements***

Management is responsible for the preparation and fair presentation of the financial statements in accordance with the modified cash basis of accounting described in Note B; this includes determining that the modified cash basis of accounting is an acceptable basis for the presentation of the financial statements in the circumstances. Management is also responsible for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

In preparing the financial statements, management is required to evaluate whether there are conditions or events, considered in the aggregate, that raise substantial doubt about the Plan's ability to continue as a going concern for one year after the date that the financial statements are issued.

Management is also responsible for maintaining a current plan instrument, including all plan amendments, administering the plan, and determining that the plan's transactions that are presented and disclosed in the financial statements are in conformity with the plan's provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.

## ***Auditor's Responsibilities for the Audit of the Financial Statements***

Except as described in the Scope and Nature of the ERISA Section 103(a)(3)(C) Audit section of our report, our objectives are to obtain reasonable assurance about whether the financial statements as a whole are free from material misstatement, whether due to fraud or error, and to issue an auditor's report that includes our opinion. Reasonable assurance is a high level of assurance but is not absolute assurance and therefore is not a guarantee that an audit conducted in accordance with GAAS will always detect a material misstatement when it exists. The risk of not detecting a material misstatement resulting from fraud is higher than for one resulting from error, as fraud may involve collusion, forgery, intentional omissions, misrepresentations, or the override of internal control. Our audits did not extend to the certified investment information, except for obtaining and reading the certifications, comparing the certified investment information with the related information presented and disclosed in the financial statements, and reading the disclosures relating to the certified investment information to assess whether they are in accordance with the presentation and disclosure requirements of the modified cash basis of accounting.

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with the modified cash basis of accounting.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audit.

The information included in the supplemental schedule, other than that agreed to or derived from the certified investment information, has been subjected to auditing procedures applied in the audit of the financial statements and certain additional procedures, including comparing and reconciling such information directly to the underlying accounting and other records used to prepare the financial statements or to the financial statements themselves, and other additional procedures in accordance with GAAS. For information included in the supplemental schedule that agreed to or is derived from the certified investment information, we compared such information to the related certified investment information.

#### NOTE A--DESCRIPTION OF PLAN

The following description of the Jackson Orlando Associates 401(k) Plan (the "Plan") provides only general information. Participants should refer to the Plan document for a more complete description of the Plan's provisions.

General: The Plan was a defined contribution plan covering substantially all internal employees of Jackson Therapy Partners, LLC ("the Employer" and "Plan Administrator"), and certain controlled and affiliated companies. The Plan included employees of: Kirby Bates Associates, LLC; Healthcare Workforce Logistics, LLC; JTP Staffing Associates, LLC; JNP Staffing Associates, LLC; and JPP Staffing Associates, LLC. Employees were eligible to participate in the Plan the first day of the month coinciding with or following their employment date. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 ("ERISA"), as amended.

Effective January 1, 2023, the Plan merged with the Jackson Healthcare 401(k) Savings Plan (the "JH Plan") which is sponsored by an affiliate of the Employer. In connection with the merger, the Plan Sponsor and all participating employers of the Plan became participating employers in the JH Plan. These financial statements reflect the transfer of the Plan's net assets on January 1, 2023 as control of the Plan's net assets was transferred to the JH Plan on this date.

Contributions: The Plan provided for employee elective pre-tax and/or after-tax contributions, not to exceed the Federal statutory maximum, with an Employer discretionary matching provision. No contributions were made to the Plan during the period ended January 1, 2023.

Participant Accounts: Each participant's account was credited with their contributions, the Employer's matching contributions, their account's earnings or losses, and an allocation of any Employer discretionary profit-sharing contribution. All investments were participant directed. Participants could change their investment options daily.

Investments: Participants could allocate their contributions and Employer contributions among a selection of equity and fixed income mutual funds, pooled separate accounts and collective investment trusts.

Vesting: Participants were immediately vested in their voluntary contributions, and allocated earnings thereon. Employer matching and discretionary contributions and earnings thereon vest at the rate of 25% per year of credited service. A participant was 100% vested after four years of credited service, or in the event of death, disability or normal retirement. Forfeited amounts could be used to pay administrative expenses of the Plan and to reduce future Employer contributions to the Plan.

#### NOTE A--DESCRIPTION OF PLAN--Continued

Administration: The Plan was administered by the Employer. The funds of the Plan were held by the following service providers (collectively "Principal") in their capacity as trustee or custodian for the Plan: Delaware Charter Guarantee & Trust Company d/b/a Principal Trust Company, Principal Global Investors Trust Company, and State Street Corporation on behalf of Principal Life Insurance Company. These entities held the Plan's assets and invested participants' account balances as directed by the participants.

Withdrawals: A participant could withdraw his vested account balance plus earnings thereon in the case of a financial hardship. Withdrawals were taxable in the year received by the participant and may be subject to a penalty tax. Additionally, after reaching the age of 59½, a participant could request an in-service distribution from vested accounts.

Payment of Benefits: Upon a participant's termination of employment with the Company, or after reaching the age of 59 ½, the participant was entitled to receive a distribution of their vested account balance. The participant could elect to receive a distribution at any time in the form of a lump sum payment. If the participant died or was totally and permanently disabled prior to receiving their entire vested account balance, the balance would be paid to the participant's beneficiary or estate.

Notes Receivable from Participants: Participants could borrow from their account a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000, or 50% of their vested account balance. Participants could only have one loan outstanding at any given time. Loans were repaid through payroll deductions over periods of up to 60 months, except in circumstances when the loan proceeds were used to purchase the primary residence of the participant. In such circumstances, the loan repayment schedule would be determined on a case-by-case basis. The loans were secured by the balance in the participant's vested account and bore interest at the prime rate plus 2% at the loan date.

#### NOTE B--SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

The Plan followed the Financial Accounting Standards Board Accounting Standards Codification as its sole source of authoritative accounting guidance.

The financial statements for the Plan are prepared utilizing the modified cash basis method of accounting, which differs from generally accepted accounting principles, which uses the accrual method.

## NOTES TO FINANCIAL STATEMENTS--Continued

#### NOTE B--SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES--Continued

The Plan's investments were stated at fair value, as further described in Note C. Investment securities, in general, are exposed to various risks, including credit, interest and overall market volatility risks. Due to the level of risk associated with certain investment securities, it is possible that changes in values of investment securities will occur and that such changes could materially affect the amounts reported in the statements of net assets available for benefits--modified cash basis.

Loans to participants are reported separately from Plan investments as notes receivable. These loans are recorded at their unpaid principal balance.

The preparation of financial statements requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities, and the disclosure of contingent assets and liabilities at the date of the financial statements and the reported amounts of additions to and deductions from net assets during the reporting period. Actual results could differ from those estimates.

Subsequent events have been evaluated through April 4, 2024, which is the date the financial statements were available to be issued. The Plan had no activity after the merger effective January 1, 2023.

#### NOTE C--FAIR VALUE MEASUREMENTS

Current accounting guidance establishes a framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs into valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1 measurements) and the lowest priority to unobservable inputs (level 3 measurements). The three levels of the fair value hierarchy are described below:

Level 1        Inputs to the valuation methodology are unadjusted quoted prices for identical assets and liabilities in active markets that the Plan has the ability to access.

Level 2        Inputs to the valuation methodology include quoted prices for similar assets or liabilities in active markets; quoted prices for identical or similar assets or liabilities in inactive markets; inputs other than quoted prices that are observable for the asset or liability; inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

The following is a description of the valuation methodologies used for assets measured at fair value:

Mutual funds: Valued at the quoted market price, which represents the net asset value of shares held by the Plan at year end.

Pooled separate accounts: Valued based on quoted market prices of the securities underlying the pooled separate accounts.

Collective investment trusts: Valued based on quoted market prices of the securities underlying the collective investment trusts.

The methods described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

#### NOTE D--TRANSACTIONS WITH PARTIES-IN-INTEREST

The Plan had an agreement with Principal to maintain the investments of the Plan and to provide administrative and participant recordkeeping services for the Plan. At January 1, 2023 and December 31, 2022, the Plan had \$-0- and \$10,458,456 respectively, of assets held by Principal.

#### NOTE E--TAX STATUS

The Plan was intended to satisfy the tax qualification requirements under Section 401(a) of the Internal Revenue Code; therefore, the trust funds of the Plan were intended to be exempt from federal income taxes. The Plan has not requested a favorable determination letter from the IRS since the prototype on which the Plan is based has been determined to be qualified under Section 401(a) of the Internal Revenue Code.

#### NOTE F--RECONCILIATION OF FINANCIAL STATEMENTS TO FORM 5500

There were no significant differences between the Internal Revenue Service Form 5500 and the statements of net assets available for benefits--modified cash basis as of January 1, 2023 and December 31, 2022, and the statement of changes in net assets available for benefits--modified cash basis for the period ended January 1, 2023.

#### NOTE G--FORFEITED NON-VESTED ACCOUNTS

At January 1, 2023 and December 31, 2022, investments included \$-0- and \$8,256, respectively, in unused forfeitures, which were available to pay for administrative expenses or reduce future Employer contributions.

#### NOTE H--SUMMARY OF INFORMATION CERTIFIED BY QUALIFIED INSTITUTIONS

The total fair value of the Plan's net assets was \$-0- and \$10,458,456 at January 1, 2023 and December 31, 2022, respectively. Qualified institutions (Delaware Charter Guarantee & Trust Company d/b/a Principal Trust Company and Principal Life Insurance Company) have supplied the Plan Administrator with certifications as to the completeness and accuracy of all information presented in the accompanying statements of net assets available for benefits as of January 1, 2023 and December 31, 2022, and in the statement of changes in net assets available for benefits for the period ended January 1, 2023, in regards to investment activity.
