INDEPENDENT AUDITORS' REPORT

To the Retirement Plan Committee and the Plan Participants of

Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the accompanying financial statements of ManTech International Corporation Employee Stock Ownership Plan (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits – liquidation basis as of August 9, 2023 and December 31, 2022, the related statement of changes in net assets available for benefits in liquidation for the period ended August 9, 2023, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the ManTech International Corporation Employee Stock Ownership Plan performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the Plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from a qualified institution as of August 9, 2023 and December 31, 2022, and for the period ended August 9, 2023, stating that the certified investment information, as described in Note 3 to the financial statements, is complete and accurate.

Opinion

The Plan presented the financial statements as of August 9, 2023 and December 31, 2022 and for the period ended August 9, 2023 on the liquidation basis of accounting. Our opinion is not modified with respect to that matter.

1. DESCRIPTION OF THE PLAN

The following description of the ManTech International Corporation Employee Stock Ownership Plan (the Plan or ESOP) provides only general information. Participants should refer to the Plan document for a complete description of the Plan's provisions.

General

The ESOP is a qualified retirement plan, established effective January 1, 1999, and is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA), as amended. Prior to plan termination, substantially all employees of ManTech International Corporation (the "Company") and its subsidiaries, who were on the Company's U.S. payroll, were eligible to participate in the Plan. Employees who were not eligible to participate in the Plan included: (i) leased employees; (ii) employees who were employed under the terms of contracts between the Company and the United States government, unless the contracts are designated by the Company as participating in the Plan; and (iii) employees who were employed by a subsidiary or related company that had not adopted the Plan. The Plan was most recently amended effective October 17, 2022 to conform to the CARES act and to terminate the Plan.

Plan Termination

Effective September 14, 2022, the Company was acquired, resulting in the sale of its outstanding stock. As part of this transaction, the Company made the decision to terminate the Plan effective October 17, 2022 (Note 6). The Company completed the process to distribute all assets to respective participants effective August 9, 2023.

Contributions and Eligibility

The ESOP was non-leveraged and was funded entirely through Company contributions based on a percentage of employees' compensation, as defined in the Plan. The Company's contributions to the Plan were discretionary. For the period ended August 9, 2023, the Company made a discretionary contribution to the Plan totaling \$1,916. Contributions could consist of the Company's Class A common stock or cash. Eligible employees shared in any Company contribution made for a Plan Year if they met the following minimum requirements:

- a. The employee was credited with at least 1000 hours of service during the Plan Year; and
- b. The employee was employed by the Company on the last day of the Plan Year.

Participants' Accounts

Individual accounts were maintained for each Plan participant. Each eligible participant's account was credited as of the last day of each Plan Year with an allocation of shares of the Company's common stock released by the Trustee from the unallocated account. Only those participants who were eligible employees of the Company as of the last day of the Plan Year would receive an allocation. Allocations were based on a participant's eligible compensation, relative to the total eligible compensation. The benefit to which a participant was entitled was the benefit that can be provided from the participant's vested account.

Plan Administration

The Retirement Plan Committee (the “Committee”) of the Board of Directors of the Company oversaw the operation and administration of the Plan. Fidelity Management Trust Company (“Fidelity”) was the Plan’s Trustee as of August 9, 2023 and December 31, 2022 and for the period ended August 9, 2023. The Custodian of the Plan, responsible for its administration, was Fidelity Investment Institutional Operations Company, Inc. as of August 9, 2023 and December 31, 2022 and for the period ended August 9, 2023.

Payment of Benefits

Prior to plan termination, no distributions from the Plan were to be made until a participant retired, became disabled, died (in which case, payment shall be made to his or her beneficiary or, if none, his or her legal representatives), otherwise terminated employment with the Company, or became eligible for diversification of his or her account. If the value of a terminated participant’s vested balance in his or her account did not exceed \$1,000, the vested balance would be distributed in cash in the form of a single lump sum payment, as soon as practicable, but in no event later than the last day of the Plan Year following the Plan Year in which the participant terminated employment.

Benefit payments to participants are recorded upon distribution. As of August 9, 2023 and December 31, 2022, there were no net assets of the Plan allocated to participants who had elected to withdraw from the Plan but had not received the funds as of year-end.

Dividends

Plan participants were entitled to receive any dividends that the Company paid with respect to its Class A common stock on the shares allocated to their individual accounts as of the dividend record date. At the Company’s discretion, dividends could either be paid directly to participants or distributed to the Trustee, who would then accumulate and hold in the Plan any periodic dividends that were paid and would automatically distribute the accumulated amounts to participants, plus any investment gains, less any investment losses, in a single cash lump sum on or about December 31st of each Plan Year (or such other date as the Plan administrator may determine in its discretion), or, if earlier, at the time Plan participants otherwise received a complete distribution of their individual account during the Plan Year. Plan participants could not elect to reinvest dividends in additional shares of the Company’s common stock. Dividends paid or accrued on unallocated Company common stock could be used to reduce future Company contributions or pay reasonable Plan administrative expenses.

Voting Rights

Each participant was entitled to exercise voting rights attributable to the shares allocated to his or her account and was notified by the Trustee prior to the time that such rights were to be exercised. The Trustee was not permitted to vote any allocated shares for which instructions had not been given by a participant. The Trustee was required, however, to vote any unallocated shares on behalf of the collective best interest of Plan participants and their beneficiaries.

Vesting

Participants vested in their ESOP accounts on a graduated scale based on hours of service during a Plan Year. A participant vested based on years of credited service as follows:

In addition, the Plan allowed for accelerated vesting for a participant under certain limited circumstances. All participants became 100% vested in their accounts as a result of the Plan termination in October 2022 (Note 6).

Forfeitures

Plan participants who were not 100% vested at the time of termination of employment would forfeit a pro rata share of their ESOP account balances. Forfeitures were used to offset future Company contributions or pay administrative expenses. Unused forfeitures could be reallocated to active participants at the Company’s discretion. Forfeitures were fully recognized when the participant either received a distribution of the vested portion of his or her account or incurred a one-year break in service as an employee of the Company; whichever occurred first. There were no forfeited nonvested accounts as of August 9, 2023. As of December 31, 2022, forfeited nonvested accounts totaled \$68,290. During the period ended August 9, 2023, the Plan uses \$67,697 of forfeitures to pay administrative expenses, including accrued expenses totaling \$38,750 as of December 31, 2022.

Loans

Loans were not permitted under the Plan.

Plan Expenses

Administrative expenses of the Plan are paid by the Company or the Plan as provided in the Plan document.

Diversification

Diversification was offered to participants close to retirement so that they could have the opportunity to move part of the value of their investment in Company common stock into investments which were more diversified. Participants who were at least age 55 with at least 10 years of participation in the Plan could elect to diversify a portion of their account. Diversification was offered to each eligible participant over a 6-year period. In each of the first 5 years, a participant could diversify up to 25% of shares allocated to his or her account, less any shares previously diversified. In the sixth year, the percentage changed to 50%. Participants who elected to diversify could elect to receive a cash distribution or transfer the balance to another qualified defined contribution plan maintained by the Company.

2. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Basis of Accounting

As described in Note 6 to the financial statements, the Plan terminated in 2022. The Plan's financial statements are presented using the liquidation basis of accounting as of August 9, 2023 and December 31, 2022 and for the period ended August 9, 2023 in accordance with accounting principles generally accepted in the United States of America.

Use of Estimates

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and disclosure of contingent assets and liabilities at the date of the financial statements and the reported amounts of changes in net assets available for benefits in liquidation during the reporting period. Actual results could differ from those estimates.

Risks and Uncertainties

Investment securities, in general, are exposed to risks, such as interest rate, credit, and overall market volatility. Prior to September 14, 2022, the Plan invested primarily in ManTech International Corporation Class A common stock. Due to the level of risk associated with this investment security, it was reasonably possible that changes in the value of the investment security could occur in the near term and that such changes could materially affect the amounts reported in the statements of net assets available for benefits.

Investment Valuation and Income Recognition

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on an accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold, as well as held, during the year. Effective September 14, 2022, the Company was acquired, resulting in the sale of its outstanding stock at a price of \$96 per share. With the completion of the transaction, the Company's common stock ceased trading and is no longer be listed on the NASDAQ Global Select Market.

Subsequent Events

The Plan evaluated for disclosure any subsequent events through February 1, 2024, the date the financial statements were available to be issued and determined there were no material events that warrant disclosure.

3. INVESTMENTS

All investment information disclosed in the accompanying financial statements, including assets held as of August 9, 2023 and December 31, 2022 and interest and dividend income the period ended August 9, 2023, was obtained or derived from information supplied to the Plan administrator and certified as complete and accurate by the Trustee.

4. FAIR VALUE MEASUREMENT

In accordance with Accounting Standards Codification (ASC) 820, *Fair Value Measurement*, the Plan classifies its investments into Level 1, which refers to securities valued using unadjusted quoted prices from active markets for identical assets; Level 2, which refers to securities not traded on an active market but for which observable market inputs are readily available; and Level 3, which refers to securities valued based on significant unobservable inputs. Assets and liabilities are classified in their entirety based on the lowest level of input that is significant to the fair value measurement.

There were no Plan investments at fair value as of August 9, 2023.

5. EXEMPT PARTY-IN-INTEREST TRANSACTIONS

Certain Plan investments were managed by Fidelity Investment Institutional Operations Company, Inc which acted as a custodian for the Plan's investments and was related to the Plan's Trustee. The Company provides certain accounting and administrative services to the Plan for which no fees are charged. Such transactions qualify as party-in-interest transactions, which are exempt from the prohibited transaction rules.

6. PLAN TERMINATION

The Company had the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to provisions of ERISA. Effective September 14, 2022, the Company was acquired, resulting in the sale of its outstanding stock. As part of this transaction, the Company made the decision to terminate the Plan effective October 17, 2022. Effective August 9, 2023, all the assets of the Plan had been paid out.

7. INCOME TAX STATUS

The Internal Revenue Service (IRS) has determined and informed the Company by a determination letter dated April 15, 2016, that the Plan and related trust were designed in accordance with the applicable regulations of the Internal Revenue Code. The Plan has been amended since the date covered by the latest determination letter; however, the Company and Plan management believe that the Plan was currently designed and operated in compliance with the applicable requirements of the Internal Revenue Code; and accordingly the Plan and related trust continued to be tax-exempt. Therefore, no provision for income taxes has been included in the Plan's financial statements. As of August 9, 2023, the Company has filed a request for an updated determination letter in conjunction with Plan termination (Note 6).

ASC 740, *Income Taxes*, prescribes a recognition threshold and a measurement attribute for the financial statement recognition and measurement of tax positions taken or expected to be taken in a tax return as well as guidance on de-recognition, classification, interest and penalties, and financial statement reporting disclosures. For these benefits to be recognized, a tax position must be more-likely-than-not to be sustained upon examination by taxing authorities. As the Plan was tax exempt and had no unrelated business income, these provisions of ASC 740 did not have an impact on the Plan's financial statements. The Plan recognized interest and penalties accrued on any unrecognized tax exposures as a component of income tax expense. The Plan did not have any amounts accrued relating to interest and penalties as of August 9, 2023 and December 31, 2022.

The Plan is subject to routine audits by the IRS and Department of Labor; however, there are currently no audits in progress for any open period.
