Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed an audit of the financial statements of Down East Community Hospital Defined Benefit Plan (Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of July 28, 2023 and September 30, 2022, and the related statement of changes in net assets available for benefits for the period October 1, 2022 to July 28, 2023, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's (DOL) Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the Plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the DOL's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from a qualified institution as of July 28, 2023, and September 30, 2022, and the period October 1, 2022 to July 28, 2023, stating that the certified investment information, as described in Note 6 to the financial statements, is complete and accurate.

Opinion

In our opinion, based on our audits and on the procedures performed as described in the Auditor's Responsibilities for the Audit of the Financial Statements section:

- The amounts and disclosures in the accompanying financial statements, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with U.S. generally accepted accounting principles (U.S. GAAP).
- The information in the accompanying financial statements related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

Basis for Opinion

We conducted our audits in accordance with U.S. generally accepted auditing standards (U.S. GAAS). Our responsibilities under those standards are further described in the Auditor's Responsibilities for the Audit of the Financial Statements section of our report. We are required to be independent of the Plan and to meet our other ethical responsibilities in accordance with the relevant ethical requirements relating to our audit. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our ERISA Section 103(a)(3)(C) audit opinion.

Responsibilities of Management

Management is responsible for the preparation and fair presentation of these financial statements in accordance with U.S. GAAP, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

In preparing the financial statements, management is required to evaluate whether there are conditions or events, considered in the aggregate, that raise substantial doubt about the Plan's ability to continue as a going concern for one year after the date the financial statements are available to be issued.

Management is also responsible for maintaining a current Plan instrument, including all Plan amendments; administering the Plan; and determining that the Plan's transactions that are presented and disclosed in the financial statements are in conformity with the Plan's provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.

Auditor's Responsibilities for the Audit of the Financial Statements

Except as described in the Scope and Nature of the ERISA Section 103(a)(3)(C) Audit section of our report, our objectives are to obtain reasonable assurance about whether the financial statements as a whole are free from material misstatement, whether due to fraud or error, and to issue an auditor's report that includes our opinion. Reasonable assurance is a high level of assurance but is not absolute assurance and therefore is not a guarantee that an audit conducted in accordance with U.S. GAAS will always detect a material misstatement when it exists. The risk of not detecting a material misstatement resulting from fraud is higher than for one resulting from error, as fraud may involve collusion, forgery, intentional omissions, misrepresentations, or the override of internal control. Misstatements are considered material if there is a substantial likelihood that, individually or in the aggregate, they would influence the judgment made by a reasonable user based on the financial statements.

Our audits did not extend to the certified investment information, except for obtaining and reading the certifications, comparing the certified investment information with the related information presented and disclosed in the financial statements, and reading the disclosures relating to the certified investment information to assess whether they are in accordance with the presentation and disclosure requirements of U.S. GAAP.

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with U.S. GAAP.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audit.

Emphasis of Matter - Basis of Accounting

We draw attention to Note 2 of the financial statements, which describes the basis of accounting. As described in Note 2, the Plan changed from the accrual basis of accounting to the liquidation basis of accounting for the period October 1, 2022 to July 28, 2023. Our opinion is not modified with respect to that matter.

Notes to Financial Statements

July 28, 2023 and September 30, 2022

1. Description of the Plan

The following is a brief description of the Down East Community Hospital Defined Benefit Plan (the Plan) which is provided for general information. Participants should refer to the Plan agreement for more complete information.

General

The Plan is a noncontributory defined benefit pension plan for eligible employees of Down East Community Hospital (the Hospital). The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

Effective September 30, 2006, the Plan was amended to cease the accrual of additional benefits. All active participants became 100% vested. On December 16, 2022, the Board of Directors of the Hospital voted to terminate the Plan, effective March 31, 2023 and all assets were distributed by July 28, 2023. Benefits paid to participants were made in the form of taxable distributions, rollovers to qualified retirement plans, and purchases of annuity contracts.

Pension Benefits

Benefits under the Plan are based on a formula which takes into account years of service, average monthly pay, and other factors.

2. Summary of Significant Accounting Policies

Basis of Accounting

For the period October 1, 2022 to July 28, 2023, the financial statements were prepared using the liquidation basis of accounting in accordance with U.S. generally accepted accounting principles (U.S. GAAP). For the year ended September 30, 2022, the Plan used the accrual basis of accounting in accordance with U.S. GAAP.

Use of Estimates

The preparation of financial statements in conformity with U.S. GAAP requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities, disclosure of contingent assets and liabilities, and the actuarial present value of accumulated plan benefits at the date of the financial statements. Actual results could differ from those estimates.

Valuation of Investments

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date.

Notes to Financial Statements

July 28, 2023 and September 30, 2022

Pooled separate accounts are valued at the underlying net asset value of units held by the Plan at year-end. The net asset value is used as a practical expedient to estimate fair value. The net asset value is based on the fair value of the underlying investments in the fund.

Funding Policy

Contributions to the Plan may only be made by the Hospital. The contributions are paid in amounts sufficient to fund the Plan's current service cost on a current basis. The Plan has met the ERISA minimum funding requirements. In liquidation, contributions will continue to ensure the current service cost.

Payment of Benefits

Benefit payments to participants are recorded upon distribution.

Income Tax Status

The Internal Revenue Service (IRS) has determined and informed the Hospital by a letter dated January 24, 1996, that the Plan is designed in accordance with applicable sections of the Internal Revenue Code (IRC). The Plan has been amended since receiving the determination letter. However, the plan administrator believes that the Plan is designed and is currently being operated in compliance with the applicable requirements of the IRC.

Subsequent Events

Subsequent events are events or transactions that occur after the balance sheet date, but before financial statements are issued. Management has evaluated subsequent events through April 18, 2024, the date the July 28, 2023 financial statements were available for issuance.

3. Plan Termination

When the Plan terminated, the net assets of the Plan were allocated in the manner specified by the Plan and as prescribed by ERISA and its related regulations.

4. Actuarial Present Value of Accumulated Plan Benefits

Accumulated plan benefits are those future periodic payments, including lump-sum distributions that are attributable under the Plan's provisions to services rendered by the employees to the valuation date. Accumulated plan benefits include benefits expected to be paid to (a) retired or terminated employees or their beneficiaries, and (b) present employees or their beneficiaries. Benefits are accumulated based on employees' compensation during each year of credited service. Benefits payable under all circumstances (retirement, death, disability, and termination of employment) are included to the extent they are deemed attributable to employee service rendered to the valuation date. Benefit accruals ceased effective September 30, 2006.

ACTUARIAL COST METHODS

Traditional Unit Credit

The actuarial cost method used in the development of the minimum contribution was the unit credit cost method.

The normal cost is the sum of all the individual normal costs for each participant. For active participants, the individual normal cost is the present value of the benefit earned during the year being valued. For active participants whose credited service equals or exceeds the plan maximum, if any, and for non-active participants, the normal cost is zero.

The actuarial accrued liability is the sum of the individual accrued liabilities for all participants. The individual accrued liability for an active participant is the present value of the accrued benefit as of the valuation date. The unfunded liability is the actuarial accrued liability less the valuation assets.

The total annual cost of the plan is the normal cost plus an amount to amortize the shortfall amount.

Projected Unit Credit

The actuarial cost method used in the development of the maximum contribution was the projected unit credit cost method.

Under this method, the normal cost is the sum of the individual normal costs for all participants. For an active participant, the individual normal cost is the present value at the current age of the projected benefit at the assumed retirement age, based on the actuarial assumptions, divided by the participant's expected years of credited service at that age. For a non-active participant, the normal cost is zero.

The actuarial accrued liability is the sum of the individual accrued liabilities for all plan participants. For an active participant, the individual accrued liability is the product of the normal cost and the total years of credited service at the current age. For non-active participants, the individual accrued liability is the present value at the current age of future benefits. The unfunded actuarial accrued liability equals the actuarial accrued liability less the valuation assets.

Appendix A

Summary of Plan Provisions

Plan Effective Date: October 1, 1980

Eligibility Requirements: Service: One Year of Service
Age: Age 21

Plan Entry Date: The Plan was frozen effective September 30, 2006. Any Covered Employee who was a Participant on that date shall continue as a Participant hereunder. No other person shall become a Participant hereunder after that date.

Normal Retirement Date: The first day of the month coincident with or next following the later of the date on which a Participant attains age 65 or the fifth anniversary of the date his employment commenced.

Compensation: Total compensation paid for the plan year. A Participant's Average Annual Earnings means the highest average annual Earnings received for any five consecutive years during the ten consecutive years immediately preceding the date the Participant's employment terminates. In no event shall a Participant's Average Annual Earnings exceed \$100,000.

Benefit accruals ceased effective September 30, 2006.

For plan years beginning after 12/31/88, no more than \$200,000 of compensation will be considered for plan purposes. This limit of \$200,000 is subject to adjustment by the Secretary of the Treasury or his delegate.

Normal Retirement Benefit: The amount of annual pension shall be .75% times Average Annual Earnings, multiplied by the employees credited service to date of retirement not in excess of 30 years.

Benefit accruals ceased effective September 30, 2006.

Normal Form of Benefit: Life Annuity

Accrued Benefit: The amount to which a participant would be entitled under the benefit formula based upon the Average Compensation, Years of Benefit Service, and the Plan provisions in effect as of the determination date.

Plan benefits were frozen effective September 30, 2006.

Early Retirement: A participant who has attained age 55 with 10 years of service may retire and receive an early retirement benefit equal to his vested Accrued Benefit on the date of his early retirement. The amount of such benefit shall be reduced to its Actuarial Equivalent to reflect commencement prior to his Normal Retirement Date.

Death Benefit: Qualified Pre-retirement Survivor Annuity equal to 50% of the vested benefit the participant would have received if retired and elected this option.

Vesting: A Participant's vested interest in his Accrued benefit shall be at all times 100 percent.

Optional Forms of Benefits: 50% Joint and Survivor, 75% Joint and Survivor Annuity, 100% Joint and Survivor Annuity, 10-Year Certain and Life Annuity, and 5-Year Certain and Life Annuity.
