### Opinion on the August 31, 2023 Financial Statements

We have audited the accompanying financial statements of Revised Retirement Plan for the Employees of NTELOS, Inc. (the "Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), which comprise the statement of net assets in liquidation available for benefits as of August 31, 2023, and the related statement of changes in net assets in liquidation available for benefits for the period then ended, the statement of accumulated plan benefits as of June 30, 2023 and statement of changes in accumulated plan benefits for the year ended June 30, 2023, and the related notes to the financial statements.

In our opinion, the financial statements referred to above present fairly, in all material respects, the net assets in liquidation available for benefits of Revised Retirement Plan for the Employees of NTELOS, Inc. as of August 31, 2023, the changes in its net assets in liquidation available for benefits for the year then ended, the statement of accumulated plan benefits as of June 30, 2023 and statement of changes in accumulated plan benefits for the year then ended, in accordance with accounting principles generally accepted in the United States of America.

### Basis for Opinion on the August 31, 2023 Financial Statements

We conducted our audit in accordance with auditing standards generally accepted in the United States of America. Our responsibilities under those standards are further described in the Auditor's Responsibilities for the Audit of the August 31, 2023 Financial Statements section of our report. We are required to be independent of Revised Retirement Plan for the Employees of NTELOS, Inc. and to meet our other ethical responsibilities, in accordance with the relevant ethical requirements relating to our audit. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our audit opinion.

### Emphasis of Matter – Basis of Accounting

As discussed in Note 6 to the financial statements, the governing body of Revised Retirement Plan for the Employees of NTELOS, Inc. approved a plan of liquidation on December 31, 2021, and management determined liquidation is imminent. As a result, the Plan has changed its basis of accounting from the ongoing basis used in presenting the June 30, 2021 financial statements to the liquidation basis used in presenting the June 30, 2022 financial statements. Our opinion is not modified with respect to that matter.

## **Responsibilities of Management for the August 31, 2023 Financial Statements**

Management is responsible for the preparation and fair presentation of the financial statements in accordance with accounting principles generally accepted in the United States of America, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error.

In preparing the financial statements, management is required to evaluate whether there are conditions or events, considered in the aggregate, that raise substantial doubt about Revised Retirement Plan for the Employees of NTELOS, Inc.'s ability to continue as a going concern for one year after the date the financial statements are available to be issued.

Management is also responsible for maintaining a current plan instrument, including all plan amendments, administering the plan, and determining that the plan's transactions that are presented and disclosed in the financial statements are in conformity with the plan's provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.

## **Auditor's Responsibilities for the Audit of the August 31, 2023 Financial Statements**

Our objectives are to obtain reasonable assurance about whether the financial statements as a whole are free from material misstatement, whether due to fraud or error, and to issue an auditor's report that includes our opinion. **Note 1. Description of the Plan**

The following brief description of Revised Retirement Plan for the Employees of NTELOS, Inc. (the "Plan") is provided for general information purposes only. Participants should refer to the Plan agreement for more complete information.

General

The Plan is a defined benefit pension plan covering substantially all employees of NTELOS Inc. (the "Company") who were employed prior to October 1, 2003. The Plan was amended to cease benefit accruals for all participants effective December 31, 2012, the freeze date. It is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA). The assets of the Plan are held in a trust under an agreement with John Hancock Trust Services. Shentel Management Company (the "Plan Sponsor") became the Plan Sponsor upon acquisition of NTELOS, Inc. in 2016.

Pension benefits

Employees of the Company that have completed the later of one year of service (1,000 hours) or attaining the age of 21 were eligible to participate in the plan. However, as explained in Note 7, the Plan was frozen effective October 1, 2003.

Participants are 100% vested in their accumulated benefits after five years of service.

Participating employees with five or more years of service are entitled to annual pension benefits beginning at normal retirement age (65) equal to the sum of (a) plus (b), subject to certain minimums:

- a) 1.23% of their highest average monthly compensation times each year of credited service;
- b) 0.5% of their highest average monthly compensation in excess of covered compensation times each year of credited service.

Highest average monthly compensation is total compensation, including base salary, overtime pay, bonuses, extraordinary payments, pretax benefits and other allowances, averaged over a five consecutive year period of employment producing the highest average. Covered compensation consists of the average taxable wage base during the thirty-five year period ending with the last day of the calendar year in which the participant attains social security retirement age.

The Plan permits early retirement at the age of 55 if the participating employee has completed five years of credited service. Under the terms of the Plan agreement, upon retirement or termination, participants may elect to receive the value of their accumulated Plan benefits as a lump-sum distribution or in the form of an annuity. A deferred annuity is available to participants that choose early retirement between ages 55-64.

Pension benefits (Continued)

Participants may elect to receive the value of their accumulated plan benefits in the payment of either a ten-year certain and continuous, or a joint and survivor annuity of 100%, 75%, 66.67%, or 50%. If no election is filed, unmarried participants will receive a single life annuity that ceases on death, and married participants will receive a qualified joint and survivor 50% annuity.

Pre-retirement death benefits

If a participant with five years of service dies before his annuity starting date, a qualified pre-retirement survivor annuity shall be paid to the participant's surviving spouse during such spouse's lifetime. Unless the surviving spouse elects a later date, the qualified pre-retirement survivor annuity payments must begin during the month that includes what would have been the participant's early retirement date.

**Note 2. Summary of Significant Accounting Policies**

Basis of accounting

The financial statements are prepared on the accrual basis of accounting. In accordance with accounting principles generally accepted in the United States of America, the Plan changed its basis of accounting used to determine the amounts at which investments are stated, from an ongoing Plan basis to the liquidation basis for periods after June 30, 2021. See Note 6 for discussion of Plan termination.

Estimates

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires the Plan Administrator to make estimates and assumptions that affect certain reported amounts and disclosures. Accordingly, actual results may differ from those estimates.

Cash

The Plan's cash consists of unallocated cash maintained by the Trustee. These funds are not insured by the FDIC. At June 30, 2023, the Plan held unallocated cash of \$78,989.

Investments valuation and income recognition

The Plan's investments are stated at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 3 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation or depreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially impact the amounts reported in the statements of net assets available for benefits.

Actuarial present value of accumulated plan benefits

Accumulated plan benefits are those future periodic payments, including lump-sum distributions that are attributable under the Plan's provisions to the service employees have rendered. Accumulated Plan benefits include benefits expected to be paid to retired or terminated employees or their beneficiaries, beneficiaries of employees who have died, and present employees or their beneficiaries. The accumulated Plan benefits are based on their highest average compensation for five consecutive years of service. Benefits payable upon retirement, death, disability, and termination of employment are included, to the extent they are deemed attributable to employee service rendered through the date of the benefit freeze.

The actuarial present value of accumulated Plan benefits was determined by John Hancock Trust Services as of July 1, 2021, and is that amount which results from applying actuarial assumptions to adjust the accumulated Plan benefits to reflect the time value of money (through discounts for interest) and the probability of payment (by means of decrements such as for death, disability, withdrawal, or retirement) through the date of the benefit freeze. The July 1, 2021 actuarial valuation froze benefits, with the remaining accumulated Plan benefits to be paid out subsequent to the valuation date. The payouts for the period listed in the statement of accumulated Plan benefits and statement of changes in accumulated Plan benefits comprise the amounts due to participants during the period and related activity.

Payment of benefits

Benefit payments to participants are recorded upon distribution.

Administrative expenses

Plan fees and administrative expenses are paid by the Plan and Company on a discretionary basis.

Subsequent events

Subsequent events were evaluated through April 12, 2024, the date the financial statements were available to be issued.

**Note 3. Fair Value Measurements**

The Plan's mutual fund is reported at fair value in the accompanying statements of net assets available for benefits. The methods used to measure fair value may produce an amount that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with those of other market participants, the use of different methodologies or assumptions to determine fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

The fair value measurement accounting literature establishes a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. This hierarchy consists of three broad levels: Level 1 inputs consist of unadjusted quoted prices in active markets for identical assets and have the highest priority; Level 2 inputs consist of observable inputs other than quoted prices for identical assets; and Level 3 inputs consist of unobservable inputs and have the lowest priority. The Plan uses appropriate valuation techniques based on the available inputs to measure the fair value of its investments. When available, the Plan measures fair value using Level 1 inputs because they generally provide the most reliable evidence of fair value. Level 3 inputs are used only when Level 1 or Level 2 inputs were not available.

The following table sets forth by level, within the fair value hierarchy, the Plan's assets at fair value as of June 30, 2023. Classification within the fair value hierarchy table is based on the lowest level of any input that is significant to the fair value measurement.

**Note 4. Funding Policy**

Prior to Plan termination, the Plan Sponsor contributed to the Plan an amount determined by the actuary at least sufficient to maintain the Plan as a qualified employee defined benefit plan meeting the minimum funding standard requirements of ERISA. Due to Plan termination effective December 31, 2021, there were no minimum funding requirements of ERISA for the years ended June 30, 2023 and 2022.

Upon Plan termination, the Plan Sponsor's funding policy is to make cash contributions to the Plan in amounts needed to cover distributions to participants.

**Note 5. Tax Status**

The Prototype Plan obtained its latest determination letter dated February 8, 2012, in which the Internal Revenue Service stated that the Plan, as then designed, was in compliance with the applicable requirements of the *Internal Revenue Code (IRC)*. The Plan has been amended and restated since receiving the determination letter. However, the Plan Administrator believes that the Plan is designed and is currently being operated in compliance with the applicable requirements of the *IRC*.

**Note 5. Tax Status (Continued)**

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the plan and recognize a tax liability (or asset) if the plan has taken an uncertain position that more likely than not would not be sustained upon examination by the Internal Revenue Service. The Plan Administrator has analyzed the tax positions taken by the Plan, and has concluded that as of August 31, 2023, there are no uncertain positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements.

**Note 6. Plan Termination**

The board of the Plan Sponsor resolved on October 13, 2021 to terminate the Plan effective December 31, 2021. As a result, the Plan is using the liquidation basis of accounting as described in Note 2. All payments on behalf of participants and other payments required to complete the termination of the Plan were completed on August 31, 2023.

Certain benefits under the Plan are insured by the PBGC due to plan termination. Generally, the PBGC guarantees most vested normal age retirement benefits, early retirement benefits, and certain disability and survivor's pensions. However, the PBGC does not guarantee all types of benefits under the Plan, and the amount of benefit protection is subject to certain limitations. Vested benefits under the Plan are guaranteed at the level in effect on the date of the Plan's termination. However, there is a statutory ceiling, which is adjusted periodically, on the amount of an individual's monthly benefit that the PBGC guarantees. For Plan terminations occurring during 2023, the ceiling is \$6,750 per month. That ceiling applies to those pensioners who elect to receive their benefits in the form of a single-life annuity and are at least 65 years old at the time of retirement or Plan termination (whichever comes later). For younger annuitants or for those who elect to receive their benefits in some form more valuable than a single-life annuity, the corresponding ceilings are actuarially adjusted downward.

**Note 7. Other Matters**

The Plan was closed to new participants for employees hired after October 1, 2003. Benefits in the Plan were frozen effective December 31, 2012, with no benefits accruing thereafter. Final Average Compensation, Covered Compensation, and Credited Service after December 31, 2012 will not be taken into account for purposes of determining benefits under the Plan. Credited Service after December 31, 2012 was considered for vesting purposes. No new employees shall become participants in the Plan on or after October 1, 2003.

**Note 8. Risks and Uncertainties**

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

Plan contributions are made and the actuarial present value of accumulated plan benefits are reported based on certain assumptions pertaining to interest rates, inflation rates, and employee demographics, all of which are subject to change. Due to uncertainties inherent in the estimation and assumption process, it is at least reasonably possible that changes in these estimates and assumptions in the near-term could be material to the financial statements.
