Management is also responsible for maintaining a current plan instrument, including all plan amendments; administering the plan; and determining that the plan's transactions that are presented and disclosed in the financial statements are in conformity with the plan's provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.

### **Auditor's Responsibilities for the Audit of the Financial Statements**

Our objectives are to obtain reasonable assurance about whether the financial statements as a whole are free from material misstatement, whether due to fraud or error, and to issue an auditor's report that includes our opinion. Reasonable assurance is a high level of assurance but is not absolute assurance and therefore is not a guarantee that an audit conducted in accordance with generally accepted auditing standards will always detect a material misstatement when it exists. The risk of not detecting a material misstatement resulting from fraud is higher than for one resulting from error, as fraud may involve collusion, forgery, intentional omissions, misrepresentations, or the override of internal control. Misstatements are considered material if there is a substantial likelihood that, individually or in the aggregate, they would influence the judgement made by a reasonable user based on the financial statements.

In performing an audit in accordance with generally accepting auditing standards, we:

- Exercise professional judgment and maintain professional skepticism throughout the audit.
- Identify and assess the risks of material misstatement of the financial statements, whether due to fraud or error, and design and perform audit procedures responsive to those risks. Such procedures include examining, on a test basis, evidence regarding the amounts and disclosures in the financial statements.
- Obtain an understanding of internal control relevant to the audit in order to design audit procedures that are appropriate in the circumstances, but not for the purpose of expressing an opinion on the effectiveness of Monroe Tractor & Implement Co., Inc. Employee Stock Ownership Plan's internal control. Accordingly, no such opinion is expressed.
- Evaluate the appropriateness of accounting policies used and the reasonableness of significant accounting estimates made by management, as well as evaluate the overall presentation of the financial statements.

**Note 1. Description of Plan**

General

Monroe Tractor & Implement Co., Inc. (the Company) established the Monroe Tractor & Implement Co., Inc. Employee Stock Ownership Plan (Plan) effective as of November 5, 1990. As of January 1, 1997, the Plan was amended and operates as an Employee Stock Ownership Plan (ESOP), and is designed to comply with Section 4975 (e)(7) and the regulations there under, of the Internal Revenue Code of 1986, as amended (code) and is subject to the applicable provisions of the Employee Retirement Income Security Act of 1974, as amended (ERISA). A retirement committee appointed by the Company's Board of Directors administers the Plan. Janet Felosky, Christian Felosky and Laura Wilkas are the Plan Trustees.

The Plan was amended to cease new entrants in to the plan effective December 31, 2021 and to terminate as of December 31, 2021. The termination caused benefit accruals to cease and the accrued benefits of all participants to become 100% vested as of December 31, 2021. The Plan applied for and received determination letter from the IRS dated March 2, 2023 approving the plan to liquidate. The liquidation distributions commenced in July 2022 with the final distributions completed in July 2023.

Prior to the effective date of termination, employees of the Company are generally eligible to participate in the Plan after one year of service providing they worked at least 1,000 hours during such Plan year. Participants who do not have at least 1,000 hours of service during such Plan year, or are not employed on the last working day of a Plan year, are generally not eligible for an allocation of Company contributions for such year.

Prior to the effective date of termination, no distribution from the Plan will be made until a participant retires, dies, or otherwise terminates employment with the Company except in service diversifications for employees over age 55.

Prior to the effective date of termination, all benefits paid under the Plan after January 1, 1994 will be paid in cash. Participant benefits will be paid in substantially equal amounts over a period of five years. Participants with benefits in excess of \$985,000 will receive payment of their benefits over a period of five years plus one additional year for each \$195,000 or fraction of \$195,000 by which participant's benefit exceeds \$985,000. The Trustees may accelerate these payment at their discretion, based on the liquidity needs of the Company and the Plan.

If participant's total Plan benefit is \$5,000 or less, participant will receive one lump sum payment as soon as practical after the end of the Plan year in which participant terminates.

Prior to the effective date of termination, if the value of Company securities constitutes more than ten percent of the assets of the Plan, participant will be entitled to vote the shares allocated to their account with respect to any merger or consolidation, recapitalization, reclassification, liquidation, dissolution, or sale of substantially all assets that must be approved by the shareholders of the Company. With respect to these matters, the Trustees will vote any shares that are not voted by participants. On all other matters requiring a vote of the shareholders, the Trustees will direct the vote of any shares held by the Plan.

**Note 1. Description of Plan (continued)**

Prior to the effective date of termination, the Company had the right to terminate the Plan at any time, subject to Plan provisions. Upon such termination of the Plan, the interest of each participant in the Plan will be distributed to such participant or his or her beneficiary at the time prescribed by the Plan terms and the Code. Upon termination of the Plan, all participants will automatically become fully vested in their account balances.

Contributions

The Company may make contributions to the Plan at the discretion of the Board of Directors. No participant contributions are allowed.

Participant Accounts

Employer contributions are allocated to each participant based on the ratio to which the participant's compensation bears to the compensation of all eligible participants.

Vesting

Prior to the effective date of plan termination, vesting in the Company's contributions, plus actual earnings thereon, is fully vested once they have completed three years of service. Regardless of the number of years of service a participant may have, they become fully vested upon reaching normal retirement age or terminating employment due to disability or death. Participants have the right to designate a beneficiary to receive benefits should they die.

Forfeitures

Forfeitures for terminated, non-vested participant accounts will be allocated to the participants' accounts in the same manner as employer contributions.

Participant Loans

No borrowing from this plan is permitted.

Diversification

Diversification is offered to participants close to retirement so that they may have the opportunity to move part of the value of their investment in Company Common Stock into investments which are more diversified. Participants who are at least 55 with at least 10 years of participation in the Plan may elect to diversify a portion of their account. Diversification is offered to each eligible participant over a 6-year period. In each of the first 5 years, a participant may diversify up to 25 percent of the number of shares allocated to his or her account, less any shares previously diversified. In the sixth year, the percentage changes to 50 percent. Participants electing to diversify must transfer the value to the Monroe Tractor & Implement Co., Inc 401(k) Plan.

**Note 2. Summary of Significant Accounting Policies**

Basis of Accounting

The plan's transactions are reported on the liquidation basis of accounting in accordance with U.S. generally accepted accounting principles.

Use of Estimates

The preparation of financial statements in conformity with U.S. generally accepted accounting principles requires the Plan Administrator to make estimates and assumptions that affect certain reported amounts and disclosures. Accordingly, actual results may differ from those estimates.

Investment Valuation and Income Recognition

The Plan's investments are stated at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date.

Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date.

Purchases and sales of securities are recorded on a trade-date basis. Realized gains and losses from security transactions are reported on the average cost method.

Payment of Benefits

Benefits are recorded when paid.

Operating Expenses

The employer absorbs all significant costs of the Plan without reimbursements from the Plan.

Concentration of Credit Risk

The Plan maintains its cash in bank deposit and money market accounts, which, at times, may exceed federally insured limits. The Plan has not experienced any losses in such accounts. The Plan believes it is not exposed to any significant credit risk on cash and cash equivalents.

Cash and Cash Equivalents

The Plan considers all highly liquid debt instruments purchased with a maturity of 3 months or less and money market accounts to be cash equivalents.

Events Occurring After Reporting Date

Management has evaluated subsequent events through April 25, 2024, the date which the financial statements were available to be issued.

**Note 5. Tax Status**

The Internal Revenue Service has determined and informed the Company by a letter dated March 2, 2023, that the Plan is qualified and the Trust established under the Plan is tax-exempt, under the appropriate sections of the Code. The Sponsor believes the Plan is being operated in compliance with the applicable requirements of the IRC and, therefore, believes the Plan is qualified and the related trust is tax-exempt.

**Note 5. Tax Status** (continued)

GAAP requires Plan management to evaluate tax positions taken by the Plan and recognize a tax liability or asset if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS or the Department of Labor. The IRS has conducted an audit of the plan through the year ending December 31, 2014 and concluded no adjustments are required for the Plan's filings. Sponsor has analyzed the tax positions taken by the Plan, and has concluded that as of July 31, 2023 there are no uncertain positions taken or expected to be taken that would require recognition of a liability or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress. The Plan administrator believes it is no longer subject to tax examinations for the years prior to 2021. Furthermore, there are no tax related interest or penalties included in the financial statements presented.

**Note 6. Administration of Plan Assets**

Prior to the effective date of termination, the Plan's assets, consisted principally of sponsor Company common shares, held by the Trustees of the Plan.

Company contributions are held and managed by the Trustees, which invest cash received, interest, and dividend income and make distributions to participants.

Certain administrative functions are performed by officers or employees of the Company. No such officer or employee receives compensation from the Plan. Prior to the effective date of termination, administrative expenses were paid directly by the Company. Administration expenses during the liquidation period will be paid by the Plan.

**Note 7. Related Party and Party In Interest Transactions**

The Trustees of the Plan are officers of the Company. These are related party and party-in-interest transactions. The Plan has a number of service providers. Such parties are parties-in-interest under ERISA.

**Note 8. Plan Termination**

On December 30, 2021 the board of directors of Monroe Tractor & Implement Co., Inc. (plan sponsor) adopted a resolution to terminate the Plan effective December 31, 2021 and Plan management determined liquidation is imminent. Final distributions will be determined based on all participants being 100% vested, and commenced in plan year 2022. Under the termination plan, 85% of the participants account balance was paid in July 2022 with the remaining balances were distributed in July 2023 after receiving regulatory approval from the Internal Revenue Service (IRS) in March 2023. As a result, the Plan is presenting the 2021, 2022 and 2023 financial statements on the liquidation basis of accounting.
