Independent Auditors' Report

To the Trustees of the

Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed the audits of the financial statements of UniFocus, LP Retirement Savings Plan (the "Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statement of net assets available for benefits as of January 31, 2023, and December 31, 2022, and the related statement of changes in net assets available for benefits for the period from January 1, 2023 to January 31, 2023, and the related notes to financial statements.

1. DESCRIPTION OF PLAN

The following description of the UniFocus, LP Retirement Savings Plan (the Plan) provides only general information. The Plan is sponsored by UniFocus Texas, LP (the Plan Sponsor). Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

General

The Plan is a defined contribution plan, established on February 1, 2002, as amended from time to time, covering substantially all employees of the Plan Sponsor, except union employees and employees who are not U.S. citizens. Employees are eligible to participate on the first day of the Plan month following the completion of one month of service. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA), as well as all provisions of the federal income tax laws.

The Trustees of the Plan are responsible for oversight of the Plan. The Plan Administrator determines the appropriateness of the Plan's investment offerings, monitors investment performance and reports to the Trustees of the Plan.

On January 31, 2023, the Plan merged with another plan and transferred all of the Plan's assets and participants' account balances, totaling \$6,553,352, to the new plan's custodian.

Contributions

Each year, participants may make tax-deferred contributions to the Plan not to exceed the amount deductible for federal income tax purposes. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans (rollover). Participants direct the investment of their contributions into various investment options offered by the Plan.

The Plan Sponsor may contribute to the Plan by making discretionary matching contributions, on a uniform basis to all participants, which will not exceed 2% of a participant's compensation. During the period from January 1, 2023 to January 31, 2023, the Plan Sponsor made a discretionary matching contribution of \$10,237. Contributions are subject to Internal Revenue Service (IRS) limitations.

Participant Accounts

Each participant's account is credited with the participant's tax-deferred contributions and employer contributions (if any), as well as allocations of the Plan Sponsor's profit-sharing contributions (if any) and Plan earnings. Participant accounts are charged with an allocation of administrative expenses that are paid by the Plan. Allocations are based on participant earnings, account balances, or specific participant transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

1. DESCRIPTION OF PLAN (continued)

Vesting

Participants are immediately vested in their deferred salary contributions, rollover contributions from other plans and actual earnings thereon. Vesting in the Plan Sponsor's matching contributions and profit-sharing contributions (if any) of their accounts plus actual earnings thereon is based on years of continuous service. A participant is 100% vested upon retirement, permanent disability, death or reaching age 65 while employed by the Plan Sponsor. If a participant separates from the employment of the Plan Sponsor for any other reason, vesting in the Plan Sponsor's profit-sharing discretionary contributions (if any) of their accounts plus actual earnings thereon is based upon the following schedule:

Notes Receivable from Participants

Participants may borrow against their vested account balances a minimum of \$1,000 up to a maximum amount equal to the lesser of 50% of their vested balance or \$50,000. The loans, in the form of promissory notes (Note 2), are secured by the balances in the participants' account, and bear interest at the prime rate of interest plus 2%. One loan per participant may be outstanding at any one time. Principal and interest on notes receivable from participants are repaid through payroll deductions.

Payment of Benefits

Distributions from the Plan will be made in a single lump-sum payment; or if an in-service distribution, may be received in partial distributions. If a participant's vested benefit in the Plan exceeds \$5,000, the participant must consent to the distribution before it may be made. If the participant's vested interest does not exceed \$5,000, then the participant's benefit will be distributed in a lump-sum payment as soon as practicable following the event that led to the participant being entitled to a distribution.

Forfeited Accounts

At January 31, 2023 and December 31, 2022, forfeited non-vested accounts totaled \$0 and \$38, respectively. These accounts will be used to first pay administrative expenses and then to reduce the employer's profit sharing and matching contributions to the Plan. During the period from January 1, 2023 to January 31, 2023, forfeitures of \$38 were used to reduce employer contributions.

2. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Basis of Accounting

The Plan's financial statements are prepared using the accrual method of accounting.

Use of Estimates

The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America requires the Plan's management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities at the date of the financial statements. Actual results could differ from those estimates.

Investment Valuation and Income Recognition

The Plan's investments are stated at fair value, except for the Plan's only fully benefit-responsive investment contract, which is reported at contract value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan's Administrator determines the Plan's valuation policies utilizing information provided by the custodian and insurance company. See Note 3 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation (depreciation) includes the gains and losses on the Plan's investments bought and sold as well as those held during the year.

Notes Receivable from Participants

Notes receivable from participants (Note 1) are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are earned. No allowance for credit losses has been recorded as of January 31, 2023 and December 31, 2022. Delinquent notes receivable from participants are reclassified as distributions based upon the terms of the Plan document.

Payment of Benefits

Benefits are recorded when paid.

Expenses

Certain expenses of maintaining the Plan are paid by the Plan, unless otherwise paid by the Plan Sponsor. Expenses that are paid by the Plan Sponsor are excluded from these financial statements. Fees related to the administration of notes receivable from participants are charged directly to the participant's account and are included in administrative expenses. Investment related expenses are included in net appreciation of fair value of investments.

During the period from January 1, 2023 to January 31, 2023, the Plan incurred administrative fees of \$4,950. These charges are reflected in the accompanying statement of changes in net assets available for benefits.

Recent Accounting Pronouncements

During the period from January 1, 2023 to January 31, 2023 and through April 29, 2024, there were no new accounting pronouncements issued by the Financial Accounting Standards Board that will need to be adopted.

Subsequent Events

In preparing the financial statements, the Plan's management has reviewed, as determined necessary by the Plan's management, events that have occurred after January 31, 2023, up until the issuance of the financial statements, which occurred on April 29, 2024.

3. FAIR VALUE MEASUREMENTS

Accounting Standards Codification (ASC) Topic 820, *Fair Value Measurement*, establishes a framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements).

The three levels of the fair value hierarchy under ASC Topic 820 are described as follows:

- Level 1 Valuations based on unadjusted quoted prices in active markets that are accessible at the measurement date for identical, unrestricted assets or liabilities;
- Level 2 Valuations based on quoted prices in markets that are not active, or financial instruments for which all significant inputs are observable; either directly or indirectly; and
- Level 3 Valuations based on prices or valuation techniques that require inputs that are both significant to the fair value measurement and unobservable; thus, reflecting assumptions about the market participants.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at January 31, 2023 and December 31, 2022.

Level 1 Fair Value Measurements

Mutual funds: Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the U.S. Securities and Exchange Commission. These funds are required to publish their daily net asset value and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

Investments Measured at Net Asset Value

Common/Collective trust: Valued at the net asset value (NAV) of units of a bank collective trust. The NAV, as provided by the trustee, is used as a practical expedient to estimate fair value. The NAV is based on the fair value of the underlying investments held by the fund less its liabilities.

The following tables set forth by level, within the fair value hierarchy, the Plan's assets at fair value as of January 31, 2023 and December 31, 2022. Classification within the fair value hierarchy table is based on the lowest level of any input that is significant to the fair value measurement.

4. RELATED-PARTY TRANSACTIONS AND PARTY-IN-INTEREST TRANSACTIONS

Nova 401(k) Associates, Inc. is the Plan's third-party administrator during the period from January 1, 2023 to January 31, 2023 and therefore any transactions with the Plan qualify as party-in-interest transactions.

The Plan Sponsor's Employee Benefits Administrator has a note receivable outstanding of \$0 and \$19,794 at January 31, 2023 and December 31, 2022, respectively. The note receivable was secured by the balances in the participants' accounts and bear interest at a market rate.

Principal, the Plan's custodian and recordkeeper, provides certain administrative services to the Plan pursuant to a contract between the Plan Sponsor and Principal. Principal receives revenue from mutual fund service providers for services it provides to the funds. This revenue is used to offset certain amounts owed to Principal for its administrative services to the Plan.

5. PLAN TERMINATION

The Plan Sponsor has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of plan termination, participants will immediately become 100% vested in their employer contributions.

6. REPORTABLE TRANSACTIONS

There were no reportable transactions or uncollectible, non-exempt transactions with parties-in-interest or any other prohibited transactions which would require supplemental disclosure under Department of Labor rules and regulations, except for the reportable transactions disclosed below:

We identified two operational failures that affects the Plan: 1) During the period from January 1, 2023 to January 31, 2023 the Plan improperly included commissions in the calculation of participant compensation eligible for the employee and employer deferral amounts. This resulted in an overpayment of an employer contribution for one employee in the amount of \$7. 2) During the period from January 1, 2023 to January 31, 2023, the Plan improperly calculated the employer match for one participant. This resulted in an underpayment of employer contributions to one employee in the amount of \$83.

A Schedule of Delinquent Participant Contributions has been included to reflect the late contributions and loan payments that have been corrected or not been corrected as of January 31, 2023.

The Plan Administrator believes that the aforementioned corrections will not adversely affect the Plan's qualified tax status.

7. TAX STATUS

The Plan, as originally drafted, is a Volume Submitter Profit Sharing Plan with Cash or Deferred Arrangement. The IRS has determined and informed the Plan Sponsor of the prototype plan by a letter dated June 30, 2020, that the Plan is designed in accordance with the applicable sections of the IRC.

However, a determination letter from the IRS has not yet been requested by the Plan Sponsor to determine if the Plan as amended was designed in accordance with applicable sections of the IRC. The Plan Administrator believes the Plan is being operated in compliance with the applicable requirements of the IRC and ERISA and, therefore, believes that the Plan is qualified, and the related trust is tax-exempt.

Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

8. RECONCILIATION OF THE FINANCIAL STATEMENTS TO THE FORM 5500

9. RISKS AND UNCERTAINTIES

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such change could materially affect the amounts reported in the statements of net assets available for benefits.

It is not possible at this time to reasonably estimate the possible loss or range of loss, if any. The Plan further cautions that it is not possible to list such factors, and one should not consider the identified factors as a complete list of all risks and uncertainties.

10. INFORMATION PREPARED AND CERTIFIED BY CUSTODIAN (UNAUDITED)

For the period from January 1, 2023 to January 31, 2023 and for the year ended December 31, 2022, the Plan Administrator has elected the method of compliance permitted by 29 CFR 2520.103-8 of the DOL Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, as permitted under such election, the Plan Administrator instructed the auditors to not perform any auditing procedures with respect to the information certified by the custodian of the Plan in 2023 and 2022, except for comparing such information with the related information included in the accompanying financial statements and supplemental schedule.
