NOTE 1 - DESCRIPTION OF PLAN

The following description of the Sungard Availability Services U.S. Savings Plan (the “Plan”) provides only general information. Participants should refer to the Plan document for a more detailed and complete description of the Plan’s provisions.

The Plan was a defined contribution plan established on April 1, 2014. Effective January 1, 2022, the Plan was amended and restated.

Sungard Availability Services LP (the “Plan Sponsor” or “Company”) filed for Chapter 11 restructuring on April 11, 2022. Pursuant to the restructuring plan under the Chapter 11 case, the Plan Sponsor entered several assets purchase agreements to sell substantially all of the assets and operations of the Company in several separate transactions. Effective December 31, 2022, the Plan Sponsor approved a plan of termination, contributions into the Plan were suspended, and all assets were distributed by November 2023. As a result, the Plan has changed its basis of accounting from the ongoing basis to the liquidation basis used in presenting the November 29, 2023 and December 31, 2022 financial statements, respectively. As of November 29, 2023, there were no assets left in the Plan.

The Company established and maintained the Plan for the benefit of its eligible employees and the eligible employees of any affiliate of the Company that elects to adopt the Plan as a participating employer. Prior to the termination of the Plan, an employee of the Company or participating employer was an eligible employee if they were employed by the Company or participating employer and was not any of the following: (1) an intern or special project employee; (2) an individual classified by the Company or participating employer as an “independent contractor” or a “leased employee”, (3) a member of a collective bargaining unit that negotiates with the Company or participating employer directly or indirectly regarding the issue of retirement benefits (unless the collective bargaining agreement requires that the employee be included as a participant in the Plan); or (4) a non-resident alien with no U.S. source of income from the employer.

Prior to the termination of the Plan, an employee’s participation in the Plan became effective on their employment commencement date, provided they were an eligible employee at that time. However, if an employee previously was a participant in the Plan, and ceased to be a participant due to a separation from service or a transfer to a group of employees not eligible to participate in the Plan, the employee’s participation resumed effective as of the date on which the employee again becomes an eligible employee.

The Benefit Plan Committee of the Company is the Plan Administrator and is responsible for the oversight of the Plan. Vanguard Fiduciary Trust Company (“VFTC”) is the Plan Trustee. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (“ERISA”), as amended.

CONTRIBUTIONS

Effective December 31, 2022, the Plan was amended to freeze and terminate the Plan. In conjunction with this amendment, contributions into the Plan were no longer permitted.

PARTICIPANTS' ACCOUNTS

Each participant's account is credited with Plan earnings and, prior to the termination, the participant's contribution and the Company's matching contributions as well as allocations of the Company profit sharing contributions, if any. Participant accounts are charged with an allocation of administrative expenses that are paid by the Plan. Allocations are based on participant earnings, deferrals or account balances. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

INVESTMENT OPTIONS

Prior to the termination, participants had the option to direct the investment of their contributions to the Plan into various investments offered by the Plan. Investment options included mutual funds, a common collective trust and self-directed brokerage funds.

VESTING

All participant contributions and the related plan earnings were one hundred percent (100%) vested and nonforfeitable. Company contributions and the related plan earnings were one hundred percent (100%) vested upon the earlier of completion of one year of employment, attainment of normal retirement age of 65, death, or total disability of the participant. As a result of the Plan termination, all affected participants became fully vested in their accounts.

CORONAVIRUS AID, RELIEF, AND ECONOMIC SECURITY ACT

On March 27, 2020, Congress passed the Coronavirus Aid, Relief, and Economic Security Act ("CARES Act") which included several relief provisions to tax qualified plans and their participants that were put into operation by the Plan at that time. Formal adoption of such provisions of the CARES Act provisions was amended into the Plan effective December 31, 2022.

NOTES RECEIVABLE FROM PARTICIPANTS

Prior to the Plan termination, participants could borrow from their fund accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balance. Participants were allowed a maximum of one loan at a time. The loans were secured by the balance in the participant's account. Loan repayment terms could not exceed five years, except for the purchase of a principal residence where the loan was due within a period not to exceed 15 years. Loans bore an interest rate of equal to the prime rate, plus one percentage point (interest rates ranged from 3.25% to 7.50% per annum at December 31, 2022). Principal and interest were paid ratably through payroll deductions. All loans were either repaid directly by the participant or deemed distributed during the period January 1, 2023 through November 29, 2023 as part of the Plan termination.

PAYMENT OF BENEFITS

Participants received the full amount of their vested account balances in the event of normal retirement, termination of service, death or disability. Early withdrawals are permitted at the participants requests after the age of 59½. Certain hardship withdrawals are also permitted. Distributions will be made in lump-sum payments or installments as designated by the participant.

NOTE 2 - SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

FORFEITED ACCOUNTS

Forfeitures of unvested Company contributions may be used to reduce the Company's contributions to the Plan, or to pay expenses. The forfeiture account balance totaled \$-0- and \$70,647 as of November 29, 2023 and December 31, 2022, respectively. During 2023, the Plan utilized \$103,282 in forfeitures to pay Plan expenses.

BASIS OF ACCOUNTING

The Plan's financial statements are prepared in conformity with accounting principles generally accepted in the United States of America ("GAAP").

NOTE 2 - SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES (CONTINUED)

USE OF ESTIMATES

The Plan Administrator uses estimates and assumptions in preparing financial statements. Those estimates and assumptions affect the reported amounts of assets, reported changes in net assets available for benefits and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

INVESTMENT VALUATION AND INCOME RECOGNITION

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Benefit Plan Committee determines the Plan's valuation policies utilizing information provided by the investment advisors and the Plan Trustee. See Note 3 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net depreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

NOTES RECEIVABLE FROM PARTICIPANTS

Notes receivable from participants were measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income was recorded on the accrual basis. Related fees were recorded as administrative expenses and are expensed when they are incurred. No allowance for credit losses has been recorded as of November 29, 2023 and December 31, 2022, respectively.

PAYMENT OF BENEFITS

Benefits are recorded when paid.

ADMINISTRATIVE EXPENSES

Certain expenses of maintaining the Plan were paid by the Plan, unless otherwise paid by the Company. Expenses that were paid by the Company were excluded from these financial statements. Fees related to the administration of notes receivable from participants and payment of benefits were charged directly to the participant's account and were included in administrative expenses. Investment related expenses are included in net appreciation in fair value of investments.

SUBSEQUENT EVENTS

These financial statements were approved by management and available for issuance on April 3 2024. Management has evaluated subsequent events through this date. There were no events requiring recognition or disclosure in the financial statements.

NOTE 3 - FAIR VALUE MEASUREMENTS

GAAP defines fair value, provides guidance for measuring fair value and requires certain disclosures. GAAP provides for a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value into three broad levels.

The following is a brief description of those three levels:

Level 1: Observable inputs such as quoted prices (unadjusted) in active markets for identical assets or liabilities.

Level 2: Inputs other than quoted prices that are observable for the asset or liability, either directly or indirectly. These include quoted prices for similar assets or liabilities in active markets and quoted prices for identical or similar assets or liabilities in markets that are not active.

Level 3: Unobservable inputs that reflect the Company's own assumptions.

The following is a description of the valuation methodologies used for the investments measured at fair value, including the general classification of such instruments pursuant to the valuation hierarchy.

MUTUAL FUNDS

Mutual funds are valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds registered with the Securities and Exchange Commission and are required to publish their daily Net Asset Value ("NAV") and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded and are categorized as Level 1.

BROKERAGE OPTIONS

The Plan offered the Vanguard Brokerage Option, a participant directed brokerage account which allowed participants to establish a brokerage account and select various investments consisting of interest-bearing cash, mutual funds, common stocks, and corporate bonds. Interest bearing cash is valued at the carrying amounts as this approximates fair value (Level 1). Common stocks are valued at the closing price reported on the active market on which the individual securities are traded (Level 1). Corporate bonds are valued using pricing models maximizing the use of observable inputs for similar securities. This includes basing value on yields currently available on comparable securities of issuers with similar credit ratings (Level 2).

STABLE VALUE COMMON COLLECTIVE TRUST FUND

Valued at the NAV of units of the bank collective trust and composed primarily of fully benefit-responsive investment contracts. The NAV is used as a practical expedient to estimate fair value. The NAV is based on the fair value of the underlying investments held by the fund less its liabilities. This practical expedient is not used when it is determined to be probable that the fund will sell the investment for an amount different than the reported NAV. Participant transactions (purchases and sales) may occur daily.

The issuer reserves the right to require 12 months' notification of a full redemption in order to ensure that securities liquidations will be carried out in an orderly business manner. As the Plan did not provide the required 12 month notification for full redemption of this fund, a market value adjustment was charged to participants who remained invested in this fund at the end of March 2023 and this adjustment is included in the net appreciation in fair value of investments during the period January 1, 2023 through November 29, 2023.

TARGET DATE COMMON COLLECTIVE TRUST FUNDS

The Plan invested in Vanguard Target Retirement Date Funds through common collective trust funds. The fair values of the Vanguard Target Retirement Date Trusts II are reported at the NAV of the participation units owned by the Plan at year end. The NAV is used as a practical expedient to estimate fair value. The NAV is based on the fair value of the underlying investments held by the fund less its liabilities. This practical expedient is not used when it is determined to be probable that the fund will sell the investment for an amount different than the reported NAV. Participant transactions (purchases and sales) may occur daily. There are currently no redemption restrictions on these investments.

NOTE 4 - RELATED-PARTY AND PARTIES-IN-INTEREST TRANSACTIONS

The Plan invests in shares of mutual funds as well as common collective trust funds managed by an affiliate of VFTC. VFTC acts as the Plan Trustee and custodian for Plan investments. The self-directed brokerage accounts are managed by TD Ameritrade. Transactions in such investments qualify as party-in-interest transactions, which are exempt from the prohibited transaction rules. The Plan paid administrative fees related to the Plan's Third Party Administrator ("TPA") and record keeper of \$37,000 for the period January 1, 2023 through November 29, 2023. Participant loans are also considered party-in-interest transactions.

NOTE 5 - PLAN TERMINATION

The Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan, subject to the provisions of ERISA. In the event of Plan termination, participants will become 100% vested in their accounts. Any unallocated assets of the Plan will be allocated to participant accounts and distributed in such a manner as the Company may determine.

The Company terminated the Plan effective December 31, 2022. All affected participants became fully vested in their accounts. The final distribution of all Plan assets took place during the 4th quarter of 2023. As of November 29, 2023, there were no assets left in the Plan.

NOTE 6 - TAX STATUS

Effective April 13, 2018, the Plan adopted a pre-approved plan offered by The Vanguard Group. By adopting this pre-approved plan, the Plan is covered, by an opinion letter from the Internal Revenue Service (“IRS”) dated May 31, 2014, issued to The Vanguard Group, the parent company of the Plan Trustee, determining that the Plan is designed in accordance with applicable sections of the Internal Revenue Code (“IRC”) and therefore, the related trust is exempt from taxation. Although the Plan has been amended and restated since adopting the pre-approved plan, the Plan Administrator believes that the Plan is designed, and is currently being operated, in compliance with the applicable requirements of the IRC and, therefore, believes that the Plan is qualified, and the related trust is tax-exempt. The 2022 restated pre-approved plan is covered by an opinion letter dated June 30, 2020.

GAAP requires Plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. At November 29, 2023 and December 31, 2022, there were no uncertain tax positions taken or expected to be taken, and the Plan has recognized no interest or penalties related to uncertain tax positions. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods pending or in progress.

NOTE 7 - INVESTMENTS CERTIFIED BY THE PLAN TRUSTEE
