## Notes to Financial Statements

### 1. Description of Plan

The following description of the Gastroenterology Associates 401(k) Plan (the Plan) provides only general information. Participants should refer to the plan agreement for a more complete description of the Plan's provisions.

*General.* The Plan is a defined contribution plan established effective January 1, 2020, as restated January 1, 2021. The Plan covers all employees, excluding collectively bargained employees, non resident aliens and leased employees, of Gastroenterology Associates Clinical Practice PLLC (the Partnership) who have completed three months of service. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974, as amended (ERISA). The Plan Administrator is responsible for oversight of the Plan. The Plan's investment committee determines the appropriateness of the Plan's investment offerings, monitors investment performance, and reports to the Plan's Plan Administrator.

On December 15, 2022 the plan was amended to terminate the plan effective December 31, 2022, at which point the contributions to the plan ceased. During 2023 the assets of the plan were distributed by July 31, 2023, and the Plan ceased to exist as of that date. In accordance with the Plan's termination provisions, all participants of the Plan became fully vested in their account balances as of the date of the plan termination. Furthermore, the Company has adopted a plan of liquidation and determined that liquidation was imminent.

A participant is 25 percent vested after four years of credited service and continues to vest in increments of 25 percent until 100 percent vested after 4 years of credited service.

All participants became 100% vested in their account balances on December 31, 2022, as a result of the plan termination as described in Note 5.
