### Note 1: Description of the Plan

The following description of Master Magnetics, Inc. 401(k) Plan (Plan) provides only general information. Participants should refer to the Plan Document and *Summary Plan Description* for a more complete description of the Plan's provisions, which are available from the Plan Administrator.

#### **General**

The Plan is a defined-contribution plan sponsored by Master Magnetics, Inc. (Company or Employer) for the benefit of its employees who have at least 30 days of service and are age 18 or older. Collectively bargained employees, independent contractors, and reclassified employees are not eligible for the Plan. Employees become eligible for Employer contributions once 18 years old and completion of one year of service. The Principal Trust Company (Principal) serves as Plan trustee. The Plan is subject to the provisions of the *Employee Retirement Income Security Act of 1974* (ERISA).

#### **Contributions**

The Plan permits eligible employees through a salary deferral election to have the Company make annual contributions of up to the maximum allowed by law. Roth and rollover contributions are also permitted. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. The Company may also make a discretionary contribution for employees during the Plan year determined annually. The Company made no contributions in 2023 or 2022. Contributions are subject to certain limitations.

The Plan includes an automatic deferral feature whereby a participant is treated as electing to defer 4% of eligible compensation unless the participant made an affirmative election otherwise. The automatic deferral feature also provides for an annual increase of 2% in the percentage deferred and is ultimately capped at 10%.

#### **Participant Investment Account Options**

Investment account options available include various funds. Each participant has the option of directing his/her contributions into any of the separate investment accounts and may change the allocation at any time.

#### **Participant Accounts**

Each participant's account is credited with the participant's contribution, the Company's contribution and Plan earnings. Allocations are based on participant earnings or account balances, as defined. The benefits to which a participant is entitled is the benefit that can be provided from the participant's vested account.

### ***Vesting***

Participants are always 100% vested in their entire account balance, which includes participant and Company contributions and earnings thereon. Discretionary Company contributions vest according to the following schedule based on years of credited service:

Less than 2	0%
2	20%
3	40%
4	60%
5	80%
6 or more	100%

Participants terminating due to death, disability or normal retirement age, age 65, become 100% vested in their account.

### ***Payment of Benefits***

Upon termination of service, a participant may elect to receive either a lump-sum amount equal to the value of his/her account upon retirement, termination of employment, death or disability. Rollover distributions into another qualified plan are permitted. In-service withdrawals are allowed under certain circumstances provided by the Plan Document.

### ***Notes Receivable From Participants***

Prior to July 1, 2018, the Plan Document included provisions authorizing loans from the Plan to active eligible participants. Loans were made to any eligible participant demonstrating a qualifying need. The minimum amount of a loan could be \$1,000. The maximum amount of a participant's loans were determined by the available loan balance restricted to the lesser of \$50,000 or 50% of the participant's vested account balance. All loans were covered by demand notes and were repayable over a period not to exceed five years (except for loans for the purchase of a principal residence) through payroll withholdings unless the participant was paying the loan in full. Interest on the loans was based on local prevailing rates as determined by the Plan Administrator.

### ***Plan Termination***

Although it has not expressed an intention to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan, subject to the provisions of ERISA. In the event of Plan termination, participants would become 100% vested in their employer contributions.

### Note 2: Summary of Significant Accounting Policies

#### ***Basis of Accounting***

The accompanying financial statements are prepared on the accrual basis of accounting.

#### ***Use of Estimates***

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of net assets and changes in net assets and disclosure of contingent assets and liabilities at the date of the financial statements. Actual results could differ from those estimates.

#### ***Investment Valuation and Income Recognition***

Investments are reported at fair value. Quoted market prices, if available, are used to value investments. Mutual funds are valued at the net asset value (NAV) of shares held by the Plan at year end.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation (depreciation) includes the Plan's gains and losses on investments bought and sold as well as held during the year.

#### ***Plan Tax Status***

Effective February 17, 2022, the Plan operates under a non-standardized adoption agreement in connection with a prototype profit-sharing plan and trust/custodial document sponsored by Principal Life Insurance Company. Prior to February 17, 2022, the Plan operated under a volume submitter adoption agreement in connection with a prototype profit-sharing plan and trust/custodial document sponsored by Principal Life Insurance Company. The Plan has not submitted to the Internal Revenue Service (IRS) for an individual determination letter as the prototype documents have received a favorable opinion letter from the IRS. The Plan Administrator believes that the Plan is currently designed and being operated in compliance with the applicable requirements of the Internal Revenue Code and that the Plan was qualified and the related trust was tax-exempt as of the financial statement date.

#### ***Notes Receivable From Participants***

Notes receivable from participants are reported at their unpaid principal balance plus any accrued but unpaid interest. Delinquent participant loans are reclassified as distributions based upon the terms of the Plan Document.

#### ***Payment of Benefits***

Benefit payments to participants are recorded upon distribution.

#### ***Forfeited Accounts***

At June 30, 2023 and 2022, forfeited nonvested accounts totaled \$1,016 and \$0, respectively. These accounts will be used to reduce future employer contributions or pay Plan expenses.

#### ***Administrative Expenses***

Administrative expenses may be paid by the Company or the Plan, at the Company's discretion.

#### **Note 3: Certification of Plan Trustee**

The Plan Administrator has elected the method of annual reporting compliance permitted by ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, Principal, a qualified institution, has certified the following investment information included in the accompanying financial statements and ERISA-required supplemental schedule is complete and accurate:

- Investments as shown in the statements of net assets available for benefits as of June 30, 2023 and 2022
- Investment income (loss) as shown in the statements of changes in net assets available for benefits for the years ended June 30, 2023 and 2022
- Investment information included in the accompanying schedule of assets (held at year end) as of June 30, 2023

The Plan's independent auditors did not perform auditing procedures with respect to this certified investment information, except for comparing such certified investment information to the related investment information included in the financial statements and ERISA-required supplemental schedule.

### Note 4: Disclosures About Fair Value of Plan Assets

Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. Fair value measurements must maximize the use of observable inputs and minimize the use of unobservable inputs. There is a hierarchy of three levels of inputs that may be used to measure fair value:

- Level 1** Quoted prices in active markets for identical assets or liabilities
- Level 2** Observable inputs other than Level 1 prices, such as quoted prices for similar assets or liabilities; quoted prices in markets that are not active; or other inputs that are observable or can be corroborated by observable market data for substantially the full term of the assets or liabilities
- Level 3** Unobservable inputs supported by little or no market activity and are significant to the fair value of the assets or liabilities

#### Recurring Measurements

### ***Investments***

Where quoted market prices are available in an active market, securities are classified within Level 1 of the valuation hierarchy. If quoted market prices are not available, then fair values are estimated by using quoted prices of securities with similar characteristics or independent asset pricing services and pricing models, the inputs of which are market-based or independently sourced market parameters, including, but not limited to, yield curves, interest rates, volatilities, prepayments, defaults, cumulative loss projections and cash flows. Such securities are classified in Level 2 of the valuation hierarchy. In certain cases where Level 1 or Level 2 inputs are not available, securities are classified within Level 3 of the hierarchy. There are no Level 2 or Level 3 securities held by the Plan.

### **Note 5: Party-in-Interest Transactions**

Party-in-interest transactions include those with fiduciaries or employees of the Plan, any person who provides services to the Plan, an employer whose employees are covered by the Plan, an employee organization whose members are covered by the Plan, a person who owns 50 percent or more of such an employer or employee association or relatives of such persons.

The Plan paid \$22,337 and \$25,011 of fees to Principal Life Insurance Company during 2023 and 2022. The Company provides certain administrative services at no cost to the Plan.

The Plan maintains an ERISA Budget account separate from the Plan. \$12,000 of credits to this account were used to pay investment advisory fees to Castle Rock Investments during 2023 and 2022. There were no unused credits as of June 30, 2023 and 2022.

### **Note 6: Risks and Uncertainties**

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect the participants' account balances and the amounts reported in the statements of net assets available for benefits.

### **Note 7: Subsequent Events**

Subsequent events have been evaluated through March 12, 2024, which is the date the financial statements were available to be issued.
