## **Independent Auditors' Report**

### **Report on the Financial Statements**

### **Basis for Disclaimer of Opinion**

As permitted by 29 CFR 2520.103-8 of the Department of Labor's ("DOL") Rules and Regulations for Reporting and Disclosure under the Employee Retirement Income Security Act of 1974, the plan administrator instructed us not to perform, and we did not perform, any auditing procedures with respect to the information summarized in Note 3, which was certified by Ascensus as agent for Ascensus Trust Company, the trustee of the plan, except for comparing the information with the related information included in the financial statements. We have been informed by the plan administrator that the trustee holds the plan's investment assets and executes investment transactions. The plan administrator has obtained a certification from the trustee as of October 14, 2020 and for the period between January 1, 2020 and October 14, 2020, that the information provided to the plan administrator by the trustee is complete and accurate.

### **Disclaimer of Opinion**

Because of the significance of the matter described in the Basis for Disclaimer of Opinion paragraph, we have not been able to obtain sufficient, appropriate audit evidence to provide a basis for an audit opinion. Accordingly, we do not express an opinion on the 2020 financial statements.

As a result, the plan has changed its basis of accounting from the going concern basis used in presenting the December 31, 2019 financial statements to the liquidation basis used in presenting the 2020 financial statements. Our opinion is not modified with respect to that matter.

**Note 1 - DESCRIPTION OF PLAN**

The following description of the Yesler, Inc. 401(k) Plan (the "plan") provides only general information. Participants should refer to the plan document or Summary Plan Description for a more complete description of the plan's provisions, which are available from the plan administrator.

The plan sponsor has the right under the plan to discontinue its contributions at any time and to terminate the plan subject to the provisions set forth in ERISA. Effective April 1, 2020 the company resolved to terminate the plan as a result of a sale of the plan sponsor's business. The resolution specified that all participants under the plan shall become 100% vested in all accounts and all accounts should be distributed to participants as soon as administratively feasible. Liquidation of assets through distributions to participants with account balances began in 2020, with full liquidation occurring as of October 14, 2020.

**GENERAL**

The plan is a defined contribution plan sponsored by Yesler, Inc. (the "company") for the benefit of all of its employees who are age twenty-one or older. The plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 ("ERISA").

**CONTRIBUTIONS**

Participants may contribute up to 80% or the annual dollar limitation defined by the Internal Revenue Code, of annual compensation as pre-tax or Roth contributions, as defined in the plan. Participants may also contribute amounts representing rollover distributions from other qualified plans. Additionally, participants age 50 or older, who are making contributions to the plan, are allowed to make catch-up contributions as defined in the plan.

The company may make matching contributions. The matching contributions are limited to 50% of employee contributions with a maximum of up to 2% of the participant's compensation. The company may also make a discretionary profit sharing contribution. Participants must have completed three months of service to be eligible for the matching and profit sharing contributions. The company made discretionary matching contributions of \$136,096 and \$485,243 for the period ended October 14, 2020 and year ended December 31, 2019, respectively. There were no discretionary profit sharing contributions for the period ended October 14, 2020 and year ended December 31, 2019.

Contributions are subject to certain Internal Revenue Code ("IRC") limitations and were invested with Ascensus Trust Company.

**PARTICIPANT ACCOUNTS**

Each participant's account is credited with the participant's contribution and allocations of (a) the company's contribution and (b) plan earnings, and charged with an allocation of administrative expenses. Allocations are based on participant earnings or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

**VESTING**

Participants are immediately vested in their contributions and company contributions plus actual earnings thereon.

**INVESTMENT OPTIONS**

Upon enrollment in the plan, participants are able to direct their contributions, including company contributions, among any or all of the multiple investment account options. Investment options are shares of registered investment companies. Participants may change their investment options daily. There are no nonparticipant directed investments.

Contributions may be temporarily held as cash balances with a corresponding accrued liability prior to the execution of the investment according to the participant's direction.

The plan provides for various investment fund options, which in turn invest in a combination of stocks, bonds, and other investment securities. Investment securities, in general, are exposed to various risks such as interest rate, credit and overall market volatility risks. Due to the level of risk associated with certain investment securities, it is reasonably possible that changes in the values of investment securities will occur in the near term and that such change could materially affect participant account balances and the amounts reported in the statement of net assets available for benefits.

**NOTES RECEIVABLE FROM PARTICIPANTS**

Participants may borrow from their fund accounts. The amount the plan may loan to a participant is limited by rules under the Internal Revenue Code. The maximum amount a participant may borrow is equal to the lesser of \$50,000 or 50% of their vested account balance with a minimum loan amount of \$1,000. Loan terms generally range from one to five years. If used to acquire a principal residence the plan administrator can permit a longer repayment period. The loans are secured by the balance in the participant's account and bear interest at the prime rate plus 1.0% and are fixed over the life of the loan. The plan requires loan obligations to be repaid through payroll deductions. The loans can be repaid at any time.

**PAYMENT OF BENEFITS**

On termination of service due to death, disability or retirement, a participant may elect to receive a lump sum amount equal to the value of the participant's vested interest in his or her account. For termination of service due to other reasons, a participant with vested benefits between \$1,000 and \$5,000, will automatically be rolled over into another qualified account. For termination of service with vested benefits of \$1,000 or less, a participant will automatically receive the value of his or her account as a lump sum distribution.

**HARDSHIP WITHDRAWALS**

Participants are permitted to withdrawal, in a single sum, the vested portion of their account balance under certain conditions. These conditions include unreimbursed medical expenses, the purchase of the participant's principal residence, the payment of post-secondary education tuition, the payment of funeral expenses or casualty losses or to prevent eviction or foreclosure from the participant's principal residence. Effective January 1, 2019, the plan removed the requirement that participant deferrals be suspended for six months after the receipt of hardship withdrawal.

**Note 2 - SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES****BASIS OF ACCOUNTING**

The financial statements of the plan for the period ended October 14, 2020 were prepared under the liquidation basis of accounting as a result of the resolution to terminate the plan. Under the liquidation basis of accounting, assets are recorded at the amount expected to be collected and liabilities are recorded at amounts expected to be paid during the course of liquidation. The December 31, 2019 financial statements of the plan were prepared using the accrual method of accounting.

**USE OF ESTIMATES**

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect reported amounts of assets and liabilities and changes therein, and disclosures of contingent assets and liabilities. Accordingly, actual results may differ from those estimates.

**INVESTMENT VALUATION AND INCOME RECOGNITION**

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 4 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the plan's gains and losses on investments bought and sold, as well as held during the period.

**NOTES RECEIVABLE FROM PARTICIPANTS**

Notes receivable from participants are measured at their unpaid principal balance plus accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred. No allowance for credit losses has been recorded as of December 31, 2019.

**PAYMENT OF BENEFITS**

Benefits are recorded when paid.

**ADMINISTRATIVE EXPENSES**

Certain expenses of the plan are paid by the company and are not included in the statements of changes in net assets available for benefits. Fees related to the administration of notes receivable from participants and distributions are charged directly to the participant's account and are included in administrative expenses. Investment related expenses are included in net appreciation of fair value of investments.

**SUBSEQUENT EVENTS**

The plan has evaluated subsequent events through September 3, 2021, which is the date the financial statements were available to be issued. No significant matters were identified for disclosure during this evaluation.

**Note 3 - INFORMATION PREPARED AND CERTIFIED BY THE TRUSTEE**

The plan administrator has elected the method of annual reporting compliance permitted by 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, Ascensus as agent for Ascensus Trust Company, the trustee of the plan, has certified that the following data included in the accompanying financial statements is complete and accurate with respect to investments:

- Investments at fair value
- Notes receivable from participants
- Net appreciation in fair value of investments
- Interest and dividends
- Interest income on notes receivable from participants

The plan's independent public accountants did not perform auditing procedures with respect to this information, except for comparing such information to the related information included in the financial statements.

**Note 4 - FAIR VALUE MEASUREMENTS**

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). The three levels of the fair value hierarchy under FASB ASC 820 are described below:

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2019.

*Registered investment companies:* Valued at the daily closing price as reported by the fund. Registered investment companies held by the plan are open-end mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily Net Asset Value ("NAV") and to transact at that price. The mutual funds held by the plan are deemed to be actively traded.

#### Note 5 - RELATED PARTY TRANSACTIONS AND PARTY-IN-INTEREST TRANSACTIONS

Ascensus Trust Company and related entities provide the plan with trustee services, plan administration and record keeping. Investment advising is provided by a separate entity. Expenses related to these services are paid by the plan and therefore qualify as party-in-interest transactions. Transactions with these parties may qualify as party-in-interest transactions.

#### Note 6 - TAX STATUS

The plan sponsor adopted a Prototype Non-Standardized Profit Sharing Plan with a deferral arrangement that received a favorable opinion letter from the Internal Revenue Service on March 31, 2014, which stated the plan, as then designed, was in compliance with the applicable sections of the Internal Revenue Code (the Code). Once qualified, the plan is required to operate in conformity with the Code to maintain its qualification. However, the plan administrator believes that as of October 14, 2020, the plan and related trust are being operated in compliance with the applicable requirements of the Code. Therefore, no provision for income taxes has been included in the plan's financial statements.

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the plan and recognize a tax liability (or asset) if the plan has taken an uncertain tax position that more likely than not would not be sustained upon examination by the IRS. The plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

#### Note 7 - OTHER MATTER

The plan is late in filing the 2020 Form 5500 and audited financial statements due turnover at the plan sponsor. The plan sponsor is working to rectify this filing issue and believes with filing the 2020 Form 5500 and audited financial statements, its noncompliance with DOL Regulations will be resolved.
