Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

- The amounts and disclosures in the financial statements referred to above, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.
- The information in the financial statements referred to above related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

Basis for Opinion

We conducted our audits in accordance with auditing standards generally accepted in the United States of America. Our responsibilities under those standards are further described in the Auditor's Responsibilities for the Audit of the Financial Statements section of our report. We are required to be independent of USA Truck Employees' 401(k) Savings Plan and to meet our other ethical responsibilities in accordance with the relevant ethical requirements relating to our audits. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our ERISA Section 103(a)(3)(C) audit opinion.

Plan Merger

As described in Notes 1 and 5 to the financial statements, the Boards of Directors of USA Truck, Inc. and Schenker, Inc., a subsidiary of DB Schenker, the Employer's parent company, approved resolutions dated June 8, 2023 and June 15, 2023, respectively, to merge the Plan into and with Schenker, Inc. 401(k) Savings and Investment Plan, effective July 1, 2023.

Responsibilities of Management for the Financial Statements

Management is responsible for the preparation and fair presentation of these financial statements in accordance with accounting principles generally accepted in the United States of America, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

In preparing the financial statements, management is required to evaluate whether there are conditions or events, considered in the aggregate, that raise substantial doubt about USA Truck Employees' 401(k) Savings Plan's ability to continue as a going concern within one year after the financial statements are available to be issued.

Management is also responsible for maintaining a current plan instrument, including all plan amendments; administering the plan; and determining that the plan's transactions that are presented and disclosed in the financial statements are in conformity with the plan's provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.

Auditor's Responsibilities for the Audit of the Financial Statements

Except as described in the Scope and Nature of the ERISA Section 103(a)(3)(C) Audit section of our report, our objectives are to obtain reasonable assurance about whether the financial statements as a whole are free from material misstatement, whether due to fraud or error, and to issue an auditor's report that includes our opinion. Reasonable assurance is a high level of assurance but is not absolute assurance and therefore is not a guarantee that an audit conducted in accordance with generally accepted auditing standards will always detect a material misstatement when it exists. The risk of not detecting a material misstatement resulting from fraud is higher than for one resulting from error, as fraud may involve collusion, forgery, intentional omissions, misrepresentations, or the override of internal control. Misstatements are considered material if there is a substantial likelihood that, individually or in the aggregate, they would influence the judgment made by a reasonable user based on the financial statements.

In performing an audit in accordance with generally accepted auditing standards, we:

- Exercise professional judgment and maintain professional skepticism throughout the audit.
- Identify and assess the risks of material misstatement of the financial statements, whether due to fraud or error, and design and perform audit procedures responsive to those risks. Such procedures include examining, on a test basis, evidence regarding the amounts and disclosures in the financial statements.
- Obtain an understanding of internal control relevant to the audit in order to design audit procedures that are appropriate in the circumstances, but not for the purpose of expressing an opinion on the effectiveness of USA Truck Employees' 401(k) Savings Plan's internal control. Accordingly, no such opinion is expressed.
- Evaluate the appropriateness of accounting policies used and the reasonableness of significant accounting estimates made by management, as well as evaluate the overall presentation of the financial statements.
- Conclude whether, in our judgment, there are conditions or events, considered in the aggregate, that raise substantial doubt about USA Truck Employees' 401(k) Savings Plan's ability to continue as a going concern for a reasonable period of time.

Our audits did not extend to the certified investment information, except for obtaining and reading the certification, comparing the certified investment information with the related information presented and disclosed in the financial statements, and reading the disclosures relating to the certified investment information to assess whether they are in accordance with the presentation and disclosure requirements of accounting principles generally accepted in the United States of America.

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audit.

Supplemental Schedules Required by ERISA

The supplemental schedules of delinquent participant contributions for the period from January 1, 2023 to July 1, 2023 and the year ended December 31, 2022, and schedule of assets (held at end of year) as of December 31, 2022, are presented for purposes of additional analysis and are not a required part of the financial statements but are supplementary information required by the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Such information is the responsibility of management and was derived from and relates directly to the underlying accounting and other records used to prepare the financial statements. The information included in the supplemental schedules, other than that agreed to or derived from the certified investment information, has been subjected to auditing procedures applied in the audit of the financial statements and certain additional procedures, including comparing and reconciling such information directly to the underlying accounting and other records used to prepare the financial statements or to the financial statements themselves, and other additional procedures in accordance with generally accepted auditing standards. For information included in the supplemental schedules that agreed to or is derived from the certified investment information, we compared such information to the related certified investment information.

In forming our opinion on the supplemental schedules, we evaluated whether the supplemental schedules, other than the information agreed to or derived from the certified investment information, including their form and content, are presented in conformity with the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA.

- The form and content of the supplemental schedules, other than the information in the supplemental schedules that agreed to or is derived from the certified investment information, are presented, in all material respects, in conformity with the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA.

NOTES TO FINANCIAL STATEMENTS July 1, 2023 and December 31, 2022 and 2021

NOTE 1 - DESCRIPTION OF PLAN

The following description of USA Truck Employees' 401(k) Savings Plan (the Plan) provides only general information. Participants should refer to the Plan Agreement for a more complete description of the Plan's provisions.

General: The Plan was organized effective July 1, 1988, as a defined contribution retirement savings plan covering all eligible employees of USA Truck, Inc. and its affiliated participating employers (collectively the Employer) who have at least three months of service. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA). The Retirement Plan Committee of the Employer was responsible for oversight of the Plan and determined the suitability of the Plan's investment offerings, monitored investment performance, and reported to the Board of Directors.

On September 15, 2022, the Employer announced that it had been acquired by DB Schenker. The completed acquisition was previously approved by the Employer's stockholders on September 12, 2022, per the terms of a merger agreement from June 23, 2022.

The Boards of Directors of USA Truck, Inc. and Schenker, Inc., a subsidiary of DB Schenker, the Employer's parent company, approved resolutions dated June 8, 2023 and June 15, 2023, respectively, to merge the Plan into and with Schenker, Inc. 401(k) Savings and Investment Plan (Schenker Plan), effective July 1, 2023. Due to the Plan's merger, no additional employees became eligible to participate in the Plan nor were any additional contributions or benefits accrued under the Plan after June 30, 2023. All of the Plan's assets and liabilities were assigned to or assumed by the Schenker Plan immediately as of July 1, 2023, at which time the Plan and its related trust ceased to exist. All affected Plan participants immediately became eligible in the Schenker Plan as of July 1, 2023. See Note 5.

Contributions: Each year, participants could authorize the Employer to contribute to the Plan up to 100% of their eligible annual compensation, subject to the maximum annual amount permitted under Section 402(g) of the Internal Revenue Code (IRC). Participants who attained age 50 before the end of the Plan year were eligible to make catch-up contributions. Participants could also make rollover contributions from amounts representing distributions from other qualified plans and certain Individual Retirement Accounts (IRA) as defined in the Plan Agreement. Contributions were subject to certain limitations under the IRC.

The Employer could elect to make discretionary matching contributions to the Plan. During the period from January 1, 2023 to July 1, 2023 and the year ended December 31, 2022, the Employer made matching contributions equal to 50% of the first 4% of compensation that each participant contributed to the Plan.

Participants directed the investment of their contributions, as well as those made by the Employer, into various investment options offered by the Plan.

Participant Accounts: Each participant's account was credited with the participant's contributions and the Employer's matching contributions, as well as allocations of Plan earnings. Participant accounts could also be charged with an allocation of certain administrative expenses of the Plan. Allocations were based on participant earnings or account balances, or specific participant transactions, as defined in the Plan Agreement. The benefit to which a participant was entitled was the benefit that could be provided from the participant's vested account.

Vesting and Forfeitures: Participants were vested immediately in their contributions plus actual earnings thereon. Vesting in the Employer's contribution portion of their account was based on years of service. A participant became 100% vested after two years of service.

NOTE 1 - DESCRIPTION OF PLAN (CONTINUED)

At July 1, 2023 and December 31, 2022 and 2021, forfeited nonvested accounts of terminated participants totaled \$106,044, \$27,768, and \$0, respectively. These accounts could be used to reduce future Employer contributions, pay Plan expenses, and/or be allocated or reinstated to the accounts of eligible participants, as defined in the Plan Agreement. In 2023 and 2022, forfeited nonvested accounts of \$0 and \$21,118, respectively, were used to reduce Employer contributions.

Notes Receivable from Participants: Participants could borrow from their account a minimum of \$1,000 up to a maximum amount equal to the lesser of \$50,000 or 50% of their vested account balance. The repayment terms of the notes could not exceed five years except for the purchase of the participant's principal residence, for which the terms could exceed five years per the Plan Agreement. The notes were secured by the balance in the participant's account and bore interest at rates which were commensurate with local prevailing rates as determined by the Plan Administrator. Principal and interest were paid ratably through regular payroll deductions.

Benefits: Upon the occurrence of a distributable event due to separation from service by termination, death, disability, or retirement, as defined by the Plan Agreement, a participant could elect to receive a lump-sum cash distribution equal to the value of the participant's vested interest in their account, partial payments or installment payments. Hardship and in-service withdrawals, as well as, required minimum distributions, rollover contribution accounts, and automatic distributions to former participants, as defined in the Plan Agreement, were also permitted from a participant's account.

Plan Termination: Prior to the Plan's merger, the Employer had the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, the participants would have become 100% vested in their accounts.

NOTE 2 - SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Basis of Accounting: The financial statements of the Plan are prepared on the accrual basis of accounting.

Estimates: The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America requires the Plan's management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and the disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

Investment Valuation and Income Recognition: The Plan's investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Retirement Plan Committee determined the Plan's valuation policies utilizing information provided by the Plan's investment advisor and trustees. See Note 3 for discussion of fair value measurements.

Purchases and sales of securities were recorded on a trade-date basis. Interest income was recorded on the accrual basis. Dividends were recorded on the ex-dividend date. Net appreciation (depreciation) included the Plan's gains and losses on investments bought and sold as well as held during the year.

Notes Receivable from Participants: The Plan's notes receivable from participants were measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income was recorded on the accrual basis. No allowance for credit losses was recorded as of July 1, 2023 and December 31, 2022 and 2021. If a participant ceased to make repayments and the Plan Administrator deemed the note receivable from the participant to be in default, the balance of the note receivable from the participant was reduced and a benefit payment was recorded per the Plan Agreement.

Excess Contributions Payable: Amounts payable to participants for contributions in excess of amounts allowed under the IRC were recorded as a liability with a corresponding reduction in participant contributions. The Plan distributed excess contributions at December 31, 2021 to the applicable participants prior to March 15th of the following year.

NOTE 2 - SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES (CONTINUED)

Payment of Benefits: Benefits were recorded when paid.

Expenses: Administrative expenses for maintaining the Plan could be paid by the Employer or the Plan, at the Employer's discretion. Certain administration fees were charged directly to the participant's account and were included in administrative expenses. Investment related expenses were included in net appreciation (depreciation) in fair value of investments.

Tax Status: The Plan is based on a pre-approved defined contribution plan document whose sponsor has received an opinion letter from the Internal Revenue Service (IRS) dated August 19, 2020, stating that the pre-approved defined contribution plan document was designed in accordance with the applicable sections of the IRC. Although the Plan and the pre-approved defined contribution plan document have been amended since receiving the opinion letter, the Plan Administrator believes that the Plan is designed in compliance with the applicable requirements of the IRC. Therefore, the Plan Administrator believes that the Plan is qualified, and the related trust is tax-exempt.

Accounting principles generally accepted in the United States of America require the Plan's management to evaluate tax positions taken by the Plan and to recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS or other taxing authorities.

The Plan is subject to routine audits by taxing authorities; however, there are currently no audits for any tax periods in process.

Subsequent Events: The Plan Administrator has evaluated the financial statements for subsequent events occurring through May 9, 2024, the date the financial statements were available to be issued.

NOTE 3 - FAIR VALUE MEASUREMENTS

The Plan has categorized its assets and liabilities that are measured at fair value into a three-level fair value hierarchy. The hierarchy prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

The three levels of the fair value hierarchy are described as follows:

Level 1 – Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 – Inputs to the valuation methodology include: quoted prices for similar assets or liabilities in active markets; quoted prices for identical or similar assets or liabilities in inactive markets; inputs other than quoted prices that are observable for the asset or liability; and inputs that are derived principally from or corroborated by observable market data by correlation or other means. If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 – Inputs to the valuation methodology are unobservable and significant to the fair value measurement. In situations where there is little or no market activity for the asset or liability, the Plan makes estimates and assumptions related to the pricing of the asset or liability including assumptions regarding risk.

NOTE 3 - FAIR VALUE MEASUREMENTS (CONTINUED)

Following is a description of the valuation methodologies used by the Plan for assets that are measured at fair value on a recurring basis. There have been no changes in the methodologies used at July 1, 2023 and December 31, 2022 and 2021.

Registered Investment Companies (Mutual Funds) and Money Market Fund Shares: Valued at the daily closing price as reported by the funds. These funds are required to publish their daily net asset value (NAV) and to transact at that price. These funds held by the Plan are deemed to be actively traded.

Collective Trust Funds: Valued at the unit price reported by the sponsoring bank or trust company. The underlying investments owned by the funds can include money market funds, stable value funds, fixed-income securities, registered investment companies, common stocks, corporate bonds, U.S. Government securities, other collective trust funds, or guaranteed investment contracts priced by the sponsoring insurance company using applicable interest rates and contract provisions. The unit price is based on the fair value of these underlying investments owned, less any accrual of fees and expenses borne by the fund, and divided by the number of units outstanding. The unit price is readily determinable and quoted on the active private market on which participants can transact daily with no redemption restrictions on these investments.

The preceding methods may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan's management believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain assets could result in a different fair value measurement at the reporting date.

Following is a summary, within each level of the fair value hierarchy, of the Plan's assets that are measured at fair value on a recurring basis as of December 31, 2022 and 2021. The Plan held no investments measured at fair value as of July 1, 2023.

NOTE 4 - INFORMATION CERTIFIED BY THE PLAN'S TRUSTEES (UNAUDITED INFORMATION)

All Plan information related to investments and notes receivable from participants held at July 1, 2023 and December 31, 2022 and 2021, and net appreciation or depreciation in fair value of investments, interest and dividends, and interest income on notes receivable from participants for the period from January 1, 2023 to July 1, 2023, and the year ended December 31, 2022, disclosed in the accompanying financial statements and supplemental schedules was obtained or derived from information provided to the Plan Administrator and certified as complete and accurate by Matrix Trust Company and Vanguard Fiduciary Trust Company, the Plan's trustees, in accordance with Section 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA.

**NOTE 4 - INFORMATION CERTIFIED BY THE PLAN'S TRUSTEES (UNAUDITED INFORMATION)
(CONTINUED)**

The Plan's independent auditor did not perform auditing procedures with respect to this information, except for comparing such information to the related information included in the financial statements and supplemental schedules.

NOTE 5 - PLAN AMENDMENTS

On May 17, 2022, the Employer adopted an amendment to the Plan Agreement to comply with the Bipartisan Budget Act of 2018 regarding the Plan's financial hardship distribution provisions, effective as of the applicable due date as set forth under the Act.

Effective July 1, 2022, the Employer amended and restated the Plan Agreement in its entirety to incorporate all prior amendments and to comply with the 2017 Cumulative List of Changes in Plan Qualification Requirements, per IRS Notice 2017-37, and with the requirements under IRS Revenue Procedure 2017-41 to maintain the Plan's tax-qualified status. The Plan has adopted a pre-approved defined contribution plan document whose sponsor has received an opinion letter from the Internal Revenue Service (IRS) dated August 19, 2020, stating that the plan document was designed in accordance with the applicable sections of the IRC.

In conjunction with the amended and restated document, the Employer engaged Matrix Trust Company to serve as the Plan's new trustee and American United Life Insurance Company, a OneAmerica company, to serve as the Plan's new recordkeeper and third-party administrator. All of the Plan's investments and notes receivable from participants totaling were transferred from Vanguard Fiduciary Trust Company to Matrix Trust Company during the 2022 Plan year. There were no other significant changes in the Plan's provisions during the change in service providers.

The Boards of Directors of USA Truck, Inc. and Schenker, Inc., a subsidiary of DB Schenker, the Employer's parent company, approved resolutions dated June 8, 2023 and June 15, 2023, respectively, to merge the Plan into and with the Schenker Plan, effective July 1, 2023. All affected Plan participants immediately became eligible in the Schenker Plan as of July 1, 2023. In addition, all of the Plan's assets and liabilities were assigned to or assumed by the Schenker Plan immediately as of July 1, 2023, at which time the Plan and its related trust ceased to exist.

As of July 1, 2023, the Employer was recognized as a participating employer in the Schenker Plan, for which all Plan participants affected by the merger have been granted service credits for purposes of eligibility, vesting, and contribution allocations under the Schenker Plan. The resolutions and adoption agreement, as well as any future changes to the Schenker Plan will not reduce the accrued benefit of the Plan's participants in violation of Section 411(d)(6) of the IRC or under ERISA Rules & Regulations.

NOTE 6 - PARTY-IN-INTEREST TRANSACTIONS

Party-in-interest transactions include those with fiduciaries or employees of the Plan, any person who provides services to the Plan, an employer whose employees are covered by the Plan, an employee organization whose members are covered by the Plan, a person who owns 50% or more of such an employer or employee association, or relatives of such persons.

The Plan had arrangements with several third-party service providers. The Plan paid certain expenses related to the Plan's operation, administration, and investment activity. The Plan's expenses could be paid directly to the respective service provider or indirectly through the Plan's investments returns. Therefore, these transactions qualify as exempt party-in-interest transactions under ERISA.

The Plan could receive revenue-sharing compensation from certain Plan investment options. This revenue, if any, was used to offset certain recordkeeping and administration services to the Plan and/or allocated to participant accounts as additional earnings.

NOTE 6 - PARTY-IN-INTEREST TRANSACTIONS (CONTINUED)

The Employer provided certain accounting, administrative and investment management services to the Plan for which it received no compensation.

Notes receivable from participants are permitted party-in-interest transactions.

NOTE 7 - DELINQUENT PARTICIPANT CONTRIBUTIONS

Defined contribution plans are required to remit participant contributions and participant loan repayments to the Plan as soon as they can be segregated from the Employer's general assets. Contributions and loan repayments totaling \$337,702, \$345,767, \$3,881, \$182,096, and \$66,021 were not remitted within the required time period for the period from January 1, 2023 to July 1, 2023 and for the years ended December 31, 2022, 2021, 2020, and 2019, respectively, as reported on the attached Schedules of Delinquent Participant Contributions. The Employer corrected the delinquent contributions and loan repayments for the 2021 and 2020 Plan years by calculating and remitting related lost earnings to the Plan during the period from January 1, 2023 to July 1, 2023 to be allocated to the affected participants. For the 2023, 2022, and 2019 Plan years, the Employer has submitted all of the delinquent contributions and loan repayments to the Plan's trust and/or Schenker Plan's trust, and as of July 1, 2023, the Employer was in the process of calculating and remitting the related lost earnings to the Schenker Plan to be allocated to the affected participants.

NOTE 8 - RISKS AND UNCERTAINTIES

The Plan's investment securities are exposed to various risks, such as interest rate, market and credit risks. Market risks include global events which could impact the value of investment securities, such as a pandemic or international conflict. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the Plan's financial statements.
