Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the financial statements of Cazenovia College 403(b) Retirement Plan (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) [ERISA Section 103(a)(3)(C) audit]. The financial statements comprise the statements of net assets available for benefits as of July 31, 2023 (in liquidation) and December 31, 2022 (ongoing), and the related statement of changes in net assets available for benefits for the period from January 1, 2023 to July 31, 2023 (in liquidation), and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from a qualified institution as of July 31, 2023 and December 31, 2022, and for the period from January 1, 2023 to July 31, 2023, stating that the certified investment information, as described in Note 3 to the financial statements, is complete and accurate.

Basis for Opinion

We are required to be independent of the Plan and to meet our other ethical responsibilities, in accordance with the relevant ethical requirements relating to our audits. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our ERISA Section 103(a)(3)(C) audit opinion.

Emphasis of Matter - Plan Termination and Liquidation Basis of Accounting

As further discussed in Note 1 to the financial statements, the Plan's Board of Trustees approved a plan of liquidation on January 5, 2023, and management determined liquidation was imminent. As a result, the Plan changed its basis of accounting from the going-concern basis of accounting used in presenting the 2023 financial statements to the liquidation basis of accounting used in presenting the 2023 financial statements. Our opinion is not modified with respect to this matter.

Responsibilities of Management for the Financial Statements

Management is responsible for the preparation and fair presentation of the financial statements in accordance with accounting principles generally accepted in the United States of America, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

Management is also responsible for maintaining a current plan instrument, including all plan amendments; administering the plan; and determining that the plan's transactions that are presented and disclosed in the financial statements are in conformity with the plan's provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.

Auditor's Responsibilities for the Audit of the Financial Statements

Except as described in the Scope and Nature of the ERISA Section 103(a)(3)(C) Audit section of our report, our objectives are to obtain reasonable assurance about whether the financial statements as a whole are free from material misstatement, whether due to fraud or error, and to issue an auditor's report that includes our opinion. - Obtain an understanding of internal control relevant to the audit in order to design audit procedures that are appropriate in the circumstances, but not for the purpose of expressing an opinion on the effectiveness of the Plan's internal control. Accordingly, no such opinion is expressed.
- Evaluate the appropriateness of accounting policies used and the reasonableness of significant accounting estimates made by management, as well as evaluate the overall presentation of the financial statements.

Our audits did not extend to the certified investment information, except for obtaining and reading the certification, comparing the certified investment information with the related information presented and disclosed in the financial statements, and reading the disclosures relating to the certified investment information to assess whether they are in accordance with the presentation and disclosure requirements of accounting principles generally accepted in the United States of America.

NOTES TO FINANCIAL STATEMENTS

JULY 31, 2023 (IN LIQUIDATION) AND DECEMBER 31, 2022 (ONGOING)

1. DESCRIPTION OF PLAN

The following brief description of the Cazenovia College 403(b) Retirement Plan (the Plan) is provided for general information purposes only. Participants should refer to the Plan document for a more complete description of the Plan's provisions.

General

The Plan was a defined contribution 403(b) plan available to all full-time employees of Cazenovia College (the College) who meet certain eligibility requirements. The Plan was administered by the Board of Trustees of the College. Teachers Insurance and Annuity Association of America and College Retirement Equities Fund (TIAA and CREF) were the insurance companies and issuers of the annuity contracts of the Plan. TIAA, FSB was the directed custodian of certain assets of the Plan record kept by TIAA. TIAA was the recordkeeper of the Plan. The Plan was subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

Plan Termination

On January 5, 2023, in conjunction with the College closing, the College's Board of Trustees adopted a resolution to terminate the Plan effective May 31, 2023. As part of the termination of the Plan, participants were able to withdraw their funds through July 31, 2023.

Eligibility

All employees of the College, except for student employees, were eligible to immediately begin salary deferrals pursuant to a properly completed and valid salary reduction agreement. Employees were eligible to receive College contributions on the first pay period following the completion of one year of eligible service with 1,000 hours.

Contributions

Active participants were able to make voluntary contributions in the form of salary reductions and any applicable rollovers from other qualified plans, subject to certain limitations of the Plan and the Internal Revenue Code (the Code) under Section 403(b). Eligible participants, who attained the age of 50 or had 15 years of service before the end of the Plan year, were eligible to make catch-up contributions, subject to certain limitations of the Code.

The College made discretionary contributions on behalf of eligible employees in an amount to be determined from year to year. The College contributed 3% of eligible wages to the Plan through May 31, 2023.

Participant Accounts

Each participant's account was credited with the participant's contribution, the College's contribution, and Plan earnings/losses on all contributions. Allocations of earnings/losses and administrative expenses were based on participant account balances, according to specific terms provided by the Plan. The benefit to which a participant was entitled was the benefit that would be provided from the participant's account balance.

1. DESCRIPTION OF PLAN (Continued)

Funding Vehicles

Plan contributions were invested in one or more of the funding vehicles offered by the Plan. The Plan did not permit contract exchanges with any annuity contract or custodial account that were not a funding vehicle specifically approved by the Plan Administrator for use under the Plan.

Vesting

Participants were immediately vested in their account balance, which included voluntary contributions, the College's contributions, and actual earnings/losses thereon.

Plan Loans

Plan loans were issued directly from the funds owned by TIAA and CREF and were not issued directly from a participant's account. Accordingly, these loans were not presented as part of the Plan assets on the accompanying statement of net assets available for benefits. An adequate portion of the participant's account was reserved, or held in collateral, to cover 110% of the outstanding loan in case of default. The collateral was held in the fixed annuity contract investment option. Total plan loans outstanding at July 31, 2023 and 2022 amounted to \$- and \$52,344 respectively. Plan loans in default at December 31, 2022 totaled \$35,038.

Notes Receivable from Participant

Participants were able to borrow an amount up to the lesser of 50% of the amount of their vested balance or \$50,000. The loan amount could not exceed the maximum amount imposed by the Code. A participant could borrow a minimum of \$1,000. Notes were repayable over not more than five years, except in the case of a loan for the purchase of a primary residence. All notes bore interest at prime plus 1%. Total notes receivable from participants outstanding at July 31, 2023 and December 31, 2022 were \$- and \$4,230, respectively. The notes bore interest at 4.50% and were scheduled to mature in April 2026.

Payment of Benefits

Vested funds were paid to participants when they retired or terminated employment with the College. Benefits were paid in periodic installments over a period that was not greater than the life expectancy of the participant. Benefits were paid out in a single lump sum if the vested benefit in the Plan did not exceed \$1,000 or if the participant and their spouse waived the annuity form of payment.

Hardship Withdrawals

Hardship withdrawals from the Plan were permitted from a participant's account. All hardship withdrawals were required to comply with Internal Revenue Service rules relating to hardships, which were uniformly applicable to all participants.

2. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Basis of Accounting

The accompanying financial statements of the Plan were prepared in accordance with accounting principles generally accepted in the United States of America.

As a result of management's decision to terminate the Plan as described in Note 1, the Plan changed its basis of accounting from the going concern basis to the liquidation basis for the period from January 1, 2023 to July 31, 2023. The liquidation basis of accounting presents assets at amounts expected to be realized in liquidation and liabilities at amounts expected to be paid.

2. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES (Continued)

Investments

Investments, except for fully benefit responsive fixed annuity contracts, were reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. Fully benefit responsive fixed annuity contracts were reported at contract value. Contract value is the relevant measure for the portion of the net assets available for benefits attributable to fully benefit responsive investment contracts because contract value is the amount participants would receive if they were to initiate permitted transactions under the terms of the Plan.

Purchases and sales of securities are reflected on a trade date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year. All investments are participant directed.

The Plan had fully benefit responsive fixed annuity contracts and stable value funds. The accounts were credited with contributions and earnings on the underlying investments and were charged for Plan withdrawals. Earnings on the underlying investments were guaranteed by TIAA and CREF at a rate of 1% to 3%.

The Plan utilized Retirement Annuity (RA) contracts, which were included in the non-benefit responsive fixed annuity contracts on the statements of net assets available for benefits. Under RA contracts, lump-sum withdrawals were not permitted. Participant initiated transfers or withdrawals were only made in 10 annual installments over a period of approximately nine years.

The Plan utilized Group Retirement Annuity (GRA) contracts, which were included in non-benefit responsive fixed annuity contracts on the statements of net assets available for benefits. Under GRA contracts, lump-sum withdrawals were available within 120 days of termination of employment and were subject to a 2.5% surrender charge. All other withdrawals and transfers from the account were required to be spread over 10 annual installments (over five years for withdrawals after termination of employment).

The Plan utilized Retirement Choice Annuity (RC) contracts, which were included in non-benefit responsive fixed annuity contracts on the statements of net assets available for benefits. Under RC contracts, lump-sum withdrawals are available within 120 days of termination of employment and were subject to a 2.5% surrender charge. All other withdrawals and transfers from the account were required to be spread over 84 monthly installments (over seven years for withdrawals after termination of employment).

The fixed annuity contracts guaranteed minimum returns were supported by the TIAA-CREF General Account portfolio, which invests primarily in U.S. debt instruments and investment grade corporate bonds; however, is also permitted to invest in higher risk securities, including but not limited to, sub-investment grade corporate bonds, common stock and real estate. The assets and earnings from this portfolio were used to pay the guaranteed interest rate associated with the annuity contracts, as well as future annuity payments.

2. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES (Continued)

Fair Value Measurement

Accounting Standards Codification (ASC) Section 820 establishes a framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair market value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets and liabilities (level 1 measurements) and the lowest priority to unobservable inputs (level 3 measurements). The three levels of the fair value hierarchy under ASC Section 820 are described below:

- Level 1 - Valuations based on quoted prices in active markets for identical assets or liabilities that the Plan has the ability to access. Valuation adjustments are not applied to Level 1 instruments. Since valuations are based on quoted prices that are readily and regularly available in an active market, valuation of these products does not entail a significant degree of judgment.
- Level 2 - Valuations based on quoted prices in markets that are not active or for which all significant inputs are observable, directly or indirectly.
- Level 3 - Valuations based on inputs that are unobservable and significant to the overall fair value measurement.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

The following is a description of the valuation methodology used for assets measured at fair value.

Registered investment companies: Registered investment companies included mutual funds and variable annuities, which were valued at the net asset value of shares held at year end based on quoted market prices in active markets.

Pooled separate accounts: The fair value of interests in pooled separate accounts was measured based upon net asset value per share published on a daily basis using the fair value of the fund's underlying assets.

Non-benefit responsive fixed annuity contracts: Value was calculated based on discounted cash flows using risk-adjusted discount rates.

There were no changes in the valuation methodologies used during 2023 and 2022.

The methods described previously may produce a fair value calculation that may not have been indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

2. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES (Continued)

Risks and Uncertainties

The Plan invested in various investment securities. Investment securities were exposed to various risks, such as interest rate, market, currency, and credit risks. Due to the level of risk associated with certain investment securities, it was at least reasonably possible that changes in the values of investment securities would occur in the near term and that such changes could have materially affected participants' account balances and the amount reported in the financial statements.

Notes Receivable from Participant

Notes receivable from participant were measured at the unpaid principal balance plus any accrued but unpaid interest. Delinquent participant loans were reclassified as distributions based upon the terms of the Plan document.

Payment of Benefits

Benefit payments to participants were recorded when paid.

Administrative Expenses

Substantially all administrative expenses associated with the Plan were paid by participants. Management fees and operating expenses charged to the Plan for investments were deducted from income earned on a daily basis and were not separately reflected. Consequently, management fees and operating expenses were reflected as a reduction of net appreciation (depreciation) in fair value of investments.

Estimates

The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America requires the Plan Administrator to make estimates and assumptions that affect the amounts reported in the financial statements and accompanying notes. Actual results could differ from those estimates.

The Plan Administrator assesses the fair value measurements used by TIAA and CREF, including those for Level 3 investments. Annually, the Plan Administrator, together with TIAA and CREF, determine if the current valuation techniques used in the fair value measurements are still appropriate.

5. TAX STATUS

The Plan was exempt from federal income tax under Section 403(b) of the Code. The Plan was required to operate in conformity with the Code to maintain its tax-exempt status for Plan participants. The Plan Administrator believes that the Plan was designed and operated in compliance with the applicable requirements of the Code. Therefore, no provision for income tax have been included in the Plan's financial statements.

For employee benefit plans, their qualified status itself is deemed to be an uncertainty, since events could potentially occur to jeopardize their qualified status. As of July 31, 2023 (in liquidation) and December 31, 2022 (on going), the Plan did not have a liability for unrecognized tax benefits. The Plan files the Annual Return/Report of Employee Benefit Plan (Form 5500) in the U.S. federal jurisdiction.

6. RELATED PARTY TRANSACTIONS

TIAA and CREF were the insurance companies and issuers of annuity contracts of the Plan. TIAA was the recordkeeper of the Plan's assets. TIAA also served as the authorized agent of TIAA, FSB, the directed custodian of certain assets of the Plan record kept by TIAA. Therefore, transactions between TIAA and CREF, TIAA, FSB, and the Plan qualified as party-in-interest transactions. Additionally, notes receivable from participants were party-in-interest transactions.

7. RECONCILIATION TO FORM 5500

Certain items have been classified differently between the financial statements and Form 5500. Net assets available for benefits and changes in net assets available for benefits per the financial statements agree to Form 5500 in total as of July 31, 2023 (in liquidation) and for the period from January 1, 2023 to July 31, 2023 (in liquidation), and as of December 31, 2022 (on going).

8. SUBSEQUENT EVENTS

Subsequent events have been evaluated through May 10, 2024, which is the date the financial statements were available to be issued.
