### Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have audited the accompanying financial statements of Great Lakes Foods, LLC 401k Plan (Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), which comprise the statements of net assets available for benefits as of July 31, 2023 (in liquidation), and the related statement of changes in net assets available for benefits for the seven months then ended (in liquidation), and the statement of net assets available for benefits as of December 31, 2022 (ongoing), and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by a bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from qualified institutions as of July 31, 2023 and December 31, 2022 and for the seven months ended July 31, 2023, stating that the certified investment information, as described in Note 7 to the financial statements, is complete and accurate.

### Opinion

In our opinion, based on our audits and on the procedures performed as described in the Auditors' Responsibilities for the Audit of the Financial Statements section—

- the amounts and disclosures in the accompanying financial statements, other than those agreed to or derived from the certified investment information, are present fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.
- the information in the financial statements related to assets held by and certified to by qualified institutions agrees to or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

### Basis for Opinion

We conducted our audits in accordance with auditing standards generally accepted in the United States of America (GAAS). Our responsibilities under those standards are further described in the Auditors' Responsibilities for the Audit of the Financial Statements section of our report. We are required to be independent of the Plan and to meet our other ethical responsibilities in accordance with the relevant ethical requirements relating to our audits. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our ERISA Section 103(a)(3)(C) audit opinion.

### **Emphasis of Matter – Plan Termination and Liquidation Basis of Accounting**

As discussed in Note 6 to the financial statements, the governing body of the Plan approved a plan of liquidation on January 25, 2023, and management determined liquidation is imminent. As a result, the Plan has changed its basis of accounting from the going-concern basis used in presenting the 2022 financial statements to the liquidation basis used in presenting the 2023 financial statements. Our opinion is not modified with respect to that matter.

### **Responsibilities of Management for the Financial Statements**

Management is responsible for the preparation and fair presentation of the financial statements in accordance with accounting principles generally accepted in the United States of America, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's election of the ERISA section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

Management is also responsible for maintaining a current plan instrument, including all plan amendments; administering the plan; and determining that the plan's transactions that are presented and disclosed in the financial statements are in conformity with the plan's provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.

### **Auditors' Responsibilities for the Audit of the Financial Statements**

### Note 1 - Plan Description

The following brief description of the Great Lakes Foods, LLC 401(k) Plan (Plan) is provided for general information purposes only. Participants should refer to the plan document for more complete information.

#### General

The Plan is a defined contribution pension plan covering substantially all eligible full-time employees of Great Lakes Foods, LLC (Company) who have 90 days of service. Part-time employees must complete 1,000 hours of service during a computation period to be eligible to participate in the Plan. Employees enter the Plan on the first day of each plan quarter following meeting eligibility requirements (January 1, April 1, July 1 and October 1). The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA) as amended. The Board of Trustees is responsible for oversight of the Plan. The Investment Committee determines the appropriateness of the Plan's investment offerings, monitors investment performance and reports to the Plan's Board of Trustees.

#### Contributions

Participants may defer up to 100% of their compensation as a pre-tax or Roth contribution each year not to exceed the thresholds set by the Internal Revenue Code. Participants who have attained age 50 before the end of the plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans (rollover contributions). Rollover contributions do not qualify for the discretionary match, as noted below. The Plan also includes an auto-enrollment provision whereby all newly eligible employees are automatically enrolled in the Plan unless they affirmatively elect not to participate in the Plan or elect an alternative deferral rate. Automatically-enrolled participants have their deferral rate set to 3% of eligible compensation and their contributions invested in a designated fund until changed by the participant. At the beginning of each plan year, after the completion of year two, the deferral rate for automatically-enrolled participants increases 1% up to a maximum of 10% of compensation, unless an alternative election is made by the participant. Participants direct the investment of their contributions and employer contributions into various investment options offered by the Plan.

The Company may make discretionary matching and profit-sharing contributions to the Plan. Participants must have a year of credited service to be eligible to receive these discretionary contributions. Participants must also complete 1,000 hours of service during the current plan year and be employed on the last day of the plan year in order to participate in the discretionary matching and profit-sharing contributions. For 2023, the Company did not make discretionary matching nor profit-sharing contributions.

#### Participant Accounts and Rollovers

Each participant's account is credited with the participant's contributions, the Company's discretionary matching contribution, and allocations of (a) the Company's discretionary profit-sharing contribution, (b) plan earnings or losses, and (c) forfeitures of terminated participants' unvested accounts. Each participants' account is reduced for withdrawals and an allocation of administrative expenses. Allocations are based on participant earnings or losses, account balances, or specific participant transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account. The Plan permits the transfer of funds from other qualified plans to a separate participant's rollover account

#### Vesting

Participants are immediately vested in their voluntary contributions and the Company's discretionary matching contributions plus actual earnings thereon. Vesting in the Company's non-elective contributions and earnings thereon vest under a graded vesting schedule becoming 20% vested after two years of employment until 100% vested after six years of service. All participants were fully invested.

#### Payment of Benefits

Plan benefits are available at normal retirement (age 65), disability, death, and termination of employment with vested interest. Benefits are paid in the form of either a lump sum distribution or installments/partial payments. The Plan also allows for in-service distributions upon attaining age 59½. Participants may withdraw their rollover contributions at any time.

#### Forfeited Accounts

Plan forfeitures arise as a result of participants who terminate service from the Company before becoming 100% vested in the Company's non-elective contributions and related earnings. These forfeitures are used for plan expenses, offset Company contributions or be allocated to participants as additional Company contributions. At December 31, 2022, forfeited non-vested accounts totaled \$12,574. Forfeitures of \$10,234 were used to reduce Company contributions for the seven months ended July 31, 2023. No forfeitures were used for plan expenses for the seven months ended July 31, 2023.

### Note 2 - Summary of Significant Accounting Policies

The Plan's significant accounting policies consistently applied in the preparation of the accompanying financial statements follows.

#### Basis of Accounting

The accompanying financial statements have been prepared using the accrual method of accounting in accordance with accounting principles generally accepted in the United States of America.

#### Use of Estimates

The preparation of financial statements in conformity with generally accepted accounting principles requires management to make estimates and assumptions that affect certain reported amounts and disclosures. Actual results could differ from those estimates.

#### Investment Valuation and Income Recognition

The Plan's investments are stated at fair value. Fair value is the price that would be received to sell an asset or be paid to transfer a liability in an ordinary transaction between market participants at the measurement date. See Note 4 for discussion of fair value measurements. Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on an accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the plan's gains and losses on investments bought and sold as well as held during the year.

#### Payment of Benefits

Benefits are recorded when paid.

#### Expenses

Certain expenses of maintaining the Plan are paid by the Plan, unless otherwise paid by the Company. Expenses that are paid by the Company are excluded from these financial statements. Certain expenses to maintain the Plan are allocated and charged to participants based on participant account balance, as defined, and are included in expenses. Investment related expenses are included in net appreciation of fair value of investments.

#### Subsequent Events

The Plan has evaluated subsequent events through May 14, 2024, the date the financial statements were available to be issued.

#### Note 3 - Income Taxes

The Company adopted the volume submitter prototype non-standard 401(k) profit sharing plan. The prototype has received a favorable opinion letter from the Internal Revenue Service. As such, the Plan qualifies under Section 401(a) of the Internal Revenue Service Code and, therefore, is not subject to tax under present income tax laws. The plan administrator believes that the Plan is designed and is currently being operated in compliance with the applicable requirements of the Internal Revenue Code.

Accounting principles generally accepted in the United States of America require the plan administrator to evaluate tax positions taken by the Plan and to recognize a tax liability for any uncertain position that more likely than not would not be sustained upon examination by the Internal Revenue Service. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

#### Note 4 - Fair Value Measurements

The Financial Accounting Standards Board has established a framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1 measurements) and the lowest priority to unobservable inputs (level 3 measurements). The three levels of the fair value hierarchy are described below:

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

The following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2022.

*Fixed Annuity Contract:* The value of this general account product is derived from contract provisions and, therefore, contract value approximates fair value when using a discounted cash flow valuation methodology where the interest rate is reset quarterly. The value of the fund is calculated based on contributions plus interest less withdrawals and charges. Due to provisions within the contract, immediate and full payment of the contract value is prevented. As a result, this fixed annuity contract is not considered fully-benefit responsive.

*Mutual Funds:* Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the SEC. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded (level 1 inputs).

The methods described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of other methodologies or assumptions to determine fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

### Note 5 - Related Party Transactions

All plan investments are managed by the custodians of the Plan and, therefore, these transactions qualify as party-in-interest transactions. Fees paid by the Plan to Empower Annuity Insurance Company of America and Empower Trust Company, LLC for administrative expenses during 2023 amounted to \$10,035. Blue Chip Retirement Plans, Inc. ("Blue Chip") is the third-party administrator of the Plan and, therefore, transactions with Blue Chip qualify as party-in-interest transactions. Fees paid from plan assets in 2023 to Blue Chip for administrative services were \$12,459. In addition, certain investment-related fees incurred by the Plan are included in net appreciation in fair value of investments, since they are paid through revenue sharing rather than a direct payment.

### Note 6 - Plan Termination

The Plan sponsor terminated the Plan effective January 31, 2023.

As the company submitted a formal record of action with respect to the termination of the Plan, the Company had the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. The net assets of the Plan were allocated as prescribed by ERISA and its related regulations, generally to provide the following benefits in the order indicated:

- a. Participants that were 100 percent vested in their accounts,
- b. Benefits held under the Plan shall be distributed to plan participants as soon as administratively feasible pursuant to the terms of the plan; and
- c. That the officers of the Employer be, and they hereby are, authorized and directed to take any and all actions and execute and deliver such documents as they deem necessary, appropriate or convenient to effect the foregoing resolutions including, without limitation, causing to be prepared and filed such reports, documents or other information as may be required under applicable law.
