### ***Scope and Nature of the ERISA Section 103(a)(3)(C) Audit***

We have performed audits of the financial statements of Way Station, Inc. Retirement Plan, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for plan benefits as of July 3, 2023, June 30, 2023 and June 30, 2022, and the related statements of changes in net assets available for plan benefits for the period July 1, 2023 through July 3, 2023 and the year ended June 30, 2023, and the related notes to the financial statements.

In our opinion, based on our audits and on the procedures performed as described in the Auditor's Responsibilities for the Audit of the Financial Statements section—

- the amounts and disclosures in the accompanying financial statements, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.

- the information in the accompanying financial statements related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

### ***Basis for Opinion***

We conducted our audits in accordance with auditing standards generally accepted in the United States of America (GAAS). Our responsibilities under those standards are further described in the Auditor's Responsibilities for the Audit of the Financial Statements section of our report. We are required to be independent of Way Station, Inc. Retirement Plan and to meet our other ethical responsibilities in accordance with the relevant ethical requirements relating to our audits. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our ERISA Section 103(a)(3)(C) audit opinion.

### ***Emphasis of Matter – Plan Merger***

As discussed in Note 1 to the financial statements, the trustees and Plan Administrator of the Way Station, Inc. Retirement Plan voted to merge the Plan into the Sheppard Pratt Health System 403(b) Retirement Plan effective July 3, 2023. All plan assets were transferred to the control of the Sheppard Pratt Health System 403(b) Retirement Plan on July 3, 2023. Our opinion has not been modified with respect to this matter.

### ***Responsibilities of Management for the Financial Statements***

Management is responsible for the preparation and fair presentation of the financial statements in accordance with accounting principles generally accepted in the United States of America, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

In preparing the financial statements, management is required to evaluate whether there are conditions or events, considered in the aggregate, that raise substantial doubt about Way Station, Inc. Retirement Plan's ability to continue as a going concern for one year after the date the financial statements are available to be issued.

Management is also responsible for maintaining a current plan instrument, including all plan amendments; administering the plan; and determining that the plan's transactions that are presented and disclosed in the financial statements are in conformity with the plan's provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.

### ***Auditor's Responsibilities for the Audit of the Financial Statements***

Except as described in the Scope and Nature of the ERISA Section 103(a)(3)(C) Audit of the Financial Statements section of our report, our objectives are to obtain reasonable assurance about whether the financial statements as a whole are free from material misstatement, whether due to fraud or error, and to issue an auditor's report that includes our opinion. Reasonable assurance is a high level of assurance but is not absolute assurance and therefore is not a guarantee that an audit conducted in

accordance with GAAS will always detect a material misstatement when it exists. The risk of not detecting a material misstatement resulting from fraud is higher than for one resulting from error, as fraud may involve collusion, forgery, intentional omissions, misrepresentations, or the override of internal control. Misstatements are considered material if there is a substantial likelihood that, individually or in the aggregate, they would influence the judgment made by a reasonable user based on the financial statements.

In performing an audit in accordance with GAAS, we:

- Exercise professional judgment and maintain professional skepticism throughout the audit.
- Identify and assess the risks of material misstatement of the financial statements, whether due to fraud or error, and design and perform audit procedures responsive to those risks. Such procedures include examining, on a test basis, evidence regarding the amounts and disclosures in the financial statements.
- Obtain an understanding of internal control relevant to the audit in order to design audit procedures that are appropriate in the circumstances, but not for the purpose of expressing an opinion on the effectiveness of the Way Station, Inc. Retirement Plan's internal control. Accordingly, no such opinion is expressed.
- Evaluate the appropriateness of accounting policies used and the reasonableness of significant accounting estimates made by management, as well as evaluate the overall presentation of the financial statements.
- Conclude whether, in our judgment, there are conditions or events, considered in the aggregate, that raise substantial doubt about Way Station, Inc. Retirement Plan's ability to continue as a going concern for a reasonable period of time.

Our audits did not extend to the certified investment information, except for obtaining and reading the certification, comparing the certified investment information with the related information presented and disclosed in the financial statements, and reading the disclosures relating to the certified investment information to assess whether they are in accordance with the presentation and disclosure requirements of accounting principles generally accepted in the United States of America.

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audit.

The supplemental Schedule H, Part IV, line 4i – Schedule of Assets (Held at Year End) as of June 30, 2023 and Schedule H, Part IV, line 4a – Schedule of Delinquent Participant Contributions for the year ended June 30, 2023 and for the period July 1, 2023 to July 3, 2023 are presented for purposes of additional analysis and are not a required part of the financial statements but are supplementary information required by the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Such information is the responsibility of management and was derived from and relates

directly to the underlying accounting and other records used to prepare the financial statements. The information included in the supplemental schedules, other than that agreed to or derived from the certified investment information, has been subjected to auditing procedures applied in the audit of the financial statements and certain additional procedures, including comparing and reconciling such information directly to the underlying accounting and other records used to prepare the financial statements or to the financial statements themselves, and other additional procedures in accordance with GAAS. For information included in the supplemental schedule that agreed to or is derived from the certified investment information, we compared such information to the related certified investment information.

In forming our opinion on the supplemental schedules, we evaluated whether the supplemental schedules, other than the information agreed to or derived from the certified investment information, including their form and content, are presented in conformity with the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA.

### NOTE 1 DESCRIPTION OF PLAN

---

The following description of the Way Station, Inc. Retirement Plan (the Plan) is provided for general information purposes only. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

#### *General*

The Plan is a 403(b) defined contribution plan, which was established on July 1, 1997 and covers all employees of Way Station, Inc. (the Company). Employees are eligible to participate immediately upon employment. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 ("ERISA").

#### *Plan Merger*

Effective July 3, 2023, the Plan merged into the Sheppard Pratt Health System 403(b) Retirement Plan. In connection with the merger, the Plan transferred net assets of \$8,478,551 into the Sheppard Pratt Health System 403(b) Plan on July 3, 2023 when legal control was assumed by the Sheppard Pratt Health System 403(b) Plan. The transfer was the only activity for the period from July 1, 2023 through July 3, 2023.

#### *Contributions*

Participants may contribute a portion of their annual compensation, as defined by the Plan, not to exceed the maximum amount allowed under the Internal Revenue Code. Participants who have attained age 50 before the end of the Plan year and participants with more than 15 years of service may make additional contributions, subject to limitations imposed by the Code. Also, those participants who have at least fifteen years of service with the Company may contribute a special section 403(b) catch-up contribution to the Plan. Participants may also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans (rollover). The Plan also features an automatic enrollment provision whereby all newly eligible employees are automatically enrolled at 2% unless they affirmatively elect to defer a different percentage or to not participate in the Plan.

The Company may contribute a discretionary matching contribution to participants who have worked 1,000 hours in a Plan year and are employed at the end of the Plan year except in the case of death, disability, retirement or military service. During the year ended June 30, 2023, the Company did not make a discretionary matching contribution.

The Company may also contribute a discretionary non-elective contribution to participants who have worked 1,000 hours in a Plan year and are employed at the end of the Plan year except in the case of death, disability, retirement or military service. For the year ended June 30, 2023, the Company discretionary non-elective contributions totaled \$211,202 for eligible participants.

Both participant and employer contributions are subject to limitations under applicable provisions of the Internal Revenue Code.

#### *Participant's Accounts*

Each participant's account is invested in accordance with the participant's instructions in one or more funds selected and approved by the Plan. Each participant's account is credited with the participant's contributions and Company matching contributions, as well as allocations of the Company's discretionary contribution and Plan earnings (losses). Participant accounts are charged with an allocation of administrative expenses that are paid by the Plan. Allocations are based on participant earnings, account balances, or specific participant transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

#### *Vesting*

Participants are immediately vested in their voluntary contributions and rollover contributions plus actual earnings thereon. Participants who are active on or after July 1, 2022 are also immediately vested in their employer contributions. Vesting in the Company's discretionary matching contribution and the Company's non-elective discretionary contribution portion of their accounts for those participants who terminated prior to July 1, 2022 is based on years of continuous service. Participants automatically become fully vested upon reaching normal retirement age (65 years old), or in the event of disability or death.

Vesting in the Company's discretionary matching contribution and the Company's non-elective discretionary contribution portion of their accounts for participants who terminated prior to July 1, 2022 is based on years of service as follows:

#### *Notes Receivable from Participants*

Participants may borrow from their fund accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50 percent of their vested account balance. Loan terms may not exceed 5 years except for loans for the purchase of a principal residence. The loans are secured by the balance in the participant's account and bear interest at one percent in excess of the prime rate, as defined. Principal and interest are paid ratably through bi-weekly payroll deductions.

#### *Forfeited Accounts*

At June 30, 2023 and 2022, forfeited non-vested accounts totaled \$17,122 and \$17,068, respectively. These accounts will be used to offset future Company contributions or pay administrative expenses. During the year ended June 30, 2023, the amount of forfeitures used to reduce Company contributions for the year totaled \$13,079. This amount was used to reduce the Company contribution receivable as of June 30, 2023.

#### *Payment of Benefits*

Benefits under the Plan become distributable to participants (or their beneficiary, in the event of death) upon termination of employment, on or after normal retirement at age 65, disability or upon death, attainment of age 59 ½, or qualified reservist duty. Benefit payments are made as a lump sum distribution or rollover into a qualified plan. Upon termination of service, participants with vested account balances of \$1,000 to \$5,000 that meet the provisions for a mandatory distribution will be paid as a direct rollover to an affiliate of Principal Life Insurance Company if the participant does not elect the distribution method. Distributions of account balances less than \$1,000 that meet the provisions for a mandatory distribution will automatically be paid to participants as a cash distribution if the participant does not elect the distribution method. Participants may also elect to withdraw all or any part of rollover contributions into the Plan at any time. In addition, hardship distributions are permitted if certain criteria are met.

### NOTE 2 SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

---

#### *Basis of Accounting*

The financial statements of the Plan are prepared on the accrual basis of accounting.

#### *Use of Estimates*

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

#### *Investment Valuation and Income Recognition*

The Plan's investments are stated at fair value (except for fully benefit-responsive investment contracts, which are reported at contract value). Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan Sponsor determines the Plan's valuation policies utilizing information provided by the investment advisers and the custodian. See Note 4 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the plan's gains and losses on investments bought and sold as well as held during the year.

#### *Notes Receivable from Participants*

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred. No allowance for credit losses has been recorded as of June 30, 2023 and 2022.

#### *Payments of Benefits*

Benefits are recorded when paid.

#### *Expenses*

Certain expenses of maintaining the Plan are paid by the Plan, unless otherwise paid by the Company. Expenses that are paid by the Company are excluded from these financial statements. Fees related to the administration of notes receivable from participants are charged directly to the participant's account and are included in administrative expenses. Investment related expenses are included in net appreciation in fair value of investments.

### NOTE 3 INFORMATION CERTIFIED BY THE PLAN CUSTODIAN

Following is a summary of the unaudited information included in the Plan's financial statements and supplemental schedule that was prepared by the custodian of the Plan, and furnished to the Plan Administrator. The Plan Administrator has obtained a certification from the custodian that such information is complete and accurate.

A – Certified investment statement certified to \$7,930,445 of assets transferred out of the Plan as of June 30, 2023 however, trade date of transfer was not effective until July 3, 2023. Therefore, balance reflected on the June 30, 2023 financial statements reflects these funds as an asset at June 30, 2023 since settlement did not occur until July 3, 2023.

B – The difference of \$145,509 compared to the balance on the statement of net assets available for plan benefits as of June 30, 2023 is due to Principal certifying the loans being transferred out of the Plan on June 30, 2023. ### NOTE 4 FAIR VALUE MEASUREMENTS

---

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1) and the lowest priority to unobservable inputs (level 3). The three levels of the fair value hierarchy under FASB ASC 820 are described as follows:

**Level 1** – Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

**Level 2** – Inputs to the valuation methodology include:

- quoted prices for similar assets or liabilities in active markets;
- quoted prices for identical or similar assets or liabilities in inactive markets;
- inputs other than quoted prices that are observable for the asset or liability;
- inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the level 2 input must be observable for substantially the full term of the asset or liability.

**Level 3** – Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at June 30, 2023 and 2022.

#### ***Registered Investment Companies (i.e. Mutual Funds)***

Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the SEC. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

### NOTE 5 PRINCIPAL FIXED INCOME GUARANTEED OPTION

The Plan maintains a fully benefit-responsive guaranteed investment contract with Principal Life Insurance Company totaling \$159,972 and \$497,635 for June 30, 2023 and 2022, respectively. Principal maintains the contributions in a general account. The account is credited with earnings on the underlying investments and charged for participant withdrawals and administrative expenses. The guaranteed investment contract issuer is contractually obligated to repay the principal and a specified interest rate that is guaranteed to the plan. The crediting rate is based on a formula established by the contract issuer but may not be less than zero percent. Such interest rates are reviewed on a monthly or quarterly basis for resetting. The guaranteed investment contract does not permit the insurance company to terminate the agreement prior to the scheduled maturity date.

This contract meets the fully benefit-responsive investment contract criteria and therefore is reported at contract value. Contract value is the relevant measure for fully benefit-responsive investment contracts because this is the amount received by participants if they were to initiate permitted transactions under the terms of the Plan. Contract value, as reported to the Plan by Principal, represents contributions made under the contract, plus earnings, less participant withdrawals and administrative expenses. Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investment at contract value.

The Plan's ability to receive amounts due is dependent on the issuer's ability to meet its contractual obligations, which may be affected by future economic and regulatory developments.

Certain events might limit the ability of the Plan to transact at contract value with the contract issuer. Such events include (1) amendments to the Plan documents (including complete or partial Plan termination or merger with another plan), (2) changes to the Plan's prohibition on competing investment options or deletion of equity wash provisions, (3) bankruptcy of the Plan sponsor or other Plan sponsor events (for example, divestitures or spin-offs of a subsidiary) that cause a significant withdrawal from the Plan, or (4) the failure of the trust to qualify for

exemption from federal income taxes or any required prohibited transaction exemption under ERISA (5) premature termination of the contract. No events are probable of occurring that might limit the ability of the Plan to transact at contract value with the contract issuers and that also would limit the ability of the plan to transact at contract value with the participants.

In addition, certain events allow the issuer to terminate the contracts with the Plan and settle at an amount different from contract value. Such events include (1) an uncured violation of the Plan's investment guidelines, (2) a breach of material obligation under the contract, (3) a material misrepresentation, (4) a material amendment to the agreement without the consent of the issuer.

### NOTE 6 RELATED-PARTY TRANSACTIONS AND PARTY IN INTEREST TRANSACTIONS

---

Certain Plan investments are managed by Principal, the custodian as defined by the Plan, and therefore, these transactions qualify as party-in-interest transactions. Fees incurred by the plan for the investment management services are included in net appreciation in fair value of investments, as they are paid through revenue sharing, rather than a direct payment. The Plan made a direct payment to Principal of \$9,797 which was not covered by revenue sharing. The Plan Sponsor pays directly any other fees related to the plan's operations.

### NOTE 7 PLAN TERMINATION

---

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants would become 100 percent vested in their employer contributions.

### NOTE 8 TAX STATUS

---

The Plan adopted a non-standardized prototype plan with Principal, which received a favorable opinion letter from the Internal Revenue Service dated March 31, 2017, stating that the Plan is qualified under Section 403(b) of the Code and therefore, the related trust is exempt from taxation. Subsequent to the issuance of the opinion letter, the Plan has been amended. Once qualified, the Plan is required to operate in conformity with the Code to maintain its qualification. The Plan administrator believes that the Plan is designed and currently being operated in compliance with the applicable requirements of the Code. Therefore, no provision for income taxes has been included in the Plan's financial statements.

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the plan and recognize a tax liability if the plan has taken an uncertain position that more likely than not would not be sustained upon examination by the government authority. The Plan is subject to routine audits by taxing jurisdictions, generally for a period of three years after the returns are filed; however, there are currently no audits for any tax periods in progress.

### NOTE 9 RISKS AND UNCERTAINTIES

---

The Plan invests in various investment securities. Investment securities are exposed to various risks, such as interest rate, market, and credit risks. Market risks include global events which could impact the value of investment securities, such as a pandemic or international conflict. Due to level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for plan benefits.

### NOTE 10 DELINQUENT PARTICIPANT CONTRIBUTIONS

---

During the June 30, 2023 plan year, the Plan Sponsor failed to remit certain participant contributions and loan repayments to the Plan totaling \$2,234. The Company is in the process of determining the lost earnings to be funded on all delinquent participant contributions and loan repayments. See the attached Schedule of Delinquent Participant Contributions for pay dates and amounts.
