### *Scope and Nature of the ERISA Section 103(a)(3)(C) Audit*

We have performed audits of the financial statements of the Dorsey School of Business, Inc 401(k) Plan (the "Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits in liquidation as of July 25, 2023 (date of termination) and December 31, 2022, and the related statement of changes in net assets available for benefits in liquidation for the period from January 1, 2023 through July 25, 2023 (date of termination), and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's (DOL) Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the Plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the DOL's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from a qualified institution as of July 25, 2023 and December 31, 2022 and for the period from January 1, 2023 to July 25, 2023, stating that the certified investment information, as described in Note 3 to the financial statements, is complete and accurate.

### *Opinion*

In our opinion, based on our audits and on the procedures performed as described in the *Auditors' Responsibilities for the Audit of the Financial Statements* section of our report,

- the amounts and disclosures in the accompanying financial statements, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America ("GAAP").
- the information in the accompanying financial statements related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management has determined meets the requirements of ERISA Section 103(a)(3)(C).

### ***Basis for Opinion***

We conducted our audits in accordance with auditing standards generally accepted in the United States of America ("GAAS"). Our responsibilities under those standards are further described in the *Auditors' Responsibilities for the Audit of the Financial Statements* section of our report. We are required to be independent of the Plan and to meet our other ethical responsibilities, in accordance with the relevant ethical requirements relating to our audits. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our ERISA Section 103(a)(3)(C) audit opinion.

### ***Emphasis of Matter - Basis of Accounting***

As discussed in Note 1(a) to the financial statements, the Plan Sponsor's Board of Directors approved a plan of liquidation with a termination date of July 25, 2023, and accordingly, determined liquidation was imminent. As a result, the Plan has changed its basis of accounting from the going concern basis used in presenting the 2022 financial statements to the liquidation basis used in presenting the 2023 financial statements. Our opinion is not modified with respect to this matter.

### ***Responsibilities of Management for the Financial Statements***

Management is responsible for the preparation and fair presentation of the financial statements in accordance with GAAP, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

Management is also responsible for maintaining a current plan instrument, including all plan amendments, administering the Plan, and determining that the Plan's transactions that are presented and disclosed in the financial statements are in conformity with the Plan's provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.

### ***Auditors' Responsibilities for the Audit of the Financial Statements***

Except as described in the *Scope and Nature of the ERISA Section 103(a)(3)(C) Audit* section of our report, our objectives are to obtain reasonable assurance about whether the financial statements as a whole are free from material misstatement, whether due to fraud or error, and to issue an auditors' report that includes our opinion. ### (1) Description of plan

The following description of the Dorsey School of Business, Inc 401(k) Plan (the "Plan") provides only general information. Participants should refer to the plan agreement for a more complete description of the Plan's provisions.

#### (a) General

The Plan was a defined contribution plan which was adopted to provide retirement benefits for employees of Dorsey School of Business, as well as Taylortown School of Beauty Inc. and Dorsey Training Direct LLC, who were considered adopting employers (collectively, the "Employer or "Plan Sponsor"). The Plan covered substantially all full-time employees who were age twenty one or older and had completed three months of service ("participant"). Eligible employees could begin participating in the Plan on the earliest monthly date when the eligibility requirements are met. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 ("ERISA").

The Plan Sponsor's Board of Directors approved a plan of liquidation of the Plan and accordingly, determined liquidation was imminent. As a result, the Plan changed its basis of accounting from going concern basis used in presenting the 2022 financial statements to the liquidation basis used in presenting the 2023 financial statements and all participants were considered to be fully vested in their accounts. All participants account balances and Plan assets were transferred out of the Plan as of July 25, 2023.

#### (b) Contributions

Prior to July 25, 2023, participants could voluntarily make qualified retirement contributions to the Plan which could be after-tax Roth deferrals or pre-tax deferrals deductible by the participants for federal income tax purposes under Section 401(k) of the Internal Revenue Code ("IRC"). Participants could also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans. Participants direct the investment of their contributions into various investment options offered by the Plan. Participant contributions are permitted up to 100% of compensation subject to certain IRC limitations.

The Plan automatically enrolled all newly eligible employees at a deferral rate of 5%, unless the employee elected to not participate in the Plan or elected otherwise. Each enrolled employee's deferral percentage automatically increased by 1% per year up to 8%.

The Plan also provided that the Employer could contribute a discretionary matching contribution to be determined by the Employer each plan year. The Employer matched 1% of the eligible participant's compensation for those employees who elected a salary deferral.

The Plan also provided that the Employer may contribute a discretionary profit sharing contribution. The participant's share of the discretionary contribution would be the same percentage of compensation for all eligible participants. The percentage is determined by dividing the total profit sharing contribution by the total of all participants' compensation. Profit sharing contributions made by the Employer were allocated to the employee's profit sharing account as of the last day of the plan year. There were no profit-sharing contributions in 2023.

(c) Participant accounts

Each participant's account was credited (charged) with the participant's contributions, Plan Sponsor contributions, investment earnings (losses), and administrative expenses. Allocations are based on participant's compensation or account balances as defined in the plan agreement. The benefit to which a participant was entitled was the benefit that can be provided from the participant's vested account.

(d) Vesting

Participants were immediately vested in their elective salary deferral, Roth contributions, and Employer contributions plus actual earnings and losses thereon.

(e) Participant notes receivable

Participants could borrow from their accounts a minimum of \$500 up to a maximum equal to the lesser of \$50,000 or 50% of their account balance. The notes receivable were secured by the balance in the participant's account and bore interest at fixed rates ranging from 5.25% to 10.00%, which was commensurate with local prevailing rates as determined quarterly by the plan administrator. Principal and interest was paid ratably through payroll deductions.

(f) Payment of benefits

On termination of service due to death, permanent disability, or retirement, a participant could elect to receive a lump-sum payment equal to his or her entire account.

(g) Hardship withdrawals

The Plan permitted distributions in the event of a hardship, as defined in the plan agreement. These distributions were taxable and subject to a tax penalty equal to 10% of the hardship distribution amount if the participant is younger than age 59½. Hardship withdrawals was limited to the participant's elective account balance.

**(h) Administrative expenses**

Certain expenses of maintaining the Plan were paid directly by the Plan Sponsor and are excluded from these financial statements. Contract administrator fees are included in administrative expenses. Certain fees incurred by the Plan are charged against the funds and reflected in the value of the Plan's investments.

**(2) Summary of significant accounting policies**

**(a) Basis of accounting**

As described in Note 1 of the financial statements, the Plan Sponsor elected to terminate the Plan. In accordance with accounting principles generally accepted in the United States of America ("GAAP"), the Plan has changed its basis of accounting as of and for the period from January 1, 2023 to July 25, 2023, from going concern to the liquidation basis.

**(b) Investment valuation and income recognition**

Investments were reported at fair value as reported by Delaware Charter Guarantee & Trust Company d/b/a Principal Trust Company ("Principal Trust Company"). Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The investment values are discussed more fully in Note 4 and Note 5. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year. Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividend income is recorded on the ex-dividend date.

**(c) Participant notes receivable**

Participant notes receivable were measured at their unpaid principal balance plus any accrued but unpaid interest. Delinquent participant notes were reclassified as distributions based upon the terms of the plan document.

**(d) Payment of benefits**

Benefits were recorded when paid.

**(e) Use of estimates**

The preparation of financial statements in conformity with U.S. GAAP requires management to make estimates and assumptions that affect the reported amounts of net assets available for benefits and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

(f) Events occurring after reporting date

The Plan Sponsor has evaluated events and transactions that occurred between July 25, 2023 and May 14, 2024, which is the date that the financial statements were available to be issued, for possible recognition or disclosure in the financial statements.

(3) Certified information

Certain information related to investments reported and disclosed in the accompanying financial statements including the fair value or contract value of investments and notes receivable from participants held at July 25, 2023 and December 31, 2022, and net appreciation in fair value of investments; dividends, interest, and interest on notes receivable from participants for the period from January 1, 2023 through July 25, 2023, was obtained or derived from information supplied to the plan administrator and certified as complete and accurate by Principal Trust Company.

(4) Fair value measurements

Fair value is a market-based measurement, not an entity-specific measurement. Therefore, a fair value measurement should be determined based on the assumptions that market participants would use in pricing the asset or liability. As a basis for considering market participant assumptions in fair value measurements, fair value accounting standards establish a fair value hierarchy that distinguishes between market participant assumptions based on market data obtained from sources independent of the reporting entity including quoted market prices in active markets for identical assets (Level 1), or significant other observable inputs (Level 2) and the reporting entity's own assumptions about market participant assumptions (Level 3). The Plan does not have any fair value measurements using significant unobservable inputs (Level 3) as of December 31, 2022.

The asset's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs. The following is a description of the valuation methodology used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2022.

- (i) *Mutual funds*: Valued based on the funds' reported closing net asset values ("NAV") of shares held by the Plan as of the last business day of the plan year. The mutual funds are deemed to be actively traded.

The method described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan's management believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

**(5) Investment contract with insurance company**

The Plan had a traditional benefit-responsive investment contract with Principal Life Insurance Company ("Principal Life") totaling \$169,906 as of December 31, 2022. Principal maintained the Plan's contributions in a general account which was credited with earnings on the underlying investments and charged for participant withdrawals and administrative expenses. The guaranteed insurance contract issuer were contractually obligated to repay the principal and a specified interest rate that was guaranteed to the Plan.

This contract met the fully benefit-responsive investment contract criteria and therefore was reported at contract value. Contract value is the relevant measure for fully benefit-responsive investment contracts because this is the amount received by participants if they were to initiate permitted transactions under the terms of the Plan. Contract value, as reported to the Plan by Principal Trust Company, represented contributions made under the contract, plus earnings, less participant withdrawals and administrative expenses. Participants could ordinarily direct the withdrawal or transfer of all or a portion of their investment at contract value.

The Plan's ability to receive amounts due was dependent on the issuer's ability to meet its financial obligations. The issuer's ability to meet its contractual obligations could be affected by future economic and regulatory developments.

### (6) Income tax status

The Plan Sponsor adopted a non-standardized pre-approved profit sharing plan, which received a favorable opinion letter from the Internal Revenue Service ("IRS") on June 30, 2020, which stated that the pre-approved plan was designed in accordance with the applicable sections of the IRC. The Plan itself had not received a determination letter from the IRS stating that the Plan was qualified under Section 401(a) of the IRC. However, the plan administrator believed that the adopted pre-approved plan was designed, as amended, and is currently being operated in compliance with the applicable requirements of the IRC and is therefore, qualified and exempt from taxation.

U.S. GAAP requires plan management to evaluate tax positions taken by the Plan and recognize a tax liability or asset if the Plan had taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The plan administrator had analyzed the tax positions taken by the Plan, and has concluded that as of July 25, 2023, there are no uncertain positions taken or expected to be taken that would require recognition of a liability or asset or disclosure in the financial statements. The Plan was subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

### (7) Related party and party-in-interest transactions

Certain Plan investments were pooled separate accounts, collective trusts funds and an insurance contract managed by Principal Life and Principal Trust Company and, therefore, these transactions qualified as party-in-interest transactions under ERISA. As described in Note 1, the Plan paid expenses to various service providers and held participant notes receivable which also qualify as party-in-interest transactions.
