INDEPENDENT AUDITORS' REPORT

To the Trustees of the

SCOPE AND NATURE OF THE ERISA SECTION 103(A)(3)(C) AUDIT

We performed audits of the accompanying financial statements of the Daycon Products Company, Inc. 401(k) Plan (Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) [ERISA Section 103(a)(3)(C) audit]. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the Plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

BASIS FOR OPINION

We conducted our audits in accordance with auditing standards generally accepted in the United States of America. Our responsibilities under those standards are further described in the Auditors' Responsibilities for the Audits of the Financial Statements section of our report. We are required to be independent of the Plan and to meet our other ethical responsibilities in accordance with the relevant ethical requirements relating to our audits. We believe that the audit evidence we obtained is sufficient and appropriate to provide a basis for our ERISA Section 103(a)(3)(C) audit opinion.

EMPHASIS OF MATTER – PLAN TERMINATION

As discussed in Note 1 to the financial statements, the Board of Directors of Daycon Products Company, Inc. (Company) made a decision to terminate the Plan and transfer balances to the Envoy Solutions Retirement Savings Plan effective July 31, 2023. Our opinion is not modified with respect to this matter.

RESPONSIBILITIES OF MANAGEMENT FOR THE FINANCIAL STATEMENTS

Management is responsible for the preparation and fair presentation of these financial statements in accordance with accounting principles generally accepted in the United States of America; this includes the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

Management is also responsible for maintaining a current Plan instrument, including all Plan amendments; administering the Plan; and determining that the Plan's transactions presented and disclosed in the financial statements are in conformity with the Plan's provisions, including maintaining sufficient records with respect to each of the participants to determine the benefits due or which may become due to such participants.

AUDITORS' RESPONSIBILITIES FOR THE AUDITS OF THE FINANCIAL STATEMENTS

Except as described in the Scope and Nature of the ERISA Section 103(a)(3)(C) Audit section of our report, our objectives are to obtain reasonable assurance about whether the financial statements as a whole are free from material misstatement, whether due to fraud or error, and to issue an auditors' report that includes our opinion. Reasonable assurance is a high level of assurance but is not absolute assurance and, therefore, is not a guarantee that an audit conducted in accordance with generally accepted auditing standards will always detect a material misstatement when it exists. NOTE 1 **DESCRIPTION OF PLAN**

The following brief description of the Daycon Products Company, Inc. 401(k) Plan (Plan) is provided for general information purposes only. Participants should refer to the Plan documents or the Summary Plan Description for more complete information.

GENERAL

The Plan is a defined-contribution plan open to all employees of Daycon Products Company, Inc. and its subsidiaries (collectively referred to as the Company). Full-time employees who are at least 21 years old and complete 30 days of service with the Company are eligible to participate. Part-time employees who are at least 21 years old and who complete one year of service with the Company are eligible to participate. Once these requirements are met, participants may enter the Plan on the first Plan year quarter. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

Effective July 31, 2023, the Plan was terminated and balances were transferred to the Envoy Solutions Retirement Savings Plan.

CONTRIBUTIONS

Each year, participants may contribute up to 100% of pretax or after-tax annual compensation, as defined in the Plan, subject to certain annual limitations in the Internal Revenue Code. For the period from January 1, 2023 to July 31, 2023, the Company contributed 50% of the first 6% of base compensation. Additional amounts may be contributed at the discretion of the Company's management.

PARTICIPANT ACCOUNTS

Each participant's account is credited with the participant's contribution, any Company contributions, and an allocation of any Plan earnings. Participants' accounts are charged with an allocation of administrative expenses. Allocations are based on participants' earnings or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

INVESTMENT OPTIONS

Upon enrollment in the Plan, a participant may direct contributions to specified investment options. Specific information regarding these options may be obtained from the Plan Administrator. Participants may change their investment options at any time.

(See Independent Auditors' Report)

NOTES RECEIVABLE FROM PARTICIPANTS

Participants may borrow an amount from the Plan collateralized by their account balances. The maximum loan permitted is the lesser of (1) \$50,000 or (2) 50% of the participant's vested account balance. Principal and interest are paid ratably through payroll deductions. Loans mature within five years or a period to be determined by the Plan Administrator for the purchase of a primary residence.

VESTING

Participants are immediately vested in their contributions plus actual earnings thereon. A participant's interest in Company contributions becomes fully vested and nonforfeitable upon six years of service, retirement, disability, or death, as defined by the Plan.

PAYMENT OF BENEFITS

In the case of normal retirement, retirement due to permanent disability, or termination of employment, a participant may elect to receive the value of the participant's account in a lump-sum distribution or mutually agreed-upon alternative manner. If a participant dies before retirement, the beneficiary will receive the value of the participant's account in a lump-sum distribution or mutually agreed-upon alternative manner.

ADMINISTRATIVE EXPENSES

Certain administrative expenses of the Plan are paid by the Company and excluded from these financial statements. In addition, the Company provides services to the Plan without charge.

FORFEITED ACCOUNTS

At July 31, 2023 and December 31, 2022, forfeited nonvested accounts totaled \$21,811 and \$10,731, respectively. The forfeiture balance at July 31, 2023 was transferred to the Envoy Plan. These accounts will be used to reduce the Company's contributions in accordance with the Plan documents. In 2023, the Company's contributions were reduced by forfeitures of \$11,443.

SUBSEQUENT EVENTS

The Plan evaluated subsequent events and transactions for potential recognition or disclosure in the financial statements through May 10, 2024, the date the financial statements were available to be issued.

NOTE 2 SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

ACCOUNTING STANDARDS CODIFICATION

All references in the financial statements to the Codification refer to the Accounting Standards Codification and the Hierarchy of Generally Accepted Accounting Principles (GAAP) issued by the Financial Accounting Standards Board. The Codification is the single source of authoritative GAAP in the United States.

BASIS OF ACCOUNTING

The accompanying financial statements were prepared on the accrual basis of accounting.

USE OF ESTIMATES

The preparation of financial statements in conformity with GAAP requires management to make estimates and assumptions that affect the amounts reported in the financial statements and accompanying notes. Actual results could differ from those estimates.

VALUATION OF INVESTMENTS

Investments are stated at fair value except for fully benefit-responsive investment contracts, which are reported at contract value. See Note 4 for a discussion of fair value measurements.

PAYMENTS OF BENEFITS

Benefits are recorded when paid.

RISK AND UNCERTAINTIES

The Plan provides for investments in various investment securities, which are exposed to various risks, such as interest rate, credit, and overall volatility. Due to the level of risk associated with certain investment securities, it is reasonably possible that changes in the values of investment securities will occur in the near term, and such changes could materially affect the amounts reported in the Statements of Net Assets Available for Benefits.

NOTES RECEIVABLE FROM PARTICIPANTS

Notes receivable from participants are carried at their unpaid principal balance plus accrued interest. Delinquent participant loans are reclassified as distributions based upon the terms of the Plan documents.

NOTE 3 INFORMATION CERTIFIED BY THE CUSTODIANS

Plan investments were held by the Custodians, Principal Trust Company and Principal Life Insurance Company, at July 31, 2023 and December 31, 2022. Financial information related to those investments is included in the accompanying financial statements based on information certified as complete and accurate by the Custodians. That information, which was not audited by independent auditors, is summarized below.

NOTE 4 VALUATION OF INVESTMENTS

Investments are recorded at fair value in accordance with the provisions of the Fair Value Measurements and Disclosures Topic of the Codification, which establishes a framework for measuring fair value. The framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements). The three levels of the fair value hierarchy under the Codification are described below:

Level 1 Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 Inputs to the valuation methodology include:

Quoted prices for similar assets or liabilities in active markets;

Quoted prices for identical or similar assets or liabilities in inactive markets;

Inputs other than quoted prices that are observable for the asset or liability;
Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Below are descriptions of the valuation methodologies used for assets measured at fair value. There was no change in the methodologies used at July 31, 2023 and December 31, 2022.

Mutual Funds: Valued at the net asset value (NAV) of shares held by the Plan at year end. NAV is based on the value of the underlying assets owned by the fund, minus its liabilities, and then divided by the number of shares outstanding. NAV is a quoted price in an active market.

Pooled Separate Accounts: Valued using NAV per unit. The NAV is based on the value of the underlying investments owned by each fund, minus its liabilities, and then divided by the number of units outstanding. Participant-initiated transactions may occur daily at NAV.

The methods described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

NOTE 5 **GUARANTEED INVESTMENT CONTRACT**

The Plan has an investment in the Principal Fixed Income Guaranteed Option Account, which is a fully benefit-responsive investment contract and, therefore, reported at contract value. Contract value, as reported to the Plan by Principal Life Insurance Company (Principal), represents contributions made under the fund, plus earnings, less participant withdrawals and administrative expense. Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investment at contract value.

There are no reserves against contract value for credit risk of the contract issuer or otherwise. Certain events limit the Plan's ability to transact at contract value with Principal. Such events include the following: (a) amendments to the Plan documents (including complete or partial Plan termination or merger with another plan), (b) changes to the Plan's prohibition on competing investment options or deletion of equity wash provisions, (c) bankruptcy of the Plan sponsor or other Plan sponsor events (for example, divestitures or spin-offs of a subsidiary) that cause a significant withdrawal from the Plan, or (d) the failure of the trust to qualify for exemption from federal income taxes or any required prohibited transaction exemption under ERISA. Furthermore, certain events would allow the issuer to terminate the contract with the Plan and settle at an amount different from contract value. Examples of such events include (a) an uncured breach of the Plan's investment guidelines, (b) a material amendment to the contract without the issuer's consent, (c) a violation of a material obligation under the contract, or (d) a material misrepresentation. The Plan Administrator does not believe any events that would limit the Plan's ability to transact at contract value with Plan participants or the issuer are probable of occurring.

The guaranteed investment contract does not permit the insurance company to terminate the agreement prior to the scheduled maturity date.

NOTE 6 TAX STATUS

The Plan adopted a prototype standardized profit-sharing plan with a cash or deferred arrangement that received its most recent favorable opinion letter from the Internal Revenue Service (IRS) on March 31, 2008, which stated the Plan and related trust were designed in accordance with applicable requirements of the IRS. The Plan since was amended. The Plan Administrator believes the Plan is currently designed and being operated in compliance with the applicable requirements of the Internal Revenue Code. Therefore, no provision for income taxes was included in the Plan’s financial statements.

GAAP requires Plan management to evaluate uncertain tax positions for recognition in the financial statements. The Plan Administrator concluded that there were no uncertain tax positions taken as of July 31, 2023.

NOTE 7 RELATED-PARTY TRANSACTIONS

The Plan pays investment management and recordkeeping fees to parties in interest. The Plan paid approximately \$73,000 to parties in interest for the period from January 1, 2023 to July 31, 2023. These party-in-interest transactions are exempt from the prohibited transaction rules of ERISA.

In addition, administrative fees were paid indirectly through revenue sharing and are included in the net appreciation in fair value of investments.
