As a result, the Plan changed its basis of accounting from the ongoing basis of accounting used in presenting the 2022 financial statements to the liquidation basis of accounting used in presenting the 2023 financial statements. Our opinion is not modified with respect to this matter.

Responsibilities Of Management For The Financial Statements

NOTES TO FINANCIAL STATEMENTS

September 30, 2023 And 2022

1. Description Of The Plan

The following description of the Spectrum Pharmaceuticals, Inc. 401(k) Plan (the Plan) is provided for general information purposes only. Participants should refer to the Plan Document for a more complete description of the Plan's provisions.

General

The Plan was a defined contribution pension plan covering eligible employees of Spectrum Pharmaceuticals, Inc. (the Company or Spectrum) as defined in the Plan Document. The Plan was adopted January 1, 1990, and established for the purpose of providing retirement benefits for eligible employees of the Company. The Plan was subject to regulation under the Employee Retirement Income Security Act of 1974 (ERISA), as amended, and the qualification provisions of the Internal Revenue Code (the Code).

Thomas Riga, Chief Executive Officer and Keith McGahan, Executive Vice President and Chief Legal Officer were the trustees of the Plan. Matrix Trust Company, LLC, (Matrix Trust) served as the account custodian for the Plan. Digital Retirement Solutions, Inc. (DRS) performed administrative and record keeping services for the Plan.

Effective July 31, 2023, the Plan sponsor was acquired by another entity, and as a result management terminated the Plan and liquidated all participant accounts as of September 8, 2023. All participants became immediately vested in their accounts upon termination of the Plan.

On January 5, 2022, the Plan Sponsor, Spectrum Pharmaceuticals, Inc., finalized an agreement to restructure the workforce by 30%, which resulted in a partial plan termination. As a result, the affected participants were determined to be 100% vested in their accounts notwithstanding their credited services.

Eligibility

All Company employees were eligible to participate in the Plan, provided the employee had completed three months of employment. An eligible employee could enter the Plan on the first day of the month following the satisfaction of the eligibility requirements.

Notes To Financial Statements (*Continued*)

In the event of the Company's acquisition of a business, the employees of the newly acquired entity were given credit for the years of service earned prior to the Company's ownership. If this credit for prior service allowed such employees to meet Plan eligibility requirements, each had the option of participating in the Plan on the first day of the month following the business acquisition date.

Contributions

Each year, participants could elect to make pre-tax contributions up to 75% of their eligible compensation, as defined in the Plan Document. In addition, participants could elect to make after-tax (Roth) contributions up to 75% of their eligible compensation. Compensation deferrals could not exceed the maximum deferral, as determined by the Internal Revenue Service (IRS) each year. Employees who attained the age of 50 before the end of the Plan year were eligible to make additional catch-up contributions. Participants could also make rollover contributions into the Plan from other qualified plans.

The Company provided matching contributions, under a safe harbor arrangement, equal to 100% of the first 3% of eligible compensation deferred by a participant and 50% of the next 2% of eligible compensation deferred by a participant. The Company's matching contribution made on behalf of any participant for any Plan year could not exceed 4% of their eligible compensation.

The Company also provided a discretionary profit sharing contribution to the Plan. The allocation conditions of this discretionary profit sharing contribution included: (i) all employees who were employed on the last day of the Plan year, and (ii) all employees who completed 1,000 hours of service during the Plan year, except for reasons including death, disability, or termination of employment after normal retirement age (defined as 65 years of age). The profit sharing contribution for the period beginning January 1, 2023 and ended September 8, 2023 was 0.75% of an employee's compensation. There was no profit sharing contribution for the year ended December 31, 2022.

Participant Accounts

Each participant's account was credited with the participant's contributions, the Company's contributions and an allocation of Plan earnings (losses). Participant accounts were charged with an allocation of administrative expenses that were paid by the Plan. Allocations were based on participant earnings (losses), account balances, or specific participant transactions, as defined by the Plan. The benefit to which a participant was entitled was the benefit that could be provided from the participant's vested account balance.

Notes To Financial Statements *(Continued)*

Investment Options

Participants directed the investment of their contributions and the Company's safe harbor matching and discretionary profit sharing contributions into various investment options offered by the Plan. These options included numerous registered investment companies and a collective trust fund. Participants could change their investment elections at any time for both existing account balances and future contributions.

Vesting

Participants were immediately vested in deferrals and rollover contributions and Company safe harbor matching contributions. Vesting in the Company's profit sharing contribution portion of their accounts was based on years of service. A participant vests 20% each year after the second year of service and was fully vested after six years of service or upon reaching normal retirement age (age 65), death, or total and permanent disability. All participants became immediately vested in their accounts upon termination of the Plan.

Forfeitures

Although participant contributions and the Company's safe harbor matching contributions were fully vested at all times, forfeitures could result from the Company's discretionary profit sharing contributions and certain excess matching contributions. Excess Company matching contributions results in a credit to the Plan and are held in a separate account for the payment of Plan administrative expenses or allowed Company contributions. During the period beginning January 1, 2023 and ended September 8, 2023 and the year ended December 31, 2022, \$6,539 and \$7,456, respectively, was used to pay administrative expenses. At September 8, 2023, there were no amounts held in this account. At December 31, 2022, there was \$6,525 held in this account.

Notes Receivable From Participants

Loans to participants were secured by the participant's account balance and could not exceed the lesser of 50% of the participant's account balance or \$50,000 in the aggregate for any individual participant. Loans bore interest at fixed annual rates, as determined by the Plan trustees, that were the prime interest rate plus two percent on the date the loan was processed. Principal and interest were paid ratably through payroll deductions over a term not to exceed five years, unless the loan qualified as a home loan, in which case the term could not exceed 15 years. A participant applying for a loan through the Plan was charged a \$100 loan application fee. The loan application fee was nonrefundable and was used to offset the administrative expenses associated with the loan. All notes receivable from participants had been repaid or deemed distributed as of September 8, 2023.

Payment Of Benefits

Upon termination of service due to death, disability, retirement, or other reasons, a participant could receive the value of the vested interest in his or her account as a lump-sum distribution, or as directed by the participant in accordance with the Plan's provisions.

In-Service And Hardship Withdrawals

The Plan also permitted in-service withdrawals for participants attaining certain age requirements and withdrawals for hardships, as defined in the Plan Document.

Administrative Expenses

The compensation or fees of accountants, counsel and other specialists and any other costs of administering the Plan were generally paid by the Company. Administrative expenses that were not paid by the Company are paid by the Plan.

Investment management fees and operating expenses charged to the Plan for investments in the various funds are included in income (loss) on a daily basis and are reflected as a component of the net change in the fair value of investments. Effective January 1, 2015, an ERISA Investment Advisory Agreement was entered into whereby rebates from certain fund investments were deposited into a separate account to be used to pay investment advisory fees and other revenue sharing is credited to the Plan to offset administrative expenses. Such amounts are reported in administrative expenses, rather than in net change in fair value of investments.

2. Summary Of Significant Accounting Policies

Basis Of Accounting

Due to the Plan termination, management determined that liquidation of the Plan is imminent and the financial statements for 2023 have been prepared using the liquidation basis of accounting. Under the liquidation basis of accounting, assets are measured at the expected cash proceeds from liquidation and liabilities are measured in accordance with accounting principles generally accepted in the United States of America (U.S. GAAP) that otherwise apply to those liabilities. The 2022 financial statements were prepared on the accrual basis of accounting.

Estimates And Assumptions

The preparation of the financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities, disclosure of contingent assets and liabilities at the date of the financial statements and the reported amounts of additions to and deductions from net assets during the reporting period. Actual results could differ from those estimates.

Investment Valuation And Income Recognition

The Plan's investments are stated at fair value, which is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 4 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded as earned on the accrual basis. Dividends are recorded on the ex-dividend date. The net change in fair value of investments represents the difference between the aggregate fair value of investments at year end and the values at the beginning of the year, and includes any realized gains and losses in securities that were bought and sold during the year.

Notes Receivable From Participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred. No allowance for credit losses has been recorded as of December 31, 2022. All notes receivable from participants had been repaid or deemed distributed as of September 8, 2023.

Payment Of Benefits

Benefits are recorded when paid.

Subsequent Events

Management evaluates subsequent events through the date the financial statements are available for issue, which is the date of the Independent Auditors' Report.

3. Certified Investment Information

4. Fair Value Measurements

The Plan utilized an established framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements).

The three levels of the fair value hierarchy under the standards are described below:

- Level 1 Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.
- Level 2 Inputs to the valuation methodology include:
- Quoted prices for similar assets or liabilities in active markets;
 - Quoted prices for identical or similar assets or liabilities in inactive markets;
 - Inputs other than quoted prices that are observable for the asset or liability;
 - Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

- Level 3 Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value:

Registered Investment Companies

Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

Collective Trust Fund

Valued at the NAV of units of bank collective trusts. The NAV, as provided by trustees of the funds, is used as a practical expedient to estimate fair value. The NAV is based on the fair value of the underlying investments held by the fund less its liabilities. This practical expedient is not used when it is determined to be probable that the fund will sell the investment for an amount different than the reported NAV.

The methods described above may produce fair value calculations that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

The Plan held no assets as of September 8, 2023.

5. Party In Interest Transactions

The Plan allowed for transactions with certain parties who may perform services or have fiduciary responsibilities to the Plan. During the period beginning January 1, 2023 and ended September 8, 2023 and the year ended December 31, 2022, certain participants had outstanding loans with the Plan. Such transactions qualified as exempt party-in-interest transactions under the provisions of ERISA.

6. Income Tax Status

The Plan adopted a volume submitter plan document sponsored by DRS. DRS received an advisory letter from the IRS, dated June 30, 2020, which states that the pre-approved plan document satisfies the applicable provisions of the IRC. The Plan itself has not received a determination letter from the IRS. However, the Plan Administrator and the Plan's tax counsel believe that the Plan was designed and operated in compliance with the applicable requirements of the IRC. Therefore, no provision for income taxes has been included in the Plan's financial statements.

U.S. GAAP requires Plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the organization has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan administrator has analyzed the tax positions taken by the Plan, and has concluded that as of September 8, 2023 and December 31, 2022, there are no uncertain positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.
