NOTE 1 - DESCRIPTION OF PLAN

The following description of the Advanced Management Strategies Group Retirement Savings Plan (the "Plan") provides only general information. Participants should refer to the Summary Plan Description for a more complete description of the Plan's provisions.

General

The Plan is a defined contribution plan sponsored by Advanced Management Strategies Group, Inc. (the "Company"). The Plan is a single employer plan and exists for the exclusive benefit of its eligible employees who are 21 years of age. The Plan was formed effective June 1, 2018. Participants should refer to the Plan document for a complete description. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

Effective March 7, 2023, substantially all of the Plan's assets were transferred to another qualified plan.

Entrance Date

An employee was eligible to enter the Plan the first day of the first month following completion of the eligibility requirements.

Contributions

Each year, participants could contribute from 1% up to 98% of their annual compensation, as defined by the Plan. Participants who had attained age 50 before the end of the Plan year were eligible to make catch-up contributions. Participants could also contribute rollover amounts from other qualified plans.

The Plan allowed the Plan Sponsor to make matching contributions to the Plan. The contributions were discretionary as determined by the Company's board of directors. The matching contributions were based on a percentage of the participant's compensation that is contributed to the Plan. There were no match contributions made to the Plan from January 1, 2023 through July 23, 2023.

The Plan also allowed for the Plan Sponsor to make non-elective profit-sharing contributions to the Plan. These contributions were permitted at the discretion of the Board of Directors in accordance with the Plan. Participants had to be employed on the last day of the year to be eligible for such contributions. For the period January 1, 2023 through July 23, 2023, there were no non-elective contributions made to the Plan.

Forfeitures

Forfeited balances from terminated participants' accounts were used to first reduce Plan expenses, then if amounts remain, could be used to reduce employer contributions, and finally, if amounts remained, could be used as a non-elective contribution. There were no forfeitures available for use as of July 23, 2023 and December 31, 2022.

Participant Accounts

Each participant's account was credited with the participant's contribution and allocations of (a) the non-elective profit-sharing contributions, if any, and (b) Plan earnings. Allocations were based on participant's qualified compensation or account balances, as defined. The benefit to which a participant is entitled is the benefit that could be provided from the participant's vested account.

Upon enrollment in the Plan, a participant could direct contributions to a selection of a money market fund, stock and bond funds under an arrangement with the custodian of the Plan investments. Participants could change the allocation of their account in different funds at any time.

Participant Notes Receivable

Participants could borrow from their fund accounts a minimum of \$1,000 up to a maximum of \$50,000 or 50% of their vested account balance, whichever was less. All loans were to be repaid over a period not to exceed five years, although an extension of the repayment period could be granted if the loan proceeds were used to purchase a participant's principal residence. The loans were secured by the balance in the participant's account and bear interest at the local prevailing rates charged by commercial lending institutions in the region in which the employer was located for comparable loans as determined by the Plan administrator at the time the loan was approved. Principal and interest were paid ratably through payroll deductions. Should the participant terminate as an employee, the balance of the outstanding loan became due and payable and the participant's vested account was be used to pay the outstanding loan.

Vesting

Participants are immediately vested in their voluntary and employer contributions and actual earnings thereon.

Benefit Payments

On termination of service due to death, disability or retirement, a participant may elect to (a) receive a lump-sum amount equal to the value of the participant's vested interest in his or her account, (b) elect to have the benefits paid in the form of a direct rollover to an individual retirement account or (c) elect to have the benefit paid to another qualified retirement plan described in Section 401(a) of the Internal Revenue Service. Withdrawals other than for termination are permitted under certain circumstances provided by the Plan. Benefits are recorded when paid.

Plan Termination

The Company reserves the right to terminate the Plan at any time.

NOTE 2 - SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Basis of Accounting

The financial statements of the Plan are prepared using the accrual method of accounting.

Estimates

The preparation of financial statements in conformity with GAAP required the Plan administrator to make estimates and assumptions that affected certain reported amounts and disclosures. Accordingly, actual results may differ from those estimates.

Valuation of Investments

Quoted market prices are used to value Plan investments. Purchase and sales of securities are recorded on the trade-date basis. Dividend income is recorded on the ex-dividend date.

Fair Value Measurements

Accounting Standards Codification (ASC) 820 defines fair value, establishes a framework for measuring fair value and enhances disclosures about fair value measurements. Fair value is defined as the exchange price that would be received for an asset or paid to transfer a liability (or exit price) in the principal or most advantageous market for the asset or liability in an orderly transaction between market participants at the measurement date. Valuation techniques used to measure fair value must maximize the use of observable inputs and minimize the use of unobservable inputs. Observable inputs are inputs that market participants would use in pricing the asset or liability based on market data obtained from sources independent of the Company. Unobservable inputs are inputs that reflect the Company's assumptions about the inputs that market participants would use in pricing the asset or liability and are developed based on the best information available in the circumstances.

The fair value hierarchy input levels are as follows:

Level 1 - Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 - Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets;
- Quoted prices for identical or similar assets or liabilities in inactive markets;
- Inputs other than quoted prices that are observable for the asset or liability;
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Fair Value Measurements (Continued)

Level 3 - Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

There have been no changes in valuation methodologies at July 23, 2023. The Company's policy is to recognize transfers between levels at the end of each reporting period, if applicable.

Recently Issued Accounting Pronouncements

Recent accounting pronouncements issued by the Financial Accounting Standards Board ("FASB") (including technical corrections to the FASB's Accounting Standards Codification), and the American Institute of Certified Public Accountants did not, or are not, expected to have a material effect on the Plan's net assets available for benefits or changes in net assets available for benefits.

Management Evaluation of Subsequent Events

The Company has evaluated subsequent events through May 15, 2024, the date on which the financial statements were available to be issued.

NOTE 3 - PARTICIPANT-DIRECTED INVESTMENTS

Participant contributions held in the Plan are participant-directed accounts. That is, individual participants decide how funds held in trust for them are allocated among various investment options.

NOTE 4 - TRANSACTIONS WITH PARTIES-IN-INTEREST

Certain Plan investments are shares of registered investment companies managed by Slavic Integrated Administration ("third party administrator" or "Slavic") and held by Fidelity Investments ("custodian" or "Fidelity"). Fidelity, under terms of an investment contract, serves as the custodian and holds all the Plan's investment assets and executes transactions therein. Fidelity is the custodian as defined by the Plan and, therefore, the related transactions qualify as party-in-interest.

Slavic provides to the Plan certain accounting and administrative services for which the fees are charged to the Plan. Slavic also provides broker related services to the Plan for which commissions are charged to the Plan. The Plan was charged fees related to maintaining custody of the Plan's assets and various Plan management services which amounted to \$7,133 for the period January 1, 2023 through July 23, 2023.

The Company provides to the Plan certain accounting and administrative services for which no fees are charged.

NOTE 5 - TAX STATUS

The Plan has received a favorable determination letter from the Internal Revenue Service dated June 30, 2020, stating the Plan is qualified under Section 401 of the Internal Revenue Code ("IRC"). Although the Plan has not been issued an individual determination letter and has been amended since receiving the opinion letter, the Plan administrator believes the Plan is currently designed and being operated in compliance with the applicable requirements of the IRC.

Authoritative accounting standards require the Plan to examine its tax positions for uncertain positions. Management is not aware of any tax positions that are more likely than not to change in the next 12 months or that would not sustain an examination by applicable taxing authorities.

The Plan's policy is to recognize penalties and interest as incurred in its Statement of Changes in Net Assets Available for Benefits, which totaled \$0 for the period January 1, 2023 through July 23, 2023.

NOTE 6 - ADMINISTRATIVE EXPENSES

Administrative expenses paid from the Plan represent fees relating to the Plan which amounted to \$7,133 for the period January 1, 2023 through July 23, 2023.

NOTE 7 - FAIR VALUE MEASUREMENTS

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. The Company's policy is to recognize transfers between levels at the end of each reporting period, if applicable. There were no transfers of financial instruments into or out of Level 3 during the period January 1, 2023 through July 23, 2023.

Money market funds: Valued at the net asset value of shares held by the Plan at year-end.

Registered investment companies: Valued at the daily closing price as reported by the underlying fund, which is traded on a national exchange.

The methods described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.
