## **INDEPENDENT AUDITOR'S REPORT**

### **Opinion**

### NOTES TO FINANCIAL STATEMENTS DECEMBER 31, 2022

#### 1. DESCRIPTION OF THE PLAN

The following description of Social Current Retirement Plan (the Plan) is provided for general information purposes only. Participants should refer to the Plan document and related Summary Plan Description for more complete information.

##### Plan merger -

The Plan was formed on January 1, 2022, as a result of the merger of Council on Accreditation Retirement Plan (COA Plan) and Employee Benefit Plan of Alliance for Strong Families and Communities, Inc. (ASFC Plan). COA Plan's net assets available for benefits totaled \$7,823,811 as of December 31, 2021. ASFC Plan's net assets available for benefits totaled \$7,569,707 as of December 31, 2021. Therefore, the Plan's net assets available for benefits totaled \$15,393,518 as of January 1, 2022, which is the effective date of the merger.

##### Plan sponsor -

Social Current, Inc. (the Plan Sponsor) was formed on April 1, 2022, as a result of the merger of Council on Accreditation for Children and Family Services, Inc. (COA), a New York corporation, with and into Alliance for Strong Families and Communities, Inc. (ASFC), a Delaware corporation.

##### General -

The Plan is subject to the provisions of the Employee Retirement Income Security Act. The Plan's custodian is T. Rowe Price (TRP), which was also the custodian for COA Plan. Mutual of America Life Insurance Company (MOA) was the trustee for ASFC Plan. Participants in the ASFC Plan were timely notified of the Plan merger and were provided the opportunity to withdraw their account balances or rollover their account balances to another qualified plan. As a result, the assets transferred from MOA to TRP totaled \$5,508,947 on March 4, 2022.

##### Future Plan amendments -

The Secure 2.0 Act of 2022 was signed into law on December 29, 2022. This legislation includes a vast array of provisional changes to retirement plans, which become effective in 2023 and beyond. Plan management is evaluating the impact of this legislation on the Plan.

##### Eligibility -

In accordance with the Plan document, an eligible employee may make elective deferrals into the Plan and participate in the employer safe harbor matching contribution upon their date of hire and when they have attained age 18.

##### Contributions -

The Plan requires automatic pre-tax deferrals equal to 3% of participant compensation unless participants choose to opt-out. The Plan has no automatic escalation provision. Participants may also make additional voluntary pre-tax contributions and Roth contributions to the Plan. For participants who are 50 and older, the Plan allows for catch up contributions. All contributions are subject to certain limitations as described by the Internal Revenue Code.

The Plan Sponsor makes a safe harbor matching contribution equal to 4% of eligible compensation. The Plan Sponsor may also make discretionary nonelective contributions, which are determined annually. There were no discretionary nonelective contributions for the year ended December 31, 2022.

#### 1. DESCRIPTION OF THE PLAN (Continued)

##### Vesting -

Participants are fully vested in their elective deferral contributions, rollover contributions, and employer contributions, plus actual earnings thereon.

##### Participant accounts -

Each participant's account is credited with (a) the employee's contributions, (b) investment earnings and losses, and (c) the employer's contributions. Participants accounts are charged with an allocation of administrative expenses that are paid by the Plan. Allocations of investment earnings and losses, and administrative expenses, are based on account balances, or specific participant transactions, as defined in the Plan document.

##### Investment elections -

Contributions to the Plan are invested according to participant instructions. The Plan Administrator has selected a list of investment options and has provided participants with information describing these investment options.

##### Payment of benefits -

Benefits provided by the Plan are paid from net assets available for benefits. The benefit to which a Plan participant is entitled is the benefit that can be provided by the contributions and net earnings thereon allocated to such participant's account. Benefit payments are made in the form of participant directed lump sum, installment, or annuity payments upon separation, retirement, total and permanent disability, or death, as applicable. Benefits are recorded when paid whether directly to or on behalf of a participant.

If the total value of a participant's account balance is less than \$5,000 upon termination, the Plan's provisions require a distribution to the participant regardless of whether or not the participant consents to the distribution. If the total value of a participant's account balance is greater than \$5,000 upon termination, the participant must provide consent for a rollover to another qualified plan or an Individual Retirement Account.

Hardship distributions to employees are permitted if certain conditions are met.

The Plan also provides for minimum required distributions per IRS regulations by April 1 of the calendar year following the later of the calendar year in which the participant reaches age 72 or the calendar year the participant retires. In addition, participants may elect in-service withdrawals of their vested account balances after reaching age 59½.

##### Notes receivable from participants -

Participants may borrow from their accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balance. Principal and interest is paid ratably through payroll deductions. Note terms are up to five years, except for notes to fund the purchase of a principal residence, for which the note may be repaid over a reasonable period that may exceed five years. All notes receivable from participants are secured by the balance in the participant's account. Interest rates on loans to participants range from 4.25% to 6.25%.

##### Plan termination -

Although it has not expressed any intent to do so, the employer has the right under the Plan to discontinue contributions at any time and to terminate the Plan subject to the provisions of ERISA.

#### 2. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

##### Basis of accounting -

The financial statements are prepared on the accrual basis of accounting and in accordance with FASB ASC 962, *Plan Accounting Defined Contribution Pension Plans*.

##### Use of estimates -

The preparation of the financial statements in conformity with accounting principles generally accepted in the United States of America requires the Plan Administrator to make estimates and assumptions that affect certain reported amounts and disclosures. Accordingly, actual results could differ from those estimates.

##### Fair value measurement -

The Plan applies the provisions of FASB ASC 820, *Fair Value Measurement*. FASB ASC 820 defines fair value, establishes a framework for measuring fair value, establishes a fair value hierarchy based on the quality of inputs (assumptions that market participants would use in pricing assets and liabilities, including assumptions about risk) used to measure fair value, and enhances disclosure requirements for fair value measurements. The Plan accounts for a significant portion of its financial instruments at fair value or considers fair value in their measurement.

##### Valuation of investments -

Investments are stated at their fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 6 for details related to investments and fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net depreciation in fair value of investments includes the Plan's net losses on investments bought and sold as well as held during the year.

##### Notes receivable from participants -

Notes receivable from participants are measured at their unpaid principal balance, plus accrued interest. Delinquent loans are treated as distributions based upon the terms of the Plan document. Delinquent loans are loans for which any scheduled repayment remains unpaid at the end of the period specified in the loan documents and any loans for which there is an outstanding principal balance existing after the last scheduled repayment date. No allowance for credit losses has been recorded as of December 31, 2022.

##### Benefit payments -

Benefits are recorded when paid.

##### Administrative expenses -

Certain expenses of maintaining the Plan are paid directly by the Plan Sponsor and some are paid out of the Plan, which are included in these financial statements. Investment-related expenses are included as a reduction in the net depreciation of fair value of investments presented in the accompanying Statement of Change in Net Assets Available for Benefits. Expenses that are paid by the Plan Sponsor are excluded from these financial statements.

#### 3. INCOME TAX STATUS

The Plan has a volume submitter opinion letter dated December 31, 2018, in which the Internal Revenue Service (the IRS) indicated that the prototype Plan document, as then designed, was in compliance with the applicable requirements of the IRC and was qualified and tax-exempt.

As described in Note 1, the Plan merger was effective on January 1, 2022, when the Plan adopted its most recent Plan amendment. Management of the Plan, in consultation with its legal counsel, believes that the Plan continues to meet the requirements of Section 401 of the IRC. Therefore, the Plan Administrator believes that the Plan was qualified and tax-exempt as of December 31, 2022.

Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the Internal Revenue Service.

The Plan Administrator has analyzed the tax positions taken by the Plan, and has concluded that as of December 31, 2022, there are no uncertain positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

#### 4. PARTY-IN-INTEREST TRANSACTIONS

TRP is the Plan's custodian and also provides recordkeeping services. The Plan paid administrative fees to TRP which totaled \$45,999 for the year ended December 31, 2022. In addition, the Plan also paid administrative fees to MOA in relation to the asset transfer which totaled \$148 for the year ended December 31, 2022.

#### 5. RISKS AND UNCERTAINTIES

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rates, market and credit risks. Market risks include global events which could impact the value of investment securities, such as a pandemic or international conflict. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in reported in the Statement of Net Assets Available for Benefits.

#### 6. INVESTMENTS AND FAIR VALUE MEASUREMENTS

In accordance with FASB ASC 820, *Fair Value Measurement*, the Plan has categorized its financial instruments, based on the priority of the inputs to the valuation technique, into a three-level fair value hierarchy. The fair value hierarchy gives the highest priority to quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). If the inputs used to measure the financial instruments fall within different levels of hierarchy, the categorization is based on the lowest level input that is significant to the fair value measurement of the instrument. Investments recorded in the Statement of Net Assets Available for Benefits are categorized based on the inputs to valuation techniques as follows:

**Level 1.** These are investments where values are based on unadjusted quoted prices for identical assets in an active market the Plan has the ability to access.

#### 6. INVESTMENTS AND FAIR VALUE MEASUREMENTS (Continued)

**Level 2.** These are investments where values are based on quoted prices for similar instruments in active markets, quoted prices for identical or similar instruments in markets that are not active, or model-based valuation techniques that utilize inputs that are observable either directly or indirectly for substantially the full-term of the investments.

**Level 3.** These are investments where inputs to the valuation methodology are unobservable and significant to the fair value measurement.

Following is a description of the valuation methodology used for investments measured at fair value.

*Registered Investment Companies* - Valued at the daily closing price as reported by the fund. Registered investment companies (mutual funds) held by the Plan are open-end mutual funds that are registered with the SEC. The mutual funds are required to publish their daily value and to transact at that price and are deemed to be actively traded.
