Scope and Nature of the ERISA Section 103(a)(3)(C) Audit for the Financial Statements

We have performed audits of the financial statements of Feeser's, Inc. Profit Sharing Plan (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of September 1, 2023 and December 31, 2022 and the related statement of changes in net assets available for benefits for the period ended September 1, 2023 and the related notes to the financial statements.

Management has obtained certifications from a qualified institution as of September 1, 2023 and December 31, 2022 and for the period ended September 1, 2023, stating that the certified investment information, as described in Note 2 to the financial statements, is complete and accurate.

Opinion on the Financial Statements

In our opinion, based on our audits and on the procedures performed as described in the Auditor's Responsibilities for the Audit of the Financial Statements section:

- the amounts and disclosures in the accompanying financial statements, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.
- the information in the accompanying financial statements related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

Basis for Opinion on the Financial Statements

We conducted our audit in accordance with auditing standards generally accepted in the United States of America (GAAS). Our responsibilities under those standards are further described in the Auditor's Responsibilities for the Audit of the Financial Statements section of our report. We are required to be independent of the Plan and to meet our other ethical responsibilities, in accordance with the relevant ethical requirements relating to our audits. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our ERISA Section 103(a)(3)(C) audit opinion.

Responsibilities of Management for the Financial Statements

Management is responsible for the preparation and fair presentation of the financial statements in accordance with accounting principles generally accepted in the United States of America, and for the design, implementation and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.

NOTES TO FINANCIAL STATEMENTS PERIOD ENDED SEPTEMBER 1, 2023 (with comparative information at December 31, 2022)

1. Description of the Plan and summary of significant accounting policies:

Description of Plan:

The following description of Feeser's, Inc. Profit Sharing Plan (the Plan) provides only general information. Participants should refer to the Plan document and Summary Plan Description for a more complete description of the Plan's provisions.

Plan merger:

Effective September 1, 2023, the Plan merged with the Aon Pooled Employer Plan (the PEP). The PEP is a defined contribution 401(k) plan for plans with at least 100 participating employees. All eligible participants were enrolled in the PEP on such date and retained their prior service for purposes of determining eligibility and years of service for the PEP.

General:

The Plan is a defined contribution plan covering all eligible employees of Feeser's, Inc. (the Company) who have completed three months of service and are age 21 or older. Effective October 1, 2022, the eligibility age was decreased from 21 to 18. The Plan is subject to the provisions of ERISA.

Contributions:

401(k) elective deferral contributions:

Each year, participants may contribute from 1% to 50% of eligible compensation, subject to certain limitations.

Employer matching contributions:

Employer matching contributions to the Plan are made at the discretion of the board of directors to eligible participants who contributed 401(k) elective deferral contributions during the Plan year. In 2023, the amount of the employer matching contribution was equal to 50% of the first 4% of compensation contributed by participants. Participant contributions in excess of 4% are not matched.

Employer profit sharing contributions:

Contributions are at the discretion of the board of directors. Contributions are allocated, based upon compensation as defined in the Plan document, to eligible participants who had 1,000 hours of service during the Plan year and who were employed at December 31.

Participant accounts:

Each participant in the Plan has an account which is credited or charged with the participant's contribution and an allocation of: (a) the Company's contributions; (b) Plan income, gains and losses; (c) forfeitures of separated participants' nonvested account balances and (d) certain administrative expenses. Allocations are based upon compensation or account balances, as defined in the Plan document. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account balance. Participants direct all of their investments.

1. Description of the Plan and summary of significant accounting policies (continued):

Vesting:

Participants are always 100% vested in their 401(k) elective deferral account. Participants become 100% vested in their employer matching and employer profit sharing accounts after three years of service or if the participant becomes completely disabled or dies.

Any employee who terminates employment prior to becoming 100% vested in his or her account balance under the Plan has the right to have the nonvested benefit restored upon return to employment prior to a five-year break in service.

Withdrawals:

A participant may make a one-time in-service withdrawal of all or any portion of his or her vested account prior to separation from service after attainment of age 59 ½.

Payment of benefits:

Upon termination of service for any reason, including death, disability or retirement, a participant or beneficiary may elect to receive his or her vested balance as a lump-sum distribution.

Forfeitures:

Forfeitures, if any, would be reallocated to remaining eligible participants, along with the profit sharing contribution for the Plan year. Unallocated forfeitures of approximately \$5,000 were transferred to the PEP on September 1, 2023.

Basis of presentation:

The financial statements of the Plan are prepared under the accrual method of accounting.

Investment valuation:

Mutual funds are stated at fair value as determined by quoted market prices.

Interest-bearing cash (money market funds) are valued at cost, which approximates fair value.

Benefit payments:

Benefits are generally recorded as paid.

Administrative expenses:

Certain expenses of maintaining the Plan are paid directly by the Company and are excluded from these financial statements. Certain other investment related and recordkeeping service expenses are included in net depreciation in fair value of investments, as they are paid through revenue sharing rather than a direct payment. Recordkeeping fees and custodial fees are charged directly to the participant's account on a pro rata basis and are included in administrative expenses.

1. Description of the Plan and summary of significant accounting policies (continued):

Use of estimates:

The preparation of financial statements in accordance with generally accepted accounting principles requires the Plan administrator to make assumptions and estimates about certain reported amounts, and changes therein, and disclosure of contingent assets and liabilities. Accordingly, actual results could differ from these estimates.

2. Plan asset transfers:

Effective September 1, 2023, the Plan merged into the PEP. Effective that date, assets of \$17,415,430 were transferred into the PEP.

3. Information certified by the trustee:

The Plan's investments are held by Charles Schwab Trust Bank (the trustee). Investment information disclosed in the accompanying financial statements, specifically investments held at December 31, 2022, and net appreciation in fair value of mutual funds, interest and dividends for the period ended September 1, 2023, was obtained or derived from information supplied to the Plan administrator and certified as complete and accurate by the trustee.

4. Fair value measurement:

The Plan ranks investments required to be reported in the three-level hierarchy for fair value measurements based upon the transparency of inputs to the valuation of an asset. Inputs may be observable or unobservable and refer broadly to the assumptions that market participants would use in pricing the asset. Observable inputs reflect the assumptions market participants would use in pricing the asset based on market data obtained from sources independent of the reporting entity. Unobservable inputs reflect the reporting entity's own assumptions about the assumptions that market participants would use in pricing the asset developed based on the best information available in the circumstances. The three levels of the fair value hierarchy are described below:

Level 1 – Quoted prices in active markets for identical investments.

Level 2 – Other significant observable inputs (including quoted prices for similar investments, interest rates, prepayment speeds, credit risk, etc.).

Level 3 – Significant unobservable inputs (including the Plan's own assumptions in determining the fair value of investments). The Plan does not hold any Level 3 investments.

See Note 1 for a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at September 1, 2023.

5. Income tax status:

Effective January 1, 2015, the Plan trustees adopted the Conrad M. Siegel Inc. DBA Conrad Siegel Volume Submitter Profit Sharing Plan with CODA (Conrad Siegel). Conrad Siegel received a letter from the Internal Revenue Service (IRS) dated June 30, 2020 that the form of the Plan was acceptable under provisions of the Internal Revenue Code (IRC) for use by employers. The Plan administrator, based on the advice received from Conrad Siegel, believes the Plan was designed and operated in compliance with the applicable requirements of the IRC and, therefore, believes that the Plan, as amended, is qualified, and the related trust is tax-exempt.

6. Related party transactions and party-in-interest transactions:

The Schwab Bank Savings Fund is managed by Charles Schwab Bank. Charles Schwab Bank is the custodian, as defined by the Plan, and therefore, these transactions qualify as party-in-interest transactions.

7. Concentrations:

Three investments accounted for approximately 49% at December 31, 2022.

8. Subsequent events:

The Plan has evaluated subsequent events through May 8, 2024, the date which the financial statements were available to be issued.
