INDEPENDENT AUDITORS' REPORT

Scope and Nature of the ERISA Section 103(a)(3)(C) Audits

We have performed audits of the financial statements of the R&D Partners 401(k) Plan (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the Plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the DOL's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Opinion

Basis for Opinion

Emphasis of Matter – Plan Termination

As described in Note 1 to the financial statements, the Plan sponsor's Board of Directors resolved in December 2022 to terminate the Plan due to the acquisition of the Plan sponsor by another company. Effective December 31, 2022, the Plan was terminated and contributions to the Plan ceased. The Plan continued to operate in accordance with the Plan agreement through October 31, 2023, when all assets had been distributed to participants. Our opinion is not modified with respect to these matters.

Responsibilities of Management for the Financial Statements

Management is responsible for the preparation and fair presentation of the financial statements in accordance with GAAP, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

In preparing the financial statements, management is required to evaluate whether there are conditions or events, considered in the aggregate, that raise substantial doubt about the Plan's ability to continue as a going concern for one year after the date the financial statements are available to be issued.

Management is also responsible for maintaining a current Plan instrument, including all Plan amendments; administering the Plan; and determining the Plan's transactions that are presented and disclosed in the financial statements are in conformity with the Plan's provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to the participants.

Auditors' Responsibilities for the Audit of the Financial Statements

Except as described in the *Scope and Nature of the ERISA Section 103(a)(3)(C) Audits* section of our report, our objectives are to obtain reasonable assurance about whether the financial statements as a whole are free from material misstatement, whether due to fraud or error, and to issue an auditors' report that includes our opinion. Reasonable assurance is a high level of assurance but is not absolute assurance and, therefore, is not a guarantee that an audit conducted in accordance with GAAS will always detect a material misstatement when it exists. The risk of not detecting a material misstatement resulting from fraud is higher than for one resulting from error, as fraud may involve collusion, forgery, intentional omissions, misrepresentations, or the override of internal control. Misstatements, including omissions, are considered material if there is a substantial likelihood that, individually or in the aggregate, they would influence the judgment made by a reasonable user based on the financial statements.

In performing an audit in accordance with GAAS, we:

- Exercise professional judgment and maintain professional skepticism throughout the audit.
- Identify and assess the risks of material misstatement of the financial statements, whether due to fraud or error, and design and perform audit procedures responsive to those risks. Such procedures include examining, on a test basis, evidence regarding the amounts and disclosures in the financial statements.
- Obtain an understanding of internal control relevant to the audit in order to design audit procedures that are appropriate in the circumstances, but not for the purpose of expressing an opinion on the effectiveness of the Plan's internal control. Accordingly, no such opinion is expressed.
- Evaluate the appropriateness of accounting policies used and the reasonableness of significant accounting estimates made by management, as well as evaluate the overall presentation of the financial statements.

- Conclude whether, in our judgment, there are conditions or events, considered in the aggregate, that raise substantial doubt about the Plan's ability to continue as a going concern for a reasonable period of time.

Our audits did not extend to the certified investment information, except for obtaining and reading the certification, comparing the certified investment information with the related information presented and disclosed in the financial statements, and reading the disclosures relating to the certified investment information to assess whether they are in accordance with the presentation and disclosure requirements of GAAP.

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with GAAP.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control related matters we identified during the audit.

1. Description of the Plan and Plan Termination

The R&D Partners 401(k) Plan (the Plan) was established to provide retirement benefits to eligible employees of R&D Consulting Group, Inc. DBA R&D Partners (the Company). The Plan was most recently amended and restated as of January 1, 2021.

The following description of the Plan provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

The Company's capital stock was acquired by ICS US Staffing, Inc. in June 2022. The Company's Board of Directors resolved to terminate the Plan effective December 31, 2022 (the Termination Date) and ceased allowing contributions to the Plan at that time. The Plan continued to operate subsequent to the Termination Date to distribute Plan assets to the participants and ceased to exist on October 31, 2023.

General:

The Plan was a defined contribution plan under Sections 401(a) and 401(k) and related provisions of the Internal Revenue Code (the Code) and applicable state laws. The Plan was subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

The Company was the Plan sponsor and Plan administrator. The Plan was administered by Company employees, and the Plan trustees are employees of the Company. The Plan administrator was responsible for selecting investment options offered under the Plan and monitoring investment performance. Charles Schwab Trust Bank (Charles Schwab) served as the Plan's investment custodian. Charles Schwab held, invested, and reinvested Plan assets in the interest and direction of the participants and their beneficiaries. Primark Benefits (Primark) served as the Plan's record keeper. Primark utilized the Schwab Retirement Technologies, Inc. (Schwab RT) system in carrying out its record keeper functions. Schwab RT is a related party entity of Charles Schwab. The Company engaged Emery Howard Portfolio Management (Emery) as an investment advisor. Emery assisted the Plan in selecting investment options offered under the Plan and monitoring investment performance.

Eligible Participants:

Eligible employees of the Company, as defined by the Plan agreement, aged 21 or older, could participate in the Plan through the Termination Date upon completing at least one hour of service during the employee's first three months of employment, or upon completing 1,000 hours of service during the twelve month period immediately following the employee's date of hire. An eligible employee could participate in the Plan on the first day of the month coinciding with or following the completion of the aforementioned service requirements.

1. Description of the Plan and Plan Termination (continued)

Contributions:

Participants could contribute a percentage of their pre-tax and after-tax annual compensation, as defined, to the Plan through the Termination Date. Participants who had reached the age of 50 could also elect to withhold additional catch-up contributions under the Code. Participants could also contribute amounts representing distributions from other qualified defined contribution or defined benefit plans (rollovers), subject to Code regulations.

The Company automatically enrolled all newly eligible participants and withheld 6% of their compensation as a pre-tax salary deferral contribution to the Plan. Participants who were automatically enrolled could request a different percentage be withheld or decline to participate in the Plan at any time.

Company contributions were not permitted under the Plan.

In years prior to 2023, the Company discovered a certain type of compensation was improperly excluded from eligible compensation. As a result, the Company determined a qualified non-elective contribution of \$13,086 was required to be remitted to the Plan to correct this administrative failure. This was remitted to the Plan in October 2023.

Participant Accounts:

Participant accounts were credited with participant pre-tax salary deferral and post-tax contributions, rollovers through the Termination Date and an allocation of the Plan's net earnings or losses. Allocations were based on participant earnings or account balances, in accordance with the Plan agreement. Participants were fully vested in their account balances. The benefit to which participants were entitled was the benefit that could be provided from the participant accounts.

Participants could elect to invest their accounts in a variety of participant-directed investment options offered by the Plan that were designed to provide the participants with a wide range of investment options. Participants could authorize transfers among investment options at any time.

Notes Receivable from Participants:

Notes receivable from participants were not permitted under the Plan.

Payment of Benefits:

Upon termination of employment, a participant could elect to receive an amount equal to the value of their account balance through the Termination Date. Distributions were paid as soon as administratively feasible and could be paid in lump sum cash payment, in installment payments or rolled into another qualified retirement plan or individual retirement account, as elected by the participant, subject to certain stipulations as defined in the Plan agreement. The Plan could elect to distribute a terminated participant's account balance without the participant's consent, if the balance was \$5,000 or less. Benefits were recorded when paid.

Corrective Distributions Payable:

The corrective distributions payable represented contributions made by participants during the year that were required to be refunded in order for the Plan to be in compliance with required non-discrimination tests. The December 31, 2022 liability of \$9,723 was refunded in 2023.

Plan Expenses:

Several of the investment fund options were subject to investment fees based on a percentage of invested assets, as disclosed in the fund's prospectus. These fees were charged directly against the fund's investment performance and, thus, were not separately disclosed in the financial statements. Certain account maintenance fees were paid by the Plan and charged to participant accounts. All other administrative expenses related to the Plan were paid by the Company and are not reflected in these financial statements.

Risks and Uncertainties:

Participants could invest their account balances in a variety of investment options offered by the Plan. Investments are exposed to various risks, such as interest rate, market fluctuation and credit risks. Due to the level of risk associated with certain investment options offered by the Plan, it is at least reasonably possible changes in risk in the near term could materially affect participant account balances and the amounts reported in the statement of net assets available for benefits.

2. Summary of Significant Accounting Policies

Basis of Accounting:

The Plan's financial statements are prepared on the accrual method of accounting in accordance with accounting principles generally accepted in the United States of America (GAAP).

Investments:

Investments consisted of mutual funds and a common/collective trust. These investments were reported at fair value and accounted for as follows:

Mutual Funds: These funds were valued at the net asset value (NAV) of shares held by the Plan at year end based on quoted prices in active markets. It was not probable the funds would be sold at amounts that differ materially from the NAV of shares held.

Common/Collective Trust: The Plan's investments included the Morley Stable Value Fund Class 25 (the SVF), which is a common/collective trust. The SVF was valued based on the NAV of the fund's underlying assets provided by Charles Schwab. The NAV was used as a practical expedient to estimate fair value and was based upon the units of the SVF held by the Plan at year end multiplied by the respective unit value. The unit value was based on the fair value of the underlying investments, including direct and indirect interests in fully benefit-responsive contracts. The practical expedient would not be used if it was determined to be probable the Plan would sell the investment for an amount different from the reported NAV.

The objective of the SVF was to provide preservation of capital and relatively stable returns. The SVF primarily consisted of a diversified portfolio of stable value investment contracts issued by life insurance companies, banks, and other financial institutions. Participant transactions (purchases and sales) could occur daily.

Fair Value Measurement:

The Plan used a three-level hierarchy for fair value measurement based on the nature of inputs used in the valuation of an asset or liability at the measurement date. The three-level hierarchy prioritized within the measurement of fair value, the use of market-based information over entity-specific information. Fair value focuses on an exit price and was defined as the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The inputs or methodology used for valuing financial instruments were not necessarily an indication of the risk associated with those instruments.

Fair Value Measurement: (continued)

The three-level hierarchy for fair value measurement was defined as follows:

Level I: Inputs to the valuation methodology are quoted prices (unadjusted) for identical assets or liabilities in active markets.

Level II: Inputs to the valuation methodology included quoted prices for similar assets and liabilities in active markets, and inputs that were observable for the asset or liability, either directly or indirectly, for substantially the full term of the financial instrument.

Level III: Inputs to the valuation methodology, which were significant to the fair value measurement, were unobservable.

A financial instrument's categorization within the fair value hierarchy was based upon the lowest level of input that was significant to the fair value measurement.

The Plan's mutual funds valued at fair value are classified as Level I within the fair value hierarchy as of December 31, 2022.

The Plan's investment in the SVF was measured at fair value using the NAV value per share as a practical expedient, and, therefore, was not classified within the fair value hierarchy under GAAP.

Income Recognition:

Purchases and sales of investments were recorded on a trade date basis. Interest income was recorded on the accrual method of accounting. Dividends were recorded on the ex-dividend date. Net appreciation included gains and losses on the Plan's investments bought, sold or held during the period.

4. Party-In-Interest Transactions

Certain mutual funds held by the Plan were managed by Charles Schwab. As Charles Schwab was the Plan's investment custodian, purchases and sales of these investments qualified as party-in-interest transactions and were exempt from the prohibited transaction rules of ERISA.

5. Income Tax Status

The Plan was a pre-approved plan offered by Primark. The Internal Revenue Service (IRS) determined and informed Primark by a letter dated June 30, 2020, that the plan submitted for review was qualified under applicable provisions of the Code. The Plan was amended since receipt of this letter. However, the Plan and Plan sponsor believe the Plan was designed and was being operated in compliance with the applicable requirements of the Code and related state statutes and was, therefore, qualified and the trust, which forms a part of the Plan, was exempt from federal and state income taxes through October 31, 2023.

GAAP requires Plan management to evaluate income tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain income tax position that more likely than not would not be sustained upon examination by the IRS. The Plan administrator has analyzed the income tax positions taken by the Plan, and has concluded, at October 31, 2023, there were no uncertain income tax positions taken or expected to be taken that would require recognition of a liability or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress. The Plan administrator believes the Plan is subject to income tax examinations for years subsequent to 2019.

6. Subsequent Events

Subsequent events have been evaluated through May 24, 2024, which is the date the financial statements were approved by the Plan and available to be issued.
