Management, having determined it is permissible in the circumstances, has elected to have the audits of Viterbo University Tax-Deferred Annuity Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the plan (investment information) by banks or similar institutions or insurance carriers that are regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the banks or similar institutions or insurance carriers in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from qualified institutions as of December 31, 2023 and 2022, and for the year ended December 31, 2023, stating that the certified investment information, as described in Note 4 to the financial statements, is complete and accurate.

### ***Opinion***

In our opinion, based on our audits and on the procedures performed as described in the Auditor's Responsibilities for the Audit of the Financial Statements section:

- The amounts and disclosures in the financial statements, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America (GAAP).
- The information in the financial statements related to assets held by and certified to by qualified institutions agrees to, or is derived from, in all material respects, the information prepared and certified by institutions that management determined meet the requirements of ERISA Section 103(a)(3)(C).

### ***Basis for Opinion***

We conducted our audits in accordance with auditing standards generally accepted in the United States of America (GAAS). Our responsibilities under those standards are further described in the Auditor's Responsibilities for the Audit of the Financial Statements section of our report. We are required to be independent of Viterbo University Tax-Deferred Annuity Plan and to meet our other ethical responsibilities, in accordance with the relevant ethical requirements relating to our audits. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our ERISA Section 103(a)(3)(C) audit opinion.

### ***Responsibilities of Management for the Financial Statements***

Management is responsible for the preparation and fair presentation of the financial statements in accordance with GAAP, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

In preparing the financial statements, management is required to evaluate whether there are conditions or events, considered in the aggregate, that raise substantial doubt about Viterbo University Tax-Deferred Annuity Plan's ability to continue as a going concern for one year after the date the financial statements are available to be issued.

Management is also responsible for maintaining a current plan instrument, including all plan amendments, administering the plan, and determining that the plan's transactions that are presented and disclosed in the financial statements are in conformity with the plan's provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.

### ***Emphasis of Matter - Plan Termination and Liquidation Basis of Accounting***

As further discussed in Note 6 to the financial statements, Viterbo University approved a plan of liquidation and management determined liquidation is imminent. As a result, the Plan changed its basis of accounting from the on-going basis of accounting used in presenting the 2022 financial statements to the liquidation basis of accounting used in presenting the 2023 financial statements. Our opinion is not modified with respect to this matter.

### ***Auditor's Responsibilities for the Audit of the Financial Statements***

Except as described in the Scope and Nature of the ERISA Section 103(a)(3)(C) Audit section of our report, our objectives are to obtain reasonable assurance about whether the financial statements as a whole are free from material misstatement, whether due to fraud or error, and to issue an auditor's report that includes our opinion. Reasonable assurance is a high level of assurance but is not absolute assurance and therefore is not a guarantee that an audit conducted in accordance with GAAS will always detect a material misstatement when it exists. The risk of not detecting a material misstatement resulting from fraud is higher than for one resulting from error, as fraud may involve collusion, forgery, intentional omissions, misrepresentations, or the override of internal control. Misstatements are considered material if there is a substantial likelihood that, individually or in the aggregate, they would influence the judgment made by a reasonable user based on the financial statements.

In performing an audit in accordance with GAAS, we:

- Exercise professional judgment and maintain professional skepticism throughout the audit.
- Identify and assess the risks of material misstatement of the financial statements, whether due to fraud or error, and design and perform audit procedures responsive to those risks. Such procedures include examining, on a test basis, evidence regarding the amounts and disclosures in the financial statements.
- Obtain an understanding of internal control relevant to the audit in order to design audit procedures that are appropriate in the circumstances, but not for the purpose of expressing an opinion on the effectiveness of Viterbo University Tax-Deferred Annuity Plan's internal control. Accordingly, no such opinion is expressed.
- Evaluate the appropriateness of accounting policies used and the reasonableness of significant accounting estimates made by management, as well as evaluate the overall presentation of the financial statements.
- Conclude whether, in our judgment, there are conditions or events, considered in the aggregate, that raise substantial doubt about Viterbo University Tax-Deferred Annuity Plan's ability to continue as a going concern for a reasonable period of time.

Our audits did not extend to the certified investment information, except for obtaining and reading the certifications, comparing the certified investment information with the related information presented and disclosed in the financial statements, and reading the disclosures relating to the certified investment information to assess whether they are in accordance with the presentation and disclosure requirements of GAAP.

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with GAAP.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audit.

### Note 1: Description of Plan

The following description of Viterbo University Tax-Deferred Annuity Plan (the "Plan") provides only general information. Participants should refer to the plan agreement for a more complete description of the Plan's provisions.

#### General

The Plan is a participant-directed defined contribution plan established for a not-for-profit organization, commonly known as a Code Section 403(b) savings plan. Viterbo University, Inc. (the "Organization") is the Plan sponsor and is a not-for-profit corporation as described in Section 501(c)(3) of the Internal Revenue Code (IRC). The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA), as amended. The Plan covers all employees of Viterbo University, Inc., excluding students employed by the Organization under federal or Organization work study programs or for any other purpose. Eligible employees can participate in the Plan immediately following employment at the Organization.

The Plan is intended to satisfy the requirements under Section 404(c) of ERISA and therefore provides that participants direct their contributions and their account balances among the Plan's investment alternatives. All investments are participant directed.

The Plan adopted certain optional provisions of the Coronavirus Aid, Relief, and Economic Security (CARES) Act that was signed into law on March 27, 2020, which were immediately available, for Coronavirus-related distributions, suspended participant loan payments and increased loan limits, and waiver of required minimum distributions that were due during 2020. The provisions of the CARES Act were operationalized by the Plan in accordance with applicable laws effective April 10, 2020. The Plan formally executed the required Plan amendments for these provisions during 2022.

Effective December 31, 2023, the Viterbo University Tax-Deferred Annuity Plan merged into the Viterbo University Defined Contribution Retirement Plan (see Note 6).

#### Eligibility and Participation

Substantially all employees of the Organization are eligible to participate in the Plan, except if a student of the Organization. Employees are eligible to participate on their date of hire.

#### Contributions

Each year, participants may contribute pretax annual compensation, as defined in the Plan, not to exceed the limits of the IRC. Participants who have attained the age of 50 before the end of the plan year are eligible to make catch-up contributions. Participants are allowed to transfer or roll over funds into the Plan from other qualified or 403(b) plans.

### Note 1: Description of Plan (Continued)

#### Participant Accounts

Each participant's account is credited with the participant's contribution and allocations of the plan earnings. Allocations are based on participant earnings (losses), investment elections, or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

#### Vesting

Participants are immediately vested in their contributions plus actual earnings thereon.

#### Plan Notes Receivable

Prior to January 1, 2021, the Plan allowed notes directly from funds owned by the Plan's Custodians and not directly from a participant's account therefore the notes receivable balances are not included in the Plan's statements of net assets available for benefits. Security was required, and a portion of the participant's account was reserved. The collateral was held in predetermined investment vehicles. Generally, the minimum note amount was \$1,000, and the maximum note amount was \$50,000 or 50% of a participant's account balance, whichever was less. Limits on annuity contracts, the Plan's provisions, and other factors may have adjusted the maximum limit allowable. During 2021, the Plan no longer offered plan notes; instead, the Plan began offering notes receivable from participant as described below. Existing plan loans will remain in effect until they are paid off.

The Plan note interest rate is variable and is based on prevailing market conditions by the Plan's Custodians. Interest rate on existing note is 5.28%.

Note repayments vary from one to five years. If the note was used solely to purchase a primary residence, the note can have a maximum term of 10 years. The term of the note usually can't extend past April 1 of the year after an individual attains the age of 72 1/2. Principal and interest are paid ratably by the participants to the custodians, and each payment reduces amounts secured as collateral in the predetermined investment.

The Plan note balances at December 31, 2023 and 2022, were \$67 and \$1,124, respectively.

#### Notes Receivable From Participants

Participants may borrow from their fund accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their account balance. The notes are secured by the balance in the participant's account and bear interest at a rate ranging from 4.25% to 9.25%, which is equal to the Wall Street Journal Prime Rate plus a margin of 1% and is commensurate with local prevailing rates as determined by the plan administrator. Principal and interest are paid ratably by participants directly, rather than through payroll deductions.

### **Note 1: Description of Plan** (Continued)

#### **Payment of Benefits**

Plan benefits are paid to the participant or beneficiary upon death, disability, early retirement (age 59 1/2), financial hardship withdrawal, normal retirement (age 65), deferred retirement, or termination of employment, up to the amount of the participant's account. Benefits may be paid in a lump sum distribution, installment distribution, or annuity payments. Distributions may be made as soon as administratively feasible.

### **Note 2: Summary of Significant Accounting Policies**

#### **Basis of Accounting**

As discussed in Notes 1 and 6, the plan was terminated effective December 31, 2023. In accordance with accounting principles generally accepted in the United States of America (GAAP), the Plan changed its basis of accounting from the ongoing plan basis to the liquidation basis. The change to the liquidation basis had no material impact on the accompanying financial statements.

#### **Use of Estimates**

The preparation of the financial statements in accordance with GAAP requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein and disclosure of contingent assets and liabilities. Actual results may differ from these estimates.

#### **Investment Valuation and Income Recognition**

Investments are reported at fair value, except for fully benefit-responsive investment contracts (FBRICs). Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

FBRICs are reported at contract value, which is the amount participants would normally receive if they were to initiate permitted transactions under the terms of the Plan.

#### **Notes Receivable From Participants**

Notes receivable from participants are measured at their unpaid principal balance plus any accrued, but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred. No allowance for credit losses has been recorded as of December 31, 2023 and 2022. Delinquent participant notes receivable are recorded as benefit payments on the basis of the terms of the plan document.

#### Payment of Benefits

Benefits are recorded when paid.

#### Administrative Expenses

The Organization pays essentially all administrative expenses relating to the Plan. All such other costs and expenses from the Plan are, unless allocable to the accounts of particular participants, charged against the accounts of all participants on a pro rata basis or in such other reasonable manner as may be directed by the Organization and accepted by the Custodians.

#### Subsequent Events

The Plan has evaluated subsequent events through May 10, 2024, which is the date the financial statements were available to be issued.

### Note 3: Fair Value Measurements

GAAP establishes a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. This hierarchy consists of three broad levels: Level 1 inputs consist of unadjusted quoted prices in active markets for identical assets and have the highest priority level. Level 2 inputs consist of observable inputs other than quoted prices for identical assets (Level 1). Level 3 inputs are unobservable and have the lowest priority. The Plan uses appropriate valuation techniques based on the available inputs to measure the fair value of its investments. When available, the Plan measures fair value using Level 1 inputs because they generally provide the most reliable evidence of fair value. Level 2 inputs are used for investments for which Level 1 inputs were not available. Level 3 inputs would be used only if Level 1 or Level 2 inputs were not available.

Following is a description of the valuation methodologies used for assets measured at fair value.

*Fixed annuity contracts - RA:* Represent the TIAA Traditional Non Benefit Responsive Annuity Contracts. The accounts are valued at fair value and represent the contributions to the account plus the guaranteed rate of return. The guaranteed interest rate was 3.00% for the years ended December 31, 2023 and 2022. The guaranteed interest rate for a calendar year is determined at the end of the preceding calendar year and will never be less than the minimum interest rate specified in the contract.

*Variable annuities and pooled separate accounts:* Valued at the net asset value (NAV) of the units held by the Plan at year-end, provided by the administrator of the fund. The NAV is based on the value of the underlying assets of the fund, minus its liabilities, and then divided by the number of units outstanding. The NAV's unit price is quoted on a private market that is not active; however, the unit price is based on underlying investments, which are traded on an active market.

*Mutual funds:* Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the U.S. Securities and Exchange Commission. These funds are required to publish their daily NAV and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

### Note 4: Information Prepared and Certified by Custodians

The plan administrator has elected the method of compliance permitted by 29 CFR 2520.103-8 of the DOL's Rules and Regulations for Reporting and Disclosure under ERISA. Certain information disclosed in the accompanying financial statements, including investments and notes receivable from participants held at December 31, 2023 and 2022, and net appreciation in fair value of investments, interest income on notes receivable from participants, and interest and dividends for the year ended December 31, 2023 was obtained or derived from information supplied to the plan administrator and certified as complete and accurate by Teachers Insurance and Annuity Association of America and College Retirement Equity Fund ("TIAA-CREF"), Ameriprise Trust Company, and RiverSource Life Insurance Company, the Custodians of the Plan.

### Note 5: Fixed Annuity Contracts

Fixed annuity contracts consist of investment options available to participants known as the TIAA Traditional Annuity Contracts ("Annuity"). Annuity contracts are established between the participants and Teachers Insurance and Annuity Association (TIAA), an insurance company registered in the state of New York. This investment option is offered in retirement annuities (RA) and group supplemental retirement annuities (GSRA). The return of Annuity contributions, plus interest to participants, is subject to TIAA's claims-paying ability.

Annuity accounts are credited with a guaranteed minimum rate of interest that is determined annually. Participants may also earn interest in addition to the guaranteed rate at the discretion of TIAA. Such discretionary interest, if any, is declared by TIAA on a year-by-year basis and is not guaranteed for future years.

### Note 5: Fixed Annuity Contracts (Continued)

Contributions to the Annuity accounts are grouped by TIAA into "vintages" composed of premiums received over defined time periods of one or more contiguous calendar months. The interest crediting rate for each vintage is determined, in part, by the net investment earnings rate of the TIAA assets supporting that vintage, minus a charge for administrative expenses and an amount set aside for contingency reserves. Crediting rates are also determined by the performance of investments contained in TIAA's general account.

During 2022, the crediting rates of the Annuity contracts were 3.70% to 6.25% and 3.00% to 5.50% for RA accounts and GSRA accounts, respectively, for the entire Plan year. At December 31, 2022, the RA account had a balance of \$2,019,277. At December 31, 2022, the GSRA account had a balance of \$2,069,511.

RA account balances may be withdrawn only over 10 annual payments. Because this provision is considered to restrict participant's "reasonable access" to their contract balances, RAs are not considered to be fully benefit-responsive investment contracts as defined by Accounting Standards Codification (ASC) 962.

GSRAs are considered FBRICs because they are fully liquid and immediately cashable once a participant terminates employment with the employer.

Annuity balances are stated at contract value in the accompanying statements of net assets available for benefits. The plan custodians have represented that contract value approximates fair value.

### Note 6: Plan Termination

The Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. Effective December 31, 2023, the Plan merged into the Viterbo University Defined Contribution Retirement Plan (the DC plan) and transferred plan assets of \$18,993,646 into the DC plan.

### **Note 7: Tax Status**

The Plan is placing reliance on an opinion letter dated August 7, 2017, received from the IRS on the volume submitter plan indicating that the Plan is qualified under Section 403(b) of the IRC and is therefore not subject to tax under the current income tax law. The volume submitter plan has been amended since receiving the opinion letter. However, the plan administrator believes that the Plan is designed, and is currently being operated, in compliance with the applicable requirements of the IRC and, therefore, believes that the Plan is qualified and the related trust is tax-exempt.

GAAP requires plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain positions that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax period in progress.

### **Note 8: Party-In-Interest**

Certain plan investments were managed by TIAA-CREF, Ameriprise Trust Company, and RiverSource Life Insurance Company. TIAA-CREF, Ameriprise Trust Company, and RiverSource Life Insurance Company were the Custodians; therefore, these transactions qualify as party-in-interest transactions.

Notes receivable from participants also qualify as party-in-interest transactions, which are exempt from prohibited transaction rules of ERISA.

### **Note 9: Risks and Uncertainties**

The Plan invested in various investment securities. Investment securities were exposed to various risks, such as interest rate, market, and credit risk. Due to the level of risk associated with certain investment securities, it was at least reasonably possible that changes in values of investment securities could occur and affect amounts reported.
