Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We were engaged to perform audits of the financial statements of Suzuki School Employees' Savings and Retirement Plan, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) [ERISA Section 103(a)(3)(C) audit]. The financial statements comprise the statements of net assets available for benefits for the period January 1 - August 23 (date of termination) and year ended December 31, 2022, and the related statement of changes in net assets available for benefits for the year ended December 31, 2023, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of Suzuki School Employees' Savings and Retirement Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from a qualified institution for the period January 1 - August 23, 2023 (date of termination) and year ended December 31, 2022, and for the period January 1 - August 23, 2023, stating that the certified investment information is complete and accurate.

Disclaimer of Opinion

We do not express an opinion on the financial statements of Suzuki School Employees' Savings and Retirement Plan referred to in the first paragraph. Because of the significance of the matter described in the Basis for Disclaimer of Opinion section of our report, we have not been able to obtain sufficient appropriate audit evidence to provide a basis for an audit opinion on the financial statements.



Basis for Disclaimer of Opinion

As permitted by 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under the Employee Retirement Income Security Act of 1974, the plan administrator instructed us not to perform, and we did not perform, any auditing procedures with respect to the information summarized below, which was certified by Empower Retirement Company, the trustee of the Plan, except for comparing the information with the related information included in the financial statements. We have been informed by the plan administrator that the trustee holds the Plan's investment assets and executes investment transactions. The plan administrator has obtained a certification from the trustee as of and for the year the period January 1 - August 23, 2023, that the information provided to the plan administrator by the trustee is complete and accurate.

Responsibilities of Management for the Financial Statements

Management is responsible for the preparation and fair presentation of the financial statements in accordance with accounting principles generally accepted in the United States of America, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

In preparing the financial statements, management is required to evaluate whether there are conditions or events, considered in the aggregate, that raise substantial doubt about Suzuki School Employees' Savings and Retirement Plan's ability to continue as a going concern for one year after the date the financial statements are available to be issued.

Management is also responsible for maintaining a current plan instrument, including all plan amendments; administering the plan; and determining that the plan's transactions that are presented and disclosed in the financial statements are in conformity with the plan's provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.

Auditor's Responsibilities for the Audit of the Financial Statements

Our responsibility is to conduct an audit of Suzuki School Employees' Savings and Retirement Plan's financial statements in accordance with auditing standards generally accepted in the United States of America and to issue an auditor's report. However, because of the matter described in the Basis for Disclaimer of Opinion section of our report, we were not able to obtain sufficient appropriate audit evidence to provide a basis for an audit opinion on these financial statements.

NOTE 1 – DESCRIPTION OF PLAN

The following description of Suzuki School (the Company) Employees' Savings and Retirement Plan (the Plan) provides only general information. Participants should refer to the plan agreement for a more complete description of the Plan's provisions.

General

The Plan is a defined contribution 401(k) plan covering substantially all employees of the Company who are age 21 or older. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA). The plan is administered by certain officers of the Company, who are appointed by the board of directors of the Company.

Under the Plan's adoption agreement employees are eligible to enroll after one year of service. The Plan has a manual deferral feature. When an employee becomes eligible to participate, the Company notifies the employee, and the employee completes registration online. The enrollee sets the contribution rate based on their discretion, and administration is automatically notified of registration and deferral changes. The employee can elect not to participate, in which case no contribution rate is set, and no contributions are made for that employee.

On August 23, 2023, the Plan's fund was closed, due to the sale of Suzuki Services on February 8, 2023.

Contributions

Participants may elect to contribute up to the maximum contribution allowable under IRS Code Sections 401(k), 404, and 415. Participants may also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans. Participants direct the investment of their contributions into various investment options offered by the Plan.

The Plan provides for employer discretionary matching contributions as declared by the Company's board of directors for the contribution period. For the period January 1 – August 23, 2023 and year ended December 31, 2022, the Company made matching contributions equal to 100% of the participant's contributions, but not exceeding a participant contribution of five percent of the participant's compensation for the matching period. The matching period is the pay period. The Plan does not provide for matching on catch-up contributions.

Participant Accounts

Each participant's account is credited with the participant's contribution, the Company's contribution, and plan earnings. Allocations are based on participant earnings or account balances, as defined in the plan agreement. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Forfeitures

Participants terminating employment forfeit employer matching contributions based upon the vesting schedule. If rehired, participants may restore the amount forfeited within a period of five years from the date of termination. Forfeitures subject to being restored are kept in non-vested forfeiture accounts.

The balance in the forfeitures account is to be used as employer discretionary, non-elective contributions and is to be allocated to all active employees as of the end of the year who had at least 1,000 hours during the year. The balance in the forfeitures account on August 23, 2023, and December 31, 2022 was \$0 and \$674, respectively.

Vesting

Participants are immediately 100% vested in their contributions and 100% vested in employer matching contributions after completing 3 years of service. The vesting percentage for a participant who is an employee on or after the date he/she reaches normal retirement is 100%.

Payment of Benefits

Plan benefits are available at the termination of service due to death, disability, or retirement. The normal retirement age is 65; the Plan does not allow for early retirement.

In-service withdrawals may be allowed under IRS safe-harbor hardship rules. Participants may receive benefit payments in the form of a lump-sum distribution, or installments (for required minimum distributions only). Distributions in hardship cases are limited to the employee's contributions.

Loans to Participants

The Plan does not allow for loans to participants.

NOTE 2 – SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Basis of Accounting

The financial statements of the Plan are prepared using the modified cash basis of accounting, which differs from financial statements prepared using accounting principles generally accepted in the United States of America, primarily due to the omission of participant and employer contributions receivable and accounts payable.

NOTE 2 – SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES (continued)

Administrative Fees

Significant plan expenses are paid by the Company and are not included in the accompanying financial statements.

Estimates

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires the plan administrator to make estimates and assumptions that affect certain reported amounts and disclosures. Accordingly, actual results may differ from those estimates.

Investment Valuation and Income Recognition

The Plan's investments are stated at contract value, which approximates fair value. Income from pooled separate accounts and common collective trust accounts is the increase or decrease in their market values from the beginning to the end of the year.

Fair Value Measurements

Financial Accounting Standards Board (FASB) Accounting Standards Codification (ASC) topic 820, Fair Value Measurements, establishes a framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1 measurements) and the lowest priority to unobservable inputs (level 3 measurements). The three levels of the fair value hierarchy under FASB ASC Topic are as follows:

Level 1 – Unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 – Quoted prices for similar assets or liabilities in active markets; quoted prices for identical or similar assets or liabilities in inactive markets; inputs other than quoted prices that are observable for the asset or liability.

Level 3 – Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

The assets or liabilities fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs. Below is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used as of August 23, 2023 and December 31, 2022.

Fair Value Measurements (continued)

Pooled Separate Accounts and Key Guaranteed Portfolio Fund: Valued at the net asset value ("NAV") of shares held by the Plan at year end. (Level 2)

Participant loans: Not applicable for the Plan.

The methods described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the Fair Value of certain financial instruments could result in a different fair value measurement at the reporting date.

Subsequent events

In preparing these financial statements, management has evaluated subsequent events for potential recognition or disclosure through May 1, 2024, the date the financial statements were available to be issued.

NOTE 3 - INVESTMENTS

The Plan's investments (including gains and losses on investments bought and sold, as well as held during the year) appreciated in value \$93,467 in 2023 and depreciated in value (\$236,402) in 2022.

NOTE 4 – TAX STATUS

The Company has adopted an Empower Retirement Company Retirement Savings Plan, which received an opinion letter dated February 2, 2018, from the Internal Revenue Service indicating that the Plan is acceptable under Section 401 of the Internal Revenue Code.

Accordingly, the Plan is exempt from federal and state income taxes.

Participants are not taxed currently on employer contributions or income earned by the Plan. When a participant receives a distribution under the Plan such distribution may be taxable. The tax treatment depends on the event giving rise to the distribution and the method of distribution selected and the use of the proceeds.

NOTE 5 – PLAN TERMINATIONS

The plan was terminated on August 23, 2023. Upon the plan termination, participants became 100% vested in their accounts.
