Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the financial statements of Eyewitness Acquisition LLC 401(k) Plan (the "Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit) which comprise the statements of net assets available for benefits as of January 28, 2022 and December 31, 2021, and the related statement of changes in net assets available for benefits for the period from January 1, 2022 to January 28, 2022, and the related notes to the financial statements.

1. DESCRIPTION OF PLAN

The following description of the Eyewitness Acquisition LLC 401(k) Plan (the “Plan”) provides only general information. Participants should refer to the Plan document for a more complete description of the Plan’s provisions.

General

The Plan is sponsored by Eyewitness Acquisition LLC (the “Sponsor” or “Company”) and is a single employer defined contribution 401(k) plan covering substantially all employees of the Company. Excluded employees include collective bargaining unit employees, non-resident aliens, leased employees, and independent contractors. Participants are eligible to participate in the Plan the first day of each month coinciding with or following attainment of age 21 and the completion of 3 months of service. Once a participant meets eligibility they are able to enter the Plan the first day of the month following the date they satisfy the eligibility requirements.

The Plan, subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA), became effective January 1, 2016.

Plan Amendment

Effective November 1, 2022, the Plan was amended and restated in order to comply with Cycle 3 in accordance with Rev. Proc. 2017-41.

Plan Merger

Effective January 28, 2022, Eyewitness Acquisition LLC 401(k) Plan merged into Stealth Monitoring 401(k) Plan due to a Company acquisition. As a result of the merger, approximately \$2,500,000 was transferred into the Plan as of January 28, 2022 and is included in statement of changes in net assets available for benefits. Subsequent to the merger, Eyewitness Acquisition LLC was made an adopting employer of the Plan.

Contributions

Participants may elect to contribute a percentage or dollar amount of their eligible compensation as defined by the Plan. Participants may select from pre-tax or Roth deferrals. These contributions are subject to annual limitations established by the Internal Revenue Service (IRS). Participants may also contribute amounts representing distributions from other qualified retirement plans.

1. DESCRIPTION OF THE PLAN (CONTINUED)

Investments

Participants direct the investments of their contributions into various investment options offered by the Plan. Currently, the Plan offers several investment choices. Participants may change their investment options for future contributions at any time.

Participant Accounts

Each participant's account is credited with the participant's contribution and allocations, (a) Plan earnings or losses and (b) charged with an allocation of administrative expenses. Allocations are based on participant earnings or account balances, as defined. The benefit to which a participant is entitled is the amount that can be provided from the participant's vested account balance.

Vesting

Participants are immediately vested in their voluntary contributions and rollover contributions plus actual earnings thereon.

Notes Receivable from Participants

Participants may borrow from their accounts a minimum of \$1,000 up to a maximum equal to the lesser of (a) 50% of their vested account balance reduced by any outstanding loan balance or (b) \$50,000, reduced by the highest outstanding loan balance during the one year period ended on the day before the loan is made. Only two loans may be outstanding at a time. Loan principal and interest is generally repaid through payroll deductions and are reinvested in the participant's account according to the individual investment elections. Loan terms generally may not exceed five years. Loans are secured by the balance in the participant's accounts and bear interest at the prime rate as of the date of the loan. Any loan origination fee will be described in the loan application form and will be deducted directly from the participant's account and are included in the administrative expenses on the statement of changes in net assets available for benefits. As of January 28, 2022, there were no loans outstanding.

Payment of Benefits

Distributions generally will be made in the event of retirement, death, disability, resignation, or dismissal. Vested account balances can be distributed by rollover or lump sum distributions. Vested account balances that do not exceed \$1,000 are subject to automatic distribution without participant's consent. Rollover contributions are included in determining the \$1,000 threshold. All other accounts must receive participant consent before a distribution to the participant can occur.

1. DESCRIPTION OF THE PLAN (CONTINUED)

Certain in-service withdrawals are allowed. A participant may elect to withdrawal all or a portion of their vested account balance while employed after reaching age 59.5. Hardship withdrawals are allowed only for immediate and heavy financial needs for reason defined by the Plan document.

2. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Basis of Accounting

The financial statements for the Plan are prepared under the accrual basis of accounting.

Use of Estimates

The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America (GAAP) requires Plan's management to make estimates and assumptions that affect certain reported amounts and disclosures. Actual results may vary from those estimates.

Investment Valuation and Income Recognition

The Plan's investments are reflected at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. The net appreciation (depreciation) includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Notes Receivable from Participants

Notes receivable from participants are recorded at the unpaid principal balance plus accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are charged directly to the borrowing participant's account and included in administrative fees when incurred.

Payment of Benefits and Receipt of Contributions

Benefits paid to participants are recorded when paid. Contributions are recorded when deemed a receivable to the Plan.

2. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES (CONTINUED)

Excess Contributions Payable

Amounts payable to participants for contributions in excess of amounts allowed by the IRS are recorded as a liability with corresponding reduction to contributions. Excess contributions totaled approximately \$66,500 for the year ended December 31, 2021.

Administrative Expenses

Certain administrative expenses of maintaining the Plan are paid by the Plan, unless otherwise paid by the Company. Expenses that are paid by the Company are excluded from these financial statements. Fees related to notes receivable from participants and benefits paid to participants are charged directly to the respective participant accounts. Administrative expenses totaling \$2,791, relating to participant fees, are included on the statement of changes in net assets available for benefits for the period ended January 28, 2022. Investment related expenses are included in net depreciation of fair value of investments on the statement of changes in net assets available for benefits.

3. INFORMATION PREPARED AND CERTIFIED BY PLAN CUSTODIAN

The Plan Sponsor has elected the method of annual reporting compliance permitted by 29 CFR 2520.103-8 of the Department of Labor's (DOL's) Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, Ascensus Trust Company, the Custodian of the Plan, has certified that the following data included in the accompanying financial statements and supplemental schedule is complete and accurate:

- a. Investments, at fair value, and notes receivable from participants, as shown in the statements of net assets available for benefits, as of January 28, 2022 and December 31, 2021.
- b. Dividends and interest income, and net depreciation in fair value of investments, as shown in the statement of changes in net assets available for benefits, for the period ended January 28, 2022.

The Plan's independent public accountants did not perform auditing procedures with respect to this information, except for comparing such information to the related information included in the financial statements.

4. FAIR VALUE MEASUREMENTS

Valuation techniques used to measure fair value use a hierarchy, which gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements). The three levels of the fair value hierarchy are described as follows:

Level 1 – Quoted prices in active markets for identical assets or liabilities

Level 2 – Valuations based on inputs other than quoted prices included within Level 1 that are observable, either directly or indirectly, such as quoted prices in markets that are not active; other inputs that are observable or can be corroborated by observable market data for substantially the full term of the assets or liabilities.

Level 3 – Valuations based on inputs that are unobservable and significant to the overall measurement.

The assessment of the significance of a particular input to the fair value measurement requires judgment and may affect the classification of assets and liabilities within the fair value hierarchy. Because of the long-term nature of certain assets and liabilities measured at fair value as well as differences in the availability of market prices and market liquidity over their terms, inputs for some assets and liabilities may fall into any one of the three levels in the fair value hierarchy. GAAP requires these assets and liabilities to be classified in the lowest level in the hierarchy for which inputs are significant to the fair value measurement; a portion of that measurement may be determined using inputs from a higher level in the hierarchy.

The availability of valuation techniques and observable inputs can vary from investment to investment and is affected by a wide array of factors. In certain cases, the inputs used to measure fair value may fall into different levels of the hierarchy. For disclosure purposes, the level in the hierarchy within which the fair value measurement in its entirety falls is determined based on the lowest level input that is significant to the fair value measurement. The estimated values do not necessarily represent the amounts that may be ultimately realized due to the occurrence of future circumstances that cannot be reasonably determined.

4. FAIR VALUE MEASUREMENTS (CONTINUED)

To the extent that a specific valuation is based on models or inputs that are less observable or unobservable in the market, the determination of fair value requires more judgment. As such, the degree of judgment exercised by the Plan in determining fair value is greatest for investments in Level 3.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used as of January 28, 2022 and December 31, 2021.

- *Money market funds.* The money market category includes money market mutual funds that generally invest in instruments that mature in one year or less and are valued at cost which approximates fair value. Also included in money market funds are certain Federal Deposit Insurance Corporation insured money market deposits that are valued at cost as they are cash equivalent holdings.
- *Mutual funds of registered investment companies.* Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the U.S. Securities and Exchange Commission. These funds are required to publish their daily net asset value to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

The Plan has no financial instruments which were categorized using Level 3 inputs as of January 28, 2022 and December 31, 2021.

The Plan recognizes transfer between levels in the fair value hierarchy as of the end of the reporting period. There were no transfers between levels for the period ended January 28, 2022 and the year ended December 31, 2021.

5. NONPARTICIPANT-DIRECTED INVESTMENTS

The Plan's participants direct all investments. There are no non-participant directed investments as of January 28, 2022 and December 31, 2021.

6. RELATED PARTY AND PARTY-IN-INTEREST TRANSACTIONS

Ascensus Trust Company, the Custodian as defined by the Plan, manages certain investment options. Fees paid by the Plan for the investment management services are included in administrative expenses reported on the statement of changes in net assets available for benefits.

The Plan also permits loans to participants.

Certain administrative functions are performed by officers and employees of the Company for which the officers or employees receive no compensation from the Plan nor is the Plan charged by the Company for these services.

These transactions qualify as party-in-interest transactions which are exempt from the prohibited transaction rules.

7. PLAN TERMINATION

Although no intent to do so has been expressed, the Sponsor has the right under the Plan to discontinue its contributions, if any, at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, Plan assets will be distributed in accordance with the Plan document. Effective January 28, 2022, the Plan merged into the Stealth Monitoring 401(k) Plan.

8. TAX STATUS

Effective November 1, 2022, the Plan is based on a prototype plan developed by Ascensus, Inc., which received a favorable opinion letter dated June 30, 2022 from the IRS stating the prototype plan constitutes a qualified plan under Section 401 of the Internal Revenue Code (IRC). Prior to November 1, 2022 the Plan was governed by a favorable determination letter dated March 31, 2014. The Plan is currently designed and being operated in compliance with the applicable requirement of the IRC.

GAAP requires Plan management to evaluate the tax positions taken by the Plan and recognize a liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the DOL or IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

9. RISKS AND UNCERTAINTIES

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Market risks include global events which could impact the value of investment securities, such as a pandemic or international conflict. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect a participants' account balance and the amounts reported in the statement of net assets available for benefits.
