Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the accompanying financial statements of Tos Farms, Inc. Profit Sharing Plan, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C). The financial statements comprise the statements of net assets available for benefits as of October 31, 2023 and June 30, 2023, and the related statement of changes in net assets available for benefits for the four-month period ended October 31, 2023, and the related notes to the financial statements.

1. DESCRIPTION OF PLAN:

The following brief description of the Plan provides only general information. Participants should refer to the Plan document for complete information.

General

The Tos Farms, Inc. Profit Sharing Plan (the “Plan”) was adopted effective July 1, 1979 for all eligible employees (participants) of Tos Farms, Inc. and Tos Farming Company, LLC, a California limited liability company and Tos Land Company, a California S Corporation. The Plan was subsequently amended effective July 1, 1980, July 1, 1984, February 4, 1992, December 20, 1994, June 28, 2005, August 31, 2008, April 5, 2012, July 1, 2021, and April 1, 2022. The Plan and the related trust fund are established for the exclusive benefit of the participating employees and no part of the trust fund, including income from investments and employer contributions, can revert to the Plan or the Partnership. The Plan is subject to the provisions of the Employees Retirement Income Security Act of 1974 (ERISA).

Eligibility and Vesting

An employee becomes eligible for participation in the Plan upon attainment of his twenty-first birthday, after completing one year of service and after completing one thousand hours of service. Contributions vest 100% at the end of the third year of service in the Plan and become fully vested upon the employee’s death, incapacity, attainment of normal retirement age or upon termination of the Plan. An employee becomes eligible for normal retirement benefits upon attainment of his sixty-fifth birthday. Benefit payments may be made in a lump sum or in installments.

Administration

The Plan is administered by Pace TPA, and plan administration costs were paid for by the Plan.

Contributions

The Plan is a defined contribution plan. As such, the Plan’s contributions are determined each year at the discretion of the Board of Directors. All contributions made by the Plan to the trust are irrevocable and are used to pay benefits under the Plan or to pay expenses incurred in connection with the purchase and sale of securities or other investments of the trust fund.

Distributions

Distributions are recorded when paid. In the event of death, disability, retirement or termination, a participant’s vested interest in the Plan will be distributed in a lump-sum payment or in installments as soon as administratively feasible. All distribution claims have been processed and approved by the end of the year at October 31, 2023 and June 30, 2023.

1. DESCRIPTION OF PLAN (CONTINUED):

Forfeited Accounts

Forfeitures may be used to reduce any employer contribution. Forfeitures in the amount of \$9,295 and \$7,341 were available for the reduction of employer contributions at October 31, 2023 and June 30, 2023, respectively.

Certified Investments

Certain information related to investments disclosed in the accompanying financial statements, including investments held at October 31, 2023 and June 30, 2023, and net appreciation (depreciation) in fair value of investments and interest for the four-month period ended October 31, 2023, was obtained or derived from information supplied to the plan administrator and certified as complete and accurate by Standard Insurance Company (the trustee of the Plan).

2. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES:

Accounting Method

The financial statements of the Plan are prepared under the accrual method of accounting.

Use of Estimates

The preparation of financial statements in conformity with accounting principles generally accepted in the United States (“GAAP”) requires the Plan to make estimates that affect the amounts reported in the financial statements, accompanying notes, and supplemental schedule. Actual results could differ from these estimates.

Investments

As of October 31, 2023 and June 30, 2023, investments of the Plan are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. Standard Insurance Company determines the Plan’s valuation policies. Purchases and sales of investments are accounted for as of the trade date. Interest is recorded on the accrual basis. Net appreciation (depreciation) includes the Plan’s gains and losses on investments bought and sold as well as held during the period. The primary objective of the Plan investments is to achieve long-term capital appreciation within reasonable risk parameters. The investments are reviewed annually for impairment by management. No impairments were recognized by the Plan during the four-month period ended October 31, 2023 and year ended June 30, 2023.

Operating Expenses

All expenses of maintaining the Plan are paid by the Plan. The Plan may also impose specific charges against individual participant accounts for certain transactions.

3. INVESTMENTS:

For the four-month period ended October 31, 2023, and year ended June 30, 2023, the Plan's investments held by Standard Insurance Company, party-in-interest, (including investments bought, sold, and held during the year) are stated at fair value. Fair values and appreciation (depreciation) in value are summarized as follows:

4. FAIR VALUE MEASUREMENTS:

Generally accepted accounting principles establish a framework for measuring fair value. This framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1 measurements) and the lowest priority to unobservable inputs (level 3 measurements).

The three levels of the fair value hierarchy are described as follows:

Level 1 Fair Value Measurements: Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 Fair Value Measurements: Inputs to the valuation methodology include:

1. quoted prices for similar assets or liabilities in active markets;
2. quoted prices for identical or similar assets or liabilities in inactive markets;
3. inputs other than quoted prices that are observable for the asset or liability;
4. inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 Fair Value Measurements: Fair values are based on inputs other than quoted prices included within Level 1 that are unobservable and significant to the fair value measurements.

4. FAIR VALUE MEASUREMENTS (CONTINUED):

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at October 31, 2023 and June 30, 2023.

Insurance company guaranteed interest: Not traded on an open market and public prices are not available. Backed by a general account and does not have specific underlying assets assigned.

Pooled separate accounts: An investment where each plan shares in a pooled fund on a participation unit basis. The Plan's interest in the account is the cumulative record of the number of participation units credited to the account and the number of units allocated or withdrawn from the account. The participation unit value is adjusted periodically to reflect investment results under the separate account.

The preceding method described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation method is appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

5. RECONCILIATION OF FINANCIAL STATEMENTS TO SCHEDULE H, FORM 5500:

At October 31, 2023 and June 30, 2023, there were no differences between assets available for benefits per the financial statements and the assets available per Schedule H, Form 5500. Also, there were no differences in benefits paid to participants per the financial statements and Schedule H, Form 5500.

6. INCOME TAXES:

The Plan obtained its latest determination letter on January 14, 2004, in which the Internal Revenue Service stated that the Plan, as then designed, was in compliance with the applicable requirements of the Internal Revenue Code. The Plan has been amended since receiving the determination letter. However, the Plan administrator and the Plan's tax counsel believe that the Plan is currently designed and being operated in compliance with the applicable requirements of the Internal Revenue Code. Therefore, no provisions for income taxes have been included in the Plan's financial statements.

GAAP requires plan management to evaluate tax positions taken by the Plan. The financial statement effects of a tax position are recognized when the position is more likely than not, based on the technical merits, to be sustained upon examination by the IRS. The Plan Administrator has analyzed the tax positions taken by the Plan and has concluded that as of October 31, 2023 and June 30, 2023 there are no uncertain positions taken or expected to be taken. The Plan has recognized no interest or penalties related to uncertain tax positions. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

The income tax returns for the three prior years for federal and the four prior years for state income tax purposes are subject to examination by appropriate tax authorities. Interest and penalties, if imposed from tax positions, are recognized in the financial statements as general and administrative expenses.

7. RISKS AND UNCERTAINTIES:

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statement of net assets available for benefits.

8. RELATED PARTIES:

Party-in-interest transactions include fiduciaries or employees of the Plan, any person who provides services to the Plan, an employer whose employees are covered by the Plan, an employee organization whose members are covered by the Plan, a person who owns 50% or more of such an employer or employee organization, or relatives of such persons.

Certain Plan investments are shares of pooled separate accounts and insurance company guaranteed interest managed by Standard Insurance Company. Standard Insurance Company is the funding medium as defined by the Plan and, therefore, these transactions qualify as party-in-interest transactions. Fees paid by the Plan for the investment management services are included in the investment fair value amount.

9. PLAN TERMINATION:

On October 13, 2023, the Board of Directors of Tos Farms, Inc. Profit Sharing Plan approved the transfer of this Plan into a Pooled Employer Plan (PEP), effective October 13, 2023. As a result, all investments were transferred from the Plan into the PEP Plan on that date.

10. SUBSEQUENT EVENT:

Management has evaluated subsequent events through May 28, 2024, the date at which the financial statements were available to be issued. No significant subsequent events were discovered by management.
