Basis for Opinion

As further discussed in Note 1 to the financial statements, the Board of Managers of Sureprep LLC 401(k) Profit Sharing Plan and Trust approved a plan of liquidation on November 14, 2022, and determined liquidation is imminent. As a result, Sureprep LLC 401(k) Profit Sharing Plan and Trust changed its basis of accounting to the liquidation basis of accounting used in presenting the 2023 and 2022 financial statements. The Plan's assets were distributed on June 30, 2023. Our opinion is not modified with respect to this matter.

Responsibilities of Management for the Financial Statements

Management is responsible for the preparation and fair presentation of the financial statements in accordance with accounting principles generally accepted in the United States of America, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's election of ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

Management is also responsible for maintaining a current plan instrument, including all plan amendments, administering the plan, and determining that the plan's transactions that are presented and disclosed in the financial statements are in conformity with the plan's provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.

Note 1 - Description of Plan

The following brief description of Sureprep LLC 401(k) Profit Sharing Plan and Trust (the Plan) is provided for general information purposes only. Participants should refer to the Plan document for a more complete description of the Plan's provisions.

On November 14, 2022 the Board voted to terminate the Plan with an effective date of January 2, 2023. All employees were terminated as of December 31, 2022. On January 3, 2023, Sureprep LLC was acquired by Thomson Reuters Corporation. On June 30, 2023, all of the remaining assets in the Plan were distributed to the participants based on their respective account balance. Participants were permitted to roll over their account balance into the Thomson Reuters Corporation Plan, into an IRA, or take as a distribution.

General

The Plan is a defined contribution plan covering qualified employees of Sureprep LLC (the Company), and Plan Sponsor. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA). The Plan Administrator is responsible for oversight of the Plan.

The Retirement Plan Committee determines the appropriateness of the Plan's investment offerings and monitors investment performance and reports to the Plan's administrator.

Eligibility

Full-time employees are eligible to participate in the Plan if they have completed the minimum service requirement of 3 months of consecutive service and are 21 years of age. Temporary employees are eligible to participate in the Plan if they have completed the minimum service requirement of 1 year of consecutive service and are 21 years of age. The minimum service requirement for purposes of the Qualified Automatic Contribution Arrangement (QACA Safe Harbor) matching contribution and qualified nonelective contributions is 3 months of consecutive service for full-time, and 1 year of consecutive service for temporary employees. The minimum service requirement for purposes of profit-sharing contributions is 1,000 hours within a 12-month period. Employees covered by a collective bargaining agreement, non-resident aliens, and employees as a result of a recent merger, acquisition, or similar transaction are excluded from participating in the Plan.

Entry Date

Employees may enter the Plan immediately upon meeting the Plan's eligibility requirements.

Contributions

Each year, participants may contribute up to 100% of their pretax annual compensation, as defined in the Plan. Contributions are subject to certain Internal Revenue Code (IRC) limitations. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. The Plan allows participants to designate contributions as Roth contributions. Participants may also contribute amounts representing distributions from other qualified plans (rollover). For the QACA Safe Harbor the Company contributes 100% of the participant's elective deferrals that do not exceed 1% of eligible compensation, plus 50% of the participant's elective deferrals that exceed 1% of eligible compensation but do not exceed 6% of eligible compensation for the allocation period. During 2023, the Company did not make a QACA Safe Harbor contribution.

In addition, the Company may contribute a discretionary profit-sharing contribution. The profit-sharing contribution is allocated based on the percentage of the participant's compensation to the total compensation of all eligible participants. During 2023, the Company did not make a profit-sharing contribution.

The Company may also make a discretionary qualified nonelective contribution. The nonelective contribution is allocated based on the percentage of the participant's compensation to the total compensation of all eligible participants.

The discretionary contributions are funded annually. During 2023, the Company did not make a discretionary contribution.

The Plan includes an auto-enrollment provision whereby all newly eligible employees are automatically enrolled in the Plan unless they affirmatively elect not to participate in the Plan. Automatically enrolled participants have their deferral rate set at 3% of eligible compensation and their contributions invested in a designated Vanguard Target Retirement date fund until changed by the participant. Each year the deferral percentage increases by 1% up to 10% unless the participant files a contrary election form.

Participant Accounts

Each participant's account is credited with the participant's contribution and the Company's matching contributions, as well as allocations of the Company discretionary contributions (if any) and Plan earnings and losses. Participant accounts are charged with an allocation of administrative expenses that are paid by the Plan. Allocations are based on participant's compensation, account balances, or specific participant transactions, as defined by the Plan document. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Investment Options

Upon enrollment to the Plan, a participant may direct deferrals and employer contributions in any of the funds offered by the Plan. Participants may change their investment options daily.

Vesting

Participants are vested immediately in their contributions, the Company's QACA Safe Harbor match, and the Company's profit-sharing contributions, plus actual earnings thereon. Vesting in the Company's qualified nonelective contributions is based on years of credited service

Prior to November 14, 2022, vesting in the Company's qualified nonelective contributions were based on years of continuous service. Effective, November 14, 2022, participants are 100% vested in the Company's qualified nonelective contributions.

Forfeitures

At June 30, 2023 and December 31, 2022, there were no forfeited non-vested account balances.

Notes Receivable from Participants

Participants may borrow from their fund accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their account balance. The notes are secured by the balance in the participant's account. The interest rate is set at 1% above the prime rate. Principal and interest is paid ratably through payroll deductions over a period not to exceed five years, unless the proceeds of the note were used to acquire the participant's residence, in which case the loan terms can range up to 30 years. A participant may have no more than one outstanding note at any one time.

Payment of Benefits

Participants may elect to receive either a lump-sum amount equal to the value of their vested interest, or annual installments, as defined in the Plan document, upon retirement, termination of service, death, or disability. A terminated participant with a balance of less than \$1,000 may be automatically paid out by the Plan upon termination. Any terminated participants with a balance between \$1,000 and \$5,000 can still be automatically paid out if their balance is rolled into a qualified Individual Retirement Account. Distributions may be made at the participant's election prior to termination upon attainment of age 59 ½ or hardship, as defined in the Plan document.

Plan Termination

The Company had the right to terminate the Plan subject to the provisions set forth by ERISA. On November 14, 2022, the Board resolved to terminate the Plan effective January 2, 2023. The Company terminated all employees in December 2022 at which time all participants became fully vested in their employer contributions. As of June 30, 2023, the remaining assets of the Plan were distributed to the participants.

Note 2 - Significant Accounting Policies

Basis of Accounting

As described in Note 1, on November 14, 2022 the Board voted to terminate the Plan with an effective date of January 2, 2023. As such, the financial statements have been prepared using the liquidation basis of accounting.

Use of Estimates

The preparation of the financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect certain reported amounts of assets and liabilities, and changes therein, and disclosures of contingent assets and liabilities. Actual results may differ from those estimates.

Investment Valuation and Income Recognition

The Plan's investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan Sponsor determines the Plan's valuation policies utilizing information provided by the investment advisors and custodians. See Note 3 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Dividends are recorded on the ex-dividend date. Interest income is recorded on the accrual basis. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as those held during the year.

The classification of investment earnings reported in the statement of changes in net assets available for benefits may differ from the classification of earnings on Form 5500 due to different reporting requirements on Form 5500.

Notes Receivable from Participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred. Delinquent notes receivable are recorded as distributions based upon the terms of the Plan document.

Payments of Benefits

Benefit payments to participants are recorded upon distribution.

Expenses

The Plan's expenses are paid by either the Plan or the Company, as provided by the Plan document. Expenses that are paid directly by the Company are excluded from these financial statements. Certain expenses incurred in connection with the general administration of the Plan that are paid by the Plan are recorded as deductions in the accompanying statement of changes in net assets available for benefits. In addition, certain investment-related expenses are included in net appreciation in fair value of investments presented in the accompanying statement of changes in net assets available for benefits.

Subsequent Events

The Plan Sponsor has evaluated subsequent events through May 28, 2024, the date which the financial statements were available to be issued.

Note 3 - Fair Value Measurements

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). The three levels of the fair value hierarchy under the FASB ASC 820 are described as follows:

Level 1: Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2: Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets;
- Quoted prices for identical or similar assets or liabilities in inactive markets;
- Inputs other than quoted prices that are observable for the asset or liability; and
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3: Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Notes to Financial Statements

June 30, 2023 and December 31, 2022 (in Liquidation)

The following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at June 30, 2023 and December 31, 2022.

Mutual funds – Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-ended mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

Money market deposit accounts – Valued at carrying value, which approximates fair value, based on the amount of net contributions plus any investment earnings allocated to the account.

The methods described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

Note 4 - Certified Information

Certain information related to investments and notes receivable from participants disclosed in the accompanying financial statements and ERISA-required supplemental schedule, including investments and notes receivable from participants held at June 30, 2023 and December 31, 2022, and net appreciation in fair value of investments, interest and dividends, and interest income on notes receivable from participants for the six months ended June 30, 2023, was obtained by management and agreed to or derived from information certified as complete and accurate by Ascensus Trust Company (the trustee of the Plan).

Note 5 - Tax Status

Effective January 1, 2022, the Plan was restated as required by government regulation every six years. The Plan changed to a pre-approved plan document sponsored by Ascensus LLC, which received an opinion letter from the Internal Revenue Service (IRS), dated June 30, 2020, stating that the pre-approved document satisfies the applicable provisions of the IRC. The Plan's management believes that the Plan is currently designed and being operated in compliance with the applicable requirements of the IRC.

Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain tax position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

Note 6 - Related Party and Party-in-Interest Transactions

Certain Plan investments consist of mutual funds and money market deposit accounts managed by Vanguard, the recordkeeper, as defined by the Plan. As described in Note 2, the Plan paid certain expenses related to Plan operations and investment activity to various service providers. These transactions are exempt party-in-interest transactions under the ERISA.

Note 7 - Risks and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Market risks include global events which could impact the value of investment securities, such as a pandemic or global conflict. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statement of net assets available for benefits.

Note 8 - Late Filing

The Company did not timely file the final Form 5500 and will file the return under the IRS's Delinquent Filer Voluntary Compliance Program (DFVCP). The Plan Sponsor believes the Plan has maintained its tax-exempt status. Therefore, no provision for income taxes has been included in the Plan's financial statements.

Note 9 - Plan Amendments

Effective January 1, 2022, the Plan was amended to permit employees classified as temporary or seasonal to participate in the Plan upon completion of the minimum service requirement of 1 year of service and are 21 years of age.
