Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the accompanying financial statements of Polar Tech Industries, Inc. 401(k) Plan, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) [ERISA Section 103(a)(3)(C) audit. The financial statements comprise the statements of net assets available for benefits as of July 29, 2022, and December 31, 2021, and the related statement of changes in net assets available for benefits for the short year ended July 29, 2022, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of Polar Tech Industries, Inc. 401(k) Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from Reliance Trust Company as of July 29, 2022, and December 31, 2021, and for the short year ended July 29, 2022, stating that the certified investment information, as described in Note E to the financial statements, is complete and accurate.

Opinion

In our opinion, based on our audits and on the procedures performed as described in the Auditors' Responsibilities for the Audit of the Financial Statements section:

- the amounts and disclosures in the financial statements referred to above, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.
- the information in the financial statements referred to above related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

Basis for Opinion

We conducted our audits in accordance with auditing standards generally accepted in the United States of America. Our responsibilities under those standards are further described in the Auditors' Responsibilities for the Audit of the Financial Statements section of our report.

We are required to be independent of Polar Tech Industries, Inc. 401(k) Plan and to meet our other ethical responsibilities in accordance with the relevant ethical requirements relating to our audits. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our ERISA Section 103(a)(3)(C) audit opinion.

Emphasis of Matter

The accompanying December 31, 2021, financial statements have been prepared assuming that the Plan will continue as a going concern. As discussed in Notes A and C to the financial statements, the Board of Directors of Polar Tech Industries, Inc., the Plan sponsor, voted to transfer all the assets of the Plan, which indicated that the Plan is not a going concern as of December 31, 2021. The December 31, 2021, financial statements do not include any adjustments that might be necessary upon transfer. The Plan has changed its basis of accounting from going concern basis used in presenting the 2021 financial statements to the liquidation basis used in presenting the 2022 financial statements. Our opinion is not modified with respect to that matter.

Responsibilities of Management for the Financial Statements

Management is responsible for the preparation and fair presentation of the financial statements in accordance with accounting principles generally accepted in the United States of America, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

In preparing the financial statements, management is required to evaluate whether there are conditions or events, considered in the aggregate, that raise substantial doubt about Polar Tech Industries, Inc. 401(k) Plan's ability to continue as a going concern for one year after the date the financial statements are available to be issued.

Management is also responsible for maintaining a current plan instrument, including all plan amendments; administering the plan; and determining that the plan's transactions that are presented and disclosed in the financial statements are in conformity with the plan's provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.

Auditors' Responsibilities for the Audit of the Financial Statements

Except as described in the Scope and Nature of the ERISA Section 103(a)(3)(C) Audit section of our report, our objectives are to obtain reasonable assurance about whether the financial statements as a whole are free from material misstatement, whether due to fraud or error, and to issue an auditors' report that includes our opinion. Reasonable assurance is a high level of assurance but is not absolute assurance and therefore is not a guarantee that an audit conducted in accordance with generally accepted auditing standards will always detect a material misstatement when it exists. The risk of not detecting a material misstatement resulting from fraud is higher than for one resulting from error, as fraud may involve collusion, forgery, intentional omissions, misrepresentations, or the override of internal control. Misstatements are considered material if there is a substantial likelihood that, individually or in the aggregate, they would influence the judgment made by a reasonable user based on the financial statements.

In performing an audit in accordance with generally accepted auditing standards, we:

- Exercise professional judgment and maintain professional skepticism throughout the audit.

The information included in the supplemental schedules, other than that agreed to or derived from the certified investment information, has been subjected to auditing procedures applied in the audits of the financial statements and certain additional procedures, including comparing and reconciling such information directly to the underlying accounting and other records used to prepare the financial statements or to the financial statements themselves, and other additional procedures in accordance with generally accepted auditing standards. For information included in the supplemental schedules that agreed to or is derived from the certified investment information, we compared such information to the related certified investment information.

NOTES TO FINANCIAL STATEMENTS

NOTE A - DESCRIPTION OF PLAN

The following description of the Polar Tech Industries, Inc. 401(k) Plan (the "Plan") provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

GENERAL

The Plan is a defined contribution plan covering all eligible employees of Polar Tech Industries, Inc. (the "Company"). The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

PLAN TERMINATION

During 2022 the Board of Directors elected to transfer all assets of the plan to the Insperity 401K Plan and terminate the Polar Tech Industries, Inc. 401(k) Plan on July 29, 2022. Participants began making contributions to the Insperity 401K plan effective April 4, 2022.

The Plan was terminated, and the assets transferred on July 29, 2022. The Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provision of ERISA. All assets were transferred to Insperity 401K Plan at fair value.

CONTRIBUTIONS

Participants may elect to contribute pre-tax earnings and/or Roth contributions up to current Internal Revenue Service ("IRS") regulations. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. All employees, except collectively bargained employees and non-resident aliens, are eligible to enter the Plan after completing 90 days of service with the Company and attainment of age 21. Eligible employees can enter the Plan on the first day of the following month the eligibility requirements are met. Participants may also contribute amounts representing distributions from other qualified retirement plans. The Company may contribute a discretionary match and/or profit-sharing contribution to all eligible employees. The Company did not elect to make a discretionary profit-sharing contribution for 2022. The Company may contribute a discretionary matching contribution to the Plan. This amount is allocated to the participants' accounts who are employed during the year. The Company did not elect to make a discretionary matching contribution for the short year ended July 29, 2022. Participants direct the investment of their contributions into various investment options offered by the Plan. Contributions are subject to certain limitations.

PARTICIPANT ACCOUNTS

Each participant's account is credited with the participant's contributions and Company discretionary matching contributions, as well as allocations of the Company's discretionary non-elective contributions and Plan earnings. Participants are charged with an allocation of administrative expenses that are paid by the Plan. Allocations are based on participant earnings, account balances, or specific participant transactions, as defined. The benefit to which a participant is entitled is what can be provided from the participant's vested account.

NOTES RECEIVABLE FROM PARTICIPANTS

Participants may borrow from their account a minimum loan of \$1,000 and up to a maximum amount equal to the lesser of \$50,000 or 50 percent of their vested account balance. The loans are secured by the balance in the participant's account and bear interest at rates which are commensurate with local prevailing rates as determined by the Plan administrator. Principal and interest is paid ratably through payroll deductions. The participants may have one loan outstanding at any time.

PAYMENT OF BENEFITS

On termination of service due to death, disability, or retirement a participant or his beneficiary may elect to receive a single lump-sum payment equal to the value of the participant's vested interest. For termination of services for other reasons, a participant may receive the value of the vested interest in their account as a lump-sum payment. Account balances less than \$5,000 are subjected to payment regardless of whether the participant consented to receive it upon termination.

FORFEITED ACCOUNTS

At July 29, 2022 and December 31, 2021, forfeited non-vested accounts totaled \$0 and \$1,712, respectively. Forfeitures may be used to reduce future employer contributions or pay plan expenses.

NOTE B - SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

The summary of significant accounting policies is presented to assist in understanding the Plan's financial statements. The financial statements and notes are representations of the Plan's management, which is responsible for their integrity and objectivity. These accounting policies conform to accounting principles generally accepted in the United States of America and have been consistently applied in the preparation of the financial statements.

BASIS OF ACCOUNTING

The financial statements of the Plan are prepared using the liquidation basis of accounting in conformity with generally accepted accounting principles.

USE OF ESTIMATES

The preparation of financial statements in conformity with generally accepted accounting principles in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Accordingly, actual results may differ from those estimates.

INVESTMENT VALUATION AND INCOME RECOGNITION

Investments are reported at fair value (except for fully benefit responsive investment contracts, which are reported at contract value). Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note F for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation or depreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

NOTES RECEIVABLE FROM PARTICIPANTS

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are charged directly to the borrowing participant's account and are included in administrative expenses when incurred. As of July 29, 2022 and December 31, 2021, no allowance for credit losses has been recorded.

PAYMENT OF BENEFITS

Benefit obligations are recorded when paid.

EXPENSES

Certain expenses of maintaining the Plan are paid by the Plan, unless otherwise paid by the Company. Expenses that are paid by the Company are excluded from these financial statements. Fees related to the administration of notes receivable from participants are charged directly to the participant's account and are included in administrative expenses. Investment related expenses are included in net appreciation/depreciation of fair value of investments.

SUBSEQUENT EVENTS

The Plan has evaluated subsequent events through June 3, 2024, the date which the financial statements were available to be issued.

NOTE C - PLAN TERMINATION

The Plan was terminated and the assets transferred on July 29, 2022. The Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. All assets were transferred to Insperity 401k Plan.

NOTE D - TAX STATUS

The Plan is a Prototype Non-Standardized Pre-Approved Profit-Sharing plan sponsored by ADP, LLC that has been adopted by the Company. The plan obtained its latest opinion letter on October 6, 2020, by which the Internal Revenue Service has determined and informed the Company that the Plan and related trust are designed in accordance with the applicable sections of the Internal Revenue Code (IRC). Although the Plan has been amended since receiving the determination letter, the Plan administrator and the Plan's tax counsel believe that the Plan is designed, and is currently being operated, in compliance with the applicable requirements of the IRC and there, believe that the Plan is qualified, and the related trust in tax-exempt.

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the plan and recognize a tax liability if the plan has taken an uncertain position that more likely than not would not be sustained upon examination by the U.S. Federal or Illinois taxing jurisdictions. The plan administrator has analyzed the tax positions taken by the plan, and has concluded that as of July 29, 2022, there are no uncertain positions taken or expected to be taken that would require recognition of a liability or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

NOTE E – CERTIFIED INVESTMENTS

Certain information related to investments and notes receivable from participants disclosed in the accompanying financial statements and supplemental schedule, including investments and notes receivable from participants held at July 29, 2022 and December 31, 2021, and net depreciation/appreciation in fair value of investments, interest and dividends, and interest income on notes receivable from participants for the short year ended July 29, 2022, was obtained or derived from information supplied to the plan administrator and certified as complete and accurate by Reliance Trust Company, (the trustee of the Plan).

NOTE F - FAIR VALUE MEASUREMENTS

FASB ASC Topic 820, *Fair Value Measurements*, establishes a framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1 measurements) and the lowest priority to unobservable inputs (level 3 measurements). The three levels of the fair value hierarchy under FASB ASC Topic 820 are described as follows:

Level 1 Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 Inputs to the valuation methodology include

- Quoted prices for similar assets or liabilities in active markets;
- Quoted prices for identical or similar assets or liabilities in inactive markets;
- Inputs other than quoted prices that are observable for the asset or liability;
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in methodologies used at July 29, 2022 and December 31, 2021.

Registered investment companies: Valued at the net asset value (NAV) of shares, which are based on quoted market prices, held by the Plan as of the end of the year.

Common collective trusts: Valued using the practical expedient at the net asset value (NAV) of units held by the Plan as of the end of the year.

Stable value collective trust fund: A stable value fund that is composed primarily of fully benefit-responsive investment contracts that is valued at the net asset value of units of the bank collective trust. The net asset value is used as a practical expedient to estimate fair value. This practical expedient would not be used if it is determined to be probable that the fund will sell the investment for an amount different from the reported net asset value. Participant transactions (purchases and sales) may occur daily. If the Plan initiates a full redemption of the collective trust, the issuer reserves the right to require 12 months' notification in order to ensure that securities liquidations will be carried out in an orderly business manner.

The preceding methods described may produce a fair value calculation that may not be indicative of the net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

Polar Tech Industries has experienced delays and fines due to ADPs lack of performance, poor performance, and lack of communication which has and will result in cost impacts to Polar Tech's timely submission to the Department of Labor of compliant 401K documents for plan year 2021 and 2022. The following is a timeline detailing ADP's repeated delays impacting the completion of compliant 401k documents.

2022 Plan Year

- 1) Contacted ADP on 2/13/2024 because we had not received into our ADP portal the preliminary Form 5500 & attachments and Form 8955-SSA for the Plan Year 2022. Spoke with Renee McBrayer. As such, it was determined Plan 246357 was classified in ADP "in error" as a "transfer" to Insperity. Therefore, Renee asked for a "Plan Merger Letter of Instruction" to correct along with the date of the final merger which was noted in the letter as 8/1/2022 since ADP merged the assets into Insperity on 7/29/2022.

The Plan Merger letter was sent to Renee & received by Renee on 2/14/2024. As such, Renee opened ADP Cases t240215014t and t240215013o on 2/15/2024 to update the Plan #246357 records to reflect a merger, provide automated system & notification updates and to complete & upload the Final Form 5500 & its related attachments within approximately 10 business days.

Also, Renee opened on 2/13/2024 an ADP Compliance Case SF-3309106 to determine if a 2022 Participant and Plan Level Valuation Summary Report were available for our Auditors, Porte Brown LL who just started the 2022 Plan Year audit. As a result, we received from Renee the 2022 Participant and Plan Level Valuation Summary Report on 2/14/2024 and forwarded it to our Auditors, Porte Brown.

- 2) On 2/21/2024 we received an email from Renee that the Form 5500 and related documents were pending completion. Further, she would be out of the office for a few days and to contact ADP Retirement Services at 800 929-2170 for updates going forward.
- 3) During 2/22/2024 thru 2/26/2024 we received several emails from the ADP Compliance division that the Form 5500 & related documents were posted to our updated portal at ADP. On 2/29/2024, Alyssa Holte of ADP, sent instructions to assist us to download the form 5500 & its related documents to allow us to forward to our Auditors, Porte Brown. As such, the documents were forwarded to Porte Brown on 2/29/2024.
- 4) Based on communications from the Auditor, Jacob Staab of Porte Brown, from 4/2/2024 thru 4/3/2024, the audit was complete pending two significant required changes, specifically:
 - Schedule H should have an ending zero balance in most instances because the assets were merged from ADP to Insperity on 7/29/2022. Porte Brown provided an updated Schedule H for ADP to consider.
 - The Plan Year End should be approximately 7/29/2022, the date of the merger or 8/1/2022 at the latest, due to the weekend.
- 5) Based on 4) above, an email was sent on 4/4/2024 to the ADP Mykteam & Alyssa Holte regarding the 2022 Plan Year preliminary Form 5500 & its related documents with said email requesting changes to the preliminary Form 5500 & its related documents based on our Auditors findings. Also included was an edited copy of Schedule H from our Auditor to assist ADP in making corrections.
- 6) On 4/15/2024, followed up with ADP Retirement Services at 800 929-2170 to obtain status. Spoke with Tony at 8:40am. He said nothing was being done and that our request for changes should have gone to plan_transfer@adp.com. As such, we forwarded the 4/4/2024 email at 9:29am to the ADP Transfer Team. This did nothing as we started receiving various ADP emails that someone would contact us or to contact ADP Retirement Services at 800 929-2170. Since no one contacted us, we contacted ADP RS at 12:30pm and spoke with Tim who said we were given incorrect guidance from Tony and our request should have been sent to compliance@adp.com.
- 7) Per Tim's instructions we forwarded the original email requesting changes, correcting errors and a copy of Schedule H with corrections from our Auditor to compliance@adp.com at 2:22pm on 4/15/2024.
- 8) On 4/25/2024, we received notification the Form 5500 and related schedules were updated with instructions to access via the fisglobal website. Unfortunately, based on a review by our Auditor and us, all corrections were not made. Therefore, on 4/29/2024, we contacted the ADP Retirement Services division at 800 929-2170 to notify ADP of the errors. We were told they would take care of making the corrections and it could take 7 to 10 business days.

- 9) Since the 7 to 10 business days passed without any feedback from ADP, we again contacted the ADP Retirement Services division at 800 929-2170 on 5/17/2024 at 12:00pm and spoke with Brandon /Brendon. Per our discussion, he agreed there were multiple errors regarding the Plan ending date. In fact all documents were wrong and ADP clearly did not accurately process the documents. He then sent a request to the ADP Compliance division which included a request to expedite the corrections because we started to receive notification from the DOL regarding penalties, interest, etc.. We also informed the DOL we have been waiting on ADP to provide complete and accurate documents for our Auditor and subsequent submittal.
- 10) Since again we received no updates, on 5/29/2024 at 1:08pm we again contacted the ADP Retirement Services division at 800 929-2170 and spoke with Mary. She agreed Brandon/Brendon processed the request but the ADP Compliance division had not completed the corrections. She also said someone would get back to us the same or next day. Since we have not received an update and ALL of the corrected documents, this timeline of events was created and being sent to you. **The DOL continues to reach out to us regarding the 2022 Plan Year and has stated penalties & interest are accruing for non-filing an acceptable return.**

2021 Plan Year

- 11) **As stated above, the DOL continues to reach out to us regarding the 2022 Plan Year. Also, the DOL fined us approximately \$36,640.71 for the 2021 Plan Year because ADP included employee information within the 2021 Form 8955-SSA for that shouldn't be there. This brings up another major issue, is the 2021 Form 8955-SSA wrong or is the DOL wrong? DOL has stated to us that ADP is clearly wrong. We absolutely need your immediate feedback because this issue also affects the final 2022 Plan Year documents.** Please refer to the attached letter dated October 23, 2023 from the DOL regarding 2021, specifically, the top paragraphs on page 2. Being that ADP is PEO, does that effect what is required on and how ADP processes, uploads and instructs to file the 8955-SSA document? Also, we attached a most recent copy of a letter from the DOL, dated January 19, 2024.

Time is of the essence. Please review and ensure the ADP team properly and promptly completes compliant 401K documents for 2022, and if necessary 2021.
