Scope and Nature of the ERISA Section 103(a)(3)(C) Audits

We have performed audits of the financial statements of BSCS Science Learning 403(b) DC Plan (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C). The financial statements comprise the statements of net assets available for benefits as of June 2, 2023 (in liquidation) and December 31, 2022 (ongoing), the related statement of changes in net assets available for benefits for the period ended June 2, 2023 (in liquidation), and the related notes to the financial statements.

As discussed in Note 1 to the financial statements, the governing body of the Plan approved a plan of liquidation effective June 1, 2023, and management determined liquidation was imminent. As a result, the Plan changed its basis of accounting from the going concern basis used in presenting the 2022 financial statements to the liquidation basis used in presenting the 2023 financial statements. Our opinion is not modified with respect to that matter.

Responsibilities of Management for the Financial Statements

Management is responsible for the preparation and fair presentation of the financial statements in accordance with GAAP, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

1. DESCRIPTION OF THE PLAN:

The following brief description of BSCS Science Learning 403(b) DC Plan (the Plan) provides only general information. Participants should refer to the Summary Plan Description for a more complete description of the Plan's provisions.

GENERAL

The Plan is a 403(b) retirement plan covering all eligible employees of BSCS Science Learning (the Organization). Prior to the Organization terminating and liquidating the Plan as described below, all employees were eligible to make elective deferrals to the Plan. Employees who had attained 21 years of age were eligible to receive employer contributions after one year of service. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

Effective January 1, 2022, the Organization closed the Plan to all employee deferrals and employer contributions. The Organization started a new 401(k) plan and all employee deferrals and employer contributions are being made to the new plan. Effective June 1, 2023, the Plan adopted an amendment to terminate and liquidate the Plan. No participants were allowed to enter the Plan after the date of Plan termination. All participants were fully vested in their account balances, and the account balances were liquidated and distributed to participants on June 2, 2023.

CONTRIBUTIONS

Prior to the Organization closing the plan to new contributions as described above (Note 1, General), participants could make elective deferral contributions up to limits prescribed by law. Participants who had attained age 50 and/or had 15 years of service before the end of the plan year were eligible to make catch-up contributions. Effective August 1, 2021, participants could designate all or a portion of their contributions as Roth contributions. Participants could also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans. The Organization made contributions equal to 8 percent of eligible compensation.

Contributions are subject to certain limitations prescribed by law. Participants direct the investment of all contributions into various investment options offered by the Plan.

PARTICIPANT ACCOUNTS

Each participant's account is credited with the participant's contribution and allocations of (a) the Organization's contribution and (b) Plan earnings. Allocations are based on participant earnings or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

VESTING

Participants are vested immediately in their contributions, the Organization's contributions to their accounts, and actual earnings thereon.

1. DESCRIPTION OF THE PLAN, continued:

PLAN LOANS

Prior to the year ended December 31, 2020, participants could borrow from Teachers Insurance and Annuity Association (TIAA) a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their account balance. The loans, totaling \$65,604, as of December 31, 2022, are secured by the balance in the participant's account and bear interest at the rates from 4.00% to 4.65%. Principal and interest is paid from the participants directly to TIAA. The loans are not considered assets of the Plan and therefore are not included on the statements of net assets available for benefits. All plan loans were liquidated as of June 2, 2023.

PARTICIPANT LOANS

Participants could borrow from their accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balance. The loans are secured by the balance in the participant's account and bear interest at a rate of 4.25%. Principal and interest are paid ratably through payroll deductions. Participant loans are classified as notes receivable from participants on the statements of net assets available for benefits. All participant loans were liquidated as of June 2, 2023.

PAYMENT OF BENEFITS

Upon termination of service due to severance of employment, death, disability, retirement, or upon attaining age 59½, a participant may elect to receive an amount equal to the value of the participant's account. These payments are subject to time restrictions for those investments in the TIAA traditional annuity account under the Retirement Annuity contract. Upon proof, to the satisfaction of the plan administrator, of an immediate and heavy financial need, participant deferrals and employer contributions may be withdrawn for a hardship purpose.

2. SIGNIFICANT ACCOUNTING POLICIES:

BASIS OF ACCOUNTING

The accompanying December 31, 2022 financial statements of the Plan are prepared on the accrual basis of accounting.

The financial statements for the period ended June 2, 2023 have been prepared under the liquidation basis. This basis was adopted when liquidation was deemed imminent in accordance with Accounting Standards Update ("ASU") 2013-07, *Liquidation Basis of Accounting*. Plan management determined that liquidation was imminent upon adoption of the resolution to terminate the Plan on June 1, 2023. Under the liquidation basis of accounting, assets are measured at their net realizable value, estimated by fair value reduced by surrender charges, penalties and redemption charges, and disposal expenses, to reflect the estimated amount of cash expected to be collected in settling or disposing of the assets during the liquidation process. Liabilities are measured using the accrual basis of accounting, including any expected costs of the disposal of assets and other costs expected to be incurred during the liquidation process.

2. SIGNIFICANT ACCOUNTING POLICIES, continued:

BASIS OF ACCOUNTING, continued

The Plan liquidated all assets as of June 2, 2023, and the liquidation of the assets is reported as liquidation of plan assets due to plan termination on the statement of changes in net assets available for benefits (in liquidation).

USE OF ESTIMATES

The preparation of the financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

INVESTMENT VALUATION AND INCOME RECOGNITION

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 4 for a discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the period.

NOTES RECEIVABLE FROM PARTICIPANTS

Notes receivable from participants represent participant loans, and are measured at their unpaid principal balances plus accrued but unpaid interest. Delinquent participant loans are reclassified as distributions based upon terms of the Plan document.

PAYMENT OF BENEFITS

Benefits are recorded when paid.

3. INFORMATION CERTIFIED BY THE QUALIFIED INSTITUTOIN:

The Plan administrator has elected the method of compliance as permitted by 29 CFR 2520.103-8 of the DOL's Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, Teachers Insurance and Annuity Association of America (TIAA) and College Retirement Equity Fund (CREF) have certified the completeness and accuracy of all investments reflected on the accompanying statements of net assets available for benefits as of June 2, 2023 and December 31, 2022 and the related investment activity reflected in the statement of changes in net assets available for benefits for the period ended June 2, 2023.

4. FAIR VALUE MEASUREMENTS:

The Plan uses appropriate valuation techniques to determine fair value based on inputs available. The methods used to measure fair value may produce an amount that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date. When available, the Plan measures fair value using Level 1 inputs because they generally provide the most reliable evidence of fair value. Level 3 inputs are only used when Level 1 or Level 2 inputs were not available.

Non benefit-responsive fixed annuity contracts are reported at contract value, which represents fair value. The contract value equals the accumulated cash contributions and interest credited to the Plan's contracts, less any withdrawals. The fair value of the pooled separate account units is traded on an active market.

5. PLAN TERMINATION:

The Organization has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions set forth in ERISA. As described in Note 1 (General), the Organization resolved to terminate the Plan effective June 1, 2023. Participants became 100% vested in their accounts as of the termination date.

6. TAX STATUS:

The Plan has adopted a volume submitter plan document sponsored by TIAA. The volume submitter plan document has obtained an opinion letter from the Internal Revenue Service dated August 8, 2017, in which states that the Plan, as then designed, was in compliance with the applicable requirements of the Internal Revenue Code. The Plan has been amended since receiving the opinion letter. However, the Plan administrator and the Plan's tax counsel believe that the Plan is designed in compliance with the applicable requirements of the Internal Revenue Code.

7. PARTIES-IN-INTEREST:

Certain investments for the Plan are funds managed by TIAA. TIAA performs recordkeeping services for the Plan; therefore, these transactions qualify as party-in-interest transactions. The value of these investments is \$0 and \$8,106,852, as of June 2, 2023 and December 31, 2022, respectively. Indirect fees, such as investment management fees, are included in appreciation on the statement of changes in net assets available for benefits.

8. SUBSEQUENT EVENTS:

Subsequent events have been evaluated through June 5, 2024, which represents the date the financial statements were available to be issued. Subsequent events after that date have not been evaluated.
