Opinion

We have audited the financial statements of Diameter Health, Inc. Retirement Savings Plan (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA). Notes to Financial Statements

1. Description of the Plan

The following description of the Diameter Health, Inc. Retirement Savings Plan (the Plan) provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

General

Diameter Health, Inc. (Diameter or the Company) participated in the JustWorks Retirement Savings Plan (the Former Plan), a multiple employer 401(k) plan. On August 26, 2022, RealMed Corporation (RealMed), a wholly owned subsidiary of Availity, L.L.C. (Availity), acquired the issued and outstanding equity interests of Diameter.

Diameter terminated their participation in the Former Plan immediately preceding the consummation of the acquisition and transferred the assets and liabilities attributable to Diameter's portion of the Former Plan to the Plan, which was adopted and simultaneously terminated on August 24, 2022 as a defined contribution plan intended to conform to and qualify under Section 401 and 501 of the Internal Revenue Code of 1986 (IRC), as amended. Effective December 16, 2022, the net assets of the Former Plan totaling \$3,535,909 were transferred into the Plan. As a result of the transfer, there was a black out period from November 21, 2022 through December 21, 2022. Subsequent to termination on August 24, 2022, the Plan facilitated distribution of assets to participants or other eligible participant accounts through May 24, 2023. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974, as amended (ERISA).

All participants of the Plan were fully vested and eligible for distributions and, as of May 24, 2023, all assets of the Plan had been distributed from the Plan.

The Plan trustee and its recordkeeper were one named employee of the Company and Slavic Integrated Administration, Inc. (Slavic), respectively. Slavic established a Plan Trust Account that held all assets of the Plan in accordance with the service provider contract with the Company. Slavic Mutual Funds Management, an affiliate of Slavic, was the fiduciary and the investment manager.

Eligibility

All participants of the Former Plan were eligible to participate in the Plan. However, no participants were allowed to enter the Plan after the date of Plan termination.

Contributions

The Plan did not allow any additional contributions, other than: 1) contributions that have been accrued on behalf of participants in the Plan on or prior to August 24, 2022; 2) any corrective contributions; 3) contributions made on behalf of participants in the Plan that are based on compensation earned on or prior to August 24, 2022; and 4) repayment of loan balances (if any) to the extent permitted by the Plan.

Participant Accounts

Each participant's account was credited with the participant's contributions, the Company's contributions, and allocations of net Plan earnings or losses and charged with an allocation of administrative expenses. Allocations were based on participant earnings, account balances, or

specific participant transactions, as defined. The benefit to which participants were entitled was the vested portion of their accounts.

Vesting

Participants were vested immediately in their contributions plus all employer contributions.

Payment of Benefits

Participants may elect to roll over their vested balance to another qualified retirement plan or individual retirement account (IRA). The account balances were liquidated and distributed to participants as soon as administratively practicable after the Plan termination date.

2. Summary of Accounting Policies

Basis for Accounting

Financial Accounting Standards Board (FASB) issued Accounting Standards Codification (ASC) 205-30, *Presentation of Financial Statements: Liquidation Basis of Accounting*, which requires an entity to prepare its financial statements using the liquidation basis of accounting when liquidation is imminent. The Plan implemented ASC 205-30 for the 2022 Plan year as this is when liquidation was determined to be imminent. Therefore, the accompanying financial statements have been prepared on a liquidation basis of accounting as of May 24, 2023 and December 31, 2022, and for the period from January 1, 2023 to May 24, 2023 and for the period from August 24, 2022 to December 31, 2022. Liquidation basis accounting requires all assets to be presented at expected value in liquidation, which, for the Plan's assets, was fair market value. The adoption did not have a material impact on the financial statements.

Use of Estimates

The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America (GAAP) requires management to make estimates and assumptions that affect the reported amounts of assets, liabilities, and changes therein and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

Investment Valuation and Income Recognition

The Plan's investments were stated at fair value. Fair value was the amount that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date (the exit price). See Note 3 for discussion of fair value measurements.

Purchases and sales of investments were recorded on a trade-date basis. Dividends were recorded on the ex-dividend date and interest income was recorded on the accrual basis. Net appreciation (depreciation) included the Plan's gains and losses on investments bought and sold as well as held during the year.

Payment of Benefits

Benefit payments to participants were recorded when paid.

Administrative Expenses

Certain expenses of maintaining the Plan were paid by the Plan, unless otherwise paid by the Company. Expenses that were paid by the Company were excluded from these financial statements. Fees related to participant-initiated transactions are charged directly to the participant's account and are included in administrative expenses. Investment-related expenses are included in net appreciation (depreciation) in fair value of investments. Fees paid by the Plan for administrative expenses were \$6,325 for the period from January 1, 2023 to May 24, 2023 and \$825 for the period from August 24, 2022 to December 31, 2022.

3. Fair Value Measurements

ASC 820, *Fair Value Measurements*, establishes a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements). The three levels of the fair value hierarchy under ASC 820 are described below:

Level 1 - Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 - Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets.
- Quoted prices for identical or similar assets or liabilities in inactive markets.
- Inputs other than quoted prices that are observable for the asset or liability.
- Inputs that are derived principally from, or corroborated by, observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 - Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

A financial instrument's level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

The following is a description of the valuation methodology used for assets measured at fair value:

Mutual Funds - The shares of registered investment companies are valued at quoted market prices in an exchange and active market, which represent the net asset values (NAV) of shares held by the Plan at year-end. Investments in mutual funds are classified within Level 1 of the valuation hierarchy.

The preceding methods described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of

4. Related Party Transactions and Party-in-Interest Transactions

Certain Plan investments were in funds and accounts that are managed by the fiduciary or their subsidiaries and affiliates. Participant distribution processing fees are paid to recordkeeper by participants. As described in Note 2, the Plan paid certain expenses related to Plan operations and investment activity to various service providers. These transactions are party-in-interest transactions, which are exempt from prohibited transaction rules.

5. Tax Status

The Plan used a pre-approved plan document sponsored by Slavic. The Internal Revenue Service (IRS) determined in an opinion letter dated June 30, 2020 that the pre-approved plan complied with the appropriate sections of the IRC. The Plan's management believed that the Plan was designed and operated in compliance with the applicable requirements of the IRC.

GAAP requires Plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan was subject to routine audits by taxing jurisdictions; however, there were currently no audits for any tax periods in progress.

6. Risks and Uncertainties

The Plan provided for investment options that were comprised of various investment securities. Investment securities are exposed to various risks, such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities and the level of uncertainty related to changes in the value of investment securities, it was at least reasonably possible that changes in risks in the near term would materially affect participants' account balances and the amounts reported in the financial statements.

7. Plan Termination

The Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions set forth in ERISA. On August 24, 2022, as described in Note 1, the Company resolved to terminate the Plan effective August 24, 2022. Participants became 100% vested in their accounts as of the termination date.

8. Subsequent Events

The Plan has evaluated subsequent events through June 6, 2024, the date the financial statements were available to be issued.
