INDEPENDENT AUDITORS' REPORT

To the Plan Administrator,
Jones, Edmunds & Associates, Inc. 401(k) Plan:

Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the financial statements of Jones, Edmunds & Associates, Inc. 401(k) Plan (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of August 31, 2023 and December 31, 2022, and the related statement of changes in net assets available for benefits for the period from January 1, 2023 to August 31, 2023, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from a qualified institution as of August 31, 2023 and December 31, 2022, and for the period from January 1, 2023 to August 31, 2023, stating that the certified investment information, as described in Note 3 to the financial statements, is complete and accurate.

Opinion

In our opinion, based on our audits and on the procedures performed as described in the Auditors' Responsibilities for the Audit of the Financial Statements section:

- The amounts and disclosures in the accompanying financial statements, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.
- The information in the accompanying financial statements related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

Basis for Opinion

We conducted our audits in accordance with auditing standards generally accepted in the United States of America (GAAS). Our responsibilities under those standards are further described in the Auditors' Responsibilities for the Audit of the Financial Statements section of our report. We are required to be independent of the Plan and to meet our other ethical responsibilities, in accordance with the relevant ethical requirements relating to our audits. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our ERISA Section 103(a)(3)(C) audit opinion.

Emphasis of Matter – Plan Merger

As discussed in Note 1(b) of the financial statements, effective August 31, 2023, the Plan was merged into the NestEggs Master Pooled 401(k) Plan. The total assets of the Plan transferred to the NestEggs Master Pooled 401(k) Plan on August 31, 2023. Our opinion is not modified with respect to this matter.

Responsibilities of Management for the Financial Statements

Management is responsible for the preparation and fair presentation of the financial statements in accordance with accounting principles generally accepted in the United States of America, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

In preparing the financial statements, management is required to evaluate whether there are conditions or events, considered in the aggregate, that raise substantial doubt about the Plan's ability to continue as a going concern for one year after the date that the financial statements are issued.

Management is also responsible for maintaining a current plan instrument, including all plan amendments, administering the plan, and determining that the plan's transactions that are presented and disclosed in the financial statements are in conformity with the plan's provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.

Auditors' Responsibilities for the Audit of the Financial Statements

Except as described in the Scope and Nature of the ERISA Section 103(a)(3)(C) Audit section of our report, our objectives are to obtain reasonable assurance about whether the financial statements as a whole are free from material misstatement, whether due to fraud or error, and to issue an auditors' report that includes our opinion. Reasonable assurance is a high level of assurance but is not absolute assurance and therefore is not a guarantee that an audit conducted in accordance with GAAS will always detect a material misstatement when it exists. The risk of not detecting a material misstatement resulting from fraud is higher than for one resulting from error, as fraud may involve collusion, forgery, intentional omissions, misrepresentations, or the override of internal control. Our audits did not extend to the certified investment information, except for obtaining and reading the certification, comparing the certified investment information with the related information presented and disclosed in the financial statements, and reading the disclosures relating to the certified investment information to assess whether they are in accordance with the presentation and disclosure requirements of accounting principles generally accepted in the United States of America.

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audit.



(1) Description of Plan:

The following description of the Jones, Edmunds & Associates, Inc. 401(k) Plan (the “Plan”) provides only general information. Participants should refer to the Plan agreement for a complete description of the Plan’s provisions. Jones, Edmunds & Associates, Inc. and JEA Construction Engineering Services, Inc. (collectively referred to as the Company) have adopted the provisions of the Plan.

(a) **General**—The Plan is a defined contribution 401(k) plan that covers substantially all employees of the Company who have attained the age of 21 and have completed at least three months of service. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA), as amended.

(b) **Plan merger**—Effective August 31, 2023, the Plan was merged into the NestEggs Master Pooled 401(k) Plan. The total assets of the Plan transferred to the NestEggs Master Pooled 401(k) Plan was \$28,347,196. Participants of the Plan should refer to the NestEggs Master Pooled 401(k) Plan official plan documents for complete plan information.

(c) **Contributions**—Each year, participants may contribute a percentage of not less than 1% pretax annual compensation or a dollar amount not to exceed the IRS non-taxable limit, as defined by the Plan. If a participant is subject to the Plan’s automatic enrollment, the Company will begin to automatically deduct 4% from pre-tax compensation as a deferral contribution to the Plan. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans. The Company may contribute to the Plan on an annual basis at its discretion. For the period from January 1, 2023 to August 31, 2023, the Company contributed 50% of the participant’s elective deferral contributions to the Plan up to 4% (or 2%) of the participants’ qualified compensation. Participants direct the investment of their contributions and the Company’s contribution into various investment options offered by the Plan. Contributions are subject to certain limitations.

(d) **Participant accounts**—Each participant’s account is credited with the participant’s contribution and an allocation of (a) the Company’s contribution and (b) plan earnings or losses and is charged with an allocation of administrative expenses. Allocations are based on participant earnings or account balances, as defined by the Plan. The Company offered 14 common and collective trust funds, 14 mutual funds and 1 annuity fund as investment options for participants. Participants may change their investment options on a daily basis, however, due to the various unique investments that may be allowed in a collective trust fund and stable value fund, and the various redemption restrictions that may be imposed, there are restrictions on transfers and trades for some of the collective trust funds and the insurance company general account held in the plan. The benefit to which a participant is entitled is the benefit that can be provided from the participant’s vested account.

(e) **Vesting**—Participants are vested immediately in their contributions plus actual earnings thereon. Participants are vested in the Company’s contribution portion of their accounts based on years of service. A participant is fully vested after five years of credited service. Participants become immediately 100% vested in the Company’s contributions portion of their accounts upon death, disability, or the date the participant attains age 65.

(1) **Description of Plan:** (Continued)

(f) **Forfeited accounts**—There were no forfeited non-vested accounts at August 31, 2023. At December 31, 2022, forfeited non-vested accounts totaled \$8,825. During the period ended August 31, 2023, there were no forfeitures used to pay administrative expenses or reduce employer contributions.

(g) **Payment of benefits**—Upon termination of service or retirement, a participant may receive a distribution equal to their vested account balance. Absent the participant's election to roll distributions into another qualified plan or receive a lump sum payment, vested balances over \$1,000, but not exceeding \$5,000 for terminated participants are rolled over to an individual retirement plan designated by the plan administrator. Distribution options are based on the vested amount credited to the participant's account including the option to roll over the vested account balance to another qualified retirement plan or an IRA. Amounts not rolled over will be taxable income in the year received. The participant's contributions may also be withdrawn for certain hardship situations. Upon attainment of normal retirement age, participants who continue employment with the Company may elect to receive all or any portion of his or her vested balance.

(h) **Administrative expenses**—The Plan permits payment of administrative expenses to be made from the Plan's assets and for them to be allocated either proportionately based on the value of account balances or as an equal dollar amount based on the number of participants in the Plan. However, certain operating expenses of the Plan, such as audit fees, are paid by the Company. Plan administration and investment management fees reduce the participants' account balances. Expenses relating to specific participant transactions (i.e., distribution request, etc.) are charged directly against the appropriate participant's account.

(2) **Summary of Significant Accounting Policies:**

(a) **Basis of accounting**—The accompanying financial statements of the Plan are presented on the accrual basis of accounting.

(b) **Use of estimates**—The preparation of financial statements in conformity with accounting principles generally accepted in the United States requires management to make estimates that affect amounts reported in the financial statements and accompanying notes. Actual results could differ from those estimates.

(c) **Investment valuation and income recognition**—The Plan's investments are stated at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 4 for a discussion of fair value measurements. Interest income and dividends are recorded when paid. Net appreciation in fair value includes the Plan's gains and losses on investments bought and sold as well as held during the period.

(d) **Payment of benefits**—Benefits are recorded when paid.

(e) **Subsequent events**—The Plan has evaluated events and transactions for potential recognition or disclosure in the financial statements through May 14, 2024, the date the financial statements were available to be issued. No subsequent events requiring recognition or disclosure have been identified.

(3) Information Certified by the Trustees:

All investment information disclosed in the accompanying financial statements and schedules, including investments held at August 31, 2023 and December 31, 2022, and the net appreciation in fair value of investments and interest and dividend income for the period from January 1, 2023 to August 31, 2023, was obtained or derived from information supplied to the plan administrator and certified as complete and accurate by Empower Annuity Insurance Company of America and Empower Trust Company, LLC, the trustees of the Plan.

(4) Investments and Fair Value Measurements:

The fair value measurement accounting literature provides the framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements). The three levels of the fair value hierarchy are described below:

Level 1 – Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 – Inputs to the valuation methodology include: (1) quoted market prices for similar assets or liabilities in active markets, (2) quoted prices for identical or similar assets or liabilities in inactive markets, (3) inputs other than quoted prices that are observable for the asset or liability, and (4) inputs that are derived principally from or corroborated by observable market data by correlation or other means. If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 – Inputs to the valuation methodology are unobservable that reflect the plan's own assumptions about assumptions that market participants would use in pricing the assets, based on the best information available in the circumstance.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at August 31, 2023 and December 31, 2022.

Mutual funds – Valued at the daily closing prices as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

Fixed annuities – Valued daily at fair value based on the valuation method disclosed in the annuity contract. The fixed account value calculation in participant accounts is calculated using all contributions and deposits to a fixed account made by or on behalf of the participant or plan sponsor, plus all interest credited to the contract holder’s assets in the fixed account on an annual effective basis pursuant to the guaranteed interest rate applicable to the fixed account, less any amounts transferred or distributed from the fixed account, less any applicable charges, fees and taxes, if any.

Common collective trusts – Valued at fair value as determined by the issuers of the funds on the fair market value of the underlying investments, which is valued at net asset value (NAV) as a practical expedient to estimate fair value. The practical expedient would not be used if it is determined to be probable that the funds will sell the investment for an amount different from the reported NAV. Participant transactions (purchases and sales) may occur daily.

The preceding methods described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the plan administrator believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

Investment earnings reflect a combination of interest income, dividend income, realized gains and losses and unrealized gains and losses depending on the composition of the underlying investments held by the underlying investments. Contributions made by the Employer shall be applied or invested in accordance with participant directed allocations.

(5) **Income Tax Status:**

The Plan adopted a prototype plan that obtained a favorable determination letter from the Internal Revenue Service dated June 30, 2020. No individual determination letter has been issued specific to the Plan. A favorable determination letter qualifies the Plan under Section 401(a) of the Internal Revenue Code (IRC), and is therefore not subject to tax under present income tax law. Once qualified, the Plan is required to operate in conformity with the Internal Revenue Code (IRC) to maintain its qualification. Although the Plan has been amended since receiving the determination letter on the prototype plan, the Plan administrator and Plan's tax counsel believe that the Plan is designed and is currently being operated in compliance with the applicable requirements of the IRC and has no income subject to unrelated business income tax. The Plan is subject to routine audits by taxing jurisdictions for the last three years; however, there are currently no audits for any tax periods in progress.

(6) **Risks and Uncertainties:**

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

(7) **Related-Party Transactions and Party-in-Interest Transactions:**

Certain Plan investments are mutual funds managed by Empower Annuity Insurance Company of America and Empower Trust Company, LLC, the trustees as defined by the Plan and, therefore, these transactions qualify as party-in-interest transactions. Fees incurred by the plan for the investment management services are included in net appreciation in fair value of the investment, as they are paid through revenue sharing, rather than a direct payment. The Plan Sponsor pays directly any other fees related to the Plan's operations.
