To the Plan Sponsor and Participants of  
the MDM Rubicon, Inc. 401(k) & Profit Sharing Plan

### **Scope and Nature of the ERISA Section 103(a)(3)(C) Audit**

We have performed audits of the accompanying financial statements of MDM Rubicon, Inc. 401(k) & Profit Sharing Plan, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) [ERISA Section 103(a)(3)(C) audit]. The financial statements comprise the statements of net assets available for benefits as of December 31, 2023 (in liquidation) and 2022 (ongoing), and the related statement of changes in net assets available for benefits for the year ended December 31, 2023 (in liquidation), and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of MDM Rubicon, Inc. 401(k) & Profit Sharing Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from a qualified institution as of November 20, 2023 and December 31, 2022, and for the year ended December 31, 2023, stating that the certified investment information, as described in Note F to the financial statements, is complete and accurate.

### **Opinion**

- the information in the financial statements referred to above related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

### **Basis for Opinion**

We conducted our audits in accordance with auditing standards generally accepted in the United States of America. Our responsibilities under those standards are further described in the Auditor's Responsibilities for the Audit of the Financial Statements section of our report. We are required to be independent of MDM Rubicon, Inc. 401(k) & Profit Sharing Plan and to meet our other ethical responsibilities in accordance with the relevant ethical requirements relating to our audits.

We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our ERISA Section 103(a)(3)(C) audit opinion.

### **Emphasis of Matter – Basis of Accounting**

As discussed in Note D to the financial statements, the governing body of MDM Rubicon, Inc., 401(k) & Profit Sharing Plan approved a plan of liquidation on August 31, 2023, and management determined liquidation is imminent. As a result, the Plan has changed its basis of accounting from the going concern basis used in presenting the 2022 financial statements to the liquidation basis used in presenting the 2023 financial statements. Our opinion is not modified with respect to that matter.

### **Responsibilities of Management for the Financial Statements**

Management is responsible for the preparation and fair presentation of the financial statements in accordance with accounting principles generally accepted in the United States of America, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

Management is also responsible for maintaining a current plan instrument, including all plan amendments; administering the plan; and determining that the plan's transactions that are presented and disclosed in the financial statements are in conformity with the plan's provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.

### **Auditor's Responsibilities for the Audit of the Financial Statements**

Except as described in the Scope and Nature of the ERISA Section 103(a)(3)(C) Audit section of our report, our objectives are to obtain reasonable assurance about whether the financial statements as a whole are free from material misstatement, whether due to fraud or error, and to issue an auditor's report that includes our opinion. NOTE A – PLAN DESCRIPTION

The following description of the MDM Rubicon Inc. 401(k) & Profit Sharing Plan provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

Background: The employer established MDM Rubicon Inc. 401(k) & Profit Sharing Plan (the "Plan") effective October 1, 2007 to provide employee benefits to all employees who have met certain eligibility requirements as described below.

General: The Plan is a defined contribution plan covering all employees who have attained the age of 21, and have completed one year of service. A year of service is accomplished after completing 1,000 hours of service during the first twelve months of employment. The plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

Contributions: Contributions to the Plan, which are made by both the employee and the employer, are maintained in separate accounts for each employee. The employee may contribute any amount up to the annual dollar limitation set forth by the Internal Revenue Service. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. The employer's matching contribution is an amount equal to 100% of the employees' contributions, up to 4% of their compensation, plus any amount the Employer, in its sole discretion, may designate as a nonelective contribution (profit sharing). Eligible employees for the nonelective contribution must have also worked at least 1,000 hours during the plan year, and must be employed by the employer on the last day of the plan year. Participants may also contribute amounts representing distributions from other qualified plans (rollover). Participants direct the investment of their contributions into various investment options offered by the Plan. The Plan has elected automatic enrollment of eligible employees at a rate of 4%. Employees are able to opt-out if they desire. For the years ended December 31, 2023 and 2022, the Plan accrued profit sharing contributions of \$0.

Vesting: Participants are fully vested in their elective deferrals and the employer's matching contribution upon entry into the plan. However, non-elective contributions (profit sharing) by the employer are subject to the following vesting schedule if termination is due to any other reason besides death, disability, or normal retirement age (age 65):

<u>Calendar Years in Plan</u>	<u>Vested %</u>
Less than one year	25%
At least 1 year, but less than 2	50%
At least 2 years, but less than 3	75%
3 years or more	100%

Forfeited Accounts: Forfeitures of non-vested employer contributions are used to reduce future employer contributions or to pay administrative expenses. During 2023 and 2022, employer contributions were reduced by \$-0- from forfeited non-vested accounts. At December 31, 2023 and 2022 forfeited non-vested accounts totaled \$-0-.

Participant Accounts: Each participant's account is credited with the participant's voluntary contributions, the Company's matching contributions, as well as the Company's profit sharing contribution and Plan earnings, which are allocated proportionately among all participants based on their investment in each fund. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Notes Receivable from Participants: Participants may borrow from their fund accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000, reduced by any outstanding loans from the plan during the previous 12-month period, or 50% of their vested account balance. The loans are secured by the balance in the participant's account and bear interest at rates ranging from 3.25% to 8.50%, which is the prime rate as published in the Wall Street Journal on the 14<sup>th</sup> of each month. Principal and interest are paid ratably through payroll deductions. Loans must be paid back within 5 years unless the loan is used to purchase a primary residence.

NOTE A – PLAN DESCRIPTION (CONTINUED)

Payment of Benefits: On termination of service, for any reason, a participant may elect to receive a lump-sum payment or rollover their account in an amount equal to the value of the participant's vested interest in his or her account. If the account balance is greater than \$5,000 upon termination of service, the participant can elect to receive installments or defer receiving payments until age 72.

NOTE B – SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Basis of Accounting: The financial statements of the Plan are prepared under the accrual method of accounting in liquidation for December 31, 2023 and accrual method of accounting ongoing for December 31, 2022.

Investment Valuation and Income Recognition: Investments in all securities are stated at fair value as reported by the trustee, Ascensus Trust Company. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note E for discussion of fair value measurements. Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Estimates: The preparation of financial statements in conformity with generally accepted accounting principles requires the plan administrator to make estimates and assumptions that affect certain reported amounts and disclosures. Accordingly, actual results may differ from those estimates.

Payment of Benefits: Benefits are recorded when paid.

Administrative Expenses: Certain administrative expenses are paid by the employer.

Notes Receivable from Participants: Loans to participants are reported at their unpaid principal balances plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and expensed when they are incurred. If a participant ceases to make loan repayments and the plan administrator deems the participant loan to be in default, the participant loan balance is reduced and a benefit payment is recorded.

NOTE C – TAX STATUS

The Internal Revenue Service (IRS) has determined and informed the Plan Sponsor by a letter dated March 31, 2014, that the Plan and related trust are designed in accordance with applicable sections of the Internal Revenue Code (IRC). Although the Plan has been amended since receiving the opinion letter, the Plan administrator and the Plan's tax counsel believe the Plan is designed and is currently being operated in compliance with the applicable requirements of the IRC and therefore believe the Plan is qualified and the related trust tax exempt.

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

NOTE D – TERMINATION

On August 31, 2023, the transfer of MDM Rubicon, Inc.'s license was finalized. At this date, liquidation of the MDM Rubicon, Inc. 401(K) & Profit Sharing Plan was imminent. Final distributions were determined based on all participants being 100% vested, and were made as soon as possible after the termination date. All distributions were made and the plan officially closed on November 20, 2023. As a result, the Plan changed its basis of accounting from ongoing concern basis used in presenting the 2022 financial statements to the liquidation basis used in presenting the 2023 financial statements.

NOTE E – FAIR VALUE MEASUREMENTS

The fair value measurement accounting literature establishes a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy consists of three broad levels: Level 1 inputs consist of unadjusted quoted prices in active markets for identical assets and have the highest priority. Level 2 inputs are unobservable inputs other than quoted prices for identical assets (Level 1). Level 3 inputs are unobservable and have the lowest priority. The Plan uses appropriate valuation techniques based on the available inputs to measure the fair value of its investments. When available, the Plan measures fair value using Level 1 inputs because they generally provide the most reliable evidence of fair value. Level 2 inputs are used for investments for which Level 1 inputs were not available. Level 3 inputs would only be used if Level 1 or Level 2 inputs were not available. There are no plan assets requiring the use of Level 3 inputs for the periods presented.

*Level 1*

Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

*Level 2*

Inputs to the valuation methodology include: quoted prices for similar assets or liabilities in active markets; quoted prices for identical or similar assets or liabilities in inactive markets; inputs other than quoted prices that are observable for the asset or liability; and inputs that are derived principally from or corroborated by observable market data by correlation or other means. If the asset or liability has a specified (contractual) term, the level 2 input must be observable for substantially the full term of the asset or liability.

*Level 3*

Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2023 and 2022.

*Mutual Funds:* Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the Securities Exchanges Commission. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

*Collective Investment Fund:* Valued at the NAV of units of a collective trust. The NAV, as provided by the trustee, is used as a practical expedient to estimate fair value. The NAV is based on the fair value of the underlying investments held by the fund less liabilities. This practical expedient is not used when it is determined to be probable that the fund will sell the investment for an amount different than the reported NAV. Participant transactions (purchased and sales) may occur daily.

NOTE G – RISKS AND UNCERTAINTIES

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statement of net assets available for benefits.

As of December 31, 2022, the Plan had investments of \$1,851,919 that were concentrated in 3 funds.

NOTE H – PARTY-IN-INTEREST TRANSACTIONS

Ascensus Trust Company is the trustee as defined by the Plan at November 20, 2023 and December 31, 2022, and therefore, any transactions qualify as party-in-interest transactions. Total fees paid by the Plan for the investment management services amounted to \$30,503 and \$21,452 for the years ended December 31, 2023 and 2022, respectively. Additionally, the Plan paid \$8,271 and \$12,009 during the year ended December 31, 2023 and 2022, respectively, to Merrill Lynch, Pierce, Fenner & Smith for investment fund management.
