We have performed audits of the financial statements of the Fairystone Fabrics, LLC 401(k) Profit Sharing Plan (Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C). The financial statements comprise the statements of net assets available for benefits as of September 30, 2023 and 2022, and the related statement of changes in net assets available for benefits for the year ended September 30, 2023, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. #### **Note 1: Description of Plan**

The following description of the Fairystone Fabrics, LLC 401(k) Profit Sharing Plan (Plan) provides only general information. Participants should refer to the Plan document for a more complete description of the Plan's provisions.

**General** - The Plan, which became effective August 14, 1972, is a defined contribution plan covering all eligible Employees of Fairystone Fabrics, LLC (Employer). Employees are eligible to participate in the Plan on the first day of each Plan quarter coincident with or following completion of one year of service. It is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

**Contributions** - Participants may contribute a portion of compensation as pre-tax deferrals. Participants who have attained age 50 before the end of the plan year are eligible to make catch-up contributions. At the discretion of the Plan Administrator, employees may contribute amounts from other eligible plans. Employer matching contributions are allocated according to the following formula: Fifty percent of elective deferral contributions not exceeding four percent of compensation. The Employer may make discretionary matching contributions for eligible participants who contribute elective deferral contributions. No discretionary matching contributions were made for the plan year ended September 30, 2023. Contributions are subject to certain Plan and Internal Revenue Service (IRS) limitations.

**Participant investments** - Participants direct the investment of all contributions into various investment options offered by the Plan. Participants may change their investments at any time. Participant accounts are valued daily.

**Participant accounts** - Each participant's account is credited with the participant's contributions, the Employer's matching contributions, as well as allocations of the Employer's additional non-elective contributions and the Plan's earnings. Participant accounts are charged with an allocation of administrative expenses that are paid by the Plan. Allocations are based on participant earnings, account balances, or specific participant transactions, as defined in the plan document. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

**Vesting** - Participants are immediately vested in their contributions plus actual earnings thereon. Vesting in the Employer's contributions plus actual earnings thereon is based on years of service. A participant is fully vested when they attain normal retirement age. Prior to normal retirement age, a participant's interest in the Employer's contributions plus actual earnings thereon are vested 100% after three years of service.

**Notes receivable from participants** - Participants may borrow from their account balances a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balance at the time of the loan. Loan terms generally do not exceed five years. The loans are secured by the balance in the Participant's account and bear interest at the prime interest rate plus one percent on the date of the loan application or the last date published prior to the loan application. Principal and interest are paid by payroll deduction.

**Payment of benefits** - The Plan provides for fully vested benefits at normal retirement (age 65), death or disability. Other benefits are paid upon termination of employment and other designated conditions in which the participant is entitled to the vested portion of his or her account balance.

**Forfeitures** - Non-vested portions of terminated participant balances are either used to pay Plan expenses or reduce Employer contributions. As of September 30, 2023 and 2022, forfeited non-vested accounts were \$3,566 and \$2,292, respectively. During the year ended September 30, 2023, approximately \$2,369 of forfeited non-vested accounts were used to pay administrative expenses.

#### **Note 2: Summary of Significant Accounting Policies**

**Basis of accounting** - The financial statements of the Plan are prepared using the accrual basis of accounting.

**Use of accounting estimates** - The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

**Investment valuation and income recognition** - Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Employer is the Plan Administrator. The Plan Administrator is responsible for oversight of the Plan and determines asset valuation policies using information provided by investment advisers, custodians and the trustee. Refer to Note 4 for fair value measurements discussion.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net depreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

**Notes receivable from participants** - Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred. Should a participant terminate employment, the outstanding loan principal, plus accrued interest is due immediately.

**Payment of benefits** - Benefits are recorded when paid.

**Administrative expenses** - Certain expenses of maintaining the Plan are paid by the Plan, unless otherwise paid by the Employer. Expenses that are paid by the Employer are excluded from these financial statements. Transaction based fees are charged directly to the participant's account and are included in administrative expenses. Asset based fees are included in net appreciation or depreciation in fair value of investments.

**Subsequent events** - The Plan has evaluated subsequent events through June 4, 2024, the date the financial statements are available to be issued for possible recognition or disclosure in the financial statements.

#### **Note 3: Unaudited Certified Information**

Certain information related to investments and notes receivable from participants disclosed in the financial statements, including the associated investment income, was obtained or derived from information supplied to the plan administrator and certified as complete and accurate by Ascensus, LLC, as agent for Ascensus Trust Company, the trustee of the Plan.

#### **Note 4: Fair Value Measurement**

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1 measurements) and the lowest priority to unobservable inputs (level 3 measurements). The three levels of the fair value hierarchy under FASB ASC 820 are described as follows:

Level 1: Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2: Inputs to the valuation methodology include: quoted prices for similar assets or liabilities in active markets; quoted prices for identical or similar assets or liabilities in inactive markets; inputs other than quoted prices that are observable for the assets or liability; inputs that are derived principally from or corroborated by observable market data by correlation or other means. If the asset or liability has a specified (contractual) term, the level 2 input must be observable for substantially the full term of the asset or liability.

Level 3: Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

The following is a description of the valuation methodologies used for investments measured at fair value. There have been no changes in the methodology used as of September 30, 2023 and 2022.

Mutual funds: Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily net asset value ("NAV") and to transact at that price. These funds held by the Plan are deemed to be actively traded.

Collective trust: The fair value of participation units held in a collective trust is based on the net asset value per unit as reported by the fund manager. The collective trust provides for daily redemptions by the Plan at reported net asset value per share, with no advance notice requirement.

The methods described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation method is appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

#### Note 5: Party-in-Interest Transactions

Parties-in-interest are defined by Department of Labor regulations as any fiduciary of the Plan, any party rendering service to the Plan, the Employer, and certain others. Investment activities and certain fees paid by the Plan to parties-in-interest are considered party-in-interest transactions. The Plan engaged in the following party-in-interest transactions which are exempt from prohibited transaction rules defined by ERISA: investment transactions with the trustee; indirect fees included in the net appreciation of investments for investment management and custodial services; direct fee payments to the trustee for record keeping and custodial services.

#### Note 6: Plan Termination

Although it has not expressed any intent to do so, the Employer has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, the account balance of each participant would become fully vested, as prescribed by ERISA and its related regulations, and would be distributed to each participant according to the provisions of the Plan.

#### Note 7: Tax Status

The Plan is relying on IRS approval of the pre-approved plan it has adopted. The IRS has determined and informed the pre-approved plan sponsor by a letter dated June 30, 2020, that the Plan and related trust are designed in accordance with applicable sections of the Internal Revenue Code (IRC). Although the Plan has been amended from the original pre-approved document, Plan management believes that the Plan is currently being operated in accordance with the IRC, and therefore, believe that the Plan is qualified and the related trust is tax-exempt.

Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the Internal Revenue Service or Department of Labor. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

#### Note 8: Plan Risks and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks, such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits and the statement of changes in net assets available for benefits.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the Plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from an agent on behalf of the qualified institution as of September 30, 2023 and 2022, and for the year ended September 30, 2023, stating that the certified investment information, as described in Note 3 to the financial statements, is complete and accurate.

### Opinion

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control related matters that we identified during the audit.

#### **Other Matter**

#### **Note 1: Description of Plan**

The following description of the Fairystone Fabrics, LLC 401(k) Profit Sharing Plan (Plan) provides only general information. Participants should refer to the Plan document for a more complete description of the Plan's provisions.

**General** - The Plan, which became effective August 14, 1972, is a defined contribution plan covering all eligible Employees of Fairystone Fabrics, LLC (Employer). Employees are eligible to participate in the Plan on the first day of each Plan quarter coincident with or following completion of one year of service. It is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

**Contributions** - Participants may contribute a portion of compensation as pre-tax deferrals. Participants who have attained age 50 before the end of the plan year are eligible to make catch-up contributions. At the discretion of the Plan Administrator, employees may contribute amounts from other eligible plans. Employer matching contributions are allocated according to the following formula: Fifty percent of elective deferral contributions not exceeding four percent of compensation. The Employer may make discretionary matching contributions for eligible participants who contribute elective deferral contributions. No discretionary matching contributions were made for the plan year ended September 30, 2023. Contributions are subject to certain Plan and Internal Revenue Service (IRS) limitations.

**Participant investments** - Participants direct the investment of all contributions into various investment options offered by the Plan. Participants may change their investments at any time. Participant accounts are valued daily.

**Participant accounts** - Each participant's account is credited with the participant's contributions, the Employer's matching contributions, as well as allocations of the Employer's additional non-elective contributions and the Plan's earnings. Participant accounts are charged with an allocation of administrative expenses that are paid by the Plan. Allocations are based on participant earnings, account balances, or specific participant transactions, as defined in the plan document. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

**Vesting** - Participants are immediately vested in their contributions plus actual earnings thereon. Vesting in the Employer's contributions plus actual earnings thereon is based on years of service. A participant is fully vested when they attain normal retirement age. Prior to normal retirement age, a participant's interest in the Employer's contributions plus actual earnings thereon are vested 100% after three years of service.

**Notes receivable from participants** - Participants may borrow from their account balances a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balance at the time of the loan. Loan terms generally do not exceed five years. The loans are secured by the balance in the Participant's account and bear interest at the prime interest rate plus one percent on the date of the loan application or the last date published prior to the loan application. Principal and interest are paid by payroll deduction.

**Payment of benefits** - The Plan provides for fully vested benefits at normal retirement (age 65), death or disability. Other benefits are paid upon termination of employment and other designated conditions in which the participant is entitled to the vested portion of his or her account balance.

**Forfeitures** - Non-vested portions of terminated participant balances are either used to pay Plan expenses or reduce Employer contributions. As of September 30, 2023 and 2022, forfeited non-vested accounts were \$3,566 and \$2,292, respectively. During the year ended September 30, 2023, approximately \$2,369 of forfeited non-vested accounts were used to pay administrative expenses.

#### **Note 2: Summary of Significant Accounting Policies**

**Basis of accounting** - The financial statements of the Plan are prepared using the accrual basis of accounting.

**Use of accounting estimates** - The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

**Investment valuation and income recognition** - Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Employer is the Plan Administrator. The Plan Administrator is responsible for oversight of the Plan and determines asset valuation policies using information provided by investment advisers, custodians and the trustee. Refer to Note 4 for fair value measurements discussion.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net depreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

**Notes receivable from participants** - Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred. Should a participant terminate employment, the outstanding loan principal, plus accrued interest is due immediately.

**Payment of benefits** - Benefits are recorded when paid.

**Administrative expenses** - Certain expenses of maintaining the Plan are paid by the Plan, unless otherwise paid by the Employer. Expenses that are paid by the Employer are excluded from these financial statements. Transaction based fees are charged directly to the participant's account and are included in administrative expenses. Asset based fees are included in net appreciation or depreciation in fair value of investments.

**Subsequent events** - The Plan has evaluated subsequent events through June 4, 2024, the date the financial statements are available to be issued for possible recognition or disclosure in the financial statements.

#### **Note 3: Unaudited Certified Information**

Certain information related to investments and notes receivable from participants disclosed in the financial statements, including the associated investment income, was obtained or derived from information supplied to the plan administrator and certified as complete and accurate by Ascensus, LLC, as agent for Ascensus Trust Company, the trustee of the Plan.

#### **Note 4: Fair Value Measurement**

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1 measurements) and the lowest priority to unobservable inputs (level 3 measurements). The three levels of the fair value hierarchy under FASB ASC 820 are described as follows:

Level 1: Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2: Inputs to the valuation methodology include: quoted prices for similar assets or liabilities in active markets; quoted prices for identical or similar assets or liabilities in inactive markets; inputs other than quoted prices that are observable for the assets or liability; inputs that are derived principally from or corroborated by observable market data by correlation or other means. If the asset or liability has a specified (contractual) term, the level 2 input must be observable for substantially the full term of the asset or liability.

Level 3: Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

The following is a description of the valuation methodologies used for investments measured at fair value. There have been no changes in the methodology used as of September 30, 2023 and 2022.

Mutual funds: Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily net asset value ("NAV") and to transact at that price. These funds held by the Plan are deemed to be actively traded.

Collective trust: The fair value of participation units held in a collective trust is based on the net asset value per unit as reported by the fund manager. The collective trust provides for daily redemptions by the Plan at reported net asset value per share, with no advance notice requirement.

The methods described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation method is appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

#### Note 5: Party-in-Interest Transactions

Parties-in-interest are defined by Department of Labor regulations as any fiduciary of the Plan, any party rendering service to the Plan, the Employer, and certain others. Investment activities and certain fees paid by the Plan to parties-in-interest are considered party-in-interest transactions. The Plan engaged in the following party-in-interest transactions which are exempt from prohibited transaction rules defined by ERISA: investment transactions with the trustee; indirect fees included in the net appreciation of investments for investment management and custodial services; direct fee payments to the trustee for record keeping and custodial services.

#### Note 6: Plan Termination

Although it has not expressed any intent to do so, the Employer has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, the account balance of each participant would become fully vested, as prescribed by ERISA and its related regulations, and would be distributed to each participant according to the provisions of the Plan.

#### Note 7: Tax Status

The Plan is relying on IRS approval of the pre-approved plan it has adopted. The IRS has determined and informed the pre-approved plan sponsor by a letter dated June 30, 2020, that the Plan and related trust are designed in accordance with applicable sections of the Internal Revenue Code (IRC). Although the Plan has been amended from the original pre-approved document, Plan management believes that the Plan is currently being operated in accordance with the IRC, and therefore, believe that the Plan is qualified and the related trust is tax-exempt.

Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the Internal Revenue Service or Department of Labor. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

#### Note 8: Plan Risks and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks, such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits and the statement of changes in net assets available for benefits.
