***Scope and Nature of the ERISA Section 103(a)(3)(C) Audit***

We have performed audits of the financial statements of Somerset CPAs, P.C., Profit Sharing and 401(k) Savings Plan, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits (liquidation basis) as of August 15, 2023 and December 31, 2022, and the related statement of changes in net assets available for benefits (liquidation basis) for the period January 1, 2023 through August 15, 2023.

Management, having determined it is permissible in the circumstances, has elected to have the audits of Somerset CPAs, P.C., Profit Sharing and 401(k) Savings Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from a qualified institution as of August 15, 2023 and December 31, 2022, and for the period from January 1, 2023 through August 15, 2023, stating that the certified investment information, as described in Note 5 to the financial statements, is complete and accurate.

***Opinion***

In our opinion, based on our audits and on the procedures performed as described in the Auditor's Responsibilities for the Audit of the Financial Statements section

- the amounts and disclosures in the accompanying financial statements, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.
- the information in the accompanying financial statements related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

### ***Basis for Opinion***

We conducted our audits in accordance with auditing standards generally accepted in the United States of America (GAAS). Our responsibilities under those standards are further described in the Auditor's Responsibilities for the Audit of the Financial Statements section of our report. We are required to be independent of Somerset CPAs, P.C., Profit Sharing and 401(k) Savings Plan and to meet our other ethical responsibilities, in accordance with the relevant ethical requirements relating to our audits. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our ERISA Section 103(a)(3)(C) audit opinion.

### ***Emphasis of Matter - Terminating Plan and Liquidation Basis of Accounting***

As further discussed in Note 1 to the financial statements, the Board of Directors of the Somerset CPAs, P.C., the plan's sponsor, voted on March 1, 2023 to terminate the plan and management determined liquidation is imminent. As a result, the Somerset CPAs, P.C., Profit Sharing and 401(k) Savings Plan changed its basis of accounting from the going-concern basis of accounting used in presenting the 2022 financial statements to the liquidation basis of accounting used in presenting the 2023 financial statements. Our opinion is not modified with respect to this matter.

### ***Responsibilities of Management for the Financial Statements***

Management is responsible for the preparation and fair presentation of the financial statements in accordance with accounting principles generally accepted in the United States of America, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

In preparing the financial statements, management is required to evaluate whether there are conditions or events, considered in the aggregate, that raise substantial doubt about Somerset CPAs, P.C., Profit Sharing and 401(k) Savings Plan's ability to continue as a going concern for one year after the date that the financial statements are issued.

Management is also responsible for maintaining a current plan instrument, including all plan amendments, administering the plan, and determining that the plan's transactions that are presented and disclosed in the financial statements are in conformity with the plan's provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.

### ***Auditor's Responsibilities for the Audit of the Financial Statements***

Except as described in the Scope and Nature of the ERISA Section 103(a)(3)(C) Audit section of our report, our objectives are to obtain reasonable assurance about whether the financial statements as a whole are free from material misstatement, whether due to fraud or error, and to issue an auditor's report that includes our opinion. Reasonable assurance is a high level of assurance but is not absolute assurance and therefore is not a guarantee that an audit conducted in accordance with GAAS will always detect a material misstatement when it exists. The risk of not detecting a material misstatement resulting from fraud is higher than for one resulting from error, as fraud may involve collusion, forgery, intentional omissions, misrepresentations, or the override of internal control. Misstatements are considered material if there is a substantial likelihood

that, individually or in the aggregate, they would influence the judgment made by a reasonable user based on the financial statements.

In performing an audit in accordance with GAAS, we:

- Exercise professional judgment and maintain professional skepticism throughout the audit.
- Identify and assess the risks of material misstatement of the financial statements, whether due to fraud or error, and design and perform audit procedures responsive to those risks. Such procedures include examining, on a test basis, evidence regarding the amounts and disclosures in the financial statements.
- Obtain an understanding of internal control relevant to the audit in order to design audit procedures that are appropriate in the circumstances, but not for the purpose of expressing an opinion on the effectiveness of Somerset CPAs, P.C., Profit Sharing and 401(k) Savings Plan's internal control. Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audit.

NOTES TO FINANCIAL STATEMENTS

1. Description of the plan

The following description of the Somerset CPAs, P.C., Profit Sharing and 401(k) Savings Plan (the “Plan”) provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan’s provisions.

General and eligibility

The Plan is a defined contribution plan sponsored by Somerset CPAs, P.C. (the “Employer”) for the benefit of its employees who are at least 21 years of age and have completed one month of employment. Plan entry dates are the beginning of the month after the participant meets the eligibility requirements. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974, as amended.

The U.S. Congress enacted the SECURE Act which includes provisions that impact benefit plans. Provisions of the SECURE Act are operationally available at this time but Plan documents will not require formal amendment until 2025. SECURE increased the RMD age from 70 ½ to 72, allows for long-term part-time employees to participate and allows for in service withdrawals for childbirth and adoption expense. The Plan is not currently operating according to these provisions.

Termination of the Plan

The Company has the right to terminate the Plan subject to the provisions of ERISA. On March 1, 2023, the Company was acquired and the Plan was terminated. Beginning March 1, 2023, former participants with remaining investment balances who did not affirmatively elect a distribution in connection with the Plan termination were transferred to an IRA account for their benefit. The Plan was fully liquidated as of August 15, 2023.

Contributions and investment options

Each year, participants may contribute up to 100% of pretax annual compensation as defined by the Plan, subject to qualified limitations. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. Participants may also elect to make nontax deductible Roth contributions. Participants may also contribute amounts representing distributions from other qualified retirement plans.

The Plan includes an auto-enrollment provision whereby all newly eligible employees are automatically enrolled in the Plan unless they affirmatively elect not to participate in the Plan. Automatically enrolled participants have their deferral rate set at 3% of eligible compensation and their contributions invested in a designated target fund until changed by the participant. Each subsequent year thereafter, participant’s deferral rate increases by 1%, maxing out at 10%, unless changed by the participant.

The Employer may make matching contributions equal to a discretionary percentage of a participant’s compensation or a discretionary dollar amount. For 2023, the Employer elected to make a matching contribution of 25% of the first 6% of base compensation that a participant contributed to the Plan. For 2023, the discretionary matching contribution was \$60,889 and was funded entirely with forfeitures.

In addition, the Employer may make discretionary profit sharing contributions and may use non-safe harbor allocation methods. Participants must be employed on the last day of the plan year to receive an allocation of the discretionary profit sharing contribution, if any. Contributions are subject to certain limitations. For the 2023 plan year, there was no discretionary profit sharing contribution.

NOTES TO FINANCIAL STATEMENTS

Participants direct the investment of the amounts contributed by the participant and the Company into various investment options offered by the Plan. Participants may change their investment options as often as they choose. Participants may change their allocation on a daily basis, subject to fund restrictions, and may change the amount contributed at any time. Participants may also direct the investment of their accounts through a self-directed option.

#### Participant accounts

Each participant's account is credited with the participant's contributions and allocations of (1) the Employer's contributions and (2) Plan earnings. Allocations are based on participant earnings or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

#### Forfeited accounts

Participants who terminate employment forfeit any non-vested portion of their account. Forfeitures related to employer contributions are used to reduce future employer contributions or pay Plan expenses. At August 15, 2023 and December 31, 2022 there was a balance of \$- and \$82,923, respectively, in the forfeiture account. During the year ended August 15, 2023 forfeitures of \$105,158 were used to reduce 2022 and 2023 employer contributions.

#### Vesting

Participants are immediately vested in elective salary reduction contributions and the actual earnings thereon. Vesting in Employer contributions and the earnings thereon is based upon the years of service of the participant. A year of service means a Plan year in which the participant completes at least 1,000 hours of service. A participant becomes 20% vested after one year of service and vests an additional 20% for each year of service thereafter, and is 100% vested after five years of service.

Effective March 1, 2023, the Plan was amended to fully vest the accounts of participants affected by the Plan termination. Participants who terminated employment on or after March 1, 2023 were 100% vested in their account, without regard to the years of vesting service completed prior to termination of employment.

#### Payment of benefits

Upon termination of service or retirement, participants will receive distributions as follows. If the participant's vested account balance does not exceed \$5,000, then it may only be distributed in a single lump-sum payment. If the participant's vested account balance exceeds \$5,000, they must consent to any distribution before it may be made. The participant may elect to receive a distribution of the vested account balance in a single lump-sum payment or a partial withdrawal equal to the minimum amount required to be distributed to the participant (but not a beneficiary) each year under IRS regulations.

#### Notes receivable from participants

The Plan allows for loans to be made to active Plan participants. The maximum amount a participant may borrow may not exceed one-half of the vested value of the participant's account, up to \$50,000, less the participant's highest outstanding loan amount during the prior 12 months. Loan terms range from one to five years or up to thirty years for the purchase of a primary residence. The loans are secured by the balance in the participant's account and bear a fixed interest rate at the prevailing prime rate and are based on the prime rate at the date of the inception of the loan. Principal and interest are paid through biweekly payroll deductions.

Investment management and administrative expenses

Certain expenses of maintaining the Plan are paid by the Plan, unless otherwise paid by the Plan Sponsor. Expenses that are paid by the Plan Sponsor are excluded from these financial statements. Loan, distribution and self-directed account administration fees are charged directly to the participant's account and are included in administrative fees. Investment related expenses are included in net appreciation of fair value of investments. Certain administrative functions are performed by officers and employees of the Company. No such officer or employee receives compensation from the Plan.

2. Summary of significant accounting policies

Basis of accounting

The accompanying financial statements are prepared on the accrual basis of accounting.

Accounting estimates and assumptions

The preparation of financial statements in conformity with U.S. generally accepted accounting principles requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and disclosure of contingent assets and liabilities at the date of the financial statements and the reported amounts of revenues and expenses during the reporting period. Actual results could differ from those estimates.

Valuation of investments and income recognition

Investments are stated at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 3 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net depreciation includes the Plan's gains and losses on investments sold as well as held during the year.

Payment of benefits

Benefits to participants are recorded when paid.

Notes receivable from participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred. No allowance for credit losses has been recorded as of August 15, 2023 and December 31, 2022. Delinquent loans are treated as distributions based upon the terms of the plan document.

3. Fair value measurements

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs. The three levels of the fair value hierarchy under the Fair Value Measurement Topic of the Accounting Standards Codification (ASC 820) are described as follows:

Level 1 – Inputs to the valuation methodology are quoted prices (unadjusted) in active markets for identical assets or liabilities that the Plan can access at the measurement date.

Level 2 – Inputs other than quoted prices included within Level 1 that are observable for the asset or liability, either directly or indirectly, such as: quoted prices for similar assets or liabilities in active markets, quoted prices for identical or similar assets or liabilities in inactive markets, inputs other than quoted prices that are observable for the asset or liability, inputs that are derived principally from or corroborated by observable market data by correlation or other means. If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 – Inputs that are unobservable inputs for the asset or liability.

The following is a description of the valuation methods used for assets measured at fair value.

Common Collective Trust: A stable value fund that is invested primarily in fully benefit-responsive investment contracts. The common collective trust calculates its net asset value (NAV) daily. Units of the fund are issued and redeemed at the current net asset value. Participant transactions (purchases and sales) may occur daily. If the Plan initiates a full redemption of the collective trust, the issuer reserves the right to require 12 months notification in order to ensure that securities liquidations will be carried out in an orderly business manner. Plan management referred to the NAV and the funds audited financial statements to conclude that the NAV is a reasonable approximation of the funds fair value. Since the trust has a readily determinable fair value the investment is valued at fair value rather than using the net asset value as the practical expedient.

Registered Investment Companies (Mutual Funds): Valued at the daily closing price as reported by the fund. Registered Investment Companies held by the Plan are open-end mutual funds that are registered with the U.S. Securities and Exchange Commission. These funds are required to publish their daily net asset value and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

Self-directed brokerage accounts: Accounts primarily consist of mutual funds and common stocks that are valued on the basis of readily determinable market prices.

The following tables set forth by level, within the fair value hierarchy, the Plan’s assets measured at fair value on a recurring basis as of December 31, 2022. Classification within the fair value hierarchy table is based on the lowest level of any input that is significant to the fair value measurement.

The Plan's policy is to recognize transfers between levels at the end of each reporting period, if applicable. There were no significant transfers between Level 1, 2, or 3 assets or liabilities during the year ended December 31, 2022.

4. Plan termination

On March 1, 2023, the Plan sponsor terminated the Plan. All participants became fully vested in their accounts. As of August 15, 2023, the Plan was fully liquidated.

5. Information certified by trustees

Certain information related to investments and notes receivable from participants disclosed in the accompanying financial statements and supplemental schedule, including investments and notes receivable from participants held at December 31, 2023 and 2022, net appreciation in fair value of investments and interest and dividends for the period from January 1, 2023 through August 15, 2023, was obtained or derived from information supplied to the plan administrator and certified as complete and accurate by Fidelity Management Trust Company.

6. Reconciliation to Form 5500

There are no reconciling items between the financial statements and Form 5500 net assets available for benefits or net increase in assets available for benefits.

7. Related-party transactions and Party In Interest Transactions

Fidelity Management Trust Company was the trustee and custodian for Plan assets. Fidelity Management Trust Company, received indirect compensation from investment fund providers for recordkeeping, administration, communication and other shareholder services provided on behalf of the registered investment companies or common collective trusts. Indirect compensation is offset against administrative expenses charged to the Plan. If there is excess, it is deposited into the Plan's forfeiture account.

8. Income tax status

Effective May 1, 2022, the Plan was amended and restated by adopting the Fidelity pre-approved plan. The volume submitter obtained a determination letter dated June 30, 2020, that the Plan and related trust are designed in accordance with applicable sections of the Internal Revenue Code (IRC).

Although the Plan has been amended since receiving the determination letter, the Plan administrator and the Plan's tax counsel believe that the Plan is designed, and is currently being operated, in compliance with the applicable requirements of the IRC and, therefore, believe that the Plan is qualified, and the related trust is tax-exempt.

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the plan and recognize a tax liability if the plan has taken an uncertain tax position that more likely than not would be sustained upon examination by the Internal Revenue Service. The plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

9. Risks and uncertainties

The Plan invests in several types of investment securities. Investment securities are exposed to various risks, such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and those changes could materially affect the amounts reported in the statements of net assets available for benefits.

10. Investment in Morley Stable Value Collective Trust Fund

The Morley Stable Value Collective Trust Fund invests in a pool of guaranteed contracts, short-term investment funds and security-backed contracts. The Fund seeks to provide preservation of capital, relatively stable returns and liquidity for benefit-responsive payments. At December 31, 2022, there were no unfunded commitments. Participants may redeem units of the fund on a daily basis with no notice period.

11. Subsequent events

Subsequent events were evaluated through date of the auditor's report, which is the date the financial statements were available to be issued and has determined that, except for the matters noted below, no significant events occurred after August 15, 2023, but prior to the issuance of these financial statements, that would have a material impact on its financial statements.
