INDEPENDENT AUDITORS' REPORT

The Retirement Committee and Participants of EVO 401(k) Savings Plan

Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed an audit of the financial statements of EVO 401(k) Savings Plan (the "Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of December 29, 2023 and December 31, 2022, the related statements of changes in net assets available for benefits for the year ended December 29, 2023, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audit of the Financial Statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audit need not extend to any statements or information related to assets held for investment of the plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's (DOL's) Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained a certification from a qualified institution as of December 29, 2023 and December 31, 2022 and for the year ended December 29, 2023, stating that the certified investment information, as described in Note 3 to the financial statements, was complete and accurate.

Opinion

In our opinion, based on our audit and on the procedures performed as described in the Auditors' Responsibilities for the Audit section:

- The amounts and disclosures in the accompanying Financial Statements, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America (GAAP).
- The information in the accompanying Financial Statements related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

Basis for Opinion

We conducted our audit in accordance with auditing standards generally accepted in the United States of America (GAAS). Our responsibilities under those standards are further described in the Auditors' Responsibilities for the Audit section of our report. We are required to be independent of the Plan and to meet our other ethical responsibilities, in accordance with the relevant ethical requirements relating to our audits. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our ERISA Section 103(a)(3)(C) audit opinion.

Responsibilities of Management

Management is responsible for the preparation and fair presentation of the financial statements in accordance with GAAP, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

In preparing the financial statements, management is required to evaluate whether there are conditions or events, considered in the aggregate, that raise substantial doubt about the Plan's ability to continue as a going concern for one year after the date that the financial statements are issued or available to be issued.

Management is also responsible for maintaining a current plan instrument, including all plan amendments, administering the plan, and determining that the plan's transactions that are presented and disclosed in the financial statements are in conformity with the plan's provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.

Auditors' Responsibilities for the Audit

Except as described in the Scope and Nature of the ERISA Section 103(a)(3)(C) Audit section of our report, our objectives are to obtain reasonable assurance about whether the financial statements as a whole are free from material misstatement, whether due to fraud or error, and to issue an auditors' report that includes our opinion. Reasonable assurance is a high level of assurance but is not absolute assurance and therefore is not a guarantee that an audit conducted in accordance with GAAS will always detect a material misstatement when it exists. The risk of not detecting a material misstatement resulting from fraud is higher than for one resulting from error, as fraud may involve collusion, forgery, intentional omissions, misrepresentations, or the override of internal control. Misstatements are considered material if, there is a substantial likelihood that, individually or in the aggregate, they would influence the judgment made by a reasonable user based on the financial statements.

In performing an audit in accordance with GAAS, we:

- Exercise professional judgment and maintain professional skepticism throughout the audit.
- Identify and assess the risks of material misstatement of the financial statements whether due to fraud or error, and design and perform audit procedures responsive to those risks. Such procedures include examining, on a test basis, evidence regarding the amounts and disclosures in the financial statements.
- Obtain an understanding of internal control relevant to the audit in order to design audit procedures that are appropriate in the circumstances, but not for the purpose of expressing an opinion on the effectiveness of the Plan's internal control. Accordingly, no such opinion is expressed.
- Evaluate the appropriateness of accounting policies used and the reasonableness of significant accounting estimates made by management, as well as evaluate the overall presentation of the financial statements.
- Conclude whether, in our judgment, there are conditions or events, considered in the aggregate, that raise substantial doubt about the Plan's ability to continue as a going concern for a reasonable period of time.

Our audit did not extend to the certified investment information, except for obtaining and reading the certification, comparing the certified investment information with the related information presented and disclosed in the Financial Statements, and reading the disclosures relating to the certified investment information to assess whether they are in accordance with the presentation and disclosure requirements of GAAP.

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with GAAP.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audit.

NOTE 1 – DESCRIPTION OF PLAN

The following description of the EVO 401(k) Savings Plan (the “Plan”) provides only general information. Participants should refer to the Plan document for a more complete description of the Plan's provisions.

General

The Plan was a defined contribution plan covering all full-time employees of EVO Merchant Services, LLC (the “Company”) that are age 18 or older. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (“ERISA”).

Effective December 29, 2023, plan assets totaling \$51,182,243 transferred to the Global Payments Inc. 401(k) Plan and the Evo 401(k) Savings Plan was terminated.

Contributions

Employees were able to defer and contribute a percentage of their salary each year; however, total deferrals could not exceed certain Internal Revenue Code (“IRC”) limits. If a participant had attained age 50 prior to the end of the Plan year, they were eligible to make catch-up contributions up to the maximum allowed by the IRC. The Plan included an auto enrollment provision whereby all newly eligible employees were automatically enrolled in the Plan unless the employee elected to not participate. Automatically enrolled participants had their deferral rate set at 3% of eligible compensation. The Company matched 50% of the first 6% of employee compensation. In addition, the Employer could make a discretionary profit-sharing contribution. There was no discretionary profit-sharing contribution for 2023. Participants directed the investment of their contributions into various investment options offered by the Plan. Effective January 1, 2021, the Plan was amended to allow for participants to separately defer up to 100% of their actual cash bonus to be paid by the Company.

Participant Accounts

Each participant’s account was credited with the participant’s contribution and allocations of the Company’s matching contributions and/or profit-sharing allocation, Plan earnings or losses and charged with an allocation of administrative expenses. Allocations were based on participant earnings or account balances, as defined by the Plan. The benefit to which a participant was entitled is the benefit that can be provided from the participant’s vested account balance.

Vesting

Participants were immediately vested in their voluntary contributions plus actual earnings thereon, as well as any safe harbor employer contributions.

The Company’s contributions to the participants’ accounts become 33% vested after one year of service and fully vested after 3 years of service.

Forfeitures

Forfeitures of terminated participants' non-vested accounts could be used to pay administrative expenses or reduce the future matching contributions of the Company. There was no balance of forfeiture accounts at December 29, 2023. The balance of forfeited accounts was \$88,595 at December 31, 2022. During 2023, \$167,640 of forfeitures were used to reduce employer contributions and \$14,356 were used to pay administrative expense.

Notes Receivable from Participants

Participants could borrow from their fund accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$100,000 or 50% of their vested account balance. Each participant was limited to one outstanding note receivable at a time. The notes receivable from participants was secured by the balance in the participant's account and have interest at a rate commensurate with local prevailing rates as determined by the Plan administrator. Principal and interest repayments were made ratably through payroll deductions over a period not to exceed five years, unless the notes receivable from participants were used to purchase a primary residence in which case the notes receivable terms may exceed five years.

Payment of Benefits

Upon termination of service due to death, disability, retirement or other reasons, a participant or beneficiary could elect to receive a lump-sum amount equal to the value of the participant's vested interest in his or her account. Withdrawals from the Plan could also be made upon circumstances of hardship, in accordance with provisions specified by the Plan. Terminated participants, with less than a \$5,000 vested benefit, would have their account balance automatically transferred to an individual retirement account in the participant's name upon termination.

Plan Expenses

Certain administrative expenses of the Plan were paid by the Plan as provided in the plan agreement. Certain other administrative expenses of the Plan were paid by the Company. Investment fees were paid by the Plan in the form of reductions of net investment income earned by Plan participants.

NOTE 2 – SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Basis of Accounting

The financial statements of the Plan were prepared using the accrual basis of accounting. The Plan follows accounting standards set by the Financial Accounting Standards Board ("FASB"). The FASB sets accounting principles generally accepted in the United States of America ("GAAP"). As discussed in Note 1, the Plan assets were transferred and the Plan was terminated effective December 29, 2023.

Use of Estimates

The preparation of financial statements in conformity with GAAP required the Plan administrator to make estimates and assumptions that affected certain reported amounts and disclosures. Accordingly, actual results may differ from those estimates.

Investment Valuation and Income Recognition

Investments were reported at fair value with the exception of the Transamerica Stable Value Core Option Fund noted below. Fair value was the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan's Investment Committee determined the Plan's valuation policies utilizing information provided by the investment advisers, custodians and insurance company.

The Plan held a guaranteed investment fund that holds investment contracts as its underlying assets. Investment contracts held by a defined contribution plan were required to be reported at contract value. Contract value was the relevant measurement attribute for that portion of the net assets available for benefits of a defined contribution plan attributable to fully benefit responsive investment contracts because contract value is the amount participants would receive if they were to initiate permitted transactions under the terms of the plan. The contract value of fully benefit-responsive investment contracts represented contributions plus earnings, less participant withdrawals and administrative expenses. The Statements of Net Assets Available for Benefits present the investment contracts at contract value at December 31, 2022.

Purchases and sales of securities were recorded on a trade date basis. Dividends were recorded on the ex-dividend date. Interest income was recorded on the accrual basis. Net appreciation included the Plan's gains and losses on investments bought and sold as well as held during the year.

Notes Receivable

Notes receivable from participants were measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income was recorded on the accrual basis. Related fees were recorded as administrative expenses and were expensed when they are incurred. No allowance for credit losses has been recorded as of December 31, 2022. If a participant ceases to make loan repayments and the plan administrator deems the participant loan to be in default, the participant loan balance was reduced, and a benefit payment was recorded.

Payments of Benefits

Benefits were recorded when paid.

Risks and Uncertainties

The Plan invested in various investment securities. Investment securities were exposed to various risks, such as interest rate, market, and credit risks. Market risks included global events which could impact the value of investment securities, such as a pandemic or international conflict. Due to the level of risk associated with certain investment securities, it was at least reasonably possible that changes in the values of securities would occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statement of net assets available for benefits.

NOTE 3 – INVESTMENTS (UNAUDITED)

The plan administrator has elected the method of annual reporting compliance permitted by 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, Transamerica Life Insurance Company ("Transamerica") and State Street Bank and Trust Company ("State Street") have provided certification that the financial information included in the financial statements as of December 29, 2023 and December 31, 2022 and for the year ended December 29, 2023 provided to the plan administrator was complete and accurate. The information as to investment assets and transactions therein, and investment income included in the accompanying financial statements as of December 29, 2023 and December 31, 2022 and for the year ended December 29, 2023 was covered by such certifications and has not been audited by independent auditors.

NOTE 4 – FAIR VALUE MEASUREMENTS

GAAP establishes a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements). The three levels of the fair value hierarchy under GAAP are described below:

Basis of Fair Value Measurement

Level 1 - Unadjusted quoted prices in active markets that are accessible at the measurement date for identical, unrestricted assets or liabilities;

Level 2 - Quoted prices in markets that are not considered to be active or financial instruments for which all significant inputs are observable, either directly or indirectly;

Level 3 - Prices or valuations that require inputs that are both significant to the fair value measurement and unobservable.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

Basis of Fair Value Measurement (Continued)

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 29, 2023 and December 31, 2022.

Mutual Funds

Mutual funds were valued at the daily closing price as reported by the fund. Mutual funds held by the Plan were open-end mutual funds that are registered with the SEC. These funds were required to publish their daily NAV and to transact at that price. The mutual funds held by the Plan were deemed to be actively traded.

Self-Directed Brokerage Account

The self-directed account was comprised of money market funds and common equities. Equities were traded on national exchanges and valued at the NAV as of December 29, 2023. It was not probable that the equities will be sold at amounts that differ materially for the NAV of the shares held.

There were no plan investments at December 29, 2023 (See Note 1). At December 31, 2022, the Plan's investments within the fair value hierarchy were level 1 and totaled \$43,291,899.

NOTE 5 – FULLY BENEFIT-RESPONSIVE INVESTMENT CONTRACT

The Plan had a fully benefit-responsive investment contract with Transamerica. Transamerica maintained the contributions in a general account. The account was credited with earnings on the underlying investments and charged for participant withdrawals and administrative expenses. The contract issuer was contractually obligated to repay the principal and a specified interest rate that was guaranteed to the Plan.

Because the stable value fund was fully benefit-responsive, contract value was the relevant measurement attribute for that portion of the net assets available for benefits attributable to the contract. The contract was presented on the face of the statements of net assets available for benefits at contract value. Contract value, as reported to the Plan by Transamerica, represented contributions made under the contract, plus earnings, less participant withdrawals, and administrative expenses. Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investment at contract value. There were no reserves against contract value for credit risk of the contract issuer or otherwise.

The contract value of the investment contract at December 31, 2022 \$1,903,929. The crediting interest rate was based on a formula agreed upon with the issuer. During the year ended December 31, 2022, the crediting rate for the annuity contract was 1.85%. Such interest rates were reviewed on a semi-annual basis for resetting.

Certain events limited the ability of the Plan to transact at contract value with the issuer. Such events include (1) amendments to the Plan documents (including complete or partial Plan termination or merger with another plan), (2) changes to the Plan's prohibition on competing investment options or deletion of equity wash provisions, (3) bankruptcy of the Plan sponsor or other Plan sponsor events (for example, divestitures or spin-offs of a subsidiary) that cause a significant withdrawal from the Plan, or (4) the failure of the trust to qualify for exemption from federal income taxes or any required prohibited transaction exemption under ERISA. The Plan administrator believed that any events that would limit the Plan's ability to transact at contract value with participants were probable of not occurring.

The guaranteed investment contract did not permit the insurance company to terminate the agreement prior to the scheduled maturity date.

NOTE 6 – INCOME TAXES

The Plan was based on the Transamerica Retirement Solutions LLC Volume Submitter 401(k) Profit Sharing Plan which received an opinion letter from the Internal Revenue Service ("IRS") dated June 30, 2020, stating that the Volume Submitter 401(k) Plan was designed in accordance with the provisions of the IRC. Although the Plan had been amended since receiving the opinion letter, the Plan administrator believes that the Plan was designed and was currently being operated in compliance with the applicable provisions of the IRC. Accordingly, the Plan's net investment income was exempt from income taxes.

NOTE 7 – PLAN TERMINATION

Effective December 29, 2023, the Plan was terminated. Each participant whose employment continued with the new employer, Global Payments Inc., had the option to make a full distribution and transfer their funds into Global Payments Inc. 401(k) Plan after waiting the employment eligibility period. Participants whose employment terminated in conjunction with the Plan's termination, took a distribution to themselves or a rollover to another plan not associated with this audit.

NOTE 8 – RELATED PARTIES AND PARTY-IN-INTEREST TRANSACTIONS

The Plan allowed for transactions with certain parties who may perform services or have fiduciary responsibilities to the Plan. These parties included investment advisory, recordkeeping and accounting services.

All investments of the Plan were managed by Transamerica and State Street, the certifying entity and contract holder, and trustee, respectively. These transactions qualified as party-in-interest transactions. Notes receivable from participants were also defined by ERISA as party-in-interest transactions.

NOTE 9 – SECURE ACT 2.0

On December 23, 2022, Congress passed the Consolidated Appropriations Act of 2023 which included SECURE Act 2.0. SECURE Act 2.0 contains over 90 new retirement provisions, with varying effective dates through 2027. Since SECURE Act 2.0 provisions include both required and optional elements, the plan administrator will determine the optional provisions to elect and amend the Plan document accordingly. Most of the significant provisions will become effective in 2024 and thereafter. Accordingly, there is no material impact to the Plan's 2023 financial statements.

NOTE 10 – SUBSEQUENT EVENTS

Management has reviewed subsequent events through June 4, 2024, the date the financial statements were available to be issued.
