Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the financial statements of Performance Systems Integration, LLC 401(k) Plan (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of March 31, 2023 and December 31, 2022, the related statements of changes in net assets available for benefits for the period from January 1, 2023 to March 31, 2023 and year ended December 31, 2022, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's (DOL) Rules and Regulations for Reporting and Disclosure under ERISA. As discussed in Note 1 to the financial statements, the Plan Committee of PSI Group Acquisition Company, LLC voted and approved in March 2023, to merge the Plan into the SaveWise Pooled Employer Plan (SaveWise Plan) effective in March 2023. Our opinion has not been modified with respect to this matter.

Responsibilities of Management for the Financial Statements

Management is responsible for the preparation and fair presentation of the financial statements in accordance with U.S. GAAP, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

Management is also responsible for maintaining a current plan instrument, including all plan amendments, administering the Plan, and determining that the Plan's transactions that are presented and disclosed in the financial statements are in conformity with the Plan's provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.

1. Plan Description

The following brief description of the Performance Systems Integration, LLC 401(k) Plan (the Plan) is provided for general information purposes only. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

General

The Plan was a defined contribution plan subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA). The Plan was established to provide retirement benefits to the employees of PSI Group Acquisition Company, LLC (the Company).

Effective March 2023, the Company approved the Plan to be merged into a new plan called the SaveWise Pooled Employer Plan (SaveWise Plan). Newport Group is the custodian of the SaveWise Plan. The merger into the SaveWise Plan initiated a "Black Out" period that began March 14, 2023 and continued through April 14, 2023. Funds could not be applied to the employee selected funds or withdrawn from the Plan or the SaveWise Plan until the Newport Group had time to accurately complete the merger conversion. Plan assets of \$4,953,323 were transferred to the SaveWise Plan by March 31, 2023. Participants in the Plan became participants in the SaveWise Plan beginning in March 2023.

Employees, excluding union and nonresident aliens, were eligible to make pre-tax and designated after-tax Roth salary reduction contributions on the first day of the quarter after attaining 21 years of age and completing thirty days of service. Participants were eligible to receive safe harbor matching contributions, and to receive discretionary matching and profit-sharing contributions. Participants were only eligible to receive discretionary profit-sharing contributions if they were employed on the last day of the Plan year and completed 1,000 hours of service during the Plan year.

Contributions

Participants could elect to defer up to 100% of their annual compensation as defined by the Plan, up to the maximum dollar amounts allowable by law. Participants could also contribute amounts representing distributions from other qualified plans. At any time, a participant could elect not to contribute or could increase or decrease his or her deferral rate. The Plan was a "safe harbor 401(k) plan", whereby the Company was required to make safe harbor matching contributions equal to 100% of each participant's elective deferral up to 3% of eligible compensation, plus 50% of the next 2% of eligible compensation. The Company could also make discretionary matching and profit-sharing contributions. Participants who were eligible to make deferral contributions and who attained age 50 before the close of the calendar year were eligible to make catch-up contributions. Contributions were subject to certain limitations.

Participant Accounts

Each participant's account was credited with the participant's contributions and an allocation of a) the Company's safe harbor matching contributions, b) the Company's discretionary matching and profit-sharing contributions and c) Plan earnings or losses and charged with an allocation of administrative expenses. The Company's safe harbor and discretionary matching contributions were allocated among participants based upon each eligible participant's elected salary deferral. The Company's discretionary profit-sharing contributions were allocated based on eligible compensation of participants. Plan earnings or losses were allocated based on actual results of the investments selected by each participant. Investments were maintained in individual member accounts maintained by Voya Retirement Insurance and Annuity Company (Voya).

Vesting

Participants were immediately vested in their participant contributions and the Company's safe harbor matching contributions, plus actual earnings thereon. Vesting in the Company's discretionary matching and profit-sharing contributions credited to participants' accounts was based on years of continuous service. Participants were 100% vested in the Company's discretionary matching and profit-sharing contributions after three years of service.

Notes Receivable from Participants

Participants could borrow from their fund accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 reduced by the participant's highest outstanding loan balance during the previous twelve months or 50% of their vested account balances, subject to Plan provisions. Notes receivable terms ranged from 1 - 5 years or longer for the purchase of a primary residence. Notes receivable were secured by the balance in the participants' accounts and bear interest at the prime rate plus 1.00%. Principal and interest was paid ratably through bi-weekly payroll deductions.

Payment of Benefits

Upon termination, retirement, disability, or death, the participant or beneficiary could elect to receive a lump sum payment, installment payments, or partial withdrawals equal to the value of the vested funds allocated to the participant's account. The Plan required that distribution payments between \$1,000 and \$5,000 be directly rolled over to an individual retirement account designated by the plan administrator in the event the participant did not elect otherwise. Distributions under \$1,000 would be paid out to the participant in the event the participant did not elect a payout option. Participants could also receive hardship and in-service distributions, as permitted in the Plan document. Benefits were recorded when paid.

Forfeitures

Upon a participant's termination of employment before normal retirement, disability or death, the portion of their Company contributions not then vested were forfeited. The forfeited portion of any participant's account could be used to pay Plan expenses. As of March 31, 2023 and December 31, 2022, there were no amounts in the non-vested forfeiture accounts.

2. Summary of Significant Accounting Policies

A summary of the significant accounting policies consistently applied in the preparation of the accompanying financial statements is set forth below.

Basis of Presentation

The accompanying financial statements have been prepared on the accrual basis and in conformity with accounting principles generally accepted in the United States of America (U.S. GAAP).

Presentation of Participant-Directed Funds

The Plan's presentation of participant-directed investments is in accordance with the Financial Accounting Standards Board (FASB) Accounting Standards Codification (ASC) 962, *Plan Accounting – Defined Contribution Pension Plans*.

Use of Estimates

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires the plan administrator to make estimates and assumptions that affect certain reported amounts and disclosures. Accordingly, actual results may differ from those estimates.

Investment Valuation and Income Recognition

Investments were reported at fair value, except for fully benefit-responsive investment contracts, which were reported at contract value. Fair value is the price that would be received to buy or sell an investment in an orderly transaction between market participants at the measurement date. The Company determined the Plan's valuation policies utilizing information provided by the investment advisors and the custodian. See Note 4 for further discussion on fair value measurements.

Fully benefit-responsive investment contracts were reported at contract value. Contract value was the relevant measurement attribute for that portion of the net assets available for benefits of a defined contribution plan attributable to fully benefit-responsive investment contracts because contract value was the amount participants would receive if they were to initiate permitted transactions under the terms of the Plan. The Plan invested in investment contracts through a guaranteed interest account.

Purchases and sales of securities were recorded on a trade-date basis. Interest income was recorded on the accrual basis. Dividend income was recorded on the ex-dividend date. Net appreciation (depreciation) included the Plan's gains and losses on investments bought and sold as well as held during the year.

Notes Receivable from Participants

Notes receivable from participants were measured at their unpaid principal balance plus any accrued but unpaid interest. Delinquent participant notes were reclassified as distributions based upon the terms of the Plan document.

Other

Audit fees were paid by the Company and were excluded from these financial statements. Other certain expenses specifically incurred by or attributable to individual participants were paid from the applicable participant's accounts and were included in administrative expenses. Investment related expenses were included in net appreciation (depreciation) in fair value of investments.

Risks and Uncertainties

The Plan invested in various investment securities. Investment securities were exposed to various risks such as interest rate, market and credit risks. Due to the level of risk associated with certain investment securities, it was at least reasonably possible that changes in the values of investment securities would occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

Subsequent Events

Subsequent events are events or transactions that occur after the statement of net assets available for benefits date, but before the financial statements are available to be issued and may require potential recognition or disclosure in the financial statements. Management has considered such events or transactions through June 10, 2024, noting no items requiring disclosure.

3. Information Certified by Voya

The plan administrator had elected the method of compliance as permitted by 29 CFR 2520.103-8 of the Department of Labor's (DOL) Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, as permitted under such election, the plan administrator instructed the Plan's independent auditors not to perform any auditing procedures with respect to the following information certified by Voya, the custodian of the Plan, except for comparing such information certified by the custodian to information included in the Plan's financial statements and supplementary information.

4. Fair Value Measurements

FASB ASC 820, *Fair Value Measurements and Disclosures*, provides the framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements). The three levels of the fair value hierarchy under FASB ASC 820 are described as follows:

- Level 1 Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.
- Level 2 Inputs to the valuation methodology include:
 - Quoted prices for similar assets or liabilities in active markets;
 - Quoted prices for identical or similar assets or liabilities in inactive markets;
 - Inputs other than quoted prices that are observable for the asset or liability;
 - Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

- Level 3 Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

The following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used as of March 31, 2023 and December 31, 2022.

Pooled Separate Accounts: Valued at the Net Asset Value (NAV) of its underlying investments. The pooled separate accounts include underlying investments in mutual funds which have observable Level 1 or Level 2 pricing inputs, including quoted prices for similar assets in active or non-active markets. FASB ASC 820, *Fair Value Measurement*, allows NAV per share to estimate the fair value as long as certain requirements are met. It is the Plan's assessment that these accounts meet those requirements. Since the participants have the ability to redeem the accounts at NAV as of the measurement dates on a daily basis, the accounts are properly categorized as a Level 2 fair value measurement.

The methods described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

There were no Plan investments as of March 31, 2023.

5. Investment Contract with Insurance Company

The Plan had entered into an investment contract with Voya. Voya maintained the contributions in a money market fund and a guaranteed interest account. The accounts were credited with earnings on the guaranteed investment contract and charged for Plan withdrawals and administrative expenses charged by Voya.

The pooled separate accounts, as reported to the Plan by Voya, were included in the financial statements at fair value, which represents contributions made under the contract, plus earnings, less withdrawals and administrative expenses.

As the guaranteed interest account was fully benefit-responsive, contract value was the relevant measurement attribute for that portion of the net assets available for benefits attributable to the guaranteed interest account. Contract value, as reported to the Plan by Voya, represents contributions made under the contract, plus earnings, less participant withdrawals and administrative expenses. Participants could ordinarily direct the withdrawal or transfer of all or a portion of their investment at contract value.

The Plan's ability to receive amounts due in accordance with fully benefit-responsive contracts was dependent on the third-party issuer's ability to meet its financial obligations. The issuer's ability to meet its contractual obligations could be affected by future economic developments. No events occurred that limited the ability of the Plan to transact at contract value with the contract issuers or the participants.

6. Tax Status

The Plan was qualified as a profit sharing plan under Section 401(a) of the Internal Revenue Code and was exempt from federal income taxation under Section 501(a) of the Internal Revenue Code of 1986, as amended.

The plan administrator believed that the Plan was currently designed and being operated in compliance with the applicable requirements of the Internal Revenue Code. Therefore, no provision for income taxes was included in the Plan's financial statements.

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the applicable taxing authority. The plan administrator had analyzed the tax positions taken by the Plan and had concluded that there were no uncertain positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements. The Plan was subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress. The plan administrator believes it is no longer subject to income tax examinations for years prior to 2020.

7. Related-Party Transactions

Certain Plan investments consisting of a money market fund, guaranteed interest accounts, and pooled separate accounts with underlying shares in mutual funds were managed by Voya. Voya was the custodian of the Plan; therefore, these transactions qualified as party-in-interest transactions.
