Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the financial statements of NTT Cloud Communications U.S. Inc. 401(k) Plan (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C). The financial statements comprise the statements of net assets available for benefits as of February 15, 2023 and December 31, 2022, and the related statement of changes in net assets available for benefits for the period from January 1, 2023 to February 15, 2023, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's (DOL) Rules and Regulations for Reporting and Disclosure under ERISA (ERISA Section 103(a)(3)(C) audit). As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the Plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency (qualified institution), provided that the investment information is prepared and certified to by the qualified institution in accordance with 29 CFR 2520.103-5 of the DOL's Rules and Regulations for Reporting and Disclosure under ERISA.

Management has obtained a certification from a qualified institution as of February 15, 2023 and December 31, 2022, and for the period from January 1, 2023 to February 15, 2023, stating that the certified investment information, as described in Note 3 to the financial statements, is complete and accurate.

Opinion

In our opinion, based on our audits and the procedures performed as described in the *Auditor's Responsibilities for the Audit of the Financial Statements* section of our report:

- the amounts and disclosures in the accompanying financial statements, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America (GAAP); and
- the certified investment information in the accompanying financial statements agrees to, or is derived from, in all material respects, the information prepared and certified by a qualified institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

Basis for Opinion

We conducted our audits in accordance with auditing standards generally accepted in the United States of America (GAAS). Our responsibilities under those standards are further described in the *Auditor's Responsibilities for the Audit of the Financial Statements* section of our report. We are required to be independent of the Plan and to meet our other ethical responsibilities, in accordance with the relevant ethical requirements relating to our audits. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our ERISA Section 103(a)(3)(C) audit opinion.

Responsibilities of Management for the Financial Statements

Management is responsible for the preparation and fair presentation of the financial statements in accordance with GAAP, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

In preparing the financial statements, management is required to evaluate whether there are conditions or events, considered in the aggregate, that raise substantial doubt about the Plan's ability to continue as a going concern within one year after the date that the financial statements are issued or available to be issued.

Management is responsible for maintaining a current plan instrument, including all plan amendments. Management is also responsible for administering the Plan and determining that the Plan's transactions that are presented and disclosed in the financial statements are in conformity with the Plan's provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with GAAP.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audit.

Notes to Financial Statements

1. Description of the Plan

The following brief description of the NTT Cloud Communications U.S. Inc. 401(k) Plan (the Plan) is provided for general information purposes only. Participants should refer to the Plan document for more complete information.

General

NTT Cloud Communications U.S. Inc. (the Company and Plan sponsor) established the Plan effective January 1, 2005. The Plan was a defined contribution plan covering all employees who were least 21 years of age and worked for at least 4 consecutive months of service within a 12-consecutive month period. Once the eligibility requirements were met, the employee became a participant in the Plan on the first business day of the month after eligibility was met. The Plan was subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA), as amended.

The Plan was frozen to contributions effective August 1, 2022, and employees were no longer eligible to participate in the Plan. Effective February 15, 2023, all Plan assets and participants were merged into the NTT DATA Americas 401(k) Plan. Accordingly, assets of \$13,497,228 were transferred out of the Plan.

Contributions

Participants may have made elective contributions from 1% to 100% of their annual base compensation up to the dollar limitation set forth in Section 402(g) of the Internal Revenue Code (IRC) in effect at the beginning of the Plan year. Eligible employees who had attained age 50 before the close of the Plan year were allowed to make catch-up contributions up to the maximum allowed by the IRC. Participants may also have contributed amounts representing distributions from other qualified defined benefit or defined contribution plans. Effective January 1, 2021, eligible employees were automatically enrolled with a 5% deferral, unless the employee affirmatively elected a different percentage or elected to not have any compensation withheld. Those participants would have had that deferral increased annually by 1%, not to exceed 10%.

The Company elected to operate under a Safe Harbor provision whereby participants in the Plan received a matching contribution of 100% of participant's salary deferrals that did not exceed 3% of participant's compensation plus 50% of participant's salary deferrals between 3% and 5% of the participant's compensation. Contributions were invested into various investment options offered by the Plan in accordance with each participant's direction. Contributions were subject to certain limitations imposed by law. In addition, the Company may have made a discretionary profit-sharing contribution to the Plan. There was no such profit-sharing contribution during 2023.

Participant Accounts

Each participant's account was credited with the participant's contributions and Company matching and profit-sharing contributions, as well as allocations of the Plan earnings (losses). Participant accounts were charged with an allocation of administrative expenses that were paid by the Plan. Allocations were based on participant earnings (losses), account balances, or specific participant transactions, as defined. The benefit to which a participant was entitled was the benefit that could have been provided from the participant's vested account.

Notes Receivable from Participants

The Plan provided that loans were available to all Plan participants on a nondiscriminatory basis. Plan participants could have borrowed from their fund accounts from a minimum loan amount of \$1,000 up to a maximum of \$50,000 or 50% of the vested account balance. The loans were secured by the balance in the participant's account and bore a reasonable interest rate, as defined by the Plan. All loans were to be repaid within five years (unless it was used to purchase their primary residence) and were payable through payroll withholdings.

1. Description of the Plan (cont.)

Vesting

Participants were immediately vested in their contributions, including rollover contributions and the actual earnings (losses) thereon. Safe harbor contributions were also immediately vested. Vesting in the Company profit-sharing contributions was based on years of continuous service. A participant was vested 33% per year of service and attained 100% vesting after three years of credited service.

Payment of Benefits

A participant's contributions and Company contributions could have been withdrawn upon retirement (on or after the attainment of normal retirement age), termination of employment, disability, or death. Participants may have elected to have distributions paid in lump-sum or partial payments. Under certain qualifying circumstances, hardship and in-service withdrawals were permitted under the Plan.

Plan Expenses

Certain administrative expenses related to distributions and other participant-initiated transactions were charged to the account of the Plan participant. Certain other administrative expenses of the Plan were paid by the Company or through reductions of investment returns under the Plan's expense budget account. The Plan expense budget account totaled \$0 and \$26,050 at February 15, 2023 and December 31, 2022, respectively. During the period from January 1, 2023 to February 15, 2023, \$17,655 of funds were used to pay administrative expenses. The remaining balance of the account was included in the transfer amount to the NTT DATA Americas 401(k) Plan, as noted above.

Forfeitures

Forfeited accounts totaled \$0 at February 15, 2023 and December 31, 2022. Forfeited funds could have been used to pay the Plan's administrative expenses or offset Company match. During the period from January 1, 2023 to February 15, 2023, no forfeited funds were used.

2. Summary of Significant Accounting Policies

Basis of Accounting

The financial statements of the Plan were prepared using the accrual basis of accounting. The Plan followed accounting standards set by the Financial Accounting Standards Board (FASB). The FASB sets accounting principles generally accepted in the United States of America (GAAP).

Use of Estimates

The preparation of financial statements in conformity with GAAP required the Plan administrator to make estimates and assumptions that affect the reported amounts of net assets available for benefits and changes therein, and disclosure of contingent assets and liabilities. Actual results could have differed from those estimates.

Investment Valuation and Income (Loss) Recognition

The investments of the Plan were reported at fair value, except for fully benefit-responsive investment contracts, which were reported at contract value. Contract value was the relevant measurement for that portion of the net assets available for benefits because contract value was the amount participants normally would have received if they had initiated permitted transactions under the terms of the Plan.

2. Summary of Significant Accounting Policies (cont.)

Investment Valuation and Income (Loss) Recognition (cont.)

The fair value of a financial instrument was the amount that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date (the exit price). The Plan's investment committee determined the Plan's valuation policies utilizing information provided by the investment advisers, custodian and insurance company.

Purchases and sales were recorded on a trade-date-basis. Investment income (loss) was recorded on the accrual basis. Net appreciation (depreciation) included the Plan's gains and losses on investments bought and sold as well as held during the year.

Notes Receivable

Notes receivable from participants were measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income was recorded on the accrual basis. Related fees were recorded as administrative expenses and were expensed when they were incurred. No allowance for credit losses had been recorded as of February 15, 2023 and December 31, 2022. If a participant ceased to make loan repayments and the Plan administrator deemed the participant loan to be in default, the participant loan balance was reduced, and a benefit payment was recorded.

Payment Benefits

Benefit payments to participants were recorded upon distribution.

3. Certified Information

The Plan administrator has elected the method of annual reporting compliance permitted by 29 CFR 2520.103-8 of the Department of Labor's (DOL) Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, Reliance Trust Company has provided a certification that the financial information included in the financial statements as of February 15, 2023 and December 31, 2022, and for the period from January 1, 2023 to February 15, 2023, provided to the Plan is complete and accurate. The information as to investment assets and transactions therein, and investment income (loss) included in the accompanying financial statements as of February 15, 2023 and December 31, 2022, and for the period from January 1, 2023 to February 15, 2023, is covered by such certification.

The Plan's independent accountants did not perform auditing procedures with respect to this information, except for comparing such information to the related information included in the financial statements.

4. Fair Value Measurements

GAAP establishes a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs in which little or no market data exists (Level 3 measurements). The three levels of the fair value hierarchy under GAAP are described below:

4. Fair Value Measurements (cont.)

Basis of Fair Value Measurement

Level 1 - Unadjusted quoted prices in active markets that are accessible at the measurement date for identical, unrestricted assets or liabilities;

Level 2 - Quoted prices in markets that are not considered to be active or financial instruments for which all significant inputs are observable, either directly or indirectly;

Level 3 - Prices or valuations that require inputs that are both significant to the fair value measurement and unobservable.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

The following is a description of the valuation methodology used for assets measured at fair value. There have been no changes in the methodology used at February 15, 2023 and December 31, 2022.

Mutual Funds - Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan were open-end mutual funds that were registered with the Securities and Exchange Commission (SEC). These funds were required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan were deemed to be actively traded.

The method described above may have produced a fair value calculation that may not have been indicative of net realizable value or reflective of future fair values. Furthermore, while management believed its valuation method was appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could have resulted in a different fair value measurement at the reporting date.

The following table sets forth by level, within the fair value hierarchy, the Plan's assets at fair value as of December 31, 2022. The Plan has no assets at February 15, 2023.

5. Insurance Contract - General Account

The Plan invested in a fully benefit-responsive investment contract, where Transamerica Financial Life Insurance Company (Transamerica) maintained the contributions in a general account (Stable Fund). Transamerica credited the account with participant contributions and earnings (losses) and charged the account for participant withdrawals and administrative expenses. The issuer contractually must have repaid the principal and a specified interest rate that the issuer guaranteed to the Plan.

5. Insurance Contract - General Account (cont.)

The Stable Fund consisted of stable fund segments based on the date the Stable Fund received contributions. Transamerica established a guaranteed rate of interest for each segment and credited a rate of interest at least equal to the guaranteed rate for that Stable Fund segment until the Stable Fund segment maturity date. On the Stable Fund segment maturity date, the guaranteed rate of interest for that Stable Fund segment expired. Stable Fund segments matured at the end of each calendar year. Upon written notice, Transamerica transferred the amount in that Stable Fund segment to any of the investment funds maintained under the contract. If Transamerica did not receive written notice from the contract holder prior to the Stable Fund segment maturity date, Transamerica automatically transferred the amount in the Stable Fund segment to a successor Stable Fund segment. Quarterly, Transamerica declared an interest rate for the Stable Fund segment established for contributions received during the quarter and guaranteed the interest rate until the end of the calendar year. At the end of the year, the Stable Fund combined the quarterly segments into one segment for that year. Annually, Transamerica declared an interest rate for the Stable Fund segments for each prior year that still had a balance. The Stable Fund is reported at contract value because it met the criteria of a fully benefit-responsive contract. Contract value was the relevant measure for fully benefit-responsive investment contracts because this was the amount participants would have received if they were to have initiated permitted transactions under the terms of the Plan. Transfers from the Stable Fund elected by the Plan were subject to a market value adjustment. However, transfers from the Stable Fund at a Stable Fund segment maturity date were not subject to a market value adjustment.

Certain events may have limited the ability of the Plan to transact at contract value with the insurance company and the financial institution issuer. Such events included (1) the Plan no longer constituting a tax qualified plan according to Section 401(a) or 404(a) of the Code; (2) Transamerica determining that it could no longer continue to provide benefits under the contract because of a change in the Plan; (3) Transamerica did not receive deposits as described in the contract for three consecutive contract years; (4) Transamerica received direction from the Plan to transfer assets outside of the contract, and such outside fund or funding vehicle was not available under the entities listed in the attachment to the contract; (5) deposits were made to any fund that was not included in the contract or was not available under the entities listed in the attachment to the contract; (6) Transamerica was informed that Transamerica Retirement Solutions received, or was given, notice that Transamerica Retirement Solutions would no longer be providing services to the Plan; or (7) in the opinion of Transamerica, the Plan violated any provision of the contract. The Company did not believe that the occurrence of any such events that would have limited the Plan's ability to transact at contract value with participants was probable.

Either the Plan or Transamerica may have suspended the contract by giving written notice. Upon receipt of such written notice, the contract would have been immediately suspended. Transamerica was not permitted to pay or transfer the value of the contract, without consent from the Plan, prior to the scheduled maturity date. Upon suspension of the contract the Plan should have elected, prior to the date of transfer, one of two options regarding payment of the value of the Stable Fund: (a) Transamerica would have paid the value of each Stable Fund segment on each applicable Stable Fund segment maturity date or (b) Transamerica would have paid the balance of the Stable Fund to the contract holder or designated payee in a single sum. Any such payment could have been subject to a market value adjustment.

6. Tax Status

The Plan was based on the Non-Standardized Pre-Approved Profit Sharing/Money Purchase Plan with CODA (Pre-Approved Plan) of Ascensus LLC which received an opinion letter from the Internal Revenue Service (IRS) dated June 30, 2020, stating that the Pre-Approved Plan was designed in accordance with the provisions of the IRC. The Plan administrator believed that the Plan was designed, and was being operated, in compliance with the applicable requirements of the IRC and, therefore, believes the Plan was qualified and the related trust is tax-exempt.

GAAP required Plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan had taken an uncertain position that more likely than not would not have been sustained upon examination by the IRS. The Plan was subject to routine audits by taxing jurisdictions, however, there are currently no audits for any tax periods in progress.

7. Related Parties and Party-In-Interest Transactions

Transamerica, the Plan's recordkeeper, issued the insurance contract. These transactions, as defined by the Plan, qualified as party-in-interest transactions. Notes receivable from participants were also defined by ERISA as party-in-interest transactions.

8. Risks and Uncertainties

The Plan invested in various investment securities. Investment securities were exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it was at least reasonably possible that changes in the values of investment securities would have occurred and that such changes could have materially affected participants' account balances and the amounts reported in the statements of net assets available for benefits and the statement of changes in net assets available for benefits.

9. SECURE Act 2.0

On December 23, 2022, Congress passed the Consolidated Appropriations Act of 2023 which included SECURE Act 2.0. SECURE Act 2.0 contains over 90 new retirement provisions, with varying effective dates through 2027. Since SECURE Act 2.0 provisions include both required and optional elements, the Plan administrator will determine the optional provisions to elect and amend the Plan document accordingly. Most of the significant provisions will become effective in 2024 and thereafter. Accordingly, there is no impact to the Plan's 2023 financial statements.

10. Subsequent Events

Management has evaluated subsequent events through May 07, 2024, which is the date the financial statements were available to be issued.
