Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

As a result, the Plan used the liquidation basis of accounting to present the financial statements. Our opinion is not modified with respect to this matter.

Responsibilities of Management for the Financial Statements

Management is responsible for the preparation and fair presentation of the financial statements in accordance with U.S. GAAP, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

NOTE A - DESCRIPTION OF THE PLAN

The following description of the American Hotel Register Company Incentive Savings Plan (the Plan) provides only general information. Interested parties should refer to the plan document for a more complete description of the Plan's provisions.

1. General

American Hotel Register Company ("the Company") established a defined contribution 401(k) plan covering previously eligible employees of the Company which is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA). In August 2021, substantially all assets of the Company were acquired by Consolidated Hospitality Supplies Holdings ("CHS"). As a result of this transaction, the Company terminated all employees, and accordingly, contributions and further enrollment to the Plan ceased effective September 1, 2021.

During 2021, The Plan Administrator coordinated a group rollover of terminated participant balances and a transfer of active loan balances for participants rehired by the acquiring entity into the AMTEX Supply Holdings, Inc. Retirement Plan & Trust ("AMTEX Plan"), a Plan sponsored by CHS and its affiliates. The remaining assets in the Plan relate to participants who did not elect to rollover to the acquiring entity's plan or otherwise authorize distribution of their account balances.

As discussed in Note F, effective December 1, 2022, the Plan was terminated, and as of August 24, 2023, all plan assets were liquidated.

2. Eligibility and Contributions

Former employees could not be nonresident aliens, leased employees, or independent contractors and could not be covered by a collective bargaining agreement to be eligible for the Plan. Eligible employees were able to participate upon hire. Participants were eligible to receive employer matching contributions upon completion of one full year of employment, with at least 1,000 hours of service.

Prior to the acquisition of the Plan Sponsor described in Note A-1, the Plan was funded by voluntary contributions of participants and discretionary matching contributions of the Company. Participants were able to contribute to the Plan, through regular payroll deductions, and participants who had attained age 50 before the end of the calendar year were eligible to make catch-up contributions. Participants were also able to roll over amounts representing distributions from other qualified employee benefit plans. The Company made no discretionary matching contributions to the Plan for the period January 1, 2023 through August 24, 2023. Contributions were subject to certain IRS limitations.

2. Eligibility and Contributions (Continued)

The Plan included an auto-enrollment provision whereby all newly eligible employees were automatically enrolled in the Plan unless they affirmatively elected not to participate in the Plan. Automatically enrolled participants had their deferral rate set at 3% of eligible compensation and their contributions invested in a designated balanced fund until changed by the participant. Automatically enrolled participants had their deferral rate increased at a rate of 1% per year on January 1st up to a maximum of 75% of eligible compensation, unless otherwise elected by the participant.

3. Investment Options

Participants were permitted to direct their salary deferral contributions and the Company's contributions into a variety of investment funds made available and determined by the Plan Administrator. Participants were permitted to change their investment options at any time.

4. Participant Accounts

Each participant's account was credited with the participant's contribution, an allocation of the Company's discretionary matching contributions, and with an allocation of plan earnings. The Company's discretionary matching contribution was allocated based on a percentage of the participant's contribution. Plan earnings were allocated to participants' accounts in direct proportion to their respective account balances, based on the performance of participants' investment selections. The benefit to which a participant was entitled was the benefit that can be provided from the participant's vested account balance.

5. Vesting

Participants were immediately fully vested in all contributions to the Plan plus the actual earnings thereon.

6. Payment of Benefits

On termination of service, a participant could have elected to receive a single, lump-sum payment equal to the value of his or her vested account balance or a direct rollover distribution. In-service withdrawals were permitted upon attainment of age 59 1/2. Hardship withdrawals were also permitted by the Plan.

7. Administrative Expenses

Certain expenses incurred maintaining the Plan were recorded as expenses to the plan. Investment-related expenses are included in net depreciation in fair value of investments.

8. Forfeitures

At December 31, 2022, unallocated plan assets resulting from returned distribution checks and refunds of excess Company discretionary matching contributions were \$60,401. These accounts were to be used to pay plan expenses. Approximately \$1,570 of forfeitures were used to pay plan expenses related to the Plan year ended August 24, 2023. The remaining forfeiture balance was distributed out of the plan to Penchecks Trust (see Note F).

NOTE B - SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

1. Basis of Accounting

As a result of the Plan termination (see Note F), management determined that the liquidation of the Plan was imminent and the financial statements have been prepared using the liquidation basis of accounting.

2. Fair Value Measurements

Current accounting standards establish a framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements). The three levels of the fair value hierarchy are described below:

Level 1 Inputs to the valuation methodology are unadjusted quoted market prices for identical assets or liabilities in active markets that the Plan has the ability to access.

- Level 2 Inputs to the valuation methodology include the following:
- * Quoted prices for similar assets or liabilities in active markets;
 - * Quoted prices for identical or similar assets or liabilities in inactive markets;
 - * Inputs other than quoted prices that are observable for the asset or liability;
 - * Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

- Level 3 Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

The following are descriptions of the valuation methodologies used for the Plan's investments measured at fair value. There have been no changes in the methodologies used at August 24, 2023 and December 31, 2022.

Mutual funds: Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan were open-end mutual funds that are registered with the Securities and Exchange Commission. These funds were required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan were deemed to be actively traded.

Stable value collective trust fund: A stable value fund that was composed primarily of synthetic investment contracts backed by high-credit-quality fixed income investments and traditional investments issued by insurance companies and banks that was valued at the NAV of units of the bank collective trust. The NAV was used as a practical expedient to estimate fair value. This practical expedient would not be used if it is determined to be probable that the fund will sell the investment for an amount different from the reported NAV. Participant transactions (purchases and sales) were permitted to occur daily.

3. Investment Valuation and Income Recognition

Investments were reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan Administrator determined the Plan's valuation policies utilizing information provided by the trustee. See Note B-2 for discussion of fair value measurements.

Purchases and sales of securities were recorded on a trade-date basis. Interest income was recorded on the accrual basis. Dividends were recorded on the ex-dividend date. Net appreciation included the Plan's gains and losses on investments purchased and sold as well as held during the year.

4. Use of Estimates

In preparing the Plan's financial statements, management is required to make estimates and assumptions that affect the reported amounts of assets and liabilities, the disclosure of contingent assets and liabilities at the date of the financial statements, and the reported amounts of changes in net assets in liquidation during the reporting period. Actual results could differ from those estimates.

5. Payment of Benefits

Benefits were recorded when paid.

NOTE C - INFORMATION CERTIFIED BY VANGUARD FIDUCIARY TRUST COMPANY

Certain information related to investments disclosed in the accompanying financial statements including investments held at December 31, 2022, and net appreciation in fair value of investments, and interest and dividends, for the period January 1, 2023 through August 24, 2023, was obtained by management and agreed to or derived from information certified as complete and accurate by Vanguard Fiduciary Trust Company (the trustee of the Plan).

NOTE D - TAX STATUS

Effective January 1, 2015, the Plan adopted a nonstandardized form of a prototype plan sponsored by Vanguard Fiduciary Trust Company. The prototype plan has received an opinion letter from the Internal Revenue Service as to the prototype plan's qualified status. The prototype plan opinion letter had been relied upon by this Plan. The Plan Administrator believes that the Plan was currently designed and being operated in compliance with the applicable provisions of the Internal Revenue Code.

Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the Internal Revenue Service. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

NOTE E - RELATED PARTY-IN-INTEREST TRANSACTIONS

Plan investments were managed by Vanguard Fiduciary Trust Company. Vanguard Fiduciary Trust Company was the trustee, as defined by the Plan; therefore, these transactions qualified as party-in-interest transactions. Fees paid by the Plan for investment management services were included as a reduction of the return earned on each investment.

Certain administrative fees related to the administration of the Plan were paid by the Plan or by the Company. These transactions qualified as party-in-interest.

NOTE F - PLAN TERMINATION

Plan management approved a plan of liquidation to terminate the Plan effective December 1, 2022, and management determined liquidation is imminent. In accordance with IRS regulation, participants had the option to elect receive lump-sum cash distributions, elect to rollover their balance into another qualified plan, or in the scenario no direction was provided by the participant, their balance was automatically rolled over into an IRA held by Penchecks Trust, a third party service provider that specializes in terminated plans. As of August 24, 2023, the Plan's investments were fully liquidated and distributed to participants in a lump sum or rolled over into preselected individual retirement accounts. Administrative costs for expenses incurred by the Plan relating to the liquidation were paid by the Plan and are included in administrative expenses on the accompanying statement of changes in net assets in liquidation.

NOTE G - SUBSEQUENT EVENTS

Plan management has evaluated subsequent events through June 12, 2024, the date that these financial statements were available to be issued. Plan management has determined that no events or transactions have occurred subsequent to the statement of net assets available for benefits in liquidation date that require disclosure in the financial statements.
