Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the financial statements of the DeSales University Retirement Plan (Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of September 30, 2023 and December 31, 2022, and the related statement of changes in net assets available for benefits for the period from January 1, 2023 to September 30, 2023, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's (DOL) Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the Plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the DOL's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from a qualified institution as of September 30, 2023 and December 31, 2022, and for the period from January 1, 2023 to September 30, 2023, stating that the certified investment information, as described in Note 7 to the financial statements, is complete and accurate.

Opinion

In our opinion, based on our audits and on the procedures performed as described in the Auditors' Responsibilities for the Audit of the Financial Statements section:

- the amounts and disclosures in the financial statements, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America (GAAP).
- the information in the financial statements related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

Basis for Opinion

We conducted our audits in accordance with auditing standards generally accepted in the United States of America (GAAS). Our responsibilities under those standards are further described in the Auditors' Responsibilities for the Audit of the Financial Statements section of our report. We are required to be independent of the Plan and to meet our other ethical responsibilities, in accordance with the relevant ethical requirements relating to our audits. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our ERISA Section 103(a)(3)(C) audit opinion.

Emphasis of Matter - Plan Merger

As disclosed in Note 1 to the financial statements, the Plan merged into the Pennsylvania Association of Independent Colleges and Universities Multiple Employer Plan, effective September 30, 2023 and all assets and liabilities were legally transferred as of that date. Our opinion is not modified with respect to this matter.

Responsibilities of Management for the Financial Statements

Management is responsible for the preparation and fair presentation of the financial statements in accordance with GAAP, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

In preparing the financial statements, management is required to evaluate whether there are conditions or events, considered in the aggregate, that raise substantial doubt about the Plan's ability to continue as a going concern within one year after the date that the financial statements are available to be issued.

Management is also responsible for maintaining a current plan instrument, including all plan amendments, administering the Plan, and determining that the Plan's transactions that are presented and disclosed in the financial statements are in conformity with the Plan's provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.

Auditors' Responsibilities for the Audit of the Financial Statements

Except as described in the Scope and Nature of the ERISA Section 103(a)(3)(C) Audit section of our report, our objectives are to obtain reasonable assurance about whether the financial statements as a whole are free from material misstatement, whether due to fraud or error, and to issue an auditors' report that includes our opinion. Reasonable assurance is a high level of assurance but is not absolute assurance and therefore is not a guarantee that an audit conducted in accordance with GAAS will always detect a material misstatement when it exists. The risk of not detecting a material misstatement resulting from fraud is higher than for one resulting from error, as fraud may involve collusion, forgery, intentional omissions, misrepresentations or the override of internal control. Misstatements are considered material if there is a substantial likelihood that, individually or in the aggregate, they would influence the judgment made by a reasonable user based on the financial statements.

In performing an audit in accordance with GAAS, we:

- Exercise professional judgment and maintain professional skepticism throughout the audit.
- Identify and assess the risks of material misstatement of the financial statements, whether due to fraud or error, and design and perform audit procedures responsive to those risks. Such procedures include examining, on a test basis, evidence regarding the amounts and disclosures in the financial statements.
- Obtain an understanding of internal control relevant to the audit in order to design audit procedures that are appropriate in the circumstances, but not for the purpose of expressing an opinion on the effectiveness of the Plan's internal control. Accordingly, no such opinion is expressed.
- Evaluate the appropriateness of accounting policies used and the reasonableness of significant accounting estimates made by management, as well as evaluate the overall presentation of the financial statements.
- Conclude whether, in our judgment, there are conditions or events, considered in the aggregate, that raise substantial doubt about the Plan's ability to continue as a going concern for a reasonable period of time.

Our audits did not extend to the certified investment information, except for obtaining and reading the certification, comparing the certified investment information with the related information presented and disclosed in the financial statements, and reading the disclosures relating to the certified investment information to assess whether they are in accordance with the presentation and disclosure requirements of GAAP.

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with GAAP.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings and certain internal control-related matters that we identified during the audit.

1. Description of the Plan

The following description of the DeSales University Retirement Plan (Plan) provides only general information. Participants should refer to the plan agreement for a more complete description of the Plan's provisions.

General

The Plan was a defined contribution plan that operated under Section 403(b) of the Internal Revenue Code (IRC) covering substantially all employees of DeSales University (University) except student employees. Participants were eligible to contribute pre-tax deferral or nondeductible participant contributions as soon as administratively feasible. Participants, other than adjunct faculty, were eligible for discretionary matching contributions if they had been credited with at least 1,000 hours of service and were age 21 or older. The Plan was subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

Effective September 30, 2023, the Plan merged into the Pennsylvania Association of Independent Colleges and Universities Multiple Employer Plan (MEP) and all assets were legally transferred to that plan on September 30, 2023.

Contributions

Each year, participants could contribute pretax contributions not to exceed limits imposed by the IRC. Participants who attained age 50 before the end of the plan year were eligible to make additional catch-up contributions. Participants who completed 15 years of service could make additional contributions. Participants could also contribute amounts representing distributions from certain qualified plans or an individual retirement account (rollover). Participant contributions to the Plan were recorded in the period that payroll deductions were made from participants.

The Plan provided for a discretionary matching contribution by the University for a participant who contributed 2% or more of their eligible compensation. The discretionary matching contribution as a percent of eligible compensation was 8% in 2023.

Participants directed all contributions into various investment options offered by the Plan. Contributions were subject to certain Internal Revenue Service (IRS) limitations.

Participant Accounts

Each participant's account was credited with the participant's contributions, the University's discretionary matching contributions and allocations of the Plan's earnings. Administrative expenses could be allocated to participant's accounts or directly charged against a participant's account balance for expenses directly related to the participant. Allocations were based on participant earnings, account balances or specific participant transactions, as defined. The benefit to which a participant was entitled was the benefit that can be provided from the participant's account.

Notes Receivable From Participants

Participants could borrow from their account a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their account balance. The borrowings were secured by the balance in the participant's account. Terms extend up to a period of five years unless used for the purchase of a primary residence. Interest was fixed at origination based on the national prime rate plus 1%.

In addition, as discussed in Note 8, there were loans held outside of the Plan issued by the Teachers Insurance and Annuity Association (TIAA).

Vesting

Participants were vested immediately in both their contributions and the University's discretionary matching contributions, plus actual earnings thereon.

Payment of Benefits

On termination of service, death, disability, or attainment of age 59½, a participant was eligible to receive a distribution of their account balance. The normal form of benefit payment was a qualified joint and survivor annuity for married participants and a life annuity for unmarried participants. Participants could also elect a lump-sum, partial or installment payments. A lump-sum distribution could be paid out automatically if the participant's account balance was \$5,000 or less. Hardship withdrawals were also permitted by the Plan if certain criteria were met.

2. Summary of Significant Accounting Policies

Basis of Accounting

The accompanying financial statements of the Plan were prepared on the accrual basis of accounting.

Use of Estimates

The preparation of the Plan's financial statements in conformity with accounting principles generally accepted in the United States of America required management to make estimates and assumptions that affected the reported amounts of assets and liabilities and changes therein, and disclosures of contingent assets and liabilities. Actual results could differ from such estimates.

Investments Valuation and Income Recognition

Investments were reported at fair value (except for fully benefit-responsive investment contracts, which were reported at contract value). Fair value was the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The University's management determined the Plan's valuation policies utilizing information provided by the trustees. See Note 4 for discussions of fair value measurements.

Purchases and sales of securities were recorded on a trade-date basis. Interest income was recorded on the accrual basis. Dividends were recorded on the ex-dividend date. Net appreciation includes the gains and losses on investments bought and sold as well as held during the year.

Notes Receivable From Participants

Notes receivable from participants were measured at their unpaid principal balance plus any accrued but unpaid interest. Related fees were recorded as administrative expenses and were expensed when they were incurred. Interest income was recorded on the accrual basis. No allowance for credit losses was - recorded as of December 31, 2022.

Payment of Benefits

Benefits were recorded when paid.

Administration of Plan Assets and Expenses

The Plan's assets were administered under contracts with TIAA and the College Retirement Equities Fund (CREF), the trustees of the Plan. The trustees invested funds received from contributions, investment sales, interest and dividend income and made distribution payments to participants.

Certain administrative expenses of maintaining the Plan were paid by the Plan, unless otherwise paid by the University. Expenses paid by the University were excluded from these financial statements. Fees related to the administration of notes receivable from participants were charged directly to the participant's account and were included in administrative expenses. Investment related expenses were included in net appreciation in fair value investments.

Subsequent Events

Subsequent events have been evaluated for recognition or disclosure through June 12, 2024, the date the financial statements were available to be issued.

3. Investment Contract with TIAA

The Plan offered the option to invest in the TIAA Traditional Annuity Account, a guaranteed annuity contract with TIAA. Plan participants entered into this contractual agreement with TIAA by selecting a TIAA Traditional Annuity Account. Participants of the Plan invested in the following transitional accounts: Retirement Annuity (RA), Supplemental Retirement Annuity (SRA), or Group Supplemental Retirement Annuity (GSRA).

The SRA and GSRA were considered fully benefit-responsive and were reported at contract value. Contract value, reported to the Plan by TIAA, represented contributions made under the contract, plus earnings, less participant withdrawals and administrative expenses. The RA was considered nonbenefit-responsive and was reported at fair value.

The TIAA Traditional Annuity Account was a guaranteed annuity contract with a fixed rate of interest. Interest was credited to the account and accumulations included a guaranteed rate, plus discretionary additional amounts determined annually by the TIAA Board of Trustees. The additional amounts, when declared, remained in effect through the "declaration year," which began each March 1. The guaranteed annual interest rate was 3% for all premiums remitted since 1979 under all TIAA Traditional Annuity accumulating contracts. They were not a portfolio of contracts whose yields were based on changes in fair value of underlying assets, therefore the average yield earned by the Plan was the interest earned on the group annuity contract.

There were no reserves against contract value for credit risk of TIAA or otherwise. The crediting interest rate was based on a formula agreed upon by TIAA, which will not be less than 0%. Such interest rates were reviewed on an annual basis for resetting. The TIAA Traditional Annuity Account did not permit TIAA to terminate the agreement prior to the scheduled maturity date.

No events occurred that limited the ability of the Plan to transact at contract value with TIAA nor limited the ability of the Plan to transact at contract value with the participants.

4. Fair Value Measurements

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). The three levels of the fair value hierarchy under authoritative guidance are described as follows:

Level 1 - Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 - Inputs other than quoted prices included within Level 1 that are observable for the asset or liability, either directly or indirectly, such as:

- quoted prices for similar assets or liabilities in active markets;
- quoted prices for identical or similar assets or liabilities in inactive markets;
- inputs other than quoted prices that are observable for the asset or liability;
- inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 - Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy was based on the lowest level of any input that was significant to the fair value measurement. Valuation techniques maximize the use of relevant observables and minimize the use of unobservable inputs.

Following was a description of the valuation of methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2022.

Registered Investment Companies Funds were valued at the daily closing market price as reported by the fund. The funds held by the Plan were open-end mutual funds that were registered with the U.S. Securities and Exchange Commission. These funds were required to publish their daily NAV and to transact at that price. The funds held by the Plan were deemed to be actively traded.

Separate Accounts were valued based on NAV per unit of participation in the account. The NAV was based on the fair value of the underlying investments held by the account less its liabilities and was considered to be a readily determinable fair value. The accounts invested principally in equity securities, fixed income instruments and short-term instruments in accordance with each account's investment objectives.

Guaranteed Annuity Contract was reported at contract value, which approximated fair value, based on TIAA's ability to pay the guaranteed claims in accordance with the terms of the contract. As of December 31, 2022, TIAA's credit ratings were as follows: A++ by A.M. Best Company, AAA by Fitch Ratings, AA+ by Standard & Poor's and Aa1 by Moody's Investors Service. The high credit ratings of TIAA as of the measurement date uphold the TIAA Account's ability to meet obligations set forth in the contracts.

Contract value was the aggregation of contributions, plus interest, less withdrawals, if any. Crediting rates were a combination of a guaranteed rate and an annually established discretionary rate. Additionally, the discretionary rate applied to contributions received during a reporting period may vary from the discretionary rate applied to account balances at the end of the prior reporting period. Contract value approximated a discounted cash flow value calculated using an appropriate risk-adjusted market discount rate which correlated closely with the historical crediting rates.

The guaranteed annuity contract had redemption restrictions based on the terms of the underlying contract selected by the participant and loan agreements with participants, and claims against the contracts were solely supported by TIAA's ability to pay on such claims. The redemption restrictions did not have a material impact on the contract value.

Investment Measured at NAV was a pooled separate account valued at NAV per unit of participation in the account. The NAV was used as a practical expedient to estimate fair value. The NAV was based on the fair value of the underlying investments held by the account less its liabilities. This practical expedient was not used when it was determined to be probable that the account will sell the investment for an amount different than the reported NAV. There were no participant redemption restrictions for these investments; the redemption notice period was applicable only to the Plan as disclosed in the table below.

5. Tax Status

The Plan adopted a volume submitter plan offered by TIAA. The volume submitter plan received an advisory letter dated August 7, 2017, that the Plan, and related trust were designed in accordance with the applicable sections of the IRC. The plan administrator believes that the Plan was designed and was being operated in compliance with the applicable requirements of the IRC and therefore believes that the Plan was qualified and the related trust was tax exempt.

Management is required to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

6. Risks and Uncertainties

The Plan's investments were exposed to various risks such as interest rate, market and credit risks. Due to the level of risk associated with certain investments, it is at least reasonably possible that changes in the values of investments will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

At December 31, 2022 the Plan had \$44,926,573 concentrated in two investments.

7. Information Certified by TIAA and CREF

The plan administrator has elected the method of compliance as permitted by 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA for 2023 and 2022. Accordingly, TIAA and CREF have certified to the completeness and accuracy of all investments reported in the accompanying statements of net assets available for benefits as of September 30, 2023 and December 31, 2022 and related investment activity reported in the accompanying statement of changes in net assets available for benefits for the period from January 1, 2023 to September 30, 2023.

8. Related-Party and Party In Interest Transactions

The Plan's investments were administered under a contract with TIAA and CREF. Transactions with TIAA and CREF qualify as party in interest transactions. Additionally, the Plan issued loans to participants, which were secured by the participant's account balances. Loan transactions also qualified as party in interest transactions.

The Plan received a \$4,222 credit from TIAA for reimbursement of excess servicing costs charged to the Plan which was included in other income in the statement of changes in net assets available for benefits.

Certain administrative functions were performed by officers or employees of the University. No such officer or employee received compensation from the Plan.
