NOTE 1 - Description of Plan

The following summary description of the Premier Thermal Solutions, LLC 401(k) Plan (Plan) provides only general information. Participants should refer to the Plan agreement for more complete information of the Plan's provisions.

General - The Plan is a voluntary defined contribution plan covering the employees of Premier Thermal Solutions, LLC (the Company), excluding nonresident aliens, part time, temporary, seasonal and leased employees. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA). The Plan assets are managed by Principal Trust Company (the "trustee"), who was appointed by the Company. The 401(k) Plan administrator is responsible for oversight of the Plan. Plan management determines the appropriateness of the Plan's investment offerings and monitors investment performance. The Plan was merged into a similar Plan effective August 31, 2023. Upon merger, all assets of the Plan were transferred out of the Plan and transferred into the Aalberts Surface Technologies 401K Plan.

Contributions - Each year, participants may contribute a portion of their compensation not to exceed limits established by the Internal Revenue Code. Rollover contributions from other qualified plans are also permitted at the discretion of the plan administrator. Participants direct the investment of their contributions into various investment options offered by the Plan. The Plan includes an auto-enrollment provision whereby all newly eligible employees are automatically enrolled in the Plan unless they affirmatively elect not to participate in the Plan. As of January 1, 2023, automatically enrolled participants have their deferral rate set at 5% of eligible compensation and their contributions invested in a designated balanced fund until changed by the participant. The Plan does not include an auto escalate provision as of January 1, 2023. The Plan currently offers various mutual funds, common investment trust funds and pooled separate accounts as investment options for participants. Participants may change their investment option daily. Contributions are subject to certain limitations.

During 2023, the Company made qualified safe harbor matching contributions in an amount equal to 100% of elective deferrals up to 3% and 50% of the next 2% of elective deferrals which amounted to \$393,638. During 2022, the Company made qualified nonelective contributions in an amount equal to 100% of elective deferrals not to exceed 6%. The Company also may elect to make discretionary contributions as specified in the Plan documents. For 2023, the Company did not make any discretionary contributions. Participants direct the investment of the Company contributions as described above.

Participant accounts - Each participant's account is credited with the participant's contributions, Company's safe harbor contribution and discretionary contributions, and Plan earnings. Participant accounts are charged with an allocation of administrative expenses that are paid by the Plan. Allocations are based on participant earnings, account balances or specific participant transactions, as defined in the Plan document. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

NOTE 1 - Description of Plan - (Continued)

Vesting - Participants are vested immediately in their contributions and Company safe harbor and nonelective contributions plus actual earnings thereon. Employer discretionary matching contributions vesting is based on years of continuous service. A participant is 100% vested after five years of credited service.

Payment of benefits - Upon termination of service due to death, disability, retirement or separation of employment, a participant, or beneficiary thereof, shall be eligible to receive a distribution of the balance of the participant's vested interest in his or her account.

Notes receivable from participants - Participants may borrow from their fund accounts up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balance. The loans are secured by the balance in the participant's account. Repayments are made through payroll deductions and all payments of principal and interest are credited back to the participant's account. The interest rate is set by the Plan administrator in accordance with local prevailing rates for similar types of loans.

Forfeited accounts - At August 31, 2023 and December 31, 2022, there were no forfeited non-vested accounts.

NOTE 2 - Summary of Significant Accounting Policies

Basis of accounting - The financial statements of the Plan are prepared on the accrual basis of accounting.

Use of estimates - The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America requires Plan management to make estimates and assumptions that affect certain reported amounts of assets and liabilities and disclosure of contingent assets and liabilities at the date of the financial statements and changes therein. Actual results could differ from those estimates.

Investment valuation and income recognition - Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan's management determines the Plan's valuation policies utilizing information provided by the investment advisers and trustee. See Note 4 for discussion of fair value measurements.

Purchases and sales of investments are recorded on a trade-date basis. Dividend income is recorded on the ex-dividend date. Net appreciation included the Plan's gains and losses on investments purchased and sold as well as held during the year.

Contributions - Contributions for Plan participants and the matching contributions from the employer are recorded in the year in which the employee contributions are withheld from compensation.

Notes receivable from participants - Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred.

Payment of benefits - Benefits are recorded when paid.

Expenses - Certain expenses of maintaining the Plan are paid directly by the Company and are excluded from these financial statements. Fees related to administration benefit payments are charged directly to the participant's account and are included in administrative expenses. Investment related expenses are included in net appreciation of fair value of investments.

Subsequent events - The Plan has evaluated subsequent events through June 10, 2024, the date the financial statements were available to be issued.

NOTE 3 - Certification of Investment Information

Principal Trust Company holds the Plan's investments and notes receivable from participants and executes all related transactions. The investment and notes receivable from participant balances and related income and losses included in the accompanying financial statements and supplemental schedule of assets held at end of year are based solely on information certified by Principal Trust Company.

NOTE 4 - Fair Value Measurements

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1) and the lowest priority to unobservable inputs (level 3). Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs. The three levels of the fair value hierarchy under FASB ASC 820 are described as follows:

Level 1 - Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

NOTE 4 - Fair Value Measurements - (Continued)

Level 2 - Inputs to the valuation methodology include:

- quoted prices for similar assets or liabilities in active markets;
- quoted prices for identical or similar assets or liabilities in inactive markets;
- inputs other than quoted prices that are observable for the asset or liability;
- inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 - Inputs to the valuation methodology that are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

The following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2022.

Mutual funds – Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the Security and Exchange Commission. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

Pooled separate accounts - Valued at fair value based on the NAV of similar shares held by the Plan at period end. They are similar to mutual funds but are only available to group annuity contract holders.

Common collective trust funds – Fair value is determined by the underlying assets daily value using net asset value (NAV) of the investments as reported to current investors and in the annual audited financial statements.

NOTE 5 - Related-Party Transactions and Party In Interest Transactions

Certain Plan investments are managed by Principal Life Trust Company. Principal Trust Company is the trustee as defined by the Plan and, therefore, these transactions qualify as party in interest transactions. During 2023, the Plan incurred \$35,274 of investment management services fees and contract administration fees paid to Principal Trust Company which is included in administrative expenses.

The Plan used Gregory J. Schwartz & Co., Inc. to help manage their investments. During 2023, the Plan paid \$28,714 for investment and management fees.

Certain administrative functions are performed by officers and employees of the Company. No officer or employee receives compensation from the Plan for these services.

NOTE 6 - Plan Merger

As discussed in Note 1, the Plan was merged into a similar Plan on August 31, 2023. All participant balances were transferred into a similar Plan of the plan sponsor.

NOTE 7 - Tax Status

The trust established under the Plan to hold the Plan's assets is qualified pursuant to the appropriate section of the Internal Revenue Code, and, accordingly, the trust's net investment income is exempt from income taxes. The trust is utilizing a standardized prototype plan on which the plan document sponsor has obtained a favorable tax opinion letter and the plan sponsor believes that the Plan continues to qualify and to operate as designed.

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS or state authorities. The Plan is subject to routine audits by taxing jurisdictions; however there are currently no audits for any tax periods in progress.

NOTE 8 - Risks and Uncertainties
