Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the financial statements of the AFC Industries, Inc. Profit Sharing Plan ("Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 ("ERISA"), as permitted by ERISA Section 103(a)(3)(C). The financial statements comprise the statements of net assets available for benefits as of August 29, 2023 and December 31, 2022, and the related statement of changes in net assets available for benefits for the period ended August 29, 2023, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the Plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained a certification from a qualified institution as of August 29, 2023 and December 31, 2022 and for the period ended August 29, 2023 stating that the certified investment information is complete and accurate as described in Note 3 to the financial statements.

Opinion

In our opinion, based on our audits and on the procedures performed as described in the Auditor's Responsibilities for the Audit of the Financial Statements section:

- the amounts and disclosures in the accompanying financial statements, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America ("U.S. GAAP").
- the information in the accompanying financial statements related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

Basis for Opinion

We conducted our audits in accordance with auditing standards generally accepted in the United States of America (“U.S. GAAS”). Our responsibilities under those standards are further described in the Auditor’s Responsibilities for the Audit of the Financial Statements section of our report. We are required to be independent of the Plan and to meet our other ethical responsibilities in accordance with the relevant ethical requirements relating to our audits. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our ERISA Section 103(a)(3)(C) audit opinion.

Responsibilities of Management for the Financial Statements

Management is responsible for the preparation and fair presentation of the financial statements in accordance with U.S. GAAP, and for the design, implementation and maintenance of internal control relevant to the preparation and fair presentation of the financial statements that are free from material misstatement, whether due to fraud or error. Management’s election of the ERISA Section 103(a)(3)(C) audit does not affect management’s responsibility for the financial statements.

In preparing the financial statements, management is required to evaluate whether there are conditions or events, considered in the aggregate, that raise substantial doubt about the Plan’s ability to continue as a going concern for one year after the date the financial statements are available to be issued.

Management is also responsible for maintaining a current Plan instrument, including all Plan amendments, administering the Plan and determining that the Plan’s transactions that are presented and disclosed in the financial statements are in conformity with the Plan’s provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.

Auditor’s Responsibilities for the Audit of the Financial Statements

Except as described in the Scope and Nature of the ERISA Section 103(a)(3)(C) Audit section of our report, our objectives are to obtain reasonable assurance about whether the financial statements as a whole are free from material misstatement, whether due to fraud or error, and to issue an auditor’s report that includes our opinion. Reasonable assurance is a high level of assurance but is not absolute assurance and therefore is not a guarantee that an audit conducted in accordance with U.S. GAAS will always detect a material misstatement when it exists. The risk of not detecting a material misstatement resulting from fraud is higher than for one resulting from error, as fraud may involve collusion, forgery, intentional omissions, misrepresentations or the override of internal control. Misstatements are considered material if there is a substantial likelihood that, individually or in the aggregate, they would influence the judgment made by a reasonable user based on the financial statements. In performing an audit in accordance with U.S. GAAS, we:

- Conclude whether, in our judgment, there are conditions or events, considered in the aggregate, that raise substantial doubt about the Plan’s ability to continue as a going concern for a reasonable period of time.

Our audits did not extend to the certified investment information, except for obtaining and reading the certification, comparing the certified investment information with the related information presented and disclosed in the financial statements, and reading the disclosures relating to the certified investment information to assess whether they are in accordance with the presentation and disclosure requirements of U.S. GAAP.

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with U.S. GAAP.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings and certain internal control-related matters that we identified during the audit.

NOTE 1 - DESCRIPTION OF PLAN

The following description of the AFC Industries, Inc. Profit Sharing Plan (“Plan”) provides only general information. Participants should refer to the Plan document for a complete description of the Plan’s provisions.

General - The Plan is a defined contribution profit-sharing plan originally established on January 1, 1989 to provide retirement benefits for employees of the Plan sponsor, AFC Industries, Inc. (“Company” or “Plan Sponsor”). The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (“ERISA”).

The Plan is administered by an investment committee appointed by the Company’s management. The investment committee has the power to interpret provisions of the Plan, decide any disputes that might arise regarding the rights of the participants and, in general, direct the administration of the Plan.

On July 28, 2023, the Board of Directors approved a merger of the Plan into the Aon Pooled Employer Plan ("Aon PEP"). The merger was effective on September 1, 2023. As a result of the merger, all participants and surviving beneficiaries in the Plan will become participants in the Aon PEP. See Note 9.

The custodian of the Plan is Voya Retirement Insurance and Annuity Company (“Voya”).

Eligibility - All salaried and hourly employees of the Company who are at least 21 years of age and have been employed by the Company for any consecutive 12-month period in which the employee has at least 1,000 hours of service are eligible to participate in the Plan. Upon becoming eligible, participants may enroll at the next available entry date, January 1 or July 1. The Plan was amended in 2016, 2017 and 2019 to allow employees of Accurate Fasteners, Inc.; Best Bolt Products, Inc.; Sodell Procurement International, Inc.; The Boulder Co.; Patton Industrial Products, Inc.; and Chess Group, Inc., who became employed by the Company as a result of acquisitions by the Company, to enter the Plan on dates outside of the normal entrance dates. Additionally, the Plan was amended in 2020 and 2021 to allow employees of Master Distribution LLC, Cline Tool and Service Company, Inc.; Oregon Bolt, Inc.; and Aall American Fasteners, who became employed by the Company as a result of the acquisition by the Company, to enter the Plan on dates outside of the normal entrance dates. Additionally, employees from Cline Tool and Service Company, Inc., Oregon Bolt, Inc. and Aall American Fasteners had to have two months of service with those companies prior to the dates of acquisition by the Plan Sponsor, and employees of Cline Tool and Service Company, Inc. and Oregon Bolt, Inc. had to be 21 years of age. Employees who became participants via the acquisitions have the option of rolling their balances into the Plan.

Participant Contributions - Eligible employees can contribute, on a pretax or Roth 401(k) basis, a portion of their compensation as defined by the Plan, subject to certain limitations under the Internal Revenue Code (“IRC”). Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans (rollovers). Participants direct their contributions into various investment options offered by the Plan.

NOTE 1 - DESCRIPTION OF PLAN (Continued)

Company Contributions - The Company makes safe harbor contributions to the Plan equal to at least 3% of each eligible employee's compensation. The Company may also make discretionary matching contributions to the Plan. The Company authorized discretionary matching contributions of 25% of each employee's elective deferrals for 2023. Fiscal year 2023 safe harbor contributions and discretionary matching contributions were accrued after the Aon PEP merger and are payable in 2024. In addition, the Company may make discretionary profit-sharing contributions and qualified nonelective contributions to the Plan. No discretionary profit-sharing contributions or qualified nonelective contributions were made to the Plan in 2023.

Participant Accounts - Each participant's account is credited with the participant's contributions, Company's contributions and an allocation of Plan earnings. Participants' accounts are charged with an allocation of administrative expenses that are paid by the Plan. Allocations are based on participant earnings, account balances or specific participant transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Vesting - Participants are vested immediately in their participant contributions, rollovers, employer safe harbor contributions, qualified nonelective contributions and actual earnings thereon. Vesting in discretionary profit-sharing contributions and discretionary employer matching contributions are based on the following schedule:

Less than two years	0%
Two but less than three years	20%
Three but less than four years	40%
Four but less than five years	60%
Five but less than six years	80%
Six years and over	100%

Payment of Benefits - On termination of service due to death, retirement or other reasons, a participant may receive a lump-sum amount, installment, or both, equal to the value of the participant's vested interest in his or her account. Any balance under \$5,000 is automatically paid out as soon as administratively possible. If an account balance is under \$1,000, the Plan administrator will distribute the amount without consent or may transfer the account to an individual retirement account.

Hardship Withdrawals - The Plan administrator may direct the custodian to distribute up to 100% of a participant's vested account balance in the event of immediate financial need. Withdrawals will be authorized only if the distribution is for the payment of unreimbursed medical care expenses, costs directly related to the purchase of the participant's principal residence, tuition payments, payments to prevent eviction from his or her principal residence, payments for burial or funeral expenses for the employee's deceased parent, spouse, children or dependents, expenses for the repair of damage to a participant's principal residence that qualify for the casualty loss deduction under Code Section 165, or any other event authorized by the Internal Revenue Service ("IRS") through notices.

Forfeitures - Participants who leave the Company and incur a break in service forfeit the nonvested portion of their accounts. At August 29, 2023 and December 31, 2022, forfeited nonvested accounts approximated \$0 and \$22,000, respectively. The Plan did not utilize forfeiture funds to reduce the employer contribution during the period ended August 29, 2023.

NOTE 2 - SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

A summary of significant accounting policies consistently applied by the Plan administrator in the preparation of the accompanying statements of net assets available for benefits and related statement of changes in net assets available for benefits and the related notes to the financial statements follows:

Basis of Accounting - The financial statements of the Plan are prepared on the accrual basis of accounting.

Use of Estimates - The preparation of financial statements in accordance with generally accepted accounting principles in the United States of America ("U.S. GAAP") requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

Investment Valuation and Income Recognition - Investments are reported at fair value (except for the fully benefit-responsive investment contract, which is reported at contract value, See Note 5), which is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year. The Plan's investment committee determines the Plan's valuation policies utilizing information provided by the investment advisors and custodian.

Receivables - Contributions from the Company are accrued in the period in which they become obligations of the Company in accordance with the Plan document. Employer contributions are accrued at year-end and are payable to the Plan within one year. As of August 29, 2023, no employer contribution receivable was accrued.

Benefit Payments - Benefits are recorded when paid.

Administrative Expenses - Certain expenses of maintaining the Plan are paid directly by the Plan, unless otherwise paid by the Company. Expenses that are paid by the Company are excluded from these financial statements. Fees related to the administration of benefit payments are charged directly to the participant's account and are included in administrative expenses. Investment-related expenses are included in net appreciation in fair value of investments.

NOTE 3 - INFORMATION CERTIFIED BY THE PLAN CUSTODIAN (UNAUDITED)

Certain information related to investments disclosed in the accompanying financial statements, including investments held at August 29, 2023 and December 31, 2022, and net appreciation in fair value of investments for the period ended August 29, 2023, was obtained by management and agreed to or derived from information certified as complete and accurate by Voya, custodian of the Plan.

NOTE 4 - FAIR VALUE MEASUREMENT

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). The three levels of the fair value hierarchy under Financial Accounting Standards Board Accounting Standards Codification 820 are as follows:

Level 1 - Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 - Inputs to the valuation methodology are based on quoted prices for similar assets or liabilities in active markets, quoted prices for identical or similar assets or liabilities in inactive markets, inputs other than quoted prices that are observable for the asset or liability, or inputs that are derived principally from or corroborated by observable market data by correlation or other means. If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 - Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for investments. There have been no changes in the methodologies used at August 29, 2023 and December 31, 2022:

Pooled separate accounts - The pooled separate accounts are valued using the net asset value ("NAV") as a practical expedient of the fund shares, calculated based on the valuation of the funds' underlying investments, which consist solely of mutual funds, each of which follows a separate investment strategy. The investments are public investment vehicles, which are valued using the NAV provided by the custodian, acting as administrator of the funds. The NAV is based on the value of the underlying assets owned by the funds, excluding transaction costs, minus its liabilities, then divided by the number of shares outstanding.

The method described above might produce a fair value calculation that might not be indicative of net realizable value or reflective of future fair values. Further, while the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

NOTE 5 - INVESTMENT CONTRACT WITH INSURANCE COMPANY

The Plan offers participants the option to invest in a fully benefit-responsive investment contract with Voya, which maintains the contributions in a general account. The account is credited with earnings on the underlying investments and charged for participant withdrawals and administrative expenses. The contract is included in the financial statements at contract value as reported to the Plan by Voya. Contract value, as reported to the Plan by Voya, represents contributions made under the contract, plus earnings, less participant withdrawals and administrative expenses. Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investment at contract value.

As described in Note 2, because the fixed account is fully benefit-responsive, contract value is the relevant measurement attribute for that portion of the net assets available for benefits attributable to the fixed account. There are no reserves against contract value for credit risk of the contract issuer or otherwise. The crediting rate is based on a formula established by the contract issuer but may not be less than 1%. The crediting rate is reviewed on a quarterly basis for resetting. The fixed account does not permit the insurance company to terminate the agreement prior to the scheduled maturity date.

Certain events limit the ability of the Plan to transact at contract value with the issuer, including (1) amendments to the Plan document (including complete or partial Plan termination or merger with another plan); (2) changes to the Plan's prohibition on competing investments options or deletion of equity wash provisions; (3) bankruptcy of the Plan sponsor or other Plan sponsor events (e.g., divestitures or spinoffs of a subsidiary) that cause a significant withdrawal from the Plan; or (4) the failure of the Plan to qualify for exemption under ERISA. The Plan administrator believes that any event that would limit the Plan's ability to transact at contract value with participants are probable of occurring, due to the merger with another plan. (See Note 9.)

NOTE 6 - INCOME TAX STATUS

The Plan adopted a volume submitter prototype plan, which received an opinion letter from the IRS dated June 30, 2020 stating that the Plan is designed in accordance with the applicable sections of the IRC. Although the Plan has been amended since receiving the opinion letter, the Plan administrator and the Plan's tax counsel believe that the Plan is designed and is currently being operated in compliance with the applicable requirements of the IRC and, therefore, believes that the Plan is qualified and the related trust is tax exempt.

U.S. GAAP requires Plan management to evaluate the tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain tax position that more likely than not would not be sustained upon examination by the IRS. The Plan administrator has analyzed the tax positions taken by the Plan, and has concluded that as of August 29, 2023 and December 31, 2022, there are no uncertain tax positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress. The Plan administrator believes that the Plan is no longer subject to income tax examinations for years prior to 2020.

NOTE 7 - EXEMPT PARTY-IN-INTEREST TRANSACTIONS

Plan investments consist of investments managed by Voya, which is the custodian as defined by the Plan, and, therefore, these transactions qualify as party-in-interest transactions that are allowable under ERISA. The Company paid certain administrative expenses related to the Plan for the period ended August 29, 2023. Certain administrative functions are performed by officers or employees of the Company at no cost to the Plan.

NOTE 8 - RISKS AND UNCERTAINTIES

The Plan invests in securities that are exposed to various risks such as interest rate, market and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in value will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

NOTE 9 - SUBSEQUENT EVENTS

Subsequent events are defined as events or transactions that occur after the statement of net assets available for benefits date, but before the financial statements are issued or are available to be issued.

Effective September 1, 2023, the Plan merged into the Aon PEP, and all Plan participants and surviving beneficiaries became participants in the Aon PEP. All participant account balances were transferred to the Aon PEP on August 29, 2023, resulting in \$20,855,765 of net assets being transferred out of the Plan, as presented in the statement of changes in net assets available for benefits. No distributions were made by the Company as part of the merger, and the Company did not adopt the liquidation basis of accounting nor were the financial statements prepared using the liquidation basis of accounting.

Management has evaluated subsequent events through June 11, 2024, the date that the financial statements were issued, and determined that there have been no other events that have occurred that would require adjustments to or disclosures in the financial statements.
